1 About this Guide

This guide provides instructions on how to install and configure your Cisco Aironet 1815w access points. This guide also provides mounting instructions and limited troubleshooting procedures.

The Aironet 1815w access point is abbreviated as AP in this document.

2 About the Access Point

The Cisco Aironet 1815w access point is an 802.11 a/b/g/n/ac (Wave 2) access point, with internal antennas.

The Cisco Aironet 1815w AP can be vertically mounted on a wall or on a standard junction box. Physical security is offered with the included Torx screw and the option to add a Kensington lock.

The AP supports 2.4 GHz 2x2 802.11 b/g/n MU-MIMO and 5 GHz 2x2 802.11 a/n/ac (Wave 2) MU-MIMO applications simultaneously.

- The AP supports the following hardware external interfaces:
 - Three local GigE Ethernet Ports, one uplink GigE port, and one passive pass-through RJ45 port.
 - RS-232 management console interface through a custom 4-pin connector AIR-CONSADPT=.
 - Three 10/100/1000BASE-T ports (local Ethernet ports), one of which also serves as a PoE-Out port.

The PoE-Out port 802.3af Class 0 (15.4W) power when the AP is powered by802.3at power. The PoE-Out port does not provide any power output when the AP is powered by 802.3af power.

- One RJ-45 passive pass-through port (back to bottom).
- Mode button. For information on how to use the Mode button, see "Using the Mode Button" section on page 35.
- One multi-color LED status indicator for the AP status. LEDs are also present to indicate per-port status for local the Ethernet ports. For information, see the "Checking the Access Point LEDs" section on page 32.
- Three local Gigabit Ethernet ports available to securely connect wired devices to the network.
- Two integrated 2.4 GHz/5 GHz dual-band antennas located on the sides of the 1815w access point under the top housing. Peak antenna gain is approximately 2 dBi and 3 dBi in the 2.4 GHz and 5 GHz bands respectively.

Access Point Model Numbers and Regulatory Domains

The Cisco Aironet 1815w access point comes in the model number format AIR-AP1815W-x-K9. The 'x' in the model number is a placeholder for the regulatory domain. For information on supported regulatory domains, see the following page:

4 Unpacking the AP


To unpack the access point, follow these steps:

- **Step 1** Unpack and remove the access point and the mounting accessories, from the shipping box.
- **Step 2** Return any packing material to the shipping container and save it for future use.
- **Step 3** Verify that you have received the items listed below. If any item is missing or damaged, contact your Cisco representative or reseller for instructions.
 - The access point
 - Mounting wall-plate bracket AIR-AP-BRACKET-W3, and screws.
 - Torx security screw and mylar label to cover the screw.

The following accessories can be ordered separately from Cisco:

- Spacer kit AIR-AP1815W-KIT=, includes spacer box, RJ-45 jumper cable, four M3.5x32 mounting screws, two #6-32x1.62" truss head machine screws, two M3x8 pan head mounting screws.
- Physical security kit AIR-SEC-50=, which includes 50 security screws used to secure the access point onto the wall-mounting bracket, 50 RJ-45 block-out plugs and 2 unlock keys for blocking physical access to the RJ45 Ethernet ports.
- Bracket Kit AIR-AP-BRACKET-W3, includes the mounting bracket, one M2x5.5 Torx security screw, two M3.5x32 pan head mounting screws, two #6-32x0.81" truss head machine-type mounting screws.

Ports and Connectors on the AP






Figure 2 Base of the AP with the Ports and Connectors



A physical security kit AIR-SEC-50=, which is sold separately, includes RJ-45 block-out plugs and two unlock keys using which you can restrict physical access to the Ethernet port.

Note

All the three LAN ports support Auto-MDIX. The interface automatically detects the required cable connection type (straight through or crossover) and configures the connection appropriately.

6 Preparing the AP for Installation

Before you mount your access point, we recommend that you perform a site survey (or use the site planning tool) to determine the best location to install your access point.

You should have the following information about your wireless network available:

- Access point locations.
- Access point mounting options: vertical wall-mounting only.
- Access point power options. See the "Powering the Access Point" section on page 28

Cisco recommends that you make a site map showing access point locations so that you can record the device MAC addresses from each location and return them to the person who is planning or managing your wireless network.

8 Performing a Pre-Installation Configuration

The following procedures ensure that your access point installation and initial operation go as expected for a Cisco wireless controller-based (i.e. having a physical controller device) network. This procedure is optional.



Note Performing a pre-installation configuration is an optional procedure. If your network controller is properly configured, you can install your access point in its final location and connect it to the network from there. See the "Deploying the Access Point on the Wireless Network" section on page 31 for details.




Figure 4 Pre-Installation Configuration Setup

The pre-installation configuration setup is illustrated in Figure 4.

To perform pre-installation configuration, perform the following steps:

- **Step 1** Make sure that the Cisco wireless LAN controller DS port is connected to the network. Use the CLI, web-browser interface, or Cisco Prime Infrastructure procedures as described in the appropriate Cisco wireless LAN controller guide.
 - **a.** Make sure that access points have Layer 3 connectivity to the Cisco wireless LAN controller Management and AP-Manager Interface.
 - **b.** Configure the switch to which your access point is to attach. See the *Cisco Wireless LAN* Controller Configuration Guide for the release you are using, for additional information.
 - **c.** Set the Cisco wireless LAN controller as the master so that new access points always join with it.
 - **d.** Make sure DHCP is enabled on the network. The access point must receive its IP address through DHCP.
 - e. CAPWAP UDP ports must not be blocked in the network.
 - f. The access point must be able to find the IP address of the controller. This can be accomplished using DHCP, DNS, or IP subnet broadcast. This guide describes the DHCP method to convey the controller IP address. For other methods, refer to the product documentation. See also the "Configuring DHCP Option 43" section on page 38 for more information.



The access point requires a Gigabit Ethernet (GbE) link to prevent the Ethernet port from becoming a bottleneck for traffic because wireless traffic speeds exceed transmit speeds of a 10/100 Ethernet port.

Step 2 Apply power to the access point. See Powering the Access Point, page 28.

a. As the access point attempts to connect to the controller, the LEDs cycle through a green, red, and amber sequence, which can take up to 5 minutes.



- **Note** If the access point remains in this mode for more than five minutes, the access point is unable to find the Master Cisco wireless LAN controller. Check the connection between the access point and the Cisco wireless LAN controller and be sure that they are on the same subnet.
 - **b.** If the access point shuts down, check the power source.

- **c.** After the access point finds the Cisco wireless LAN controller, it attempts to download the new operating system code if the access point code version differs from the Cisco wireless LAN controller code version. While this is happening, the Status LED blinks amber.
- d. If the operating system download is successful, the access point reboots.
- **Step 3** Configure the access point if required. Use the controller CLI, controller GUI, or Cisco Prime Infrastructure to customize the access-point-specific 802.11ac network settings.
- **Step 4** If the pre-installation configuration is successful, the Status LED is green indicating normal operation. Disconnect the access point and mount it at the location at which you intend to deploy it on the wireless network.
- **Step 5** If your access point does not indicate normal operation, turn it off and repeat the pre-installation configuration.



Note

When you are installing a Layer 3 access point on a different subnet than the Cisco wireless LAN controller, be sure that a DHCP server is reachable from the subnet on which you will be installing the access point, and that the subnet has a route back to the Cisco wireless LAN controller. Also be sure that the route back to the Cisco wireless LAN controller has destination UDP ports 5246 and 5247 open for CAPWAP communications. Ensure that the route back to the primary, secondary, and tertiary wireless LAN controller allows IP packet fragments. Finally, be sure that if address translation is used, that the access point and the Cisco wireless LAN controller have a static 1-to-1 NAT to an outside address. (Port Address Translation is not supported.)

9 Mounting the Access Point

Cisco Aironet 1815w access points can be mounted directly on the wall, to numerous global wall junction standards.

Mounting the AP directly on a Wall

To mount the AP on a wall, follow these steps:

Step 1 Fasten the wall-mount bracket (AIR-AP-BRACKET-W3) to the wall, using two M3.5X32mm screws. Ensure that the side having the **Mount Arrows Up** label is facing outwards, and the bracket is oriented vertically as indicated by the arrows. See Figure 11.


The wall-bracket dimensions are given in Figure 12.

Step 2 Connect the power and network cables to the AP.

If you are unable to connect a PoE cable to the port on the back of the AP, then:

- **a.** On the back of the AP, use an RJ45 jumper cable to connect the PoE port to the Pass-Through port. This jumper cable is available as part of the spacer kit AIR-AP1815W-KIT=.
- **b.** Connect the PoE supply cable to the Pass-Through port on the base of the AP.

- **Step 3** Mount the AP onto the wall-mount bracket. For this, align the AP with the bracket and then offset the AP around ¹/₄ inch above the bracket.
- **Step 4** Fasten the AP to the bracket using the M2 x 5.5mm Torx security screw. Cover it with the mylar label.

Mounting the AP on an Electrical Junction Box

To mount the AP on an electrical junction box, follow these steps:

Step 1 Fasten the wall-mount bracket (AIR-AP-BRACKET-W3), using two #6-32 x 0.81 inch machine screws, to the electrical junction box. Ensure that the side having the Mount Arrows Up label is facing outwards, and the bracket is oriented vertically as indicated by the arrows. See Figure 11.

The wall-bracket dimensions are given in Figure 12.


Step 2 Connect the power and network cables to the AP.

If you are unable to connect a PoE cable to the port on the back of the AP, then:

- **a.** On the back of the AP, use an RJ45 jumper cable to connect the PoE port to the Pass-Through port. This jumper cable is available as part of the spacer kit AIR-AP1815W-KIT=.
- **b.** Connect the PoE supply cable to the Pass-Through port on the base of the AP.

- **Step 3** Mount the AP onto the wall-mount bracket. For this, align the AP with the bracket and then offset the AP around ¼ inch above the bracket.
- **Step 4** Fasten the AP to the bracket using the M2 x 5.5mm Torx security screw. Cover it with the mylar label.

Mounting the AP on a Wall using the Spacer

To mount the AP on a wall, using a spacer box, follow these steps:

Step 1 Fasten the spacer box (AIR-AP1815W-KIT=) to the wall, using four M3.5 x 32mm screws. Ensure that the side having the Mount Arrows Up label is facing outwards, and the box is oriented vertically as indicated by the arrows. See Figure 9.




Figure 10 Dimensions of Wall-Mount Spacer in AIR-AP1815W-KIT= (All values in millimeter)

The spacer box dimensions are given in Figure 10.






Figure 11 Wall-Mount Bracket AIR-AP-BRACKET-W3




Figure 12 Dimensions of Wall-Mount Bracket AIR-AP-BRACKET-W3 (All values in millimeter)

- Step 2 Fasten the wall-mount bracket (AIR-AP-BRACKET-W3) to the spacer box, using two M3X8mm tapping screws. Ensure that the side having the Mount Arrows Up label is facing outwards, and the bracket is oriented vertically as indicated by the arrows. See Figure 11. The wall-bracket dimensions are given in Figure 12.
- **Step 3** Connect the power and network cables to the AP.

If you are unable to connect a PoE cable to the port on the back of the AP, then:

- **a.** On the back of the AP, use an RJ45 jumper cable to connect the PoE port to the Pass-Through port. This jumper cable is available as part of the spacer kit AIR-AP1815W-KIT=.
- **b.** Connect the PoE supply cable to the Pass-Through port on the base of the AP.



- **Note** The punch-out holes on the spacer box (AIR-AP1815W-KIT) can be used for routing cables. However, an RJ45 connector will not fit through these holes. If this is required, you must first route a cable through the hole and then crimp an RJ45 connector on to the cable.
- **Step 4** Mount the AP onto the wall-mount bracket. For this, align the AP with the bracket and then offset the AP around ¹/₄ inch above the bracket.
- **Step 5** Fasten the AP to the bracket using the M2 x 5.5mm Torx security screw. Cover it with the mylar label.

Mounting the AP on an Electrical Junction Box using the Spacer

To mount the AP on an electrical junction box, using a spacer box, follow these steps:

Step 1 Fasten the wall-mount bracket (AIR-AP-BRACKET-W3) to the spacer box (AIR-AP1815W-KIT=), using two M3X8mm pan head tapping screws. Ensure that the side having the Mount Arrows Up label facing outwards, and the bracket oriented vertically as indicated by the arrows. See Figure 9 and Figure 11.

The spacer box dimensions are given in Figure 10.

The wall-bracket dimensions are given in Figure 12.


- **Step 2** Fasten the wall-mount bracket and spacer box assembly to the electrical junction box, using two #6-32X1.62 inch machine screws. Ensure that the side having the **Mount Arrows Up** label is facing outwards, and the box is oriented vertically as indicated by the arrows.
- **Step 3** Connect the power and network cables to the AP.


If you are unable to connect a PoE cable to the port on the back of the AP, then:

- **a.** On the back of the AP, use an RJ45 jumper cable to connect the PoE port to the Pass-Through port. This jumper cable is available as part of the spacer kit AIR-AP1815W-KIT=.
- **b.** Connect the PoE supply cable to the Pass-Through port on the base of the AP.




- **Note** The punch-out holes on the spacer box (AIR-AP1815W-KIT) can be used for routing cables. However, an RJ45 connector will not fit through these holes. If this is required, you must first route a cable through the hole and then crimp an RJ45 connector on to the cable.
- **Step 4** Mount the AP onto the wall-mount bracket. For this, align the AP with the bracket and then offset the AP around ¹/₄ inch above the bracket.
- **Step 5** Fasten the AP to the bracket using the M2 x 5.5mm Torx security screw. Cover it with the mylar label.

10 Powering the Access Point

The AP can be powered using Power-over-Ethernet (PoE) from the Ethernet cable on either one of the uplink ports, from an external power source such as:

- Cisco Power Injector AIR-PWRINJ5= (for 802.3af) or AIR-PWRINJ6= (for 802.3at).
- 802.3af or 802.3at compatible PoE switching infrastructure
- 802.3af or 802.3at compatible power injectors

The PoE-Out port (labeled PSE) provides 802.3af power when the AP is powered by 802.3at power, and no power output when the AP is powered by 802.3af power.

11 Configuring and Deploying the Access Point

This section describes how to connect the access point to a wireless LAN controller. Because the configuration process takes place on the controller, see the *Cisco Wireless LAN Controller Configuration Guide* for additional information.

The Controller Discovery Process

The access point uses standard Control and Provisioning of Wireless Access Points Protocol (CAPWAP) to communicate between the controller and other wireless access points on the network. CAPWAP is a standard, inter-operable protocol which enables an access controller to manage a collection of wireless termination points. The discovery process using CAPWAP is identical to the Lightweight Access Point Protocol (LWAPP) used with previous Cisco Aironet access points. LWAPP-enabled access points are compatible with CAPWAP, and conversion to a CAPWAP controller is seamless. Deployments can combine CAPWAP and LWAPP software on the controllers.

The functionality provided by the controller does not change except for customers who have Layer 2 deployments, which CAPWAP does not support.

In a CAPWAP environment, a wireless access point discovers a controller by using CAPWAP discovery mechanisms and then sends it a CAPWAP join request. The controller sends the access point a CAPWAP join response allowing the access point to join the controller. When the access point joins the controller, the controller manages its configuration, firmware, control transactions, and data transactions.

Note

For additional information about the discovery process and CAPWAP, see the *Cisco Wireless* LAN Controller Software Configuration Guide. This document is available on Cisco.com.

Note

CAPWAP support is provided in controller software release 5.2 or later. However, your controller must be running the release that supports Cisco Aironet 1815w access points, as specified in the access point's data sheet.



You cannot edit or query any access point using the controller CLI if the name of the access point contains a space.



Make sure that the controller is set to the current time. If the controller is set to a time that has already occurred, the access point might not join the controller because its certificate may not be valid for that time.

Access points must be discovered by a controller before they can become an active part of the network. The access point supports these controller discovery processes:

- Layer 3 CAPWAP discovery—Can occur on subnets different from that of the access point and uses IP addresses and UDP packets.
- Locally stored controller IP address discovery—If the access point was previously joined to a controller, the IP addresses of the primary, secondary, and tertiary controllers are stored in the access point's non-volatile memory. This process of storing controller IP addresses on an access point for later deployment is called *priming the access point*. For more information about priming, see the "Performing a Pre-Installation Configuration" section on page 12.
- DHCP server discovery—This feature uses DHCP option 43 to provide controller IP addresses to the access points. Cisco switches support a DHCP server option that is typically used for this capability. For more information about DHCP option 43, see the "Configuring DHCP Option 43" section on page 38.
- DNS discovery—The access point can discover controllers through your domain name server (DNS). For the access point to do so, you must configure your DNS to return controller IP addresses in response to CISCO-CAPWAP-CONTROLLER.*localdomain*, where *localdomain* is the access point domain name. Configuring the CISCO-CAPWAP-CONTROLLER provides backwards compatibility in an existing customer deployment. When an access point receives an IP address and DNS information from a DHCP server, it contacts the DNS to resolve CISCO-CAPWAP-CONTROLLER.*localdomain*. When the DNS sends a list of controller IP addresses, the access point sends discovery requests to the controllers.

Deploying the Access Point on the Wireless Network

After you have mounted the access point, follow these steps to deploy it on the wireless network:

- **Step 1** Connect and power up the access point.
- **Step 2** Observe the access point LED (for LED descriptions, see "Checking the Access Point LEDs" section on page 32).
 - **a.** When you power up the access point, it begins a power-up sequence that you can verify by observing the access point LED. If the power-up sequence is successful, the discovery and join process begins. During this process, the LED blinks sequentially green, red, and off. When the access point has joined a controller, the LED is chirping green if no clients are associated or green if one or more clients are associated.
 - **b.** If the LED is not on, the access point is most likely not receiving power.
 - **c.** If the LED blinks sequentially for more than 5 minutes, the access point is unable to find its primary, secondary, and tertiary Cisco wireless LAN controller. Check the connection between the access point and the Cisco wireless LAN controller, and be sure the access point and the Cisco wireless LAN controller, and be sure the access point has a route back to its primary, secondary, and tertiary Cisco wireless LAN controller. Also, if the access point is not on the same subnet as the Cisco wireless LAN controller, be sure that there is a properly configured DHCP server on the same subnet as the access point. See the "Configuring DHCP Option 43" section on page 38 for additional information.
- Step 3 Reconfigure the Cisco wireless LAN controller so that it is not the Master.



A Master Cisco wireless LAN controller should be used only for configuring access points and not in a working network.

12 Checking the Access Point LEDs

Access Point Status LEDs

The location of the access point status LED is shown in Figure 2. For privacy, the status LED is automatically turned off when the access point joins a controller.



Regarding LED status colors, it is expected that there will be small variations in color intensity and hue from unit to unit. This is within the normal range of the LED manufacturer's specifications and is not a defect.

The access point status LED indicates various conditions and are described in Table 2.

13 Miscellaneous Usage and Configuration Guidelines

Using the Mode Button

Using the Mode button (see Figure 3) you can:

- Reset the AP to it default factory-shipped configuration.
- Clear the AP internal storage, including all configuration files and the regulatory domain configuration.

To use the mode button, press, and keep pressed, the mode button on the access point during the AP boot cycle. Wait until the AP status LED changes to Amber. During this, the AP console shows a seconds counter, counting the number of seconds the mode button is pressed. Then:

• To reset the AP to default factory-shipped configuration, keep the mode button pressed for less than 20 seconds. The AP configuration files are cleared.

This resets all configuration settings to factory defaults, including passwords, WEP keys, the IP address, and the SSID. However, the regulatory domain provisioning is not reset.

• To clear the AP internal storage, including all configuration files and the regulatory domain configuration, keep the mode button pressed for more than 20 seconds, but less than 60 seconds.

The AP status LED changes from Amber to Red, and all the files in the AP storage directory are cleared. This also removes any regulatory domain provisioning made previously and resets the AP back to -UX domain.

If you keep the mode button pressed for more than 60 seconds, the mode button is assumed faulty and no changes are made.

Troubleshooting the Access Point to Cisco Controller Join Process



Ensure that your controller is running the latest Cisco Wireless Controller Software Release as specified in the access point's data sheet.

Access points can fail to join a controller for many reasons: a RADIUS authorization is pending; self-signed certificates are not enabled on the controller; the access point's and controller's regulatory domains don't match, and so on.

Controller software enables you to configure the access points to send all CAPWAP-related errors to a syslog server. You do not need to enable any debug commands on the controller because all of the CAPWAP error messages can be viewed from the syslog server itself.

The state of the access point is not maintained on the controller until it receives a CAPWAP join request from the access point. Therefore, it can be difficult to determine why the CAPWAP discovery request from a certain access point was rejected. In order to troubleshoot such joining problems without enabling CAPWAP debug commands on the controller, the controller collects information for all access points that send a discovery message to it and maintains information for any access points that have successfully joined it.

The controller collects all join-related information for each access point that sends a CAPWAP discovery request to the controller. Collection begins with the first discovery message received from the access point and ends with the last configuration payload sent from the controller to the access point.

You can view join-related information for up to three times the maximum number of access points supported by the platform for the 2500 series controllers and the Controller Network Module within the Cisco 28/37/38xx Series Integrated Services Routers.



The maximum number of access points varies for the Cisco WiSM2, depending on which controller software release is being used.

When the controller is maintaining join-related information for the maximum number of access points, it does not collect information for any more access points.

An access point sends all syslog messages to IP address 255.255.255.255 by default when any of the following conditions are met:

• An access point running software release 8.2.x.x or later has been newly deployed.

• An existing access point running software release 8.2.x.x or later has been reset after clearing the configuration.

If any of these conditions are met and the access point has not yet joined a controller, you can also configure a DHCP server to return a syslog server IP address to the access point using option 7 on the server. The access point then starts sending all syslog messages to this IP address.

When the access point joins a controller for the first time, the controller sends the global syslog server IP address (the default is 255.255.255) to the access point. After that, the access point sends all syslog messages to this IP address until it is overridden by one of the following scenarios:

- The access point is still connected to the same controller, and the global syslog server IP address configuration on the controller has been changed using the **config ap syslog host global syslog_server_IP_address** command. In this case, the controller sends the new global syslog server IP address to the access point.
- The access point is still connected to the same controller, and a specific syslog server IP address has been configured for the access point on the controller using the **config ap syslog host specific Cisco_AP syslog_server_IP_address** command. In this case, the controller sends the new specific syslog server IP address to the access point.
- The access point is disconnected from the controller and joins another controller. In this case, the new controller sends its global syslog server IP address to the access point.
- Whenever a new syslog server IP address overrides the existing syslog server IP address, the old address is erased from persistent storage, and the new address is stored in its place. The access point also starts sending all syslog messages to the new IP address provided the access point can reach the syslog server IP address.

You can configure the syslog server for access points and view the access point join information only from the controller CLI.

Important Information for Controller-based Deployments

Keep these guidelines in mind when you use Cisco Aironet 1815w access points:

- The access point can only communicate with Cisco wireless LAN controllers.
- The access point does not support Wireless Domain Services (WDS) and cannot communicate with WDS devices. However, the controller provides functionality equivalent to WDS when the access point joins it.
- CAPWAP does not support Layer 2. The access point must get an IP address and discover the controller using Layer 3, DHCP, DNS, or IP subnet broadcast.
- The access point console port is enabled for monitoring and debug purposes. All configuration commands are disabled when the access point is connected to a controller.

Configuring DHCP Option 43

You can use DHCP Option 43 to provide a list of controller IP addresses to the access points, enabling them to find and join a controller.

The following is a DHCP Option 43 configuration example on a Windows 2003 Enterprise DHCP server for use with Cisco Aironet lightweight access points. For other DHCP server implementations, consult product documentation for configuring DHCP Option 43. In Option 43, you should use the IP address of the controller management interface.



DHCP Option 43 is limited to one access point type per DHCP pool. You must configure a separate DHCP pool for each access point type.

The Cisco Aironet 1815w access point uses the type-length-value (TLV) format for DHCP Option 43. DHCP servers must be programmed to return the option based on the access point's DHCP Vendor Class Identifier (VCI) string (DHCP Option 43). The VCI string for the Cisco Aironet 1815w access point is:

Cisco AP c1815

The format of the TLV block is listed below:

- Type: 0xf1 (decimal 241)
- Length: Number of controller IP addresses * 4
- Value: List of WLC management interfaces

To configure DHCP Option 43 in the embedded Cisco DHCP server, follow these steps:

Step 1 Enter configuration mode at the CLI.

Step 2 Create the DHCP pool, including the necessary parameters such as default router and name server. A DHCP scope example is as follows:

ip dhcp pool <pool name>
network <IP Network> <Netmask>
default-router <Default router>
dns-server <DNS Server>
Where:
<pool name> is the name of the DHCP pool, such as AP1815W

<IP Network> is the network IP address where the controller resides, such as 10.0.15.1 <Netmask> is the subnet mask, such as 255.255.255.0 <Default router> is the IP address of the default router, such as 10.0.0.1 <DNS Server> is the IP address of the DNS server, such as 10.0.10.2

Step 3 Add the option 43 line using the following syntax:

option 43 hex <hex string>

The *hex string* is assembled by concatenating the TLV values shown below:

Type + Length + Value

Type is always f1(hex). Length is the number of controller management IP addresses times 4 in hex. Value is the IP address of the controller listed sequentially in hex.

For example, suppose that there are two controllers with management interface IP addresses, 10.126.126.2 and 10.127.127.2. The type is f1(hex). The length is 2 * 4 = 8 = 08 (hex). The IP addresses translate to 0a7e7e02 and 0a7f7f02. Assembling the string then yields f1080a7e7e020a7f7f02. The resulting command added to the DHCP scope is **option 43 hex** f1080a7e7e020a7f7f02.

Administrative Rules for Low-power Radio-Frequency Devices

Article 12

For those low-power radio-frequency devices that have already received a type-approval, companies, business units or users should not change its frequencies, increase its power or change its original features and functions.

Article 14

The operation of the low-power radio-frequency devices is subject to the conditions that no harmful interference is caused to aviation safety and authorized radio station; and if interference is caused, the user must stop operating the device immediately and can't re-operate it until the harmful interference is clear.

The authorized radio station means a radio-communication service operating in accordance with the Communication Act.

The operation of the low-power radio-frequency devices is subject to the interference caused by the operation of an authorized radio station, by another intentional or unintentional radiator, by industrial, scientific and medical (ISM) equipment, or by an incidental radiator.
