


EQP1 / EQP2 **PORTABLE AMPLIFIER WITH BUILT-IN EQUALIZER AND** SPORTCLIP[™] STEREOPHONES

COMPONENTS

The Koss EQP1 / EQP2 is designed to deliver more volume and customized sound from your PC, CD or DVD player.: 1. Sportclip Stereophone

- 3. On / Off Switch
- 5. Input Plug
- 6. Output Jack
- 7. Retractor Button
- 8. Case 9. CD Storage

- **Insert Batteries**
- 1. Locate the battery compartment door. 2. Gently slide notch on battery door
- toward Sportclip spool. 3. Insert 2 "AAA" batteries.
- 4. Close battery door.

Remove Sportclip

- 1. Grab Sportclip spool at the half-circle openings around spool.
- 2. Gently lift the spool. (Note: Sportclip spool can be removed from case with excess force. To reattach, realign spool to cylinders on base, and gently push down).
- 3. Unwind Sportclip cord from spool.
- 4. Remove Sportclip.
- 5. Gently press Sportclip spool "down" position.

Connecting and Setting levels on your EQP

- 1. Make sure EQP and power source are OFF
- 2. Make sure Volume is in the lowest position.
- 3. Plug Sportclip into the output jack
- 4. Gently pull the input plug from the EQP to your desired length (up to 24 inches) and plug into power source.
- 5. Turn on power source.
- 6. Turn on EQP.
- 7. Adjust Volume, Bass, Mid, and Treble to your listening preference.

Disconnecting your EQP

- 1. Turn off EQP.
- 2. Disconnect EQP input plug from power source.
- 3. Hold plug loosely and push Retractor button gently guiding cord back into case
- 4. Remove Sportclip from ears.
- 5. Unplug Sportclip from output jack.
- 6. Pull Sportclip spool to "up" position.
- 7. Place Sportclip back in Sportclip spool.
- 8. Gently wind Sportclip cord around spool.
- 9. Tuck 3.5 mm jack into half-circle openings.
- 10. Gently push spool to "down" position. 11. Close EQP case and zipper shut.
