General safety guidelines

Always observe the following precautions to reduce the risk of injury and property damage.

Service

Do not attempt to service a product yourself unless instructed to do so by the Customer Support Center. Use only a service provider who is approved to repair your particular product.

Note: Some parts can be upgraded or replaced by the customer. These parts are referred to as Customer Replaceable Units, or CRUs. Lenovo expressly identifies CRUs as such, and provides documentation with instructions when it is appropriate for customers to replace those parts. You must closely follow all instructions when performing such replacements. Always make sure that the power is turned off and that the product is unplugged from any power source before you attempt the replacement. If you have any questions or concerns, contact the Customer Support Center.

Power cords and power adapters

Use only the power cords and power adapters supplied by the product manufacturer.

Never wrap a power cord around the power adapter or other object. Doing so can stress the cord in ways that can cause the cord to fray, crack or crimp. This can present a safety hazard.

Always route power cords so that they will not be walked on, tripped over, or pinched by objects.

Protect the cord and power adapters from liquids. For instance, do not leave your cord or power adapter near sinks, tubs, toilets, or on floors that are cleaned with liquid cleansers. Liquids can cause a short circuit, particularly if the cord or power adapter has been stressed by misuse. Liquids can also cause gradual corrosion of the power cord terminals and/or the connector terminals on the adapter which can eventually result in overheating.

Always connect power cords and signal cables in the correct order and ensure that all power cord connectors are securely and completely plugged into receptacles.

Do not use any power adapter that shows corrosion at the ac input pins and/or shows signs of overheating (such as deformed plastic) at the ac input or anywhere on the power adapter.

Do not use any power cords where the electrical contacts on either end show signs of corrosion or overheating or where the power cord appears to have been damaged in any way.

Extension cords and related devices

Ensure that extension cords, surge protectors, uninterruptible power supplies, and power strips that you use are rated to handle the electrical requirements of the product. Never overload these devices. If power strips are used, the load should not exceed the power strip input rating. Consult an electrician for more information if you have questions about power loads, power requirements, and input ratings.

Plugs and outlets

If a receptacle (power outlet) that you intend to use with your computer equipment appears to be damaged or corroded, do not use the outlet until it is replaced by a qualified electrician.

Do not bend or modify the plug. If the plug is damaged, contact the manufacturer to obtain a replacement.

Some products are equipped with a three-pronged plug. This plug fits only into a grounded electrical outlet. This is a safety feature. Do not defeat this safety feature by trying to insert it into a non-grounded outlet. Connect and disconnect the equipment from the electrical outlet carefully

Batteries

All personal computers manufactured by Lenovo contain a non-rechargeable coin cell battery to provide power to the system clock. In addition many mobile products such as ThinkPad notebook PCs utilize a rechargeable battery pack to provide system power when in portable mode. Batteries supplied by Lenovo for use with your product have been tested for compatibility and should only be replaced with Lenovo approved parts.

Never attempt to open or service any battery. Do not crush, puncture, or incinerate batteries or short circuit the metal contacts. Do not expose the battery to water or other liquids. Only recharge the battery pack strictly according to instructions included in the product documentation.

Battery abuse or mishandling can cause the battery to overheat, which can cause gasses or flame to "vent" from the battery pack or coin cell. If your battery is damaged, or if you notice any discharge from your battery or the buildup of foreign materials on the battery leads, stop using the battery and obtain a replacement from the battery manufacturer.

Batteries can degrade when they are left unused for long periods of time. For some rechargeable batteries (particularly Lithium Ion batteries), leaving a battery unused in a discharged state could increase the risk of a battery short circuit, which could

shorten the life of the battery and can also pose a safety hazard. Do not let rechargeable Lithium-Ion batteries completely discharge or store these batteries in a discharged state.

Heat and product ventilation

Computers generate heat when turned on and when batteries are charging. Notebook PCs can generate a significant amount of heat due to their compact size. Always follow these basic precautions:

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer produces some heat during normal operation. Extended contact with the body could cause discomfort or, potentially, a skin burn.
- Do not operate your computer or charge the battery near flammable materials or in explosive environments.
- Ventilation slots, fans and/or heat sinks are provided with the product for safety, comfort, and reliable operation. These features might inadvertently become blocked by placing the product on a bed, sofa, carpet, or other flexible surface. Never block, cover or disable these features.

CD and DVD drive safety

CD and DVD drives spin discs at a high speed. If a CD or DVD is cracked or otherwise physically damaged, it is possible for the disc to break apart or even shatter when the CD drive is in use. To protect against possible injury due to this situation, and to reduce the risk of damage to your machine, do the following:

- · Always store CD/DVD discs in their original packaging
- Always store CD/DVD discs out of direct sunlight and away from direct heat sources
- Remove CD/DVD discs from the computer when not in use
- Do not bend or flex CD/DVD discs, or force them into the computer or their packaging
- Check CD/DVD discs for cracks before each use. Do not use cracked or damaged discs



Attention

- Avoid using the projector in dusty environments.
- Do not obstruct the vent openings of the projector.
- Leave the power cable plugged in (for 2-5 minutes) until the projector returns to room temperature before placing the projector inside the soft case. Placing the projector into the case too soon after switching off the power could cause the projector to overheat and will shorten lamp life.
- Be sure to attach the lens cap and place the projector into the soft case to avoid damaging the lens.




Figure 1-1. Front right view of projector




Figure 1-2. Top view of projector

- 9 Speaker




Figure 1-3. Top view of the control buttons and LEDs on the projector.

- 6 Keystone/ Down cursor7 Volume/ Left cursor




Figure 1-4. Connectors




Figure 1-5. Bottom view of the projector

Chapter 2. Setting up the projector

This chapter provides information on starting and shutting down the projector, adjusting the projector height and level, adjusting the zoom, focus, and keystone, and adjusting the volume.


Attention

Before moving the projector, be sure to power down the projector normally and disconnect the projector from the main power source.

Starting and shutting down the projector

Please follow the steps below to start the projector and to shut down the projector.

1. Connect the power cord to the projector as shown below. Connect the other end to a wall outlet. The Power LED and Lamp-ready LED turn on.



- 2. Remove the lens cover.
- 3. Connect to an input device.
- 4. Turn on the connected devices.
- 5. Ensure that the Lamp-ready LED is on a steady amber, then press the **Power** button to turn on the projector.

The projector splash screen displays and connected devices are detected. If the connected device is a ThinkPad, press Fn + F7 on the computer keyboard to switch the display output to the projector. Check the user's manual of non-Lenovo PCs to determine the appropriate Fn hot keys to change display output.

Attention

Do not look directly into the projection lens when the lamp is turned on. The bright light may harm your eyes

- 6. If more than one input devices is connected, press the Source button repeatedly to switch among devices.
- 7. To turn off the projector, press the **Power** button. The projector prepares for shutdown, and a "Wait a moment please..." message appears.
- 8. When the "Power off?/Press Power again" message appears, press the **Power** button. The projector turns off.

Note: The projector will enter a cool down mode, and the fans will continue to run for approximately 90 seconds. Do not remove power to the projector until the fans have stopped.

9. Turn off the room light and leave.

Note: Leave the power cable plugged in for at least 2-5 minutes until the projector returns to room temperature before placing the projector inside the soft case. Placing the projector into the case too soon after switching off the power could cause the projector to over heat.


Attention

Before moving the projector, be sure to power down the projector normally and disconnect the projector from the main power source.

Adjusting the projector height

To adjust the projector height, complete the following procedure:

- 1. To raise the height of the projector, lift the projector as shown in 1 and press the elevator-foot buttons as shown in 2. The elevator foot drops down as shown in 3.
- 2. To lower the height of the projector, press the elevator-foot button as shown in 2 and push down on the top of the projector.
- 3. To make adjustments to the level, rotate the leveling foot as shown in 4.



Positioning the projector

To determine where to position the projector, consider the size and shape of your screen, the location of your power outlets, and the distance between the projector and the rest of your equipment. Following are some general guidelines:

- Position the projector on a flat surface at a right angle to the screen. The projector must be at least 1.5 m (4.9 ft) from the projection screen.
- Position the projector within 2.7 m (9 ft) of your power source and within 1.8 m (6 ft) of your video device (unless you purchase extension cables). To ensure adequate cable access, do not place the projector within .15 m (6 in.) of a wall or other object.
- Position the projector the desired distance from the screen. The distance from the lens of the projector to the screen, the zoom setting, and the video format determine the size of the projected image.






Adjusting the zoom, focus and keystone

To adjust the image, follow these steps.

- 1. Use the Image-focus control on the projector to sharpen the projected image as shown in 1.
- 2. Use the Image-zoom control on the projector to resize the projected image and screen size as shown in 2.



3. Use the Keystone buttons (shown below) to correct image-trapezoid effect.




The keystone control appears on the display.

Adjusting the volume

To adjust the volume, follow the steps below.

- 1. Press the Volume +/- buttons on the projector or the remote control. The volume control appears on the OSD.
- 2. Use the Volume +/- buttons to adjust the level. The volume buttons on the projector and remote control are shown below.




- 3. Press the **Mute** button (on the remote control only) to turn off the volume. See **3** in the figure above.
- 4. Press the Volume +/- buttons on the projector or the remote control to turn off the mute.

Connecting devices


Computers and video devices can be connected to the projector at the same time. Check the user's manual of the connecting device to confirm that it has the appropriate output connector.

Note: USB mouse function is only supported with Windows 2000 and Windows

Chapter 4. Using the projector features

This chapter provides information on using the remote control, audio, keypad buttons, and other projector features.

Using the remote control


The remote uses two provided AAA batteries. They are easily installed by sliding the cover off the back of the remote, aligning the + and - ends of the batteries, sliding them into place, and then replacing the cover.



CAUTION:

To reduce the risk of injury to the eyes, do not look directly into the remote control laser light and do not point the laser light into anyone's eyes. The remote control is equipped with a Class II laser that emits radiation.




Inserting the remote control batteries

When using the remote control for the first time, install the batteries that were supplied. Follow the steps below for inserting new batteries into your remote control.


1. Remove the battery compartment cover by sliding the cover in the direction of the arrow, as shown.



2. Insert the supplied batteries taking note of the polarity (+/-), as shown.



3. Replace the cover, as shown.



Note:

- Only use AAA alkaline batteries.
- Dispose of used batteries according to local government ordinance regulations.
- Remove the batteries when not using the remote for prolonged periods.


Operating range

The remote control uses infrared transmission to control the projector. It is not necessary to point the remote directly at the projector, the remote will function well within a radius of about 10 m (33 ft) and 30° above or below the projector level. If the projector does not respond to the remote control, move a little closer.

Note: You can also point the remote at the projected image.

Projector and remote control buttons

The projector can be operated using the remote control or the buttons on the top of the projector. All operations can be carried out with the remote control. The figure below shows the corresponding buttons on the remote control and on the projector.

Note: You must have a display on the screen in order to access the OSD.


Navigating the OSD

You can use the remote control or the buttons on the top of the projector to navigate and make changes to the OSD. The following sections show the menu options in the OSD.

Setting the OSD language

You may want to reference the OSD on your projector while reading this section. Set the OSD language to your preference before continuing by following the steps below.

- 1. Press the **Menu** button. The Quality menu appears.
- 2. Press the cursor left/right button until Language is highlighted.




- 3. Press the cursor up/down button until the language you want is highlighted.
- 4. Press the Enter button to select the language.
- 5. Press the **Menu** button twice to close the OSD.







Cleaning the lens

To clean the lens, complete the following procedure:

1. Apply a non-abrasive camera lens cleaner to a soft, dry cloth.

Note: Avoid using an excessive amount of cleaner, and do not apply the cleaner directly to the lens. Abrasive cleaners, solvents or other harsh chemicals might scratch the lens.

2. Lightly wipe the cleaning cloth over the lens in a circular motion. If you do not intend to use the projector immediately, replace the lens cap.


Replacing the projection lamp

Use only a replacement lamp with the same type and rating as the original lamp. Contact your Lenovo representative for information or go to www.lenovo.com/pc.


Note: Turn off the projector, unplug the power cord, and allow the projector to cool for at least 1 hour before attempting to replace the lamp.

To replace the projector lamp, complete the following procedure:


- 1. Loosen the screw on the lamp compartment cover as shown.
- 2. Remove the lamp compartment cover as shown.



- 3. Remove the two screws from the lamp module as shown.
- 4. Lift the module handle up as shown.



5. Pull firmly on the module handle to remove the lamp module as shown.



6. Reverse steps 1 through 5 to install the new lamp module.

Resetting the lamp timer

After replacing the lamp, you should reset the lamp timer to zero. Please follow these steps:

- 1. Press the **Menu** button to open the main menu.
- 2. Press the left/right cursor button to move to the Information menu.
- 3. Press the up/down cursor button to move down to Lamp Hour Reset.
- 4. Press the Enter button. A message screen appears.
- 5. Press the cursor buttons in this order: down, up, left, right. The Information menu appears again showing the Lamp Hours reset to zero.

Attention

Lamp life is a measure of brightness degradation only, and is not a specification for the time it takes a lamp to fail and cease light output. Lamp life is defined as the time it takes for 50% of a lamp sample population to decrease in brightness by 50% of the rated lumens for the specified lamp. For example, if a sample of lamps are rated as 1500 lumens and 2000 hours of Lamp life, then after 2000 hours, 50% of the sample will experience a brightness decrease of 50% to 750 lumens.

Using the security slot

The projector has a security slot, (see Figure 1-4 on page 1-3). Refer to the information that comes with the lock for instructions on how to use it.

Appendix B. Troubleshooting

The following table provides troubleshooting information for the projector. In some cases, more than one possible solution is provided. Try the solutions in the order they are presented. When the problem is solved, you can skip the additional solutions.

The term "Machine" means a Lenovo machine, its options, features, conversions, upgrades or peripheral products, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.

What this Warranty Covers

Lenovo warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to Lenovo's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original date of installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the date of installation unless Lenovo or your reseller informs you otherwise. Unless Lenovo specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.

What this Warranty Does not Cover

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse, accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which Lenovo is not responsible; and
- any non-Lenovo products, including those that Lenovo may procure and provide with or integrate into a Lenovo Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

Lenovo does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided WITHOUT WARRANTIES OF ANY KIND.

How to Obtain Warranty Service

Warranty service may be provided by Lenovo, IBM, your reseller if authorized to perform warranty service, or an authorized warranty service provider. Each of them is referred to as a "Service Provider."

If the Machine does not function as warranted during the warranty period, contact a Service Provider. If you do not register the Machine with Lenovo, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

What Lenovo Will Do to Correct Problems

1. Customer Replaceable Unit ("CRU") Service

Lenovo will ship CRUs to you for you to install, Tier 1 CRUs are easy to install whereas Tier 2 CRUs require some technical skill and tools. You may request that a Service Provider install CRUs, at no additional charge, under the type of warranty service designated for your Machine. 
