Chapter 1:

Product Overview

Thank you for choosing the Dual-Band Wireless-N Gaming Adapter. The Adapter gives wireless connection capabilities to any wired Ethernet-equipped game console. The Game Adapter can be used in several different ways. If you have an existing home wireless network and a cable or DSL Internet connection, the Game Adapter lets your Xbox®, Xbox 360, PlayStation®2 or 3, or GameCube™ attach to the network so you can get into online games without running wires to the game room. Or, use a pair of Game Adapters to form a “cable-less cable” between two game consoles for head-to-head gaming – in the same room, or all the way across the house. There’s also a special “Wireless LAN Party” mode to connect several consoles at once.

Front Panel



Security Button If you have an Access Point that supports Wi-Fi Protected Setup, then you can use the Security button to automatically configure the Adapter’s wireless security for your wireless network.



POWER

Power (Green/Orange) The Power LED alternates between orange and green during booting, diagnostics, system self-test and firmware upgrades. The Power LED will stay green once the Adapter is powered on and ready.



ETHERNET

Ethernet (Green) The Ethernet LED lights up when the Adapter is connected to a device through the Ethernet port. If the LED is flashing, the Adapter is sending or receiving data over that port.



WIRELESS

Wireless (Green) The Wireless LED lights up when there is a wireless connection. If the LED is flashing, the Adapter is sending or receiving data over the wireless network.



SECURITY

Security (Green) The Security LED indicates when wireless security is enabled.

Back Panel



Ethernet The Ethernet port connects the Adapter to your gaming console, wired PC or other Ethernet network device.



Reset The Reset button can be used to reboot the Adapter or to restore the Adapter’s factory default settings.

- To reboot the adapter, press and release the **Reset** button quickly using a pin or straightened paper clip.
- To restore the factory default settings, press the **Reset** button for approximately five seconds, using a pin or straightened paper clip (factory defaults can also be restored via the *Tools > System* screen of the Adapter’s web-based utility).



Power The Power port is where you will connect the power adapter.



NOTE: Do not restore the factory defaults unless you are having difficulties with the Adapter and have exhausted all other troubleshooting measures. Once the Adapter is reset, you will have to re-enter all of your configuration settings.

Chapter 2: Wireless Security Checklist

Wireless networks are convenient and easy to install, so homes with high-speed Internet access are adopting them at a rapid pace. Because wireless networking operates by sending information over radio waves, it can be more vulnerable to intruders than a traditional wired network. Like signals from your cellular or cordless phones, signals from your wireless network can also be intercepted. Since you cannot physically prevent someone from connecting to your wireless network, you need to take some additional steps to keep your network secure.

1. Change the default wireless network name or SSID

Wireless devices have a default wireless network name or Service Set Identifier (SSID) set by the factory. This is the name of your wireless network, and can be up to 32 characters in length. Linksys wireless products use **linksys** as the default wireless network name. You should change the wireless network name to something unique to distinguish your wireless network from other wireless networks that may exist around you, but do not use personal information (such as your Social Security number) because this information may be available for anyone to see when browsing for wireless networks.

2. Change the default password

For wireless products such as access points, routers, and gateways, you will be asked for a password when you want to change their settings. These devices have a default password set by the factory. The Linksys default password is **admin**. Hackers know these defaults and may try to use them to access your wireless device and change your network settings. To thwart any unauthorized changes, customize the device's password so it will be hard to guess.

3. Enable MAC address filtering

Linksys routers and gateways give you the ability to enable Media Access Control (MAC) address filtering. The MAC address is a unique series of numbers and letters assigned to every networking device. With MAC address filtering enabled, wireless network access is provided solely for wireless devices with specific MAC addresses. For example, you can specify the MAC address of each computer in your home so that only those computers can access your wireless network.

4. Enable encryption

Encryption protects data transmitted over a wireless network. Wi-Fi Protected Access (WPA/WPA2) and Wired Equivalency Privacy (WEP) offer different levels of security for wireless communication.

A network encrypted with WPA/WPA2 is more secure than a network encrypted with WEP, because WPA/WPA2 uses dynamic key encryption. To protect the information as it passes over the airwaves, you should enable the highest level of encryption supported by your network equipment.

WEP is an older encryption standard and may be the only option available on some older devices that do not support WPA.

General Network Security Guidelines

Wireless network security is useless if the underlying network is not secure.

- Password protect all computers on the network and individually password protect sensitive files.
- Change passwords on a regular basis.
- Install anti-virus software and personal firewall software.
- Disable file sharing (peer-to-peer). Some applications may open file sharing without your consent and/or knowledge.

Additional Security Tips

- Keep wireless routers, access points, or gateways away from exterior walls and windows.
- Turn wireless routers, access points, or gateways off when they are not being used (at night, during vacations).
- Use strong passphrases that are at least eight characters in length. Combine letters and numbers to avoid using standard words that can be found in the dictionary.

Chapter 3: Setup Wizard Advanced Options

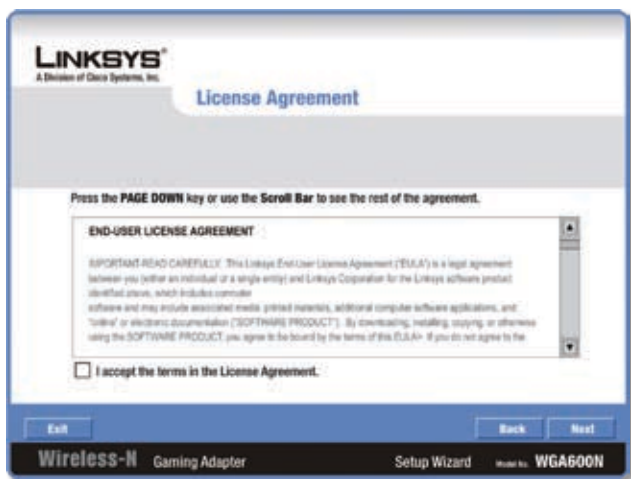
This section covers the Advanced Options found in the Setup Wizard. For additional details on the Setup Wizard, refer to the Quick Installation Guide.

1. The *Welcome* screen appears on your monitor. Click the **Click Here to Start** button.



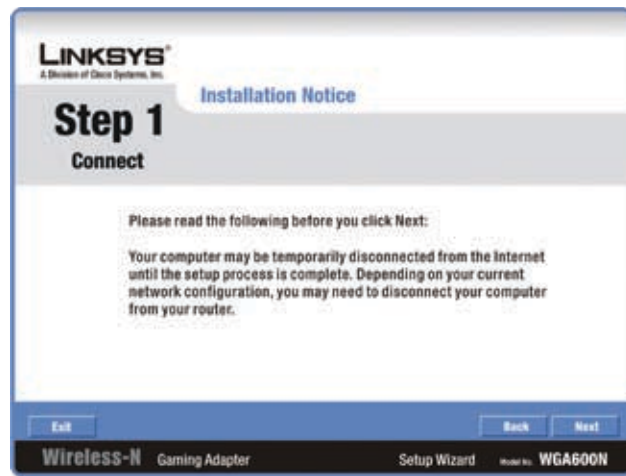

2. Read the License Agreement, and click **Next** to continue the installation.

3. The *Installation Notice* screen will appear. This message is to let you know that your computer may be temporarily disconnected from the Internet. Be sure to read the entire message and then click **Next**.

4. Connect one end of the provided network cable into your computer's network port and click **Next**.

- Enter a new password for the Gaming Adapter and enter it again in the *Re-enter Password* field. Click **Next** to continue.



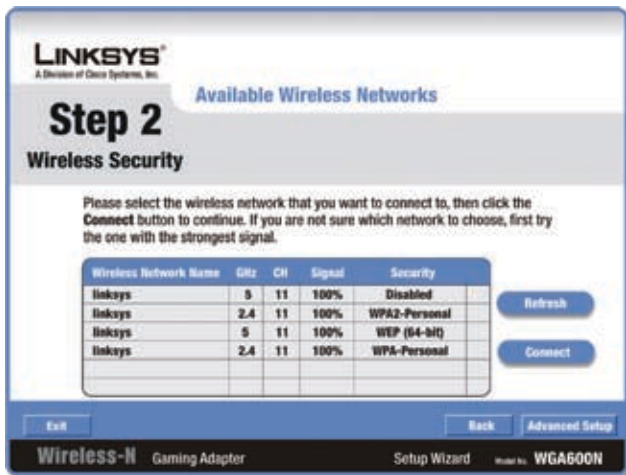

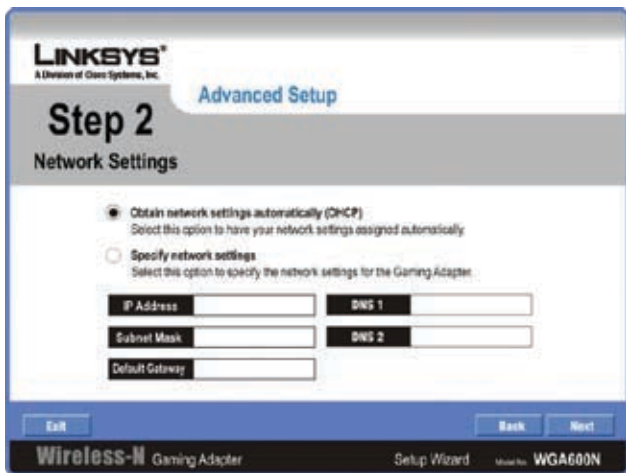

10. Click the **Advanced Setup** button in the lower right corner of the screen.

11. Select the appropriate network configuration for the Gaming Adapter.

- **Obtain network settings automatically (DHCP)** Select this option to have your network settings assigned automatically.
- **Specify network settings** Select this option to specify the network settings for the Gaming Adapter.

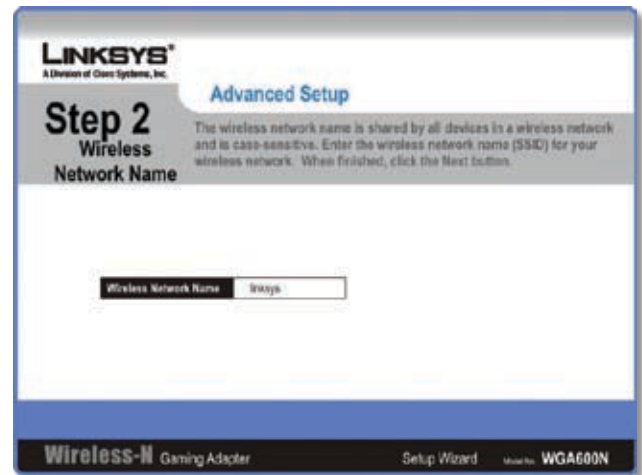
IP Address When *Specify network settings* is selected, the Adapter's IP address, as seen from the LAN (Local Area Network) can be defined in this field. This address must be unique and is used to access the web-based utility.

Subnet Mask The Adapter's Subnet Mask must be the same as your wired network's Subnet Mask.

Default Gateway This is the IP address of the default gateway for your LAN.

DNS 1 & 2 Enter the appropriate DNS server information in these fields.

12. Enter the Wireless Network Name (SSID) of your wireless network.

13. Select the level of wireless security is used on your wireless network.

- **High Security (WPA/WPA2)** If your network uses WPA/WPA2 security, enter the passphrase in the *Passphrase* field and click **Next**.

Passphrase Enter the network passphrase, this can be used any numbers or characters and must be between 8 and 63 characters in length.

- **Better Compatibility with Legacy Devices (WEP)** If your network uses WEP security, enter the necessary information in the appropriate fields and click **Next**.

WEP Settings

WEP Select a level of WEP encryption, **64 bits (10 hex digits)** or **128 bits (26 hex digits)**.

Passphrase The passphrase is case-sensitive and should be no more than 16 characters in length.

WEP Key Enter the WEP key used to access the network. This is defined on the access point or router that you are connecting to.

TX Key Select the transmit key used to access the network. The default value is **1**.

Authentication Select the appropriate authentication method used to access the network. The default setting is **Auto**.



NOTE: WEP is not supported by Draft 11N specifications. If your network uses WEP, the Adapter will only operate in 802.11B/G modes.

14. The *Network Settings* screen will appear. Verify the network settings and click **Next** to continue or **Back** to modify the settings.

15. The *Link Status* screen will appear, click **Next**.

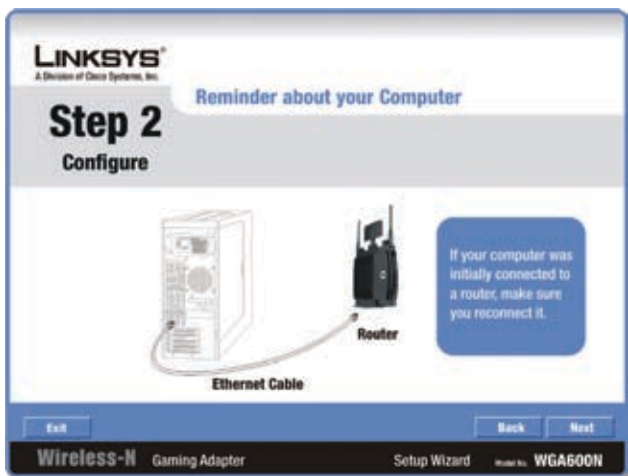

16. Unplug the Ethernet cable from your computer and plug it into your Gaming Console's Ethernet port. Click **Next** to continue.

Chapter 4: Advanced Configuration

For details on connecting and installing the Adapter, please refer to the Quick Installation. This chapter will describe each screen of the web-based utility and each screen's key functions.

How to Access the Web-Based Utility

The web-based utility can be accessed using a web browser.

If the Gaming Adapter has already been configured and is associated with a router or access point, you can access the web-based utility from a computer by entering **http://wga600n** in the address bar of your web browser.



NOTE: If the IP Address Mode of the Gaming Adapter has been set to DHCP and you cannot access the web-based utility using the address **http://wga600n** and you are not sure of the IP address of the Gaming Adapter, try to find the address in the DHCP Clients Table of your router or access point. If you are not using a router or access point or are unable to locate the address, you can reset the Gaming Adapter by pressing the **Reset** button on the back of the Gaming Adapter for approximately five seconds, using a pin or straightened paper clip. This will reset the Gaming Adapter back to the factory default settings and assign the Gaming Adapter a static IP address of **192.168.1.250**.

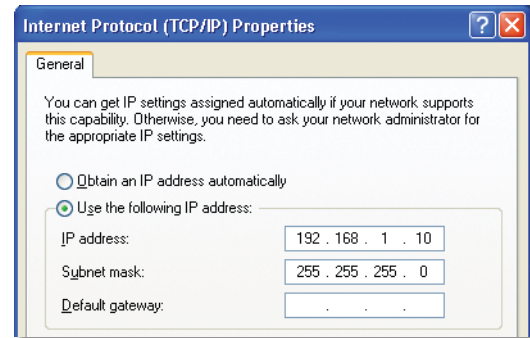
If the Gaming Adapter has not been configured and is using the factory default settings, you must connect a computer to the Gaming Adapter using an Ethernet connection to access the web-based utility. You will need to configure the Ethernet connection on the computer with a static IP address and subnet mask.

The IP address of your Ethernet adapter should be set to a specific IP address.

1. In the *IP address* field, enter the address **192.168.1.x** (x should be replaced by a number between 2 and 240, such as 10).
2. In the *Subnet Mask* field, enter **255.255.255.0**.



NOTE: The steps to assign a static IP address to the Ethernet adapter on your computer vary by operating system. For instructions, please refer to the help documentation of your specific operating system.



Ethernet Adapter IP Settings (Windows XP)

Once you've assigned your Ethernet adapter with a static IP address, launch your web browser, and enter the Adapter's IP address (the default setting is **192.168.1.250**) in the *Address* field. Press the **Enter** key.

A screen will appear asking you for your User name and Password. Enter **admin** in the *User Name* field. Enter **admin** in the *Password* field. Then click the **OK** button.



Login Screen

Make the necessary changes through the utility. When you have finished making changes to a screen, click the **Save Settings** button to save the changes, or click the **Cancel Changes** button to undo your changes. Help information is available by clicking **Help** link on the upper right side of the screen.

Status > Device Info

The *Device Info* screen is the first screen you see when you access the web-based utility.

General

Firmware Version This displays the Adapter's current firmware version.

LAN

MAC Address Displays the MAC Address as seen by other devices on your local area network.

IP Address Displays the Adapter's IP address, as it appears on your local network.

Subnet Mask The Adapter's Subnet Mask is shown here.

Default Gateway The Adapter's Default Gateway is shown here.

Wireless LAN

Wireless Radio Displays whether the wireless networking functionality of the Adapter is enabled or disabled.

Status Displays the AP association status.

WISH Indicates whether WISH (Wireless Intelligent Stream Handling) is active or not. WISH is used for prioritizing applications over the wireless network.

MAC Address Displays the MAC Address as seen by other devices on your wireless network.

Network Name (SSID) This displays the name of the wireless network or SSID.

Channel Displays the channel the Adapter is set to for wireless network communication.

Wi-Fi Protected Setup Displays the status of Wi-Fi Protected Setup.

Security Mode Displays the Security Mode currently being used or will appear as disabled if wireless security is not being used on the network.

IP Address Mode This option determines if the Adapter's IP address is set manually (Static) or obtained automatically from a DHCP server. The default is **Static**.

IP Address When IP Address Mode is set to static, the Adapter's IP address, as seen from the LAN (Local Area Network) can be defined in this field. This address must be unique and is used to access the web-based utility.

Subnet Mask The Adapter's Subnet Mask must be the same as your wired network's Subnet Mask.

Default Gateway This is the IP address of the default gateway for your LAN.

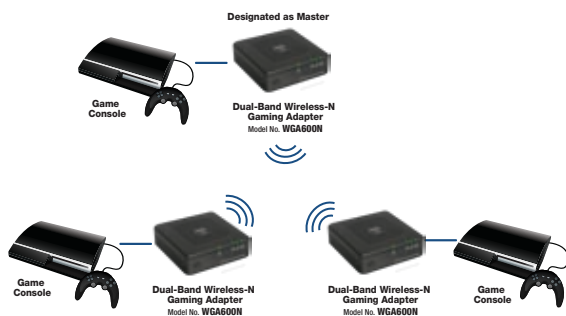

Wireless Network Mode Setting

Wireless Bridge This is the default operating mode of the Adapter. This mode is used to connect one device to a wireless network using the Ethernet port.

LAN Party Gaming This operating mode is used to connect multiple Gaming Adapters without the need for a router or access point. One Gaming Adapter serves as a master. Additional units connect to the master and can communicate with the Gaming Adapters connected to the master. This allows you to create a LAN party using only Gaming Adapters.

Configuring LAN Party Gaming

Designate a master unit and connect it to a computer with an Ethernet connection. Access the web-based utility of the master unit, and switch to *LAN Party Gaming* mode.



NOTE: If the computer doesn't already have a static IP address, refer to the beginning of this chapter for notes on configuring a static IP address on your computer.

To designate a Gaming Adapter as a master unit, perform the following steps:

1. Connect a computer to the Gaming Adapter designated as the master.
2. Launch your web browser.
3. Enter the IP address of the Gaming Adapter. The default address is **192.168.1.250**.
4. Login to the Gaming Adapter. The default user name and password is **admin**.
5. Go to the *Basic > Wireless* screen.
6. Change the *Wireless Network Mode* option to *LAN Party Gaming*.
7. Click the **Save Settings** button.



NOTE: LAN Party Gaming mode should only be enabled on the unit designated as the master.

Adding Adapters to the LAN Party



NOTE: Adapters (non-master) added to the LAN Party will need to be reset to factory defaults to return to standard operating mode.

To add a Gaming Adapter to the LAN Party, perform the following steps:

1. Press the **Security** button on the unit designated as the master.

2. Press the **Security** button on the Gaming Adapter that is joining the LAN Party.
3. Repeat steps 1 and 2 for each Gaming Adapter that will be joining the LAN Party.

Returning to Standard Operating Mode

When your LAN Party is over and you want to reconfigure the Gaming Adapters, be sure to note that the procedure is different for the Gaming Adapter designated as the master and the other adapters.

Setting the Master Adapter Back to Wireless Bridge Mode

To return the Gaming Adapter designated as the master back to Wireless Bridge Mode, access the web-based utility of the master unit, and switch to *Wireless Bridge* mode. To do this, perform the following steps:

1. Connect a computer to the Gaming Adapter designated as the master.
2. Launch your web browser.
3. Enter the IP address of the master Adapter. The IP address for the master adapter is **192.168.1.251**.

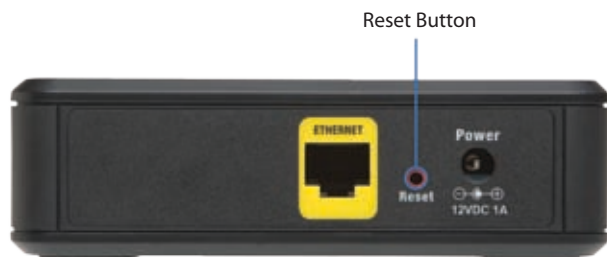


NOTE: The Gaming Adapter IP address changes from **192.168.1.250** to **192.168.1.251** when LAN Party Gaming is enabled in the web-based utility. This only applies to the adapter designated as the master.

4. Login to the Gaming Adapter. The default user name and password is **admin**.
5. Go to the *Basic > Wireless* screen.
6. Change the *Wireless Network Mode* option to *Wireless Bridge*.
7. Click the **Save Settings** button.

Removing Non-Master Adapters from LAN Party Gaming Mode

To change a Gaming Adapter (non-master) back to standard operating mode, you must press the **Reset** button for approximately five seconds, using a pin or straightened paper clip.



Upon release of the Reset button the Gaming Adapter will restart and return to standard operating mode.

Wireless Network Settings

Wireless Network Name This is the wireless network name (SSID) defined on the access point that the Adapter will associate with. Leave this field blank to associate to any access point.

802.11 Band

- **2.4GHz** This option can be selected if you only want to use the 2.4GHz spectrum of radio frequencies on your wireless network. 802.11b, 802.11g, and 802.11n support this spectrum.
- **5GHz** This option can be selected if you only want to use the 5GHz spectrum of radio frequencies for your wireless network. 802.11a and 802.11n support this spectrum.
- **2.4GHz and 5GHz** This option can be selected if you want to use both frequencies on your wireless network.

802.11 Mode The mode options available will vary based on the band mode(s) supported.

Transmission Rate By default, the fastest possible transmission rate is selected. The speed can be selected manually.

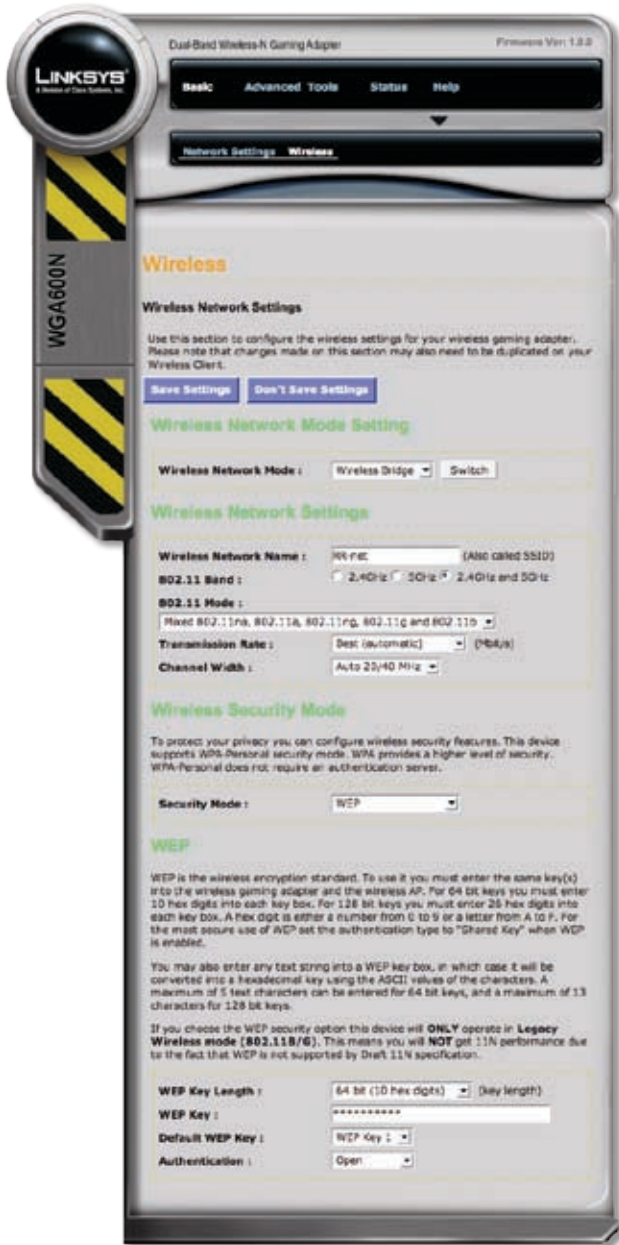
Channel Width This option is available in Mixed modes that utilize 802.11n. The default **Auto 20/40 MHz** setting is typically the best. Manual selection is possible if necessary.

Wireless Security Mode

Security Mode Below is an overview of the available security modes:

- **None** When this option is selected, encryption is not used on your wireless network.
- **WEP** This is an earlier generation of wireless encryption technology. WEP is not as secure as WPA.
- **WPA-Personal** This option uses WPA (Wi-Fi Protected Access) with a pre-shared key. There are two versions of the standard available. WPA2 is the newer and stronger version of encryption.

WEP Key Length Select a level of WEP encryption, **64 bits (10 hex digits)** or **128 bits (26 hex digits)**. The default is **64 bits (10 hex digits)**.

WEP Key Enter the WEP key used to access the network. This is defined on the access point or router that you are connecting to.

Default WEP Key Select the transmit key used to access the network. The default value is **1**.

Authentication Select the appropriate authentication method used to access the network.



NOTE: WEP is not supported by Draft 11N specifications. If your network uses WEP, the Adapter will only operate in 802.11B/G modes.

WPA Mode The default setting, **Auto (WPA or WPA2)** will automatically select the appropriate mode used on your network. If necessary, the mode can be selected manually.

Cipher Type Select the algorithm used on the network, **TKIP** or **AES**. (AES is a stronger encryption method than TKIP.)

Pres-Shared Key

Pre-Shared Key Enter the pre-shared key used by the network. It should be between 8-63 characters.

Advanced Wireless Settings

Transmit Power Normally the wireless transmitter operates at 100% power. In some circumstances, there may be a need to isolate specific frequencies to a smaller area. By reducing the power of the radio, you can prevent transmissions from reaching beyond the designated wireless area.

RTS Threshold When excessive wireless packet collisions are occurring, wireless performance can be improved by using the RTS/CTS (Request to Send/Clear to Send) handshake protocol. The wireless transmitter will begin to send RTS frames (and wait for CTS) when the data frame size (in bytes) is greater than the RTS Threshold. This setting should remain at the default setting of **2346 bytes**.

Fragmentation Threshold Wireless frames can be divided into smaller units (fragments) to improve performance in the presence of RF interference and at the limits of RF coverage. Fragmentation will occur when the frame size (in bytes) is greater than the Fragmentation threshold. Setting this value too low may result in poor performance.

A-MPDU Aggregation Aggregation of wireless packets based on MAC protocol data units is a technique for maximizing performance. This option should normally be left enabled.

Short GI Using a short (400ns) guard interval can increase throughput. However, it can also increase error rate in some installations, due to increased sensitivity to radio-frequency reflections. Select the option that works best for your installation.

Advanced > WISH

WISH (Wireless Intelligent Stream Handling) is a technology developed to enhance your experience using a wireless network by prioritizing the traffic of different applications.

Enable WISH Enable this option if you want to allow WISH to prioritize your traffic.

Priority Classifiers

HTTP Allows the Adapter to recognize HTTP transfers for many common audio and video streams and prioritize them above other traffic. Such streams are frequently used by digital media players.

Windows Media Center Enables the router to recognize certain audio and video streams generated by a Windows Media Center PC and prioritize these streams above other traffic. These streams are used by systems known as Windows Media Extenders, such as the Xbox 360.

Automatic When enabled, this option causes the router to automatically attempt to prioritize traffic streams that it doesn't otherwise recognize, based on the behavior that the streams exhibit. This acts to deprioritize streams that exhibit bulk transfer characteristics, such as file transfers, while leaving interactive traffic, such as gaming or VoIP, running at a normal priority.

Add WISH Rule

A WISH Rule identifies a specific message flow and assigns a priority to that flow. For most applications, the priority classifiers ensure the right priorities and specific WISH Rules are not required.

WISH supports overlaps between rules. If more than one rule matches a specific message flow, the rule with the highest priority is used.

Enable This option is used to enable WISH.

Name Enter a name for the rule.

Priority The priority of the message flow is entered here. Four priorities are defined:

- **BK** Background (least urgent)
- **BE** Best effort
- **VI** Video
- **VO** Voice (most urgent)

Protocol Select the protocol from the drop-down list. The default selection is **Any**.

Host 1 IP Range The rule will only apply to a flow of messages that are from a computer with an IP address in the range specified here.



Host 1 Port Range The rule will apply to a flow of messages that fall within the values defined in the *Host 1 IP Range* field and also utilize a port defined in the *Host 1 Port Range* field.

Host 2 IP Range The rule will only apply to a flow of messages that are from a computer with an IP address in the range specified here.

Host 2 Port Range The rule will apply to a flow of messages that fall within the values defined in the *Host 2 IP Range* field and also utilize a port defined in the *Host 2 Port Range* field.

WISH Rules

This section is where the defined WISH rules are displayed. WISH rules can be enabled/disabled by toggling the check box on the left of the rule. The icons next to the WISH rule are described below:

Icon	Function	Description
	Edit	Click this icon to modify an existing WISH rule.
	Delete	Click this icon to delete an existing WISH rule.

PIN Settings

A PIN is a unique number that can be used to add the Adapter to an existing network or create a new network. For extra security, a new PIN can be generated. The default PIN can be restored at any time.

Current PIN Shows the current pin setting.

Reset PIN to Default Resets the pin to the default value.

Generate New PIN Use this option to generate a new pin.

Tools > Admin

There is only one account used to access the web-based utility. This account uses the default username and password, **admin**. To keep the gaming adapter settings secure, it is recommended that you change the password.

Admin Password

Password The password used to access the web-based utility can be changed from this field. The default password is **admin**. It is recommended that the password be changed for security purposes.

Verify Password When the password is changed, it must be entered again in this field.

Administration

Gaming Adapter Name This is the name of the Adapter.

Web Idle Timeout Defines the amount of idle time before the admin is logged out of web-based utility.

Save Configuration This option allows you to save the Adapter's configuration to a file on your computer.


Lietuvškai (Lithuanian) - Aplinkosaugos informacija, skirta Europos Sąjungos vartotojams




