

## Information quality

Documents are delivered with either a Draft, Preliminary, or Standard designation for the entire book, but the content for a specific feature can be at a different stage of development.

The status definitions are as follows:

- Draft: Information is written and reviewed for technical content, but the feature is still under development and change is expected.
- Preliminary: Development of the feature content is complete and is considered stable. The content is reviewed and tested internally.
- Standard: The feature content is included in external trials and is suitable for delivery to customers.

## **Text conventions**

This chapter describes the text conventions used throughout the Nortel Secure Network Access Switch documentation suite.

### angle brackets (less than, greater than)

Indicate that you choose the text to enter based on the description inside the brackets. Do not type the brackets when entering the command. For example, if the command syntax is ping <ip\_address> you enter ping 192.32.10.12.

#### asterisk

In command syntax, the asterisk indicates that you can enter multiple instances of the preceding parameter.

#### **bold Courier text**

Indicates command names and options and text that you need to enter.

Example: Use the debug portal command.

Example: Enter show interface.

## braces ({})

Indicate required elements in syntax descriptions where there is more than one option. You must choose only one of these options. Do not type the braces when entering the command. For example, if the command syntax is

```
add loghost [server=] [[facility=] {local0, local1,
local2, local3, local4, local5, local6, local7}]
you can enter either
add loghost server=10.11.12.10 facility=local2
OR
add loghost server=10.11.12.10 facility=local3
```

### brackets ([])

Indicate optional elements in syntax descriptions. Do not type the brackets when entering the command. For example, if the command syntax is add user [epwd=] [priv={U, SU, SSU}] you can enter add user name=james epwd=pword priv=u, or you can enter add user james, and leave out the terms shown in brackets.

### ellipsis points (...)

Indicate that you repeat the last element of the command as needed. For example, if the command syntax is ethernet/2/1 [] ... you enter ethernet/2/1 and as many parameter-value pairs as needed.

#### italic text

Indicates book titles.

### plain Courier text

Indicates system output such as prompts and system messages, for example:

Set Trap Monitor Filters.

## separator (greater than symbol)

Shows menu paths. For example, File > SCS configuration identifies the SCS configuration option in the File menu.

## vertical line ( | )

Indicates the choices. Do not type the vertical line when entering the command. For example, if the command syntax is check sub [sub] = <subid> | sub = <subname> [isp] = <ispname> you can enter check sub sub = 345 isp = blue OR check sub sub = james isp = blue

#### Task-based documentation

Task-based documentation is a new way of packaging customer information in a structured, modular, task-centric format.

Task-based documentation focuses on what the user must do and the sequence in which to perform tasks.

The goal is to make Nortel documentation easy to find, easy to use, timely, and accurate.




Figure 1 Work flows, task flows, and procedures in task-based documentation

To understand the relationship between work flows, task flows, and procedures, see Figure 1 "Work flows, task flows, and procedures in task-based documentation" (page 24).

#### How is task-based documentation used?

In task-based documentation, procedural information is included in the document. Supporting conceptual and reference information is provided, and the user is guided on how to use conceptual and reference material by identified prerequisites or direct links and references.

The user navigates the information by following the flows that are provided for tasks and procedures.

### Task flow overview

Task flows are flowcharts that illustrate which procedures and decisions are involved to complete an activity.

The task flows guide you through activities to use the Nortel Ethernet Routing Switch 8600, whether it is configuration, upgrading, installation, maintenance, or troubleshooting.

Each flow provides the prerequisites and links to the tasks or procedures.

To perform or refer to a procedure, always follow the task flow. Following the task flows ensures that you meet all the requirements for successful completion of the task.

### Work flows, task flows, and procedures

Work flows, task flows, and procedures have similar elements to maintain consistency and usability. Each section has a specific function.

- "Purpose statements" (page 25)

#### **Purpose statements**

Purpose statements explain why or when you would perform a work flow, task, or procedure and its impact.

#### **Prerequisites**

Prerequisites lists everything you must do or understand before you start the workflow, task, or procedure, such as tasks that should already be completed, risks, confirmation of system status, required knowledge, time estimates or limitations, and links to supporting information.

The prerequisite section is omitted if no required prerequisites exist.

#### Work flows or task flows

This section is the flow chart diagram that represents the task flow with navigational links to the tasks or procedures in the flow.

#### Procedure steps

Procedures provide numerical steps that help you perform the procedure. Each step is a single action.

#### **Example procedures**

Some procedures use examples to show how to correctly perform the procedure with realistic settings.

#### Variable definitions

Variable definitions provide the possible values, ranges, or definitions of variables used in the procedure steps.

If variables are not used in the procedure, then the variables definition section is omitted.

#### Job aid

Job aids provide information help to successfully perform the procedure.

The job aid is only used when required.

#### Task-based documentation terms

Task-based documentation uses the following terms.

Term	Description
Work flow	A high-level or top-level group of tasks.
Task or task flow	A logical group of procedures that is represented as a single action in a flowchart diagram. Complex tasks can be divided into simpler tasks or subtasks.
Procedure	A logical group of steps that can be described as a single action in a task.
Step	A single action that is performed in a procedure.
Variable	A placeholder in procedure steps that can represent a value or definition.

Restructuring Nortel technical documents into a task-based format is an ongoing initiative. The documentation for some Nortel products is already converted to the new format.
