NOTE: The word "Windows" in this user guide refers to the following Microsoft operating systems: Windows '95, Windows NT, Windows '98, Windows 2000, Windows Me (Millennium), and Windows XP.

Package Contents

Your LCD display package includes:

- LCD display

NOTE: The CD includes the User Guide PDF files and INF/ICM display optimization files. The INF file ensures compatibility with Windows operating systems, and the ICM file (Image Color Matching) ensures accurate on-screen colors. ViewSonic recommends that you install both the INF and ICM files.

Precautions

- Sit at least 18" from the LCD display.
- Avoid touching the screen. Skin oils are difficult to remove.
- Never remove the rear cover. This LCD display contains high-voltage parts. You may be seriously injured if you touch them.
- Avoid exposing the LCD display to direct sunlight or another heat source. Orient the LCD display away from direct sunlight to reduce glare.
- Always handle the LCD display with care when moving it.

- Place the LCD display in a well ventilated area. Do not place anything on the LCD display that prevents heat dissipation.
- Ensure the area around the LCD display is clean and free of moisture.
- Do not place heavy objects on the LCD display, video cable, or power cord.

Quick Installation

1. Connect power cord (and AC/DC adapter if required)

2. Connect video cable

- Make sure both the LCD display and computer are turned OFF
- Remove rear panel covers if necessary
- Connect the video cable from the LCD display to the computer

Macintosh users: Models older than G3 require a Macintosh adapter. Attach the adapter to the computer and plug the video cable into the adapter.

3. Turn ON LCD display and computer

Turn ON the LCD display, then turn ON the computer. This sequence (LCD display before computer) is important.

NOTE: Windows users may receive a message asking them to install the INF file. This is on the CD.

4. Insert the ViewSonic Wizard CD into the computer's CD drive.

Follow the on-screen instructions. If your computer does not have a CD-ROM drive, please refer to Customer Support page.

• Wait for the CD-ROM to auto-start.

NOTE: If the CD-ROM does not autostart: double-click on the CD-ROM icon in the Windows Explorer, then double-click on **viewsonic.exe**.

• Follow the on-screen instructions.

5. Windows users: Set the timing mode (resolution and refresh rate)



HOW TO USE THE STAND

The monitor is shipped with the stand detached. Be sure to attach the stand before operating the display and remove if it is necessary to re-box.

CAUTION


- Install the Stand on a stable surface. The monitor may cause injury or damage if it falls or is dropped.
- Do not give a strong impact to the monitor. It may cause damage.
- Unplug the monitor before installation to avoid electric shock or damage.

<Installation>

1. Put a piece of soft cloth on the table beforehand to prevent the monitor from being scratched. Lay the monitor flat on a table with front face down.

2. The Stand-Bottom is pulled up as shown in the figure.


3. Install the Stand-Base to the Stand-Bottom.



<Remove>


1. Put a piece of soft cloth on the table beforehand to prevent the monitor from being scratched. Lay the monitor flat on a table with front face down.

2. Hold down the hooks outside and pull the Stand-Base away from the Stand-Bottom.



Wall Mounting (Optional)

To obtain a wall-mounting kit, contact ViewSonic[®] or your local dealer. Refer to the instructions that come with the base mounting kit. To convert your LCD display from a desk-mounted to a wall-mounted display, do the following:



- 1. Verify that the Power button is turned Off, then disconnect the power cord.
- 2. Lay the LCD display face down on a towel or blanket.
- 3. Remove the 2 screws attaching the base.
- 4. Remove the Plastic Covers from the back of the LCD display.
- 5. Attach the mounting bracket from the compatible wall mounting kit (100 mm x 100 mm distance).
- 6. Attach the LCD display to the wall, following the instructions in the wall-mounting kit.

Using the LCD Display

Setting the Timing Mode

Setting the timing mode is important for maximizing the quality of the screen image and minimizing eye strain. The **timing mode** consists of the **resolution** (example 1680 x 1050) and **refresh rate** (or vertical frequency; example 60 Hz). After setting the timing mode, use the OSD (On-screen Display) controls to adjust the screen image.

For the best picture quality set your LCD display timing mode to:


VESA 1680 x 1050 @ 60Hz.

To set the Timing Mode:

- 1. Set the resolution: Right-click on the Windows desktop > Properties > Settings > set the resolution.
- 2. Set the refresh rate: See your graphic card's user guide for instructions.

WARNING: Do not set the graphics card in your computer to exceed the maximum refresh rate of 85Hz; <u>doing so may result in permanent damage to your LCD display</u>.

OPERATING THE MONITOR

⑦ Press the ENTER Button to start the On Screen Display feature. There are additional Menu items which can be switched by using the ◀ / ▶ Buttons.




- ② Select the Menu item which contains the adjustment icon relating to the adjustment you want to make. Press the ENTER Button. Then, use the
- ③ Press the ENTER Button again. Use the ◀ / ▶ Buttons to make the appropriate adjustment or setting.
- ④ Press the EXIT Button to leave the menu, and the settings you just made would be automatically saved.

For example, to correct for vertical position, select Menu item of Geometry and then press the ENTER Button. Then, select () (V.Position) by using the \checkmark / > Buttons.



An adjustment page appears after you press the ENTER Button. Then, use the \blacktriangleleft / \blacktriangleright Buttons to change the vertical position settings. The vertical position of the overall display should be changing accordingly while you are doing this.

Press the EXIT Button lastly, it ends, any changes are saved in the memory.



NOTE

- When button operations are aborted during adjustment, On-Screen Display disappears when the time set for the OSD Time has passed. Also, press the EXIT button to quickly turn off the On-Screen Display.
- Any changes are automatically saved in the memory when the On Screen Display disappears. Turning off the power should be avoided while using the Menu.
- Adjustments for H. / V. Position, Pixel Clock and Phase are saved for each signal timing. Except for these adjustments, all other adjustments have only one setting which applies to all signal timings.

Troubleshooting

No power

- Make sure power button (or switch) is ON.
- Make sure A/C power cord is securely connected to the LCD display.
- Plug another electrical device (like a radio) into the power outlet to verify that the outlet is supplying proper voltage.

Power is ON but no screen image

- Make sure the video cable supplied with the LCD display is tightly secured to the video output port on the back of the computer. If the other end of the video cable is not attached permanently to the LCD display, tightly secure it to the LCD display.
- Adjust brightness and contrast.
- If you are using an Macintosh older than G3, you need a Macintosh adapter.

Wrong or abnormal colors

- If any colors (red, green, or blue) are missing, check the video cable to make sure it is securely connected. Loose or broken pins in the cable connector could cause an improper connection.
- Connect the LCD display to another computer.
- If you have an older graphics card, contact ViewSonic[®] for a non-DDC adapter.

Control buttons do not work

• Press only one button at a time.
