

## PREFACE

Iris Camera BM-ET500 is used in an access control system. The iris camera, which captures a user's iris image with the control by Control Unit BM-ED500, is available for following uses.

(Control Unit BM-ED500 is sold separately, however, it must be used in combination with the iris camera.)

#### As an enrollment camera for iris image capturing and Administration PC enrollment

To activate iris recognition, it is necessary to capture the iris images of a user and enroll the iris data in the administration PC. A control unit (for enrollment) generates iris data from iris images captured by an iris camera (for enrollment), and transfers the data to the administration PC in the LAN (Local Area Network). The iris data is enrolled in the iris database of the administration PC. Up to 2 000 users can enroll their iris data. \*1


\*1 To administer the iris data captured by an iris camera and generated by a control unit, you need to install the optional Administration Software BM-ES500E onto a PC. Refer to the manuals of BM-ES500E for details.

#### · As a recognition camera for iris recognition


The user can have his/her iris image captured only by looking at the iris camera (for recognition). It will take approx. 3 seconds between capturing and recognition.\*<sup>2</sup> The user can check the recognition result with the status indicator (ACCEPT/REJECT) on the front side of the iris camera.

Iris data of up to 1 000 users can be distributed from the administration PC to recognition cameras.

- \*2 The recognition time may differ depending on capturing conditions.
- \*3 The iris camera (for enrollment) captures the iris images of both eyes at the same time, but the iris data of each eye is enrolled separately.
- \*4 Capturing diagnosis is made by the administration software at the time of enrollment.
- \*5 Up to 127 gate systems (an iris camera and control unit) can be connected to the administration PC in the LAN. The control unit can also be used as both for enrollment and recognition by changing the operation mode.



- Iris recognition technology is a way to identify a person with iris patterns (an iris is the thin plate-shaped film in front of the eyeball), which differ among each person. The iris pattern of the left eye differs from that of the right eye.
- Using iris cameras, users can carry out recognition without touching any devices.
- The iris data of users need to be enrolled in the administration PC. In the iris recognition process, the users are recognized with the enrolled iris data.



## **FEATURES**

#### Automatic guidance and recognition by two cameras

When a user approaches within 66 cm {2.16 ft.} of the front of an iris camera, iris image capturing and checking will automatically start. A wide angle camera, which monitors the user's face and surroundings, and a telecamera, which captures the user's iris images, can eliminate the adjustment of the camera angle and eye positioning by users. The recognition range of the iris camera is between approx. 30 cm {0.98 ft.} and 60 cm {1.97 ft.}

#### One-time capturing of both eyes enables recognition in approx. 3 seconds\*

This iris camera captures the iris images of both eyes at the same time. A control unit generates iris data from the captured iris images, and compares the data with that distributed to the control unit. If either of the iris data is corresponding with the iris data distributed, you will be recognized as an enrolled user. The recognition time will be approx. 3 seconds (approx. 2 seconds for capturing and 1 second for recognition)\*1.

\*1 The recognition time may differ depending on capturing conditions.

#### · Built-in color CCTV camera that captures the user's facial image

The iris camera has a built-in minisize color camera. You can record the facial image of a user by connecting this camera and a recorder. Using the alarm outputs of the control unit, you can record only users that have not been recognized.

#### · Numeric keys to enter the ID-and-password

Users can carry out ID-and-password authorization, which is an alternate means of recognition when iris recognition is unavailable, with the numeric keys of the iris camera.

#### · Access control system can be composed.

Iris cameras, control units, and the administration PC can compose an access control system in combination with access control panels\*2 and electric locks\*2, etc.

\*2 These devices are independent to BM-ET500.

- This document describes basic operating instructions of Iris Camera BM-ET500.
- The operating instructions supplied to BM-ED500 Control Unit describes operating instructions, examples of system composition, and installation guide of the control unit. Normally, users of recognition cameras do not have to read them. These operating instructions and manuals are intended for system installers and administrators.

## **DOCUMENT CONVENTION**

These operating instructions use the following convention when describing the use and operation of the camera.

**Access control system:** System which controls access using iris cameras, control units, and the administration PC, in combination with access control panels, card readers, and electric locks, etc.

Administration Software: Panasonic Administration Software BM-ES500E

This software is used for administering iris enrollment/recognition.

(This product is sold separately, however, it must be used in combination with an iris camera.)

Administration PC: PC in which the administration software is installed

The PC can administer control units in the LAN.

**Control Unit:** Panasonic Control Unit BM-ED500, which is used for iris enrollment/recognition, and controls electric locks (This product is sold separately, however, it must be used in combination with iris cameras.)

Distribution: To transfer enrolled data from the administration PC to control units and to save the data in the control units

**Enrollment:** To save a user's iris data associated with the individual information (name and ID data, etc.) in the administration PC Iris data is enrolled using the administration software.

**Iris camera (The unit):** Panasonic Iris Camera BM-ET500 **Iris data:** Data that are generated from captured iris images

Iris recognition: Way to identify a person with iris patterns, which differ between each person

Recognition: To identify a user by comparing the iris data that is generated (from iris images captured) with the data enrolled

in the iris database

Wiegand: Transmission method used as an access control system interface

Warning(s): Warning statements identify conditions or practices that could result in severe injury or loss of life.

## **PRECAUTIONS**

#### Refer all work related to the installation of this product to qualified service personnel or system installers.

Consult an expert on the load bearing capacity of the installation surface and structure. If the surface is not strong enough, the camera may fall down. Refer to the product specifications for weights.

#### . Do not drop metallic parts through slots.

This could permanently damage the appliance. Turn the power off immediately and contact qualified service personnel for service.

#### · Do not attempt to disassemble the appliance.

To prevent electric shock, do not remove screws or covers.

There are no user-serviceable parts inside. Contact qualified service personnel for maintenance.

#### · Use of near-infrared ray


Near-infrared ray is used when iris data is enrolled or recognized by the unit. The near-infrared ray is compliant with the radiological safety standard of IEC60825-1.

#### Indication

Refer to the bottom of the unit as to the indications of equipment classification and power source, etc.

- This product is not designed to prevent theft in advance. We shall not guarantee you for any trouble caused by using this unit.
- If you are in a situation that iris recognition is impossible from the exterior, recognition or enrollment will be invalid.
- Iris data is privacy. Take enough care not to leak the image data out of the administration PC. It is also recommended that you should get an agreement from a person to register his or her data.
- We recommend that you note down your settings and save them. Power or battery failure may erase the setting.
- Do the self-diagnostic test, when you open this unit door for maintenance, etc. The self-diagnostic test can be carried out by turning on a power supply.
   Read BM-ED500 Operating instructions for turning on a power supply.

# MAJOR OPERATING CONTROLS AND THEIR FUNCTIONS



#### 1) Status Indicator

Shows the status of recognition or enrollment.

**ACCEPT:** Lights up when recognition has been successfully executed. \*

Or lights up when enrollment has been successfully executed through iris image capturing.

**REJECT:** Lights up when recognition has not been successfully executed.

Or lights up when enrollment has not been successfully executed through iris image capturing.

**READY:** Lights up when recognition/enrollment is available

When this indicator is blinking, recognition/enrollment is unavailable.

\* Depending on capturing condition, you might not enroll your iris data even when ACCEPT is lighting. After the enrollment, confirm through the administration PC, in which the administration software is installed, if the recognition has been successfully executed.

#### 2 User quidance indicators

These indicators light up when you stand in front of the unit, and then inform you that recognition/enrollment will start.

#### 3 Built-in color CCTV camera

This is a color camera for surveillance.

For example, it is used for status confirmation if a recognition has not been successfully executed.

#### (4) Operation indicators

These indicators show the operation statuses of the unit. The central indicator is lit all the time when power is applied. Refer to p.16.

#### 5 Front panel

#### 6 10 key cover

#### 7) LED indicator

Shows which numeric key has been pressed.

#### **8 Numeric keys**

These keys are used when you execute ID-and-password authorization instead of iris recognition.

#### 9 Buzzer-level adjustment hole

Adjusts the level of buzzer, which informs you of recognition/enrollment results. Refer to p.15 for details on level adjustment.

**Note:** Keep away from this hole except for qualified service personnel.






- Keep the unit:
- in the temperature between  $0\,^{\circ}\text{C}$  and  $40\,^{\circ}\text{C}$  {between  $32\,^{\circ}\text{F}$  and  $104\,^{\circ}\text{F}$ } and the humidity between  $30\,^{\circ}$  and  $80\,^{\circ}$ .



- · Keep the unit away from:
- · direct sunlight or light reflection.
- incandescent or halogen lighting.
- places where shadow appear over the front panel.
- noise. (for example, places near air conditioners or ventilators)
- · electricity.
- · outdoor places.
- vibration. (It may cause invalid recognition or injury.)
- Do not place anything inside the space described in the illustration.
- This unit is for indoor use only.
- This unit must be mounted horizontally on the wall.
- Determine the optimum mounting height. The recommendation is between 1.38 m {54 in.} and 1.5 m {60 in.} for enrollment/recognition effectiveness.



#### **■** Installation

The unit can be mounted over the wall as described.


1. Attach the anchor into the wall, and then attach the supplied mounting bracket to the anchor. (Refer to the figure in p.14.)


The anchor bolt should meet the standards shown in the illustration.


2. Remove the shipping lock as follows:






- (3) Bend the belt and secure it with the screw.
- Take care not to drop the screw inside the unit.
- You can use an M3 screw if you have lost this screw.
- 3. Remove the numeric keyboard.


You can remove the keys by taking off the two tamperproof screws (with the supplied tamperproof screw driver tool) and lifting up the keyboard. The control cable should also be removed.






4. Attach the unit to the mounting bracket.

You need to make a hole of approx. Ø 30 mm on the wall to pass the cables out of the rear side.




5. Connect the coaxial cable to the unit.

The unit is connected to the control unit (Camera 1 - 3).



 When you use the built-in CCTV camera, connect the supplied video output cable to VIDEO OUT. Then, connect the supplied video output cable and the video input cable of a connected device (for example, a monitor or DVR).


7. Connect the DC power cable to the unit.

If you use power supply from the control unit to the unit, connect the DC power cable to 0 V and +32 V ports.

If you use 24 V DC power supply from an external power supply device, connect the power cable to 0 V



**Caution:** Take DC 24 V power supply from a third-party external power supply device that complies with the safety standard. (Refer to p.21.)

 Attach the numeric keyboard.
 Connect the control cable which has been connected to the numeric keyboard. Then, attach the keyboard with the tamperproof screws.

**Caution:** Insert the cable into the unit so as to avoid pressure from the keyboard.


## ■ Adjustment

#### Adjusting the Buzzer Level

Adjust the buzzer level, which informs you of recognition results, as follows.

- 1. Open the cover of the numeric keyboard.
- 2. Insert a Phillips precision screwdriver into the buzzer-level adjustment hole.
- Turn the screwdriver to the right or left to adjust the buzzer level.

**To the right:** The volume will go up. **To the left:** The volume will go down.




### ■ Maintenance

## Replacing the Front Panel

When the supplied front panel has been damaged, you can replace it to a new one.

- 1. Remove the numeric keyboard. (Refer to p.12.)
- 2. Remove the front panel, and then replace it to a new one.

You can take the panel away by sliding down. During the replacement, wear gloves on your hand to keep the new panel clean.




3. When finished, connect the control cable to the numeric keyboard.

#### Cleaning the Inside of the Camera Unit

There are a mirror, proximity sensor, and two cameras inside the unit. The cameras will be used for capturing a face and irises. If dust is sticking to the cameras, it may cause malfunction. Clean the inside of the camera unit as follows.

- 1. Remove the numeric keyboard and the front panel. (Refer to p.12 and this page.)
- Blow dust away from the mirror, sensor, Camera 1 and Camera 2 by using a blower, etc.
   If dust still sticks after blowing, wipe away the appliances gently with an eyeglass cleaner or a camera-lens cleaner.
- 3. After finished, attach the front panel and numeric keyboard to the unit.



#### Notes:

- Keep your hands away from the mirror, Camera 1 and Camera 2. If you touch them directly, it may cause malfunction due to smudges.
- Do not clean the camera unit with a glass-cleaner, thinner or water. It may cause malfunction.
- Clean the camera unit with delicate care. Force may damage the appliance, which may cause trouble.

# **RECOGNITION PROCEDURES**

There is two ways of identification:

- Iris recognition
- ID-and-password authorization

**Note:** When "READY" is blinking, recognition will be unavailable. Wait until the indicator is on, not blinking.


## **■ Iris Recognition**

The procedures are as follows.

1. Stand in front of the unit and turn your face to the center front panel.

Stop at the point you can see the two guidance indicators simultaneously, and then turn your face to the unit.

Guidance indicators












2. The guidance indicators will automatically light up, and iris recognition will start. Then, the buzzer will beep briefly.




3. Status indicator ① will light up.




**Note:** Depending on the distance between you and the unit, status indicators will blink as shown in Figure 1 or 2. When the indicators show Figure 1 status, come closer to the unit. When the indicators show Figure 2 status, go farther from the unit.



- 4. The status indicators will light up in the order shown in the figure.
  - When all indicators have lighten up, the recognition will be finished.




5. When recognition has been successfully executed, ACCEPT will light up and the buzzer will beep. When recognition has not been successfully executed (or you have not been enrolled to the unit), REJECT will light up and the buzzer will beep.



#### Notes:

• The capturing range is as follows.



- The height of the unit, shown in the figure, is recommendation. Center of optical axis and upside/downside limit of eye
  position will differ depending on the installation height.
- If your eye position is higher than the upside limit, bend down. If your eye position is lower than the upside limit, get on a pedestal, etc.

## **■ ID-and-password Authorization**

You can also identify yourself by entering your ID and password with numeric keys.

The procedures are as follows.

- 1. Open the keyboard cover at the bottom of the unit. No indicator is lighting at this point.
- 2. Press a numeric key. (Any key is OK.) "0" will light up on the LED indicator.
- Enter your ID number by pressing numeric keys, and then press ENTER.

The digit number will light up on the LED indicator. For example, if you enter a five-digit password, "5" will light up on the LED indicator. (If the digit is 10 or more, the end number will light up.)

**Note:** If you cancel ID-and-password-authorization and return to iris recognition, press CANCEL.

4. Enter your password by pressing numeric keys, and then press ENTER.


The digit number will appear on the LED indicator. For example, if you enter a five-digit password, "5" will light up on the LED indicator. (If the digit is 10 or more, the end number will light up.)

**Note:** If you cancel ID-and-password-authorization and return to iris recognition, press CANCEL.

When the ID and password are matching with the enrolled information, "ACCEPT" will light up and the buzzer will beep briefly.


