



Precautions (Battery Pack)

Do Not Use with Any Other Computer

The battery pack is rechargeable and was intended for the specified computer or charger. If it is used with a computer other than the one for which it was designed, electrolyte leakage, generation of heat, ignition or rupture may result.

Do Not Charge the Battery Using the Methods Other Than Indicated in This Manual

If the battery pack is not charged using one of the methods indicated in this manual, electrolyte leakage, generation of heat, ignition or rupture may result.

Do Not Throw the Battery Pack into a Fire or Expose It to Excessive Heat

Generation of heat, ignition or rupture may result.

Avoid Extreme Heat (Near the Fire, in Direct Sunlight, for Example)

Electrolyte leakage, generation of heat, ignition or rupture may result.

Do Not Insert Sharp Objects into the Battery Pack, Expose It to Bumps or Shocks, Disassemble, or Modify It

Electrolyte leakage, generation of heat, ignition or rupture may result.

Do Not Short the Positive (+) and Negative (-) Contacts

Generation of heat, ignition or rupture may result. Do not place the battery pack together with articles such as necklaces or hairpins when carrying or storing.

Do Not Use This Computer with a Battery Pack Other Than the One Specified

Use only the specified battery pack (CF-VZSU43AU) with your CF-74. Use of battery packs other than those manufactured and supplied by Panasonic may present a safety hazard (generation of heat, ignition or rupture).


- Do not touch the terminals on the battery pack. The battery pack may no longer function properly if the contacts are dirty or damaged.
- Do not expose the battery pack to water, or allow it to become wet.
- If the battery pack will not be used for a long period of time (a month or more), charge or discharge (use) the battery pack until the remaining battery level becomes 30% to 40% and store it in a cool, dry place.

- This computer prevents overcharging of the battery by recharging only when the remaining power is less than approx. 95% of capacity.
- The battery pack is not charged when the computer is first purchased. Be sure to charge it before using it for the first time. When the AC adaptor is connected to the computer, charging begins automatically.
- Should the battery leak and the fluid get into your eyes, do not rub your eyes. Immediately flush your eyes with clear water and see a doctor for medical treatment as soon as possible.

NOTE

- The battery pack may become warm during recharging or normal use. This is completely normal.
- Recharging will not commence if internal temperature of the battery pack is outside of the allowable temperature range (0 °C to 50 °C {32°F to 122°F}) (→ ♀☐ Reference Manual "Battery Power"). - This computer has a high temperature mode function that prevents the degradation of the battery in high temperature environments. (→ ☐ Reference Manual "Battery Power") A level corresponding to a 100% charge for high temperature mode is approximately equivalent to an 80% charge level for normal temperature mode.
- The battery pack is a consumable item. If the amount of time the computer can be run by using a particular battery pack becomes dramatically shorter and repeated recharging does not restore its performance, the battery pack should be replaced with a new one.
- When transporting a spare battery inside a package, briefcase, etc., it is recommended that it be placed in a plastic bag so that its contacts are protected.
- Always power off the computer when it is not in use.
 Leaving the computer on when the AC adaptor is not connected will exhaust the remaining battery capacity.

- ③ Slide the right latch (A) to the locked position (△).

To remove the battery pack

- ① Slide the right latch (B) to the unlocked position ().
- ② Slide and hold the left latch (C) to the unlocked position (), and hold the center of the battery pack and push out in parallel with the bottom surface of the computer.

- Make sure the latch is securely locked. Otherwise the battery pack may fall when you carry the computer.
- Do not touch the terminals of the battery pack and the computer. Doing so can make the terminals dirty or damaged, and may cause malfunction of the battery pack and the computer.



Connect your computer to a power outlet.

The battery charging starts automatically.


CAUTION

- Do not disconnect the AC adaptor and do not switch the wireless switch to on until the first-time operation procedure is completed.
- When using the computer for the first time, do not connect any peripheral device except the battery pack and AC adaptor.

Handling the AC adaptor

- Do not twist or pull the AC power cord forcefully. Doing so may damage the connections.
- Use only the specified AC adaptor with your computer. Using an AC adaptor other than the one supplied might damage the battery and/or the computer.
- When the DC plug is not connected to the computer, disconnect the AC cord from your AC wall outlet.
- Problems such as sudden voltage drops may arise during periods of thunder and lightning. Since this could adversely affect your computer, an uninterruptible power source (UPS) is highly recommended unless running from the battery pack alone.

3 Turn on the computer.

- Pull the carrying handle forward.
- ② Lift up the latch (A) and lift open the display.
- ③ Press and hold the power button () for approximately one second until the power indicator () lights.

CAUTION

- Do not press the power button repeatedly.

Windows Update

Do not apply "Driver Updates" even if a message to update a driver appears. If a driver update is required, contact Panasonic Technical Support (>> page 30).

If the message "Your computer might be at risk" is displayed

Select (red icon) on the taskbar and make the appropriate settings. The Windows Security Center regularly gives you notice so that you can make the optimum settings. This is not an error message and you can use the computer. However, making appropriate measures is recommended to reduce the risk of virus and other attacks.

Note that the computer consumes electricity even when the computer power is off.

Handling and Maintenance

Operation Environment

• Place the computer on a flat stable surface. Do not place the computer upright or turn it over. If the computer is exposed to an extremely strong impact, it may become inoperable.

• Temperature: Operation: 5 °C to 35 °C {41 °F to 95 °F}

Storage: -20°C to 60 °C {- 4 °F to 140 °F}

Humidity: Operation: 30% to 80% RH (No condensation)

Storage: 30% to 90% RH (No condensation)

Even within the above temperature/humidity ranges, using for a long time in an extreme environment will result in the product deterioration and will shorten the product life.

- Do not place the computer in the following areas, otherwise the computer may be damaged.
 - Near electronic equipment. Image distortion or noise may occur.
 - · In extremely high or low temperature.
- As the computer can become hot during operation, keep it away from items that are sensitive to heat.

Handling Cautions

This computer is designed to minimize shock to parts such as the LCD and the hard disk drive and equipped with a dripproof keyboard, but no warranty is provided against any trouble caused by shock. Be extremely careful when handling the computer.

- When carrying the computer:
 - Turn off the computer.
 - Remove all external devices, cables, cards and other protruding things.
 - · Remove a disc in the CD/DVD drive.
 - Do not drop or hit the computer against solid objects.
 - Do not leave the display open.
 - · Do not grip the display part.
- Do not put anything (e.g., a piece of paper) between the display and keyboard.
- When you board an airplane, take the computer with you and never put it in your checked luggage. When using the computer on airplane, follow the airline's instructions.
- When carrying a spare battery, put it in a plastic bag to protect its terminals.
- The touch pad is designed to be used with a finger tip. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
- Avoid any harmful substances such as oil from getting into the touch pad. The cursor may not work correctly.
- <Only for model with touchscreen>
- Use only the included stylus to touch the touchscreen. Do not place any object on its surface and do not press down strongly with sharp-pointed or hard objects that may leave marks (e.g., nails, pencils and ball point pens).
- Do not use the stylus when dust or dirt (e.g., oil) is on the screen. Otherwise foreign particles on the screen/stylus can scratch the screen surface or obstruct the stylus operation.
- Use the stylus only for touching the screen. Using it for any other purpose may damage the stylus and result in scratches on the screen.

■ When using peripheral devices

Follow these instructions and the Reference Manual to avoid any damage to the devices. Carefully read the instruction manuals of the peripheral devices.

Maintenance

To clean the LCD panel

Use the soft cloth included with the computer. (For further information, refer to "Suggestions About Cleaning the LCD Surface" that comes with the soft cloth.)

To clean areas other than the LCD panel

Wipe with a soft dry cloth such as gauze. When using detergent, dip a soft cloth in water-diluted detergent and wring it thoroughly.

CAUTION

- Do not use benzene, thinner, or rubbing alcohol since it may adversely affect the surface causing discoloration, etc. Do not use commercially-available household cleaners and cosmetics, as they may contain components harmful to the surface.
- Do not apply water or detergent directly to the computer, since liquid may enter inside of the computer and cause malfunction or damage.

Hard Disk Backup Function

The hard disk backup function creates a backup area (storage area) on the hard disk. This area is to back up (store) the hard disk data or to restore the backup data to their original locations.

Using this function, you can protect your data when it is lost or corrupted by operational errors or other factors. You do not need other media or peripheral devices to back up or restore hard disk data on this computer.

At purchase, the hard disk backup function is disabled. If you create a backup area, the hard disk backup function will be enabled and you can back up your data.

The hard disk backup function cannot back up or restore data correctly if a hard disk problem occurs during data backup or restoring. If an error occurs due to an unexpected malfunction, incorrect operation, or other reason while data is being restored, the hard disk data (data before restoration) may be lost.

Matsushita Electric Industrial Co., Ltd. will bear no responsibility for any damages suffered by the user (including loss of data) as a result of the use of this function.

CAUTION

- To disable the backup function after it is enabled, you have to perform the reinstallation procedure (→ page 20).
- A backup area cannot be created if the hard disk is already divided into several partitions. Return the computer to one partition, and create the backup area.
- If the partition configuration is changed after the backup area is created (creating partitions, changing size, etc.), the backup function will be disabled. You need to return the computer to the original condition and create the backup area again.
- Do not use the NTFS file system compression function. It may result in insufficient capacity of the backup area.
- The hard disk backup function does not accommodate dynamic disks. Do not convert the hard disk to a dynamic disk.

NOTE

- The backup area requires at least half of the entire hard disk capacity. If the capacity is not sufficient, the backup area will not be created.
- When the backup area is created, the usable hard disk capacity will be less than half of the original capacity.
- The backup area cannot be accessed from Windows. The backup data cannot be copied to CD-R or other removable disk media.
- When the hard disk backup function is executed, data in the backup area will be overwritten and the data previously stored will be lost.

Creating the Backup Area

Preparation

- Prepare the following items:
 - The Product Recovery DVD-ROM (included)
 - · Panasonic CD/DVD drive (included)
- Remove all peripherals (except for the CD/DVD drive).
- Connect the AC adaptor and do not remove it until hard disk backup is complete.
- 1 Turn off the computer and insert the CD/DVD drive into the multimedia pocket (→ ♀ Reference Manual "Multimedia Pocket").
- 2 Turn on the computer, and press **F2** several times while [Panasonic] boot screen is displayed.

The Setup Utility starts up.

- If the password is requested, enter the Supervisor Password.
- 3 Select the [Boot] menu and select [IDE MP], and then press **F6** until [IDE MP] moves up to the top of the boot priority order.
- 4 Select the [Security] menu and set [CD/DVD Operation] to [Enable].
- 5 Set the Product Recovery DVD-ROM into the CD/DVD drive.

6 Press **F10**.

At the confirmation message, select [Yes] and press **Enter**.

The computer restarts.

 If [Enter Password] is displayed during the following procedures, input the Supervisor Password or the User Password.

7 Press 3 to execute [3. [Backup]].

At the confirmation message, press $\overline{\mathbf{Y}}$.

CAUTION

When you divide the hard disk into partitions:

Do not execute [1. [Recovery]] to divide the hard disk into partitions. The hard disk backup function cannot be enabled after the hard disk has been partitioned. Use step 8 to divide the hard disk.

8 Select the setting.

- To create a backup area and enable the backup function without dividing the hard disk Select [1].
- To create a backup area and divide hard disk into two partitions, for OS and data Select [2]. Enter the size of operating system partition and press **Enter**.
 - To cancel: press <u>0</u>.
 (The size of data partition will be determined by subtracting the operating system partition size from the maximum size.)
- 9 At the confirmation message, press <u>Y</u>.

The backup area is then created.

- 10 When the message [You must reboot in order to enable the Backup function.] appears, remove the Product Recovery DVD-ROM, and press any key to restart the computer.

 The computer restarts, then the backup process will begin.
- 11 When the message [[Backup] is complete] appears, press **Ctrl** + **Alt** + **Del** to restart the computer.
 - Do not press <u>Ctrl</u> + <u>Alt</u> + <u>Del</u> before the message is displayed.
 - After logging on to Windows, a message will appear indicating that a new device has been installed and that the computer must be restarted to enable the settings.

12 Select [Yes] to restart the computer.

NOTE

- The [Boot] menu in the Setup Utility is now set to start up from the CD/DVD drive. Change it if necessary.
- To perform the backup/restore function next time; "Creating/Restoring the Backup Data" (→ below).

CAUTION

- Before executing the backup function, execute a disk error check.
- Do not interrupt the backup or restore functions. Do not turn off the power and do not press **Ctrl** + **Alt** + **Del**, otherwise Windows cannot start up, or the data may be lost and the backup and restore functions may not be completed.
- Turn on the computer, and press $\overline{\mathbf{F2}}$ several times while [Panasonic] boot screen is displayed.

The Setup Utility starts up.

- If the password is requested, enter the Supervisor Password or the User Password.
- 2 Select the [Exit] menu and select [Hard Disk Backup / Restore], and then press **Enter**.

 At the confirmation message, select [Yes] and press **Enter**.

Hard Disk Backup Function

3 Select the setting.

- To back up hard disk contents to the backup area
- ① Press 1 to execute [1. [Backup]].
 - If the hard disk is divided into two partitions, select the backup method at the next screen.

When the message [[Backup] is complete] or [[Restore] is complete] is displayed, press Ctrl + Alt + Del to restart the computer.

- If the backup or restore process was interrupted before completion, execute the process again.
- After logging on to Windows, a message will appear indicating that a new device has been installed and that the computer must be restarted to enable the settings. Select [Yes] to restart the computer.

CAUTION

When the hard disk backup function has been enabled, you cannot erase the backup data even when you erase all data from user accessible area by using a commercial data erasing utility or similar software. To erase all data on the hard disk including backed up data, use the hard disk data erase utility included in this computer (→ page 19). Erase the data using the hard disk data erase utility before disposing of or transferring ownership of this computer.

To disable the hard disk backup function

Perform the reinstallation procedure.

CAUTION

All data in the backup area and hard disk will be erased.

- ① Perform steps 1-9 for "Reinstalling Software" (→ page 20).
- 2 Select [1] or [2] to execute the reinstallation at the screen for executing the reinstallation.

Hard Disk Data Erase Utility

- 7 Press $\overline{2}$ to execute [2. [Erase HDD]].
 - To cancel this operation, press \(\oldsymbol{\oldsymbol{0}} \).
 - When the hard disk backup function has been enabled, the confirmation message appears to inform that the backup function will be disabled, and the backup area and data will be erased. Press <u>▼</u> to proceed. If the reboot message appears, press <u>R</u> to proceed.
- 8 At the confirmation message, press $\overline{\mathbf{Y}}$.
- 9 When [<<< Start Menu >>>] is displayed, press Enter.

The approximate time required for erasing data will be displayed.

10 Press **Space**.

At the confirmation message, press **Enter**.

The hard disk erase process starts. When the operation is completed, the [Hard disk data has been deleted.] message will appear. If a problem has occurred during the operation, an error message will appear.

- To cancel partway, press **Ctrl** + **C**. The data erasure will be up to that point.

Reinstalling Software

- 5 Select the [Security] menu and set [CD/DVD Operation] to [Enable].
- 6 Set the Product Recovery DVD-ROM into the CD/DVD drive.
- 7 Press **F10**.

At the confirmation message, select [Yes] and press **Enter**.

The computer will restart.

- When the hard disk backup function has been enabled, the confirmation message appears to inform that the backup function will be disabled, and the backup area and data will be erased. Press ▼ to proceed.
- 8 Press 1 to execute [1. [Recovery]].

The License Agreement screen appears.

- To cancel partway, press <u>0</u>.
- 9 Press $\overline{1}$ to select [1. Yes, I agree to the provisions above and wish to continue!].
- 10 Select the settings.
 - [2]: Enter the size of operating system partition and press <u>Enter</u>.

You cannot create the hard disk backup area if you select [2].

(The size of data partition will be determined by subtracting the operating system partition size from the maximum size.)

- [3]: Windows will be installed in the first partition.
 - (The size of the first partition must be 20 GB or more. If smaller, installation will not be possible.)
