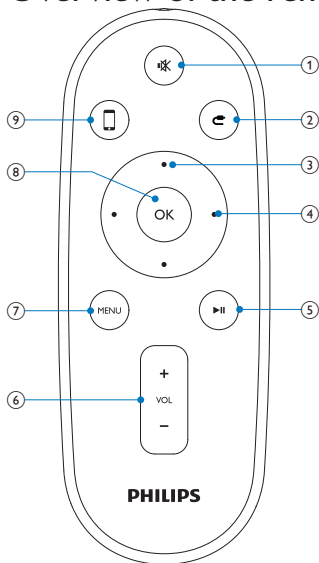

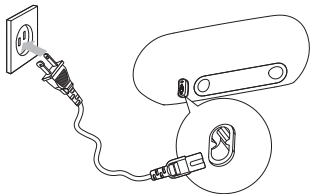
Connect power

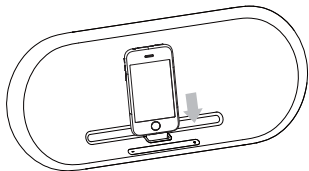
