Problem: Mousedoes not work

Tips

4. Make sure your computer fulfills the minimum system requirement.

Problem: No reaction on the mouse

1. Ensure that you have inserted battery into the mouse
2. Check if the battery was inserted correctly
3. Repeat the installation process
4. Keep the mouse within a distance of 10 meter. When you are of reach establish the steps to connect the products.

The optical technology can precisely detect the mouse motion on most surfaces. Avoid using the mouse on any reflective, transparent metallic or complex-pattern surface.

Problema: El ratón no funciona

Sugerencias

Problème :

4. Gardez la souris à une distance de 10 mètres. Lorsque vous êtes à la bonne distance, suivez les étapes pour connecter les produits.

Note:

La technologie optique détecte précisément le déplacement de la souris sur la plupart des surfaces. Éviter d'utiliser la souris pour notebook sur une surface réfléchissante, métallique transparente ou à forme complexe.
