

### **Important Information**

- **10. Grounding** This video product is equipped with a two prong wall adapter. The shield of the power cord is ground.
- 11. Power Sources This product should be operated only from the type of power source indicated on the marking label. If you are not sure of the type of power supplied to your home, consult your appliance dealer or local power company.
- 12. Power Cord Protection Power supply cords should be routed so they are not likely to be walked on or pinched by items placed upon or against them. Pay particular attention to cords and plugs, convenience receptacles, and the point where they exit from the appliance.
- 13. Lightning For added protection for this product during a lightning storm, or when it is left unattended and unused for long periods of time, unplug it from the wall outlet.
- 14. Power Lines An outside antenna system should not be located in the vicinity of overhead power lines, other electric light or power circuits, where it can fall into such power lines or circuits. When installing an outside antenna system, extreme care should be taken to keep from touching such power lines or circuits as contact with them may be fatal.
- **15.** Overloading Do not overload wall outlets and extension cords as this can result in risk of fire or electric shock.
- **16. Object and Liquid Entry** Never push objects of any kind into this product through openings as they may touch dangerous voltage points or short-out parts that could result in a fire or electric shock. Never spill liquid of any kind on the product.

- **20. Safety Check** Upon completion of any service or repairs to this product, ask the service technician to perform safety checks to determine that the product is in proper operating conditions.
- **21. Outdoor Antenna Grounding** Before attempting to install this product, be sure the antenna or cable system is grounded so as to provide some protection against voltage surges and built-up static charges.
- a. Use No.10 AWG (5.3mm) copper, No.8 AWG (8.4mm (aluminum, No.7 AWG (10mm)) copper-clad steel or bronze wire or larger, as ground wire.
- b. Secure antenna lead-in and ground wires to house with stand-off insulators spaced from 4 feet (1.22m) to 6 feet (1.83m) apart.
- c. Mount antenna discharge unit as close as possible to where lead-in enters house.
- d. A driven rod may be used as the grounding electrode where other types of electrode systems do not exist. Refer to the National Electrical Code, ANSI/NFPA 70-1984 for information.
- e. Use jumper wire not smaller than No.6 AWG (13.3mm) copper or equivalent, when a separate antenna grounding electrode is used.



## Hook-up



- Connect the RHCP LNB output and the LHCP LNB output to the RHCP(13/14V) and LHCP(17/18V) inputs respectively of the TSMS-2150X-16A.
- 2. Connect an output port from the TSMS-2150X-16At to the input of a DSS receiver.
- 3. Plug the wall adaptor 3.5mm plug into the jack located in the back of the unit. Plug the adaptor into a 120Vac, 60Hz wall receptacle.
- 4. Each of the satellite receivers can select programs in either right or left hand circular polarities. To select a right hand circular polarity, a 13/14 DC voltage is used and to select a left hand circular polarity, a 17/18 DC voltage is used.
