## Introduction


Thank you for purchasing the RadioShack RC Mantis. Drive your mantis forward and backward - you'll see its tentacles light, its eyes move, its head turn side to side, and all six legs hit the ground running! Your mantis comes in two frequencies, 27 MHz and 49 MHz, so you can play with your friends. Check your box to see what frequency you have.

## **Installing Batteries**

Your mantis requires one 9-volt battery to power the transmitter, and four AA batteries to power the receiver. Turn off the receiver before installing or replacing batteries.

- Dispose of old batteries promptly and properly.

## **Helpful Hints**

- Using your mantis for long periods of time can generate high heat levels, resulting in motor wear and tear. Let the mantis cool for about 10 minutes.
- If the mantis does not respond to the transmitter (and fresh batteries are installed), move the transmitter closer to the mantis and try again.
- If someone is using a CB nearby, it may cause interference. Try using your mantis in a different location outside the area of interference.
- Your mantis will not operate properly near devices with transmitters that use the same frequency (27/49 MHz).
