





To start using your camcorder, please follow the setup instructions in the following pages.

2. Installing the battery



Push (to the right) to unlock.

Observe the polarities.

Slide up to lock.

The camcorder can also be powered by USB. Refer to Connecting to a PC section for connecting details. When the camcorder is connected to a PC, three options will be displayed: USB connect, Web cam and USB power. Press + or - to select USB power and press **RECORD** • to confirm.

3. Inserting SD memory card

• An SD memory card (not included) is needed for recording.



Push the card in until a click is heard

- The card icon appears on the screen with memory card inserted.
- To remove card, push card in until a click is heard, then slowly release the card. As card is under minimal tension when locked in memory slot, please use care when removing.

Internal memory is not available. An SD memory card is recommended for recording. (SD memory card not included)



4. Turning on the camcorder

• Slide and hold the power switch () until the camcorder turns on.



- Slide and hold the power switch 0 to turn off the camcorder.
- The camcorder will automatically turn off after 3 minutes if not in use.





General controls



Operation modes

There are three basic modes for operating the camcorder: Video preview mode, Photo preview mode and Playback mode. It will always launch in video preview mode after being switched on. Recording videos

Recording quality

- 1. In Video preview mode, press MENU to show the camcorder menu.
- 2. Press or + to highlight Quality within the Video Menu
- 3. Press **RECORD** to select Quality which will then expose the choices of HD, HQ and WebQ.
- 4. Press or + to highlight the desired Quality from HD, HQ or WebQ, then press REC to save that setting.
- 5. Press **MENU** to exit the camcorder menu. The selected setting (HD, HQ or WebQ) appears on the display screen during preview.


1. In Video preview mode, press the red **RECORD** • button to begin recording.

- While recording, the red recording light on the camcorder front will turn on.
- 2. Press **PLAY/PAUSE** ► II to pause a recording.



- A pause indicator II replaces the red **RECORD** indicator **a** at the bottom right corner of the screen.
- To resume recording, press **PLAY/PAUSE** ► II.
- 3. Press + or to zoom in or out before or during recording.
- 4. Press the red **RECORD** button to stop recording.

Taking photos

To take photos

1. In Photo preview mode, press **RECORD** • to take photos.



- The photo resolution is 3 megapixels which is interpolated from a 1 megapixel sensor.
- 2. After taking a photo, please allow a few seconds for image processing before the next photo can be taken.

Playback mode

Playing back recordings

1. Press **PLAY/PAUSE** ► II to enter Playback mode and start playback of the most recent recording (video/ photo).



- 2. Press + or during playback to adjust volume (video only).
- 3. Hold down \triangleleft or \triangleright to fast rewind or forward the selected video during playback.
- 4. Press **PLAY/PAUSE** ► II to pause playback.
- Press PLAY/PAUSE ►II again to resume playback.



5. To select another video, press ◀ or ► to cue the previous or next video.



Viewing videos on TV

1. Plug in the AV cable (provided) – Insert the single connector end into the camcorder (AV jack) and connect the double connector ends to the corresponding video (yellow) and audio (white) input jacks on the TV.



- 2. Turn on the TV and the camcorder.
- 3. Switch the TV to the selected video input.
- Refer to your TV manual for instructions.
- 4. You may play and delete videos viewed on the TV by using the camcorder buttons.

The default TV output standard is NTSC. You can switch it to PAL standard by going to the camcorder menu. Refer to Menu settings section for more information.



Recording videos to VHS tape or DVD

- 1. Plug in the AV cable (provided) Insert the single connector end into the camcorder and connect the double connector ends to corresponding video (yellow) and audio (white) inputs of the recording device (VHS or DVD recorder).
- 2. Turn on the camcorder and the recording device.
- 3. Switch recording device to the video input connected to the camcorder.


