Step One

Operation

1. Plug your microphone's 3-pin (XLR) plug into the corresponding end of the supplied cord. To prevent feedback, be sure the microphone is turned off before connecting it to a PA or recording system.
2. Plug the cord's other end (1/4-inch plug) into the microphone jack of your PA or recording system.
3. Turn on your PA or recording system.
4. Set the microphone's **ON/OFF** switch to **ON**. When you finish using the microphone, set **ON/OFF** to **OFF**.

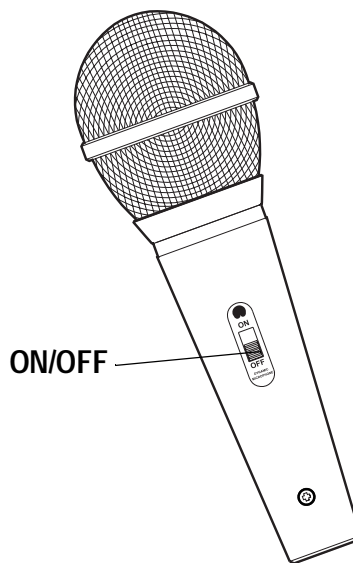
Step Two

To use the supplied microphone holder with your microphone, screw the holder down onto the top of a microphone stand. Then slide the microphone into the larger end of the holder until it is secure.

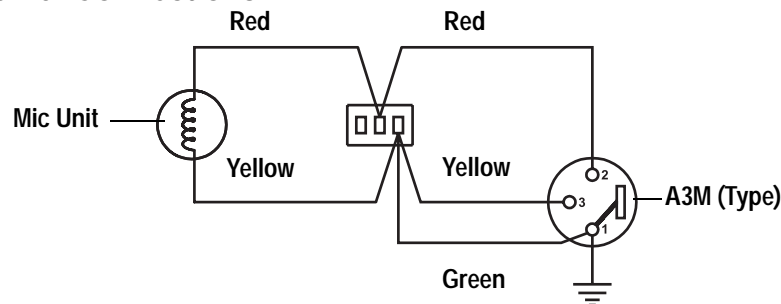

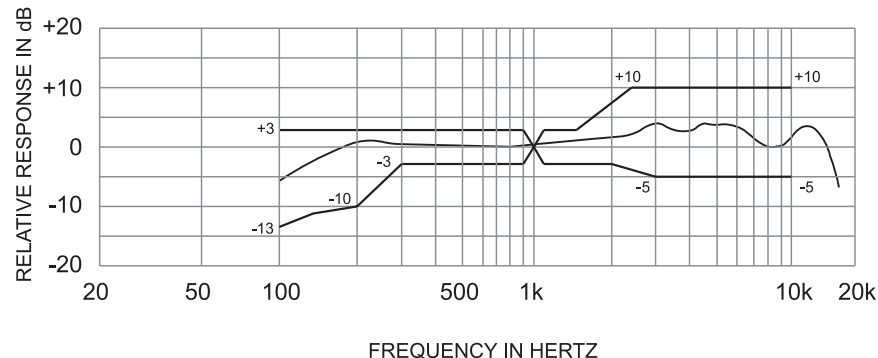


Step Three
