



(3) Setup

1. Press the eject button to eject the receiver from your mouse



- **2.** Turn on your computer. Plug the receiver into a USB port.

- **4.** Press the connect button on the bottom of the mouse and on top of the receiver simultaneously. This pairs the receiver to your mouse.
