

## Using Your Adapter

Plug the correct 1. size Adaptaplug onto the jack at the end of the adapter's cord



- If your device's DC input lack is marked • • • • align **TIP** on the adapter's lack with + on the Adaptaplug (shown).
- the adapter's jack with - on the Adaptaplug.

- 2. Plug the Adaptaplug into your device's DC input jack.
- Set the adapter's voltage switch to the correct 3. setting.
