

## Using Your Adapter

Plug the correct size Adaptaplug onto the jack at the end of the adapter's cord.



- If your device's DC input lack is marked • align **TIP** on the adapter's lack with + on the Adaptaplug (shown).
- If the DC input jack is marked  $\oplus$   $\bigcirc$  align **TIP** on the adapter's jack with - on the Adaptaplug.

CAUTION: Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.

- Plug the Adaptaplug into your device's DC input lack.
- Set the adapter's voltage switch to the correct settina.
- 4. Plug the adapter into an easily accessible power outlet located near the equipment.

- The total combined current for accessories plugged into this adapter must not exceed 2.5A.
