- 1. Set the adapter's voltage switch to the correct setting.
- Plug the correct size Adaptaplug into the jack at the end of the adapter's cord. The polarity markings (+, -) can be ignored since this adapter has AC output. It doesn't matter which way you plug in the Adaptaplug.
- 3. Plug the Adaptaplug into your device's DC input jack.
- **4.** To avoid injury, do not connect the adapter to a ceiling outlet.

- This adapter is designed specifically for use with many AT&T answering machines. It is not a general purpose adapter for other equipment such as CD players, radios, or video game consoles.
