


9VDC • 800mA **AC-to-DC Power Adapter**

Using Your Adapter

Plug the correct size Adaptaplug onto the lack at the end of the adapter's cord



- If your device's DC input lack is marked • align **TIP** on the adapter's jack with + on the Adaptaplug (shown).
- If the DC input jack is marked \oplus \bigcirc align **TIP** on the adapter's jack with - on the Adaptaplug.

!\ CAUTION: Be sure to set the correct tip polarity. Incorrect polarity can damage your device or the adapter.

- Plug the Adaptaplug into your device's DC input jack
- Plug the AC adapter into an easily accessible power outlet located near the equipment.

Cautions:

- If this adapter is not compatible with the voltage and current requirements of your portable device, it can result in PERMANENT DAMAGE to the device
