READ THIS FIRST

We have designed your telephone to conform to federal regulations and you can connect it to most telephone lines. However, each device you connect to the phone line draws power from it. This power draw is the device's *Ringer Equivalence Number*, or REN. The REN is on the bottom of your phone.

If you are using more than one phone or other device on the line, add up all the RENs. If the total is more than five (or three in rural areas) your phones might not ring. If ringer operation is impaired, remove one of the devices from the line.

If your phone causes problems on the phone line, the telephone company can disconnect your service. The phone company tries to notify you in advance. If advance notice is not practical, the telephone company notifies you as soon as possible and advises you of your right to file a complaint with the FCC.

The phone company can also make changes to its lines, equipment, operations, or procedures that could affect the phone's operation. The phone company notifies you in advance, so you can take the necessary steps to prevent interruption of your phone service.

FCC STATEMENT

Your telephone complies with Part 68 of FCC Rules. You must, upon request, provide the FCC registration number and the REN to your telephone company. Both numbers are on the bottom of your phone.

Note: You must not connect your telephone to:

- coin-operated systems
- party-line systems
- · most electronic key phone systems

- Keep the phone dry.
- Handle the phone carefully. Do not drop it.
- Do not use or store the phone in temperature extremes.
- Keep the phone away from dust and dirt.




INSTALLING THE PHONE

Wall Mounting (With or Without Wall Plate)




This symbol is intended to alert you to important operating and servicing instructions included in the papers with the telephone.


USING THE PHONE

Set to **TONE** or **PULSE** to match the type of service you have.

If you have pulse (rotary) service, press X during a call to switch from pulse to tone dialing when you want to use tone services.



Set the ringer to sound a louder ring (HI) or quieter ring (LO), or not to sound at all (OFF). You can make calls with the ringer off, and you can receive calls if you hear another phone on the same line ringing.
