





# Connecting the player to the computer

Connect the player to your computer with the USB cable provided. The player will turn on automatically. In Windows Vista<sup>™</sup> or Windows® XP (when Windows Media Player 10 or above is installed), the player will appear as a Windows portable device using the Media Transfer Protocol (MTP). If Windows Media Player 10 or above is not installed or if your computer is running Windows® 2000, the player will be connected in Mass Storage Class (MSC) mode. It will appear as a detachable drive for file transfer in one or both directions.



#### Warning:



- The USB cable provided is dedicated for this player only. DO NOT connect this player to the computer with any other USB cable. DO NOT plug this USB cable in other USB devices.
- The USB cable provided may damage other products if plugged into the earphones jack.

#### Note:

- It might take several seconds for the player to be detected. Click Refresh in My Computer or Windows Explorer to make sure the player has been detected.
- The player is capable of transferring files at USB 2.0. If USB 2.0 port is available on your computer, use it to connect to your player. The player is still backward compatible with the older USB 1.1 ports. However, you will not be able to take full advantage of the potential speed increase.

### Charging the battery

Your player is charging through the USB connection when it is connected to your computer. To fully charge the player, make sure your computer is on and the player is connected for at least 3 hours.

### Important battery information

**Caution:** Risk of explosion if battery is incorrectly replaced. Replace only with the same or equivalent type.

- Charge the player for at least 3 hours before first use.


#### Transferring files via Windows Explorer (Drag-and-Drop) In Windows® XP (with Windows Media Player 10 installed)

In Windows® XP and when Windows Media Player 10 is installed, the player is connected to the computer in MTP mode. In the Windows Explorer, when the player is opened, the "Data" and "Media" views will be displayed for the player.

The Data folder is used to manage data content on the player, such as text files. The Media folder is used to manage media content supported by the player for playback, such as mp3 and wma.

You can copy files to the player through Windows Explorer (drag-and-drop). Picture files should be copied to the "Media" folder for viewing while video files cannot be dragged and copied to the "Media" folder directly. The video files must be converted and transferred via RCA Video Converter for playback (refer to page 19). Alternatively, you can transfer the converted video files to the "Data" folder via the Windows Explorer (drag-and-drop).

You can copy files to / delete files from the player through Windows Explorer (drag-anddrop), but you cannot open or edit the files directly from the player. If you want to edit the files, you will need to copy the files from the player to another location (drive) in the system.



#### In Windows® 2000 or Windows® XP (without Windows Media Player 10 or above installed)

If Windows Media Player 10 or above is not installed in Windows® XP, or your computer is running Windows® 2000, the player is connected to the computer in MSC mode. You can transfer files via the Windows Explorer (drag-and-drop).

From Windows Explorer, highlight all the files/folders you want to transfer to your player and drag them to the drive letter that is associated with it.

Picture files should be copied to the root directory for viewing while video files can not be dragged and copied to the player directly. The video files must be converted and transferred to the player via RCA Video Converter for playback (refer to page 19). Alternatively, you can transfer the coverted video files to the root directory.

#### In Windows® XP or Windows Vista™ (with Windows Media Player 11 or above installed)

If your computer has installed Windows Media Player 11, "Internal Storage" shows instead of the folders mentioned above. Copy files inside "Internal Storage".



Note: Windows® XP requires Service Pack 1 or higher. Caution: Secure music download files must be transferred to your player through one of the provided Jukebox software packages or any applications recommended by the online music download service. Please visit the online music download service's website where you purchased your content from for more details on transferring secure music to your player.

## Transferring files to the player

### Deleting files from the player

For any files you have transferred to the player, you may delete them while you have connected the player with your computer. Highlight the unwanted file in the player's file directory on your computer and press the delete key on your computer to delete the file. It is best to remove Yahoo! Music<sup>™</sup> subscription files from the player by using the Yahoo! Music<sup>™</sup> Jukebox.

# Disconnecting your player from the computer

For Windows Vista<sup>™</sup> or Windows® XP (with Windows Media Player 10 or above installed), your player is connected in MTP mode to your computer by default, you may disconnect the USB cable directly when file download is completed.

- Problem: Cannot delete files on the player.
- For any files you have transferred to the player, you may delete them while you have connected the player with your computer. Highlight the unwanted file in the player's file directory on your computer and press the delete key on your computer to delete the file. Subscribed files from Yahoo! Music<sup>™</sup> are best to be removed through Yahoo! Music<sup>™</sup> Jukebox.
- For deleting voice recordings, refer to page 21 for details.
- Problem: Player repeats same tracks or all tracks.
- Repeat play is turned on. Press the MENU button (M) to change the play mode.
- Problem: Audio distorted at high volume.
- Change the DSP mode to Flat.
- Turn down the volume.
- Problem: The audio tracks on my player keep skipping or popping.
- You'll need to re-record the audio track make sure you close all other applications on your PC when you record.
- Try recording with Error Correction setting turned on.
- Problem: Player turns itself off.
- Your player turns itself off if you leave it in pause mode or navigation mode for the duration specified in PowerSave setting.
- Problem: The player cannot be turned on.
- Battery is empty.
- Ensure the keys lock is not activated.
- Reset the player by pressing the RESET button on the back of the player with a non-metal pointed object (e.g. toothpick).
- If the player still cannot be turned on after resetting, perform a firmware upgrade to restore it.

- Problem: Player does not respond to key presses.
- If your player stops responding to key presses, you can reset it by pressing the

RESET button on the back of the player with a non-metal pointed object (e.g. toothpick). Most of your settings will be preserved; only the settings that you have changed after your last power off will be lost.

 This player may temporarily cease to function if subjected to electrostatic disturbance.

- All picture files need to be put in the "Media" folder (if Windows Media Player 10 is installed) or "Internal Storage" folder (if Windows Media Player 11 is installed) of the player when in Windows® XP or Windows Vista<sup>™</sup> and connected in MTP mode or put in the root directory of the player when in Windows® 2000 and connected in MSC mode.

## Additional information

- Problem: Why the player cannot play the video files from the computer?
- All video contents must be converted by the video converter which comes with the player (please refer to the CD). Other format of video file will not be supported.

- You have filled the capacity of the internal memory of the player.
- You have exceeded the maximum number of items that this player supports. Your player can only support up to 2720 media files within eight hierarchy of folder in maximum.
- Problem: Cannot playback tracks on the player.
- Make sure audio tracks are encoded in the mp3 or Windows Media formats at supported bitrates.
   Bitrates support by the player: mp3 - 32 to 320 kbps wma - 48 to 192 kbps
- WMA files may be DRM protected and you don't have the proper rights (license) to play the files.
- Check the website and/or application help system of the music download service provider from where the content was purchased from for license acquisition details. For more information on how license acquisition works, go to www.microsoft.com/windowsmedia/drm.
- Problem: Why can't my portable player playback songs downloaded from my paid Music Server Provider subscription service?
