## **Section 1: Getting Started**

## **Understanding this User Manual**

The sections of this manual are laid out to assist you with your setup and follow the UI features of your Galaxy Gear $^{\mathsf{TM}}$ .

A robust index for features begins on page 79.

Also included is important safety information, beginning on page 54, that you should know before using your device.

This manual gives navigation instructions according to the default display settings.

Unless otherwise specified, all instructions in this manual assume you are starting from the Home (Clock) screen.

For a list of compatible smartphones, please visit: www.samsung.com/us/qalaxyqearsupport.

Note: Instructions in this manual are based on default settings, and may vary from your device, depending on the software version on your device, and any changes to the device's Settings.

Unless stated otherwise, instructions in this User Manual start with the device at the Home screen.

All screen images in this manual are simulated. Actual displays may vary, depending on the software version of your device and any changes to the device's firmware.

#### **Special Text**

Throughout this manual, you'll find text that is set apart from the rest. These are intended to point out important information, share quick methods for activating features, to define terms, and more. The definitions for these methods are as follows:

- Caution: Provides information for the user to take care and avoid danger or risk.
- Important: Points out important information about the current feature that could affect performance.
- Notes: Presents alternative options for the current feature, menu, or sub-menu.
- Tips: Provides quick or innovative methods, or useful shortcuts.

#### **Text Conventions**

This manual provides condensed information about how to use your phone. To make this possible, the following text conventions are used to represent often-used steps:

→ Arrows are used to represent the sequence of selecting successive options in longer, or repetitive, procedures.

Note: From the Home (Clock) screen, slide left or right to select (Apps) → Dialer.

## **Setting Up Your Device**

These steps take you through an out-of-the-box setup process. These procedures are intended to help you get your device setup, activated, and assist you with your initial connection.

#### **Charging the Battery**

Your device is powered by an internal rechargeable Li-ion battery. Use only approved chargers with this device. Ask your local Samsung dealer for further details.

**Important!** It is recommended you fully charge the battery before using your device for the first time.

Note: If the battery is completely discharged, the device cannot be turned on. Allow a depleted battery to charge for a few minutes before turning on the device.

- Before turning on your Galaxy Gear for the first time, charge it fully.
- 2. In a single motion, slide and hold the switch (1) to open the Charging cradle's protective cover. (2)





- **3.** Carefully place the device onto the cradle (3), making sure to align the connector plates to the charging pins.
- 4. Firmly close the cover (4).



**5.** Insert the power plug into a compatible electrical outlet.



**6.** Insert the USB connector into the Charging cradle's charger jack.



Caution! Connecting the charger improperly may cause serious damage to the device. Any damage caused by misuse is not covered by the warranty.

Plug the charging head into a standard AC power outlet. The device turns on and indicates its charge state.

**Note:** While charging, you cannot use calling features, voice recorder, and camera.

8. When charging is finished, first unplug the charger's power plug from the AC wall outlet, then disconnect the charger's connector from the device.

## **Turning Your Device On and Off** *Turning Your Device On*

Press and hold (Power/Home) to turn the device on



#### **Turning Your Device Off**

- With the device on, press and hold (Power/Home) until the Device options screen appears.
- 2. Tap Power off (  $\bigcirc$  )  $\rightarrow$  0K.

#### **Restarting Your Device**

- With the device on, press and hold (Power/Home) until the Device options screen appears.
- 2. Tap Restart ( $\gg$ )  $\rightarrow$  0K.

## **Checking the battery charge status**

With the device turned off, the current charge state is displayed on-screen. The following icons will show the current battery charge status when the Galaxy Gear is off:



Displays your current battery charge level. lcon shown is fully charged.



Shows your current battery level and percentage. Icon shows the device only has a few minutes of power remaining and will soon shutdown.


The Galaxy Gear communicates to a compatible smartphone via an active Bluetooth connection.

Important! Before the pairing process can be initiated, the smartphone should have a current version of the Gear Manager application loaded.

Once paired, its the Gear Manager application that provides a direct connection and access to setup/configuration menus for the Galaxy Gear.

## **Installing Gear Manager**

- 1. Remove the Charging cradle from the packaging.
- Turn on your smartphone and enable NFC communication.



Note: Ensure that a Wi-Fi or mobile network is active on your smartphone before installing the Gear Manager application.

- **3.** Tap the back of your Charging cradle (1) to the back of your compatible smartphone (2) (as indicated below).
- **4.** Read the on-screen Installation information on the smartphone, then tap **0K** → **Install**.
- 5. If prompted, Accept Google's app verification.
- 6. Confirm the Gear manager application is now open.

## Manually Installing Gear Manager

If you do not have your cradle or are having issues automatically downloading the application, it might be necessary to manually doawnload the application via Samsung Apps.

- From within your smartphone's Applications page, tap
   (Samsung Apps).
- Enter the term "Gear Manager" into the application's search field.
- Follow the on-screen prompts to manually install the Gear Manager application.

## **Launching Gear Manager**

The appearance of on-screen items within Galaxy Gear are controlled via the Gear Manager application.

 From within your smartphone's Applications page, tap (Gear Manager).

## **Pairing the Devices Automatically**

The Galaxy Gear and smartphone are paired using Bluetooth<sup>®</sup> technology.

Important! The Galaxy Gear must be paired from within the Gear Manger application. If it is paired from within your smartphone's Bluetooth menu, the Galaxy Gear will not correctly appear in the application listing.

- Press and hold (Power/Home) to turn the Galaxy Gear on.
- 2. Tap (Play) on the Gear's screen to play the connection tutorial.
- Turn on your smartphone and enable NFC communication. If not already active, you may be prompted to activate Bluetooth.

Turn your Charging cradle around and tap it to the back of the smartphone (as previously shown).

Note: The Charging cradle contains the Bluetooth connection information for the Galaxy Gear embedded within its NFC tag.

- Tap (Accept) on the Galaxy Gear screen, confirm the PIN codes match, and tap **0K** on your smartphone to confirm the pairing request.
- Read the on-screen legal and disclaimer information and accept the terms and conditions to complete the process.
- 7. Read the on-screen Galaxy Gear tips and tap Close.
- 8. Verify the Samsung Galaxy Gear entry now shows "Connected" within the Gear Manager application and the icon appears at the top of your smartphone's screen.

**Note:** If the connection process fails, restart both devices and repeat the steps above.

Important! If re-pairing a previously connected device, select
Restore to update all settings and parameters from
your smartphone.

DO NOT interrupt the restore process.

## **Pairing the Devices Manually**

If there is an issue when trying to pair the devices automatically via the use of the NFC tapping (between the smartphone and the Charging cradle), then manual pairing must be done.

**Note:** Use this process if the previous NFC automatic connection method fails.

#### To pair the devices manually:

1. Activate Bluetooth on the smartphone.

Note: Verify Bluetooth visibility is active.

2. From within your smartphone's Applications page, tap the previously installed (Gear Manager).

- If the Gear Manager has not yet been used to pair a Gear, tap Connect manually → OK.
  - or –

Tap the paired device from within the Paired Gear area of the screen and select Connect new Gear → OK → Connect manually.

Tap the listed on-screen GALAXY Gear device.



 Tap (Accept) on the Galaxy Gear screen, confirm the PIN codes match, and then tap OK on your smartphone to confirm the pairing request. Important! If prompted to restore a connection, select Restore to update all settings and parameters from your smartphone.

DO NOT interrupt the restore process.

- Read the on-screen legal and disclaimer information and accept the terms and conditions to complete the process.
- 7. Read the on-screen Galaxy Gear tips and tap Close.
- 8. Verify the Samsung Galaxy Gear entry now shows "Connected" within the Gear Manager application and the icon appears at the top of your smartphone's screen.

**Note:** If the connection process fails, restart both devices and repeat the steps above.


## **Disconnecting the Devices**

- From within your smartphone's Applications page, tap (Gear Manager).
- Tap the paired Galaxy Gear device from within the application's Paired Gear area of the screen.
- Select Disconnect → OK.

**Note:** The icon disappears from the top of your smartphone's screen.

## **Wearing the Device**

- 1. Thread the wristband through the Frame (1).
- 2. Slide your hand through the strap opening.




**Caution!** Humidity and liquids may damage your device. Keep your device dry.

3. Place the Metal Pin into the desired hole on the wristband (2).

**Note:** Use care when opening and closing the clasp.


4. In a single motion, push the metal joint downwards (towards the back of the Galaxy Gear), and then push the buckle down towards until you hear a click.



**Caution!** Do not bend the strap excessively. Doing so may damage the device.

## **Removing the Device**

- 1. Firmly grasp both sides of the buckle.
- Carefully pull the Buckle upwards and away from the wristband. This causes the metal joint to move upwards (away from the back of the Galaxy Gear).



3. Slide the wristband out from the Frame.

## **Section 2: Understanding Your Device**

This section outlines key features of your device. It also describes the device's keys, screen and the icons that display when the device is in use.

#### **Features of Your Device**

Your device is lightweight, easy-to-use and offers many significant features. The following list outlines a few of the features included in your device.

- Touch screen with virtual (on-screen) keypad
- Brilliant 1.63-inch sAMOLED (320x320)
- 800MHz Processor
- Android 4.2.2, Jelly Bean Platform
- Bluetooth<sup>®</sup> 4.0 enabled
- Capable of loading compatible third-party applications
- Display and reply to incoming calls and messages.
- 1.9 Megapixel Camera and Camcorder with autofocus
- Video recording: HD(720p) Recording
- . Music Player control of target device

#### **Front and Back Views**

The following illustrations show the main elements of your device. The following list correlates to the illustrations.

For more information, refer to "Navigation and Gestures" on page 21.

 Control panel shows information about the connection status, battery level, Volume and Brightness levels.



- Display shows all the information needed to operate your device, such as the number of wirelessly connected devices, number of received messages (along with date, time and phone number), and data usage.
- 3. Wristband threads through the frame to secure the device to your wrist.



- Buckle secures the wristband.
- Cradle Connector Plates (back of device) when connected to the connector pins on the cradle, provides charging to the device.
- Speaker allows you to hear callers during a live call and hear media that is being playback or through the device.

#### **Side View**

The following illustration shows the side elements:



Note: Do not use a screen protector. This causes sensor malfunctions

Camera lens is used to take photos and shoot videos.

- 2. Microphones (along sides) are used during phone calls and allow other callers to hear you clearly when you are speaking to them. There are two microphones on the device:
  - Bottom microphone: used during handset mode.
  - Top microphone: used while an active call is in the speakerphone mode and assists in noise cancellation (2 microphone solution).
- Power/Home key ends switches the device off and on
  - · Press and hold to turn the device on or off.
  - Press and hold for more than 7 seconds to reset the device if it develops any fatal errors, hang-ups, or freezes.
  - · Press once to return to the Home (Clock) screen.
  - Press to unlock the device. The device goes into lock mode when the touch screen turns off.
- Frame is used to thread the wristband through for securing the Galaxy Gear.
- 5. Metal Pin is placed on the wristband
- **6. Joint** is folded together to either secure the buckle to strap or aid in the removal of the Galaxy Gear.

## **Charging Cradle Views**

The Charging cradle provides both power and connectivity for a connected and mounted Galaxy Gear.

Note: The Charging Cradle contains an embedded TecTile that is used in conjunction with your smartphone's NFC technology to both acquire the Gear Manager application and aid in automatically pairing the two devices.



 Charging Port (back of unit) allows you to connect a compatible power cable.

Caution! Please use only an approved charging accessory to charge your device. Improper handling of the charging port, as well as the use of an incompatible charger, may cause damage to your device and void the warranty.

- 2. Security Latch used to release the security cover.
- **3. Charging Pins** provide power to the device once secured onto the cradle.
- Cover used to hold the Galaxy Gear securely within the Charging cradle.

#### **On-Screen Indicators**

Reveal the Control Panel (Bluetooth connection status, Battery level, Volume and Brightness levels) by quickly tapping simultaneously twice on the screen using two fingers.



The following icons will show within the Notifications Bar when the Galaxy Gear is turned on:



Displays your current battery charge level. lcon shown is fully charged.



Displays your battery is currently charging.



Displays when Bluetooth technology is active and enabled but the Galaxy Gear is not communicating with the paired smartphone.



Displays when the Bluetooth technology is active, paired, and communicating with an external device.

Once the device is connected, confirm the corresponding icon appears on the smartphone's display.



Displays when the Galaxy Gear connection is active and communicating with your smartphone. Both devices are successfully communicating via the Gear Manager.

## **Navigation and Gestures**

Using the touch screen display you can navigate the features of your device, select menu items, and enter characters.

The following conventions are used in this manual to describe the navigation action in the procedures.

#### **Waking the Device**

 Shake the Galaxy Gear on your wrist or press (Power/Home).



The following terms describe the most common hardware and on-screen actions



 Swipe or slide: Quickly drag your finger left or right across the screen to view your favorite applications. Scroll up or down to navigate within an available on-screen list.

For example: slide your finger left or right on the Home (Clock) screen to scroll among the currently loaded favorite applications or slide through an available on-screen list.

**Note:** From an open application screen, swipe down to exit the current application and return to the Home screen.

- Tap: use a brief touch to select items on the display or to enter text on the virtual keypad. For example: tap an Application icon to open the application.
- Double-Tap: in a single motion, tap the screen simultaneously with two fingers to:
  - Access the Brightness and Volume controls.
  - · View Battery and Bluetooth connection status.

- Pinch: "Pinch" the screen using your thumb and forefinger to zoom out when viewing a picture. (Move fingers inward to zoom out.)
- Spread: "Spread" the screen using your thumb and forefinger to zoom in when viewing a picture. (Move fingers outward to zoom in.)



## **Configuring your Device**

For more information, refer to "Settings" on page 48.

#### **Adjusting the Brightness**

- Double-tap the screen simultaneously once with two fingers, and then tap or to adjust Brightness.
  - or –
- 1. From the Home (Clock) screen, scroll to and then tap

  (Apps) → Settings → Display → Brightness.
- 2. Tap or to adjust the brightness, then tap **OK**.

#### **Adjusting the Volume**

- Double-tap the screen simultaneously once with two fingers, and then tap or to adjust the Volume
  - or -
- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Settings → Volume → System.
- 2. Tap or to adjust the volume, then tap **0K**.

## Switching to silent mode

- With the device on, press and hold (Power/Home) until the Device options screen appears.
- Tap the bottom-right button to toggle your selection among either (Sound), (Vibrate), or (Mute).
  - or -
- From the Home (Clock) screen, scroll to and then tap

  (Apps) → Settings → Sound → Sound mode and then select either Sound. Vibrate or Mute.

Caution! Do not hold the device's speaker close to your ear.

Excessive exposure to loud sounds can cause hearing damage.

## **Section 3: Understanding the Gear Manager**

The Gear Manager application manages the connection between your Galaxy Gear and a connected smartphone.

In works to synchronize and manage the favorite applications located on the Galaxy Gear, adjust settings, configure connections.

The appearance of on-screen items within Galaxy Gear are controlled via the Gear Manager application.

From within your smartphone's Applications page, tap
 (Gear Manager).

Important! Before using your Galaxy Gear, it must first be paired with your target smartphone via the Gear manager application (page 11).

#### **Overview**

The main application is broken out into two sections:

 Paired Gear: displays the currently paired Galaxy Gear devices on the smartphone. This menu allows you to rename and disconnect a current device, and connect to a new Galaxy Gear. Important! If you connect to a different Galaxy Gear, your smartphone's Gear Manager will have to resynchronize your settings and applications with the newly paired device.



Caution! If you try to reconnect a previously paired Galaxy Gear to your smartphone, you may be prompted to Restore your connection - **DO NOT interrupt this process**.

 Apps and Settings: provides access to on-screen configuration of your clock, allows you to modify your current favorite apps, adjust your settings, and also access other features/functions.

## **Launching Gear Manager**

This application allows you to connect to a smartphone, customize your Galaxy Gear settings and applications.

 From within your smartphone's Applications page, tap (Gear Manager).

## **Working with a Paired Gear**

- 2. Select an available on-screen menu option:
  - **Rename**: allows you to change the reference name used by the Gear Manager application for the selected Galaxy Gear.
  - Disconnect/Connect: allows you to disconnect or later reconnect a currently paired Galaxy Gear device.
  - Connect new Gear: allows you to pair a new Galaxy Gear device.
  - **Software update**: allows you to use your current smartphone connection to update the Gear manager software.
  - Model number: displays the current Galaxy Gear model number
  - Software version: displays the current Galaxy Gear software/ firmware version.

#### **Renaming the Connected Gear**

It is important to rename a currently connected Galaxy Gear so that the identity of the device can not be determined and its not left with its default name.

It is also useful to identify individual Galaxy Gear devices if you have multiple units connected/paired to the same smartphone.

- Select Rename, tap the current Device name entry field to select the current name.
- Delete the current entry, use the on-screen keyboard to enter a new unique name, and tap **0K**.
- Confirm the new name has been properly applied.

#### **Disconnecting a Currently Connected Gear**

- 2. Select Disconnect → OK. The Galaxy Gear screen will temporarily indicate "Disconnecting with ...".

## Reconnecting a Previously Connected Gear

If your currently used Galaxy Gear ever becomes temporarily disconnected, it can be reconnected (re-paired) to its current smartphones very easily.

Important! A Galaxy Gear can be temporarily disconnected if: the poser is completely depleted or if it is taken out of Bluetooth range.

- 2. Select Connect. The Galaxy Gear screen will temporarily indicate "Connect".

## **Connecting to a Different Galaxy Gear**

Although a single smartphone can be paired to multiple Galaxy Gear devices, only one device can be controlled via the application on the smartphone at any single time.

If you go from using one Galaxy Gear then begin the paring process with a secondary unit, the Gear Manager application will have to "sync up" the configuration and settings between the smartphone and the newly pairing Galaxy Gear.

This synchronization process requires that the new Galaxy Gear "Restore" its parameters and settings with your Gear Manager.

Caution! If the Gear Manager recognizes a previously paired Galaxy Gear, it will attempt to synchronize the two devices. DO NOT interrupt this restoration process.

- 2. Select Connect new Gear.
- Follow the manual pairing process described on page 12.

**Note:** If the new Galaxy Gear is recognized as a previously paired device, the Gear Manager software will attempt to restore its settings to match.

#### Clocks

This menu provides the ability to customize the Clock screen displayed as the Galaxy Gear's Home screen.

#### **Changing Your Clock Screen**

 From within the Clocks page, tap an available clock from the available list.

#### **Customizing Your Current Clock**

- From within the Clocks page, tap (Settings) next to the currently selected view within the Idle area of the page.
- Configure the available parameters, what you want to show, and available color usage.

## **My Apps**

This menu allows you manage the applications being synchronized between your smartphone and the paired Galaxy Gear.

#### Tab Overview

There are currently three tabs located within the **My apps** screen:

- Favorites: displays both your currently assigned favorite apps (those that appear on the Galaxy Gear as you swipe across the main screens) and provides you the ability to Add, Rearrange, or delete any application from this category.
- Apps: only displays a list of those currently loaded applications that appear on the Galaxy Gear. When available, some apps listed provide access to settings for configuration.
- Featured: provides an updated listing of new and feature applications that can be installed onto the Galaxy Gear directly from the Samsung Apps function on your smartphone.

## **Using the Favorites Tab**

#### **Adding Your Favorite Applications**

Galaxy Gear comes with a set of default favorite applications that appear as you scroll across the screen. This list of displayed applications can be customized via the Gear Manager application on the smartphone.

- From within your smartphone's Applications page, tap (Gear Manager) → (My apps).
- 2. Tap the Favorites tab  $\rightarrow$  [1] (Add).
- **3.** Scroll through the on-screen list and place a check mark alongside those desired applications.
- Tap Done. The My apps screen then displays the currently displayed favorite applications that will now appear on Galaxy Gear as you swipe across the screen.

#### **Reorder Applications**

- From within your smartphone's Applications page, tap (Gear Manager) → (My apps).
- Tap the Favorites tab → (Reorder).
- In a single motion, touch and drag an available on-screen application and place it into a new "slot" within the list.
- 4. Once you have assigned the desired order, tap Done. The My apps screen now displays an updated list of available applications in their new order. Confirm the order on your Galaxy Gear by swiping across the screen.

#### **Removing Favorite Applications**

- From within your smartphone's Applications page, tap (Gear Manager) → (My apps).
- Tap the Favorites tab → (Removing).
- Place a check mark alongside those applications you wish to remove.
- **4.** Tap **Done**. The **My apps** screen then displays an updated list of available applications.

## Adjusting the Settings of Installed Apps

- 1. From within your smartphone's Applications page, tap (Gear Manager) → (My apps).
- 2. Tap the Apps tab.
- Locate an application that has its settings icon displayed.
- **4.** Tap (Settings) and adjust the available parameter.

Important! If you wish your images and videos to be automatically updated to your connected smartphone, access the Gear Manager and alter the Camera settings → Auto transfer setting to Always.

## **Installing Featured Applications**

- 2. Tap the Featured tab.
- Tap Install and follow the on-screen instructions to complete the installation of the selected application from within the Samsung Apps feature on the paired smartphone.

## **Samsung Apps**

Allows you to easily download an abundance of applications that are directly compatible with your device. This includes games, news, reference, social networking, navigation, and more. Samsung Apps makes your smartphone smarter.

**Note:** Access to this feature requires that you already be logged in to your Samsung account application on the paired smartphone.

- If prompted, read the on-screen disclaimer and tap Accept.
- Tap an available category listing such as: Entertainment, Health/Fitness, Lifestyle, Social Networking, Utilities, Clock, etc..

Note: New applications are being added, so be sure to check back frequently.

 Select an available application and follow the on-screen installation instructions.

## **Finding Your Galaxy Gear**

If you should ever misplace your Galaxy Gear, use the Find my Gear function to locate the device.

- Tap Start and begin to listen for the alarm tone sounding on your Galaxy Gear.
- Once you have found your Galaxy Gear, swipe in any direction atop ...... to end the process.

## **Using Notifications**

When activated, this feature allows you to select which Notification events are displayed on the Galaxy Gear.

Note: Enable more options if you wish to see additional types of on-screen notifications such as: Emails, Messages, Gmail<sup>TM</sup>, Hangouts<sup>TM</sup>, etc..

#### To activate the notification features:

Stay up-to-date with a variety of events, such as missed calls or new chats, from the connected smartphone.

From within your smartphone's Applications page,
 tap (Gear Manager) and in a single motion touch
 and slide the Notification slider to the right to turn it on

#### To change the notification settings:

- Tap the Notifications field.
- Place a check mark alongside those notification events you would like to be displayed on the smartphone.
- Enable more options if you wish to see additional types of on-screen notifications such as: Emails, Messages, Gmail, Hangouts, etc..

This is helpful if you wish to see your incoming email notifications and new text messages.

## **Gear Manager Settings**

The setting parameters listed on this menu page are not the complete set available for configuration from within the Galaxy Gear. These settings focus on how the Galaxy Gear interacts with your target smartphone.

- 2. Configure an available on-screen setting.
  - Auto lock: when activated, allow you it use your Galaxy Gear to unlock your paired smartphone.
  - Double pressing power key: allows you to select the application that will launch when you double-press the Power key.
  - Smart relay: when activated, allows you to go from seeing content on your Galaxy Gear to then viewing it on your paired smartphone once you pick it up.
  - Wake-up gesture: when activated, this feature allows you to wake up the Galaxy Gear by simply raising the arm your Gear is on.
  - Open source licence: displays the current licensing information.

- Unkown sources: allows you to install apps to be installed within the Gear Manager if they were obtained from sources other than Samsung Apps.
- Version: displays the current Gear manager application version.

#### To activate the Smart Relay feature:

Use this feature to view new messages, events, and other information when you receive notifications. When you receive a notification, pick up the connected mobile device with the hand wearing the Galaxy Gear. Then, unlock the mobile device to view the details.

**Note:** Before using this feature, make sure the motion feature of the mobile device is activated.

# To activate the Wake-up gesture feature:

Use this feature to wake up (reactivate) the Galaxy Gear by simply raising your arm when the Gear is on.

Note: Before using this feature, make sure the motion feature of the mobile device is activated

# Help

Displays on-screen help topics related to the Galaxy Gear.

# **Section 4: Calling Features**

This section describes features and functionality associated with making or answering calls, and the Contacts list, which is used to store contact information.

# Making a Call

- From the Home (Clock) screen on your Galaxy Gear, scroll to and then tap (Apps) → Dialer.
- 2. Enter the phone number and then tap




# **Ending a Call**

 From within an active call, briefly tap (End call) to end the call.

Note: To redial a recent number, return to the Home (Clock) screen and then select Logs, tap the entry and tap (Call).

# **Answering a Call**

When somebody calls you, the phone rings and displays the incoming call image. The caller's phone number, picture, or name if stored in Contacts List, displays.

# **Making a Call Using Logs**

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Logs.
- 2. Tap an entry and select (Call)

Swipe a call log entry to the right to call.

**Note:** Swiping a call log entry to the left initiates a new outgoing message.

# **Sending a Call to the Device**


■ From within an active call, tap (Menu) → (Send to Phone).

# **Sending a Call to the Galaxy Gear**

 From within an active call screen on the smartphone, tap (Bluetooth Headset Off) to turn the connection back on and send the call to the Galaxy Gear.

# **In Call Options**

Your device provides a number of features that are available for use during an active call.




Caution! Do not hold the device's speaker close to your ear.

# More In-call Options

During a call you can save the current caller's information to the Contacts list, or create a Memo.

- From within an active call, tap (Menu) and then select an available in-call option:
  - Mutes: during a call you can mute/unmute the current call.
  - Send to Phone used to send the current call back to the paired smartphone.
  - Dialer: launches the on-screen phone Dialer.
  - Bluetooth: activates/deactivates the Bluetooth connection.

# Logs Tab

The Logs tab is a list of the phone numbers (or Contacts entries) for calls you placed, accepted, or missed. The Logs tab makes redialing a number fast and easy. It is continually updated as your device automatically adds new numbers to the beginning of the list and removes the oldest entries from the bottom of the list.

The Notification area of the Home screen (upper left) displays phone notifications, status, or alerts such as:



Displays when a call was missed.

# Accessing the Logs Tab

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → (Logs).
- 2. Tap an entry to view available options.

Note: The Logs tab only records calls that occur while the phone is turned on. If a call is received while it is turned off, it will not be included in your calling history.

Each entry contains the phone number (if it is available) and Contacts entry name (if the number is in your Contacts).



Indicates all outgoing calls made from your device.



Indicates any received calls that were answered.



Indicates a missed call.



Indicates any received calls that were rejected.

Note: You can also view missed calls from within the Notifications area. Select And tap the Missed call entry to open the Logs screen.

# **Section 5: Applications**

This section contains a description of each application that is available on the Galaxy Gear, its function, and how to navigate through that particular application. If the application is already described in another section of this user manual, then a cross reference to that particular section is provided.

**Note:** Favorite applications found on the Galaxy Gear are managed by the Gear manager application. For more information, refer to "My Apps" on page 28.

# **Accessing Applications**

- 1. Turn on Galaxy Gear and swipe across the screen to view the currently loaded feature applications.
- 2. Swipe across the screens and tap (Apps).



#### Camera

Use this application to take photos or videos. Use Image viewer to view photos and videos taken with the device's camera.

Note: The camera automatically shuts off when unused. Make sure that the lens is clean. Otherwise, the Galaxy Gear may not work properly in some modes that require high resolutions.

Important! If you wish your images and videos to be automatically updated to your connected smartphone, access the Gear Manager and alter Camera settings → Auto transfer setting to Always.

1. From the Home (Clock) screen, scroll to and then tap  $\rightarrow$  (Apps)  $\rightarrow$  Camera.

— or —

From the Home (Clock) screen, slide the screen down to reveal the camera application screen.

- 2. Select an on-screen function:
  - (Camera) indicates the camera mode is active.
  - **(Camcorder)** indicates the camcorder mode is active.
  - **(Menu**) provides access to the Camera settings menu.
  - Swipe left to access the **Image viewer** where you can view any new photos and videos taken with the device's camera.

# **Taking Photos**

- 1. Verify the camera mode is active (indicated by

- **2.** Tap the screen to take a photo. The images are also saved in the connected mobile device.
- Swipe left to open the Image viewer and review your images.

# **Shooting Videos**

- 1. Tap to change the mode. Verify the camcorder mode is active (indicated by ...).
- Tap the screen to begin shooting your video. The videos are also saved in the connected mobile device.
- Swipe left to open the Image viewer and review your images.

# **Zooming**

- Pinch: "Pinch" the screen using your thumb and forefinger to zoom out when viewing a picture. (Move fingers inward to zoom out.)
- Spread: "Spread" the screen using your thumb and forefinger to zoom in when viewing a picture. (Move fingers outward to zoom in.)

**Note:** Double tap on an image, from within the Image viewer, to zoom in or out.

# **Camera/Camcorder Settings**

## To configure settings for Camera:

- 1. Verify the camera mode is active (indicated by ).
- 2. Tap (Menu) to configure settings for the Camera.

  - Photo size: Select an available resolution. Using a higher resolution will generate a higher quality image, but will take up more memory.
  - Sound & shot: enables 9 seconds of background audio to be recorded along with your image.
  - **Signature**: adds signature logo to your image.

# To configure settings for Camcorder:

- 1. Verify the camera mode is active (indicated by
  - Tap (Menu) to configure settings for the Camcorder.
  - Video size: Select an available resolution. Using a higher resolution will generate a higher quality video, but will take up more memory.

# **Contacts**

This menu displays the list of currently available Contacts entries on your paired smartphone.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Contacts.
- 2. Tap an available entry to view its details.
  - or –

Swipe to access a quick function:

- Swipe to the right to make a call using the default number.
- Swipe to the left to use S Voice to begin a new text message.

Important! Before creating your first outbound message using the Galaxy Gear, you must first accept the terms of use for the S Voice application on your target smartphone.

For detailed instructions on related calling features and functions, see "Calling Features" on page 34.

# **Gallery**

Use this application to view images and videos.

- 1. From the Home (Clock) screen, scroll to and then tap (Apps) → Gallery.
- Scroll across the screen to view thumbnail versions of currently stored pictures and videos.
- Tap an on-screen entry to view a larger version of the current file or begin playback.

# Logs

The Logs tab is a list of the phone numbers (or Contacts entries) for calls you placed, accepted, or missed.

# Accessing the Logs Tab

- 1. From the Home (Clock) screen, scroll to and then tap  $\rightarrow$  Logs.
- 2. Tap an entry to view the details and select





#### **Media Controller**

This application leverages the media playback capabilities of your smartphones Music player application. The Galaxy Gear can only be used to control the playback of the smartphone's application.

Note: Some file formats are not supported depending on the device's software version.
Some files may not play properly depending on the encoding method used.

- Before beginning to use this application, populate the paired smartphone's Music folder with compatible audio files (ex: MP3).
- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Media Controller.
- Make an on-screen selection. The file is then played back on your paired smartphone.



#### **Pedometer**

Use this as a wellness application that allows you to better manage your health by managing your step counts.

# To set tup an initial profile:

- 1. From the Home (Clock) screen, scroll to and then tap

  (Apps) → Pedometer.
- Read the on-screen disclaimer and tap Agree to continue.
- 3. Tap Next.
- 4. Update the on-screen values as needed and tap Next.
- **5.** Read the step count information and tap **Start** to begin.

#### To create a new User Profile:

- 1. From the main Pedometer app screen, tap (Menu) to configure the application.
- Select User profile and begin to update the values as needed.
  - Gender: choose from either Male or Female.
  - Height: make adjustments using the on-screen dial. Tap ft,in to then change the measurement units to either cm or ft,in.
     Tap 0K to save the new setting.
  - Weight: make adjustments using the on-screen dial. Tap Ib to then change the measurement units to either kg or Ib.
     Tap OK to save the new setting.
  - Units (dist.): choose from either km or Miles.
- 3. Swipe down from the top of the Galaxy Gear screen to return to the previous screen.

#### To configure the Pedometer application:

- 1. From the Step count screen, tap (Menu) to configure the application.
- Tap the Goal field to assign a step count, tap to adjust the value. Tap OK to save the new setting.
- 3. Tap Reset steps to reset your current step count.
- Tap User profile to configure the application with your personalized information.
- Tap Feedback to allow form end-user feedback of the application.
- **6.** Tap **Reset** to reset not only the pedometer count but also the main application.
- 7. Tap Help to view on-screen help information.

# **Before You Start Exercising**

This app can be used to monitor your exercise. While moderate physical activity, such as brisk walking, is safe for most people, health experts suggest that you talk with your doctor before you start an exercise program, particularly if you have any of the following conditions:

- · Heart disease:
- Asthma or lung disease;
- · Diabetes, or liver or kidney disease;
- Arthritis.

You should also check with your doctor if you have symptoms suggestive of heart, lung, or other serious disease, such as:

- Pain or discomfort in your chest, neck, jaw, or arms during physical activity;
- · Dizziness or loss of consciousness;
- Shortness of breath with mild exertion or at rest, or when lying down or going to bed;
- Ankle swelling, especially at night;
- A heart murmur or a rapid or pronounced heartbeat;
- Muscle pain when walking upstairs or up a hill that goes away when you rest.

Finally, the American College of Sports Medicine recommends that you see your doctor before engaging in vigorous exercise if two or more of the following apply:

- You are a man older than age 45 or a woman older than age 55;
- You have a family history of heart disease before age 55;
- You smoke or quit smoking in the past six months;
- You have not exercised for three months or more;
- You are overweight or obese;
- You have high blood pressure or high cholesterol.
- You have impaired glucose tolerance, also called pre-diabetes.

#### When in Doubt - Check it Out

If you are unsure of your health status, have several health problems, or are pregnant, you should speak with your doctor before starting a new exercise program. Working with your doctor ahead of time is a good way to plan an exercise program that is right and safe for you. Consider it the first step on your path to physical fitness.

# **S Voice**

Use this application to command the connected smartphone remotely by voice to do such actions as: dial a number, send a message, write a memo, and more.

Using S Voice on the Galaxy Gear leverages the functionality of the same application on the paired smartphone to do the work for you. When you say a command to the microphone on this device, S Voice on the connected smartphone launches.

Important! Before launching S Voice for the first time, you will need to launch S Voice on the paired smartphone and agree its terms of use.

#### To launch S Voice:

With the device on, press (Power/Home) twice to launch the default S Voice application.

- or -

From the Home (Clock) screen, scroll to and then tap (Apps)  $\rightarrow$  S Voice.

#### Tips for better voice recognition:

- Speak clearly.
- · Speak in quiet places.
- Do not use offensive or slang words.
- · Avoid speaking in dialectal accents.

# **Settings**

Use this application to configure the Galaxy Gear and set application options.

■ From the Home (Clock) screen, scroll to and then tap (Apps) → Settings.

For more information, refer to "Settings" on page 48.

# **Stopwatch**

This feature allows you to capture elapsed time while letting the stopwatch keep running.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Stopwatch.
- 2. Tap Start to start the stopwatch counter.
- 3. Tap Lap to begin the lap time counter.
- Tap Stop to stop the counter.
- Tap Restart to restart the lap counter. You can have multiple lap times.
- 6. Tap Reset to reset the counter.

#### **Timer**

Use this application to use the device as a countdown timer.

- 1. From the Home (Clock) screen, scroll to and then tap  $(Apps) \rightarrow Timer$ .
- 2. Move the on-screen dial left or right to adjust the value.
- 3. Tap Start to start the timer.
- Tap Stop to stop the timer or Reset to reset the timer and start over.
- **5.** Tap **Restart** to resume the timer counter.

# **Today's Schedule**

This application is tied into the Calendar feature on your paired smartphone. It will display today's current Calendar events.

From the Home (Clock) screen, scroll to and then tap

(Apps) → Today's Schedule.

# **Voice Memo**

Use this application allows you to record an audio file of up to 5 minutes.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Voice Memo.
- 2. Tap (Record) to begin recording your memo.
- Tap (Stop) to stop recording. The file automatically saves to the Voice list.
- Tap (Pause) to pause the recording of an audio file.
- Tap X (Cancel) to cancel the recording of an audio file.
- **6.** Tap (Menu) to display a list of current recordings.
- 7. Tap an entry from the list to begin playback.

#### Weather

Use this application to view weather information for the region that is set by the paired smartphone.

From the Home (Clock) screen, scroll to and then tap (Apps) → Weather.

# **Section 6: Settings**

This section explains the settings for your device. It includes such settings as: clock, sound, volume, display, and any extra settings associated with your device.

# **Turning on Outdoor Mode**

This mode brightens the content on the display screen for better viewing in outdoor conditions.

#### To turn on Outdoor mode:

- With the device on, press and hold (Power/Home) until the Device options screen appears.
- Tap Outdoor mode.

#### To turn off Outdoor mode:

- With the device on, press and hold (Power/Home) until the Device options screen appears.
- 2. Tap Outdoor mode again to toggle the feature off.

# **Accessing the Settings Menu**

From the Home (Clock) screen, scroll to and then tap

(Apps) → Settings.

# Clock

This menu allows you to change the current time and date displayed.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Settings → Clock.
- 2. Tap an available on-screen option:
  - Clock type: scroll across the available clock types and make a selection by tapping an on-screen entry.
  - Date and time: allows you to adjust the date and time.
    - Auto sync: obtains the date and time information from the paired smartphone. This feature must be disabled if you wish to manually set the date and time.
    - Set date: allows you to adjust the date values as needed. Use the on-screen dial to adjust each value. Tap Set to assign the value.

- Set time: allows you to adjust the time values as needed. Use the on-screen dial to adjust each value. Tap Set to assign the value.
- Hourly alert: either activates/deactivates the hourly alert function.

# **Sound Settings**

From this menu you can control the sounds on the device as well as configure the settings.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Settings → Sound.
- 2. Tap an available on-screen option:
  - Sound mode: tap an on-screen entry to assign the sound mode. Choose from: Sound, Vibrate, and Mute.
  - Touch sounds: enables or disables sounds that play when the device screen is tapped.
  - Ringtones: tap an on-screen entry to assign a new ringtone sound. Select a ringtone (Ringtone 1-3) and then tap OK.
  - Notifications: tap an on-screen entry to assign a new notification sound. Select a notification sound (Notification1-3) and then tap OK.

- Vibration: tap an on-screen entry to assign a new vibration type. Select a vibration type (Strong, Medium, or Weak) and then tap OK.
- Preferred arm: tap an on-screen entry to assign a preferred display profile. Choose from: Left arm or Right arm.

# **Volume**

The Volume menu now provides access to various volume settings within one menu.

From the Home (Clock) screen, scroll to and then tap
 (Apps) → Settings → Volume.

**Note:** Some of these volume levels will be greyed out if the device is set to Silent mode. For more information, refer to "Switching to silent mode" on page 23.

- Select an available menu option to assign the volume settings for any of the following volume levels:
  - Multimedia: adjusts the volume levels for the device's multimedia functions, such as Media Controller.
    - Tap 🔒 or 🗀 to adjust the level and tap **OK**.

- Ringtones: adjusts the volume levels for the device's ringtone functions
  - Tap 🛑 or 📒 to adjust the level and tap **OK**.
- Notifications: adjusts the volume levels for the device's notification functions.
  - Tap ☐ or ☐ to adjust the level and tap **OK**.
- **System**: adjusts the volume levels for the device's overall system volume level.
  - Tap or to adjust the level and tap **OK**.

# Display

From this menu you can control and configure the display settings.

- From the Home (Clock) screen, scroll to and then tap
   (Apps) → Settings → Display.
- 2. Configure the following screen display settings:
  - **Brightness**: allows you to configure the LCD Brightness levels.
    - Tap or to adjust the level and tap **OK**.
  - Screen timeout: allows you to adjust the delay time before the screen automatically turns off. Make an available selection.

- Home bg color: allows you to assign the Home screen background color. Swipe across the screen until the desired color is visible and then tap the screen.

#### Bluetooth

#### **About Bluetooth**

Bluetooth is a short-range communications technology that allows you to connect wirelessly to a number of Bluetooth devices, such as headsets and hands-free car kits, and Bluetooth-enabled handhelds, computers, printers, and wireless devices. The Bluetooth communication range is usually up to approximately 30 feet.

# **Turning Bluetooth On and Off**

If the mobile device does get wet, do not accelerate drying with the use of an oven, microwave, or dryer, because this may damage the mobile device and could cause a fire or explosion. Do not use the mobile device with a wet hand. Doing so may cause an electric shock to you or damage to the mobile device. Do not wear the device when the straps are wet. #### Extreme heat or cold

# **Responsible Listening**

# **Operating Environment**

Remember to follow any special regulations in force in any area, and always switch your mobile device off whenever it is forbidden to use it, or when it may cause interference or danger. When connecting the mobile device or any accessory to another device, read its user's guide for detailed safety instructions. Do not connect incompatible products.

# Using Your Mobile Device Near Other Electronic Devices

Most modern electronic equipment is shielded from Radio Frequency (RF) signals. However, certain electronic equipment may not be shielded against the RF signals from your wireless mobile device. Consult the manufacturer to discuss alternatives.

#### **Implantable Medical Devices**

A minimum separation of six (6) inches should be maintained between a handheld wireless mobile device and an implantable medical device, such as a pacemaker or implantable cardioverter defibrillator, to avoid potential interference with the device.

Persons who have such devices:

- Should ALWAYS keep the mobile device more than six (6) inches from their implantable medical device when the mobile device is turned ON:
- Should not carry the mobile device in a breast pocket;
- Should use the ear opposite the implantable medical device to minimize the potential for interference;
- Should turn the mobile device OFF immediately if there is any reason to suspect that interference is taking place;
- Should read and follow the directions from the manufacturer of your implantable medical device. If you have any questions about using your wireless mobile device with an implantable medical device, consult your health care provider.

#### **Other Medical Devices**
