

FireWire 800 PCI-32T Quick Installation Guide

Introducing the FireWire 800 PCI-32T

The *FireWire 800 PCI-32T* is designed to support Pentium or equivalent PC computers. It provides 2 independent hot-pluggable Firewire 800 (1394b) ports and 1 1394a port with data transfer rates up to 800Mbps.

Features and Benefits

- Provides 2 FireWire 800 (1394b) ports and 1 1394a (6-pin) port for multiple 1394b/1394a device connections
- Supports IEEE 1394b and backwards compatible with 1394a-2000 and 1394-1995 standards
- Supports data transfer rates of 100, 200, 400, and 800Mbps
- Built-in 4-pin power connector provides extra power when connected to the system's power supply (Recommended)
- Supports hot-swapping and Plug-n-Play connection of peripheral devices
- Includes one spare low profile bracket for systems with low profile chassis
- Works with various types of FireWire 800 (1394b) and 1394a devices including portable hard disk, DV camcorder, digital camera, CD-RW/DVD-ROM drive and other audio/video devices

System Requirements

- Pentium or equivalent PC with an available 32-bit or 64-bit PCI slot
- Windows 98SE/ME/2000/XP

- (1) FireWire 800 PCI-32T host adapter
- (1) Spare Low Profile bracket (to use with Low Profile chassis)
- (1) Driver software

Hardware Installation

Note: For Low Profile systems, replace the currently mounted bracket with with the included Low Profile bracket.

General instructions for installing the card are provided below, since the design of computer cases and motherboards vary. Refer to your computer's reference manual for further information, if needed.

Static Electricity Discharge may permanently damage your system. Discharge any static electricity build up in your body by touching your computer's case for a few seconds. Avoid any contact with internal parts and handle cards only by their external edges.

- Turn OFF the power to your computer and any other connected peripheral devices. Unplug the computer's power cord.
- Remove your computer's cover and install the card in an available PCI slot.
- Push the board down firmly, but gently, until it is well seated.
- Connect an available 4-pin power connector from the system power supply to the 4-pin power connector on the *FireWire 800 PCI-32T* (See figure 1). This connection is recommended for reliable power output.
- Secure the card and replace the cover.

Software Installation

This section provides information on how to install the *FireWire 800 PCI-32T* drivers. Please follow the directions below for your operating system.

Windows Driver Installation

For Windows 98SE

- 1. At the Add New Hardware Wizard, click Next.
- 2. Select Search for the best driver for your device (Recommended), then click Next.
- 3. Insert the driver CD, check **CD-ROM drive**, uncheck the other boxes, then click **Next**.
- 4. Click Next, then Next again.
- 5. If prompted for the *Windows 98SE* CD, insert it, then click **OK**.
- 6. Click Finish and restart Windows to complete the installation.

For Windows ME

- 1. At the Add New Hardware Wizard, insert the driver CD, select Automatic Search for a better driver, then click Next.
- 2. Click Finish.
- 3. Click **Yes** to restart Windows and complete the installation.

For Windows 2000

Windows 2000 automatically installs it's built-in 1394a driver for the *FireWire 800 PCI-32T*. To get the full potential out of the *FireWire 800 PCI-32T*, install the Firewire 800 driver using the directions below.

- 1. Right click **My Computer**, click **Manage**, then click **Device Manager**.
- 2. Double click **IEEE 1394 Bus host controller**, then double click **Texas Instruments OHCI Compliant IEEE 1394 Host Controller**.
- 3. Click the **Driver** tab, then **Update driver** button.
- 4. At the Upgrade Device Driver Wizard window, click Next.
- 5. Select **Search for a suitable driver for my device**, then click **Next**.

- 6. Insert the driver CD, check CD-ROM drives, then click Next.
- 7. Click Next.
- 8. Click Finish. Restart Windows to complete the installation.

For Windows XP

Windows XP automatically installs it's built-in 1394a driver for the *FireWire 800 PCI-32T*. To get the full potential out of the *FireWire 800 PCI-32T*, install the Firewire 800 driver using the directions below.

- 1. Right click **My Computer**, click **Manage**, then click **Device Manager**.
- 2. Double click **IEEE 1394 Bus host controller**, then double click **Texas Instruments OHCI Compliant IEEE 1394 Host Controller**.
- 3. Click the **Driver** tab, then **Update Driver** button.
- 4. Select Install from a list or specific location, then click Next.
- 5. Select **Don't search. I will choose the driver to install**, then click **Next**.
- 6. Insert the driver CD, click Have disk.
- 7. Type in **D**:, then click **OK**. (Change **D**: to match your CD-ROM drive letter)
- 8. Select OHCI IEEE 1394b Host Controller, then click Next.
- 9. Click **Continue Anyway**. Our driver has been thoroughly tested in Windows for stability. This message appears because Microsoft has not tested this product through WHQL certification.
- 10. Click Finish. Restart Windows to complete the installation.

Verify Proper Installation in Windows

- Check Device Manager to verify successful installation. <u>Windows 98SE/ME</u>: From the main desktop, right click My Computer, then click Properties. Click Device Manager tab. <u>Windows 2000/XP</u>: Right click My Computer, then click Manage. Click Device Manager.
- 2. Double click **1394 Bus Controller** or **IEEE 1394 Bus host controllers**.
 - OHCI IEEE 1394b Host Controller should be displayed.

SIIG will refuse to accept any shipping package, and will not be responsible for a product returned without an RMA number posted on the outside of the shipping carton.

Step 3: Ship the Product
