Important Battery Precautions


- Use only the type of battery specified in this user



Control Unit




- 1. Power Switch

Battery installation (battery not included)

Before using your headphones for the first time or when the power indicator on the control unit becomes dim, insert / replace one (1) alkaline "AAA" size battery (not included) into the battery compartment of the control unit.

- 1. Open the battery cover on the back of the **Control Unit** by sliding it in the direction of the arrow.
- 2. Insert one (1) alkaline "AAA" size battery into the battery compartment.
- 3. Replace the battery cover.




NOTE: It is still possible to listen to music if the battery dies or if there is no battery installed in the **Control Unit**, but the [Power Switch] must be in the OFF position.

Using the headphones

For added comfort and noise suppression, three (3) pairs of silicone cushions are included with your Noise Cancelling **Headphones.** Choose the size that fits most comfortably in your ears, and insert it on the headphones as shown below.





Listening to music

cushions (3 sizes)

Connect your headphones to an audio source and begin playback. You may listen to music with or without turning on the Noise Cancelling function.

- 1. Connect the headphones to an audio source and begin playback.
- 2. Adjust the volume using the [Volume Dial] on the control
- 3. To activate or deactivate the Noise Cancelling feature, slide the [Power Switch] ON or OFF.

NOTE: It is possible to listen to music with the [Power **Switch**] in the **OFF** position.

Noise cancelling without music

If you plan to use your headphones for noise reduction only, simply put on your headphones and turn the [Power **Switch**] to the **ON** position.

NOTE: The [Volume Dial] has no effect on the noise reduction, it's only used to adjust the volume for audio

Troubleshooting

? No sound

• If the battery in the Control Unit is dead, or if there is no battery installed in the Control Unit and the [Power $\textbf{Switch]} \ is \ in \ the \ \textbf{CN} \ position, you \ will \ not \ be \ able \ to$ hear any audio (music) from the headphones. Slide the [Power Switch] to the OFF position to listen to audio (music) without battery power.

? Low Volume level

- Check the [Volume Dial] on the Control Unit and adjust to the desired level.
- Replace the battery.

(?) Crackling Noise / Distortion

- The Noise Cancelling feature requires fresh battery power to work effectivly. When the installed battery is weak distortion may occur. Replace the battery to correct the problem.
- Check the connection between the headphone jack and the audio source it is connected to.
