System Requirements

- PC with an Intel® Pentium® processor or equivalent
- USB 1.1 or 2.0 port

Operating System

- Windows® 98/Me/2000/XP
- Windows Vista™

Using the Keypad

Plug the USB connector into an available USB port on your computer.

Your computer's operating system identifies the keypad and begins installing the default driver. Follow any on-screen procedures to complete the installation.
