

# EN Connecting the Lyra Player to your computer

- Press and hold the lock button on the back of the player and push the USB connector out from the player.
- Insert the USB connector of the player into the USB port on the computer tightly (use the included USB extension cable if necessary).



# Selecting between USB and battery charging mode

Selecting USB mode lets you transfer files to the player while charging mode lets you charge the unit. This player uses internal (Lithium polymer) battery that can be charged with a PC.

- 1. Turn on your PC.
- Connect the player to your PC (use the included USB extension cable if necessary)
- The player will be in USB mode automactically for file transfer. Press and hold to switch to charging mode

USB Connected
Hold ► to charge batt.

In charging mode, press and hold
 It to switch the player to USB mode.

Battery Charging
Hold ►II to charge batt.



You can still transfer files to the player in the battery charging mode.





### **General Controls**



- In menu mode, press to go to previous options. In music mode, press to skip to previous files.
- In menu mode, press to go to next options. In music mode, press to skip to next files.
- M Press to enter menu setting mode and make selections.
- I Press once to turn on and press and hold to turn off the unit. In music mode, press once to start and pause playback.
- **5.** •• headphones jack Insert the headphones here.

- 6. Display
- 7. USB connector
- A-B In playback mode, press to set start and end positions for A-B repeat.
- 9. -/+ decreases / increases the volume.
- **10. hold** press and hold to lock or unlock the keys of the player

### **Playback**

Press ►II to turn on the unit. Press ✓ or ► to select the file you want to play.

### Play / pause

- Press I to begin playback.
- Press I once to pause playback, press again to resume playback.

### **Skipping files**

- To skip to the next file, press and release
- To go to the previous file, press and release within the beginning 4 seconds of the current file. Otherwise, press and release twice.

### Scanning files

- To scan forward, press and hold
- To scan backward, press and hold

### Adjusting the volume

- To turn up the volume, press +.
   The volume level shows briefly to indicate the increase in volume level.
- To turn down the volume, press -.
  The volume level shows briefly to
  show the decrease in volume level.

### A-B repeat

You can repeat certain part of a file with the help of **A-B** button.

- During playback, press A-B button to set the start repeat position (A), "A-" shows on the display.
- Press A-B button again to set the end repeat position (B), and repeat from position A to B will start, "A-B" shows on the display.
- To resume normal playback, press A-B button again.

### **Creating playlist**

To create playlist of selected files, refer to **Folders** in **Menu settings**. To play the created playlist, refer to **Repeat** in **Menu settings**.



Repeat All - Repeat all files

**Shuffle** - Play files in random order **Intro** - Play the first 10 seconds of each file in the player


**Playlist** - Play the files in the Playlist (see Folders)



#### Power save

Select this option to change the time before the player turns off automatically. There are five options:

OFF / 1 min / 2 min / 5 min / 10 min



### Lyrics

Select this option to turn on or off lyrics on the display (if available).

### **Folders**



### **Troubleshooting Tips**

#### The player does not turn on when the PLAY button is pressed?

Battery may be empty.

#### Skipping tracks or bad sound quality?

- Repeat, random or program function may be activated.
- There may be strong magnetic fields (e.g. too close to TV) near the unit.
- Low Battery level.

#### Cannot perform playback?

- LOCK function may be activated.
- There may be no mp3 tracks in the internal memory.

### USB display does not appear when connected to computer?

- Check connection between your unit and the computer. (Refer to the "USB Driver Installation: MusicMatch Jukebox™Software" instruction manual)
- Check if the USB drivers are properly installed (Refer to the "USB Driver Installation: MusicMatch Jukebox™ Software" instruction manual)

### Cannot playback tracks on the plaver.

- Make sure audio tracks are encoded in the mp3 or Windows Media formats at supported bitrates. Bitrates support by the player: mp3 - 32 to 320 kbps wma - 48 to 192 kbps

However, you will not be able to take full advantage of the potential speed increase.

### Transferring Files to the Lyra Digital Audio Player

 Drag and drop desired tracks from the Music Library to the Playlist display and save the playlist.

 From the menu area, select Files/Send to Portable Device or click Send to Portable under the copy item on the left side of the MusicMatch Jukebox screen to display the Portable Device Manager screen.

- Click on Options and select your portable device under Select Device. Click OK.
  - Your device should be listed under Portable Device.
- Select the playlist item and drag it to the active device listed under Portable Device. Only those playlists saved in step 1 are displayed on the playlist window.



# Disconnecting Your Lyra from the Computer



#### Note

Before disconnecting the USB connection from the computer or the Lyra Digital Audio Player, be sure the "Safe to unplug" message is displayed.

From the System Tray, double click the left mouse button on the icon and select *Unplug or eject hardware*. Select the drive corresponding to your Lyra player.



The Stop a Hardware device screen appears. Select the device to be stopped again for confirmation and click **OK**.



You can also stop your Lyra player by right clicking on the system tray and selecting the drive corresponding to your player.



#### Attention

If you want to go back to USB mode for file transfer at this stage, you need to unplug and connect the player to the PC again.
