
Connecting to network





Region Codes

This unit has been designed to play back BD-video with region "A" and DVD-video with region "1" or "ALL". You cannot play back BD-video or DVD-video that are labeled for other regions. Look for the symbols on the right on your BD-video or DVD-video.

If these region symbols do not appear on your BD-video or DVD-video, you cannot play back the disc in this unit. The letter or number inside the globe refers to region of the world. A BD-video or DVD-video labeled for a specific region can only be played back in the unit with the same region code.


BD-video and DVD-video are recorded in different color systems throughout the world. The most common color system is NTSC (which is used primarily in the United States and Canada).

Structure of Disc Contents


The contents of Blu-ray Disc™ / DVD / AVCHD are generally divided into titles. Titles may be further subdivided into chapters.



Audio CD is divided into tracks.



Data discs or USB flash drives containing MP3 / WMA /JPEG are divided into folders, and the folders are subdivided into files.





Preparations

Basic Playback

· When you want to view a disc, turn on the TV and select the video input connected to the Blu-ray Disc™ player.

BD AVCHD OVER OCD

Keep your fingers well clear of the disc tray as it is closing. Neglecting to do so may cause serious personal injury.





The disc tray opens.

Place the disc on the disc tray.



With the playback side down

Press OPEN/CLOSE to close the disc tray.



If you insert a Blu-ray disc or a DVD that contains a top menu, a menu may appear. Use $\P/ A/ \P/$ to select the title you want to view, then press **OK** to start playback.

 You may need to press the POP/TOP or MENU button to display disc menu (depending on the actual Blu-ray disc or DVD.)

To start playback in stop mode Press ► PLAY.

To pause playback (still mode)

Press II PAUSE during playback.

To resume normal playback, press the PLAY button.

The sound is muted during still mode.

To stop playback

Press ■ STOP. The home menu is displayed.

For Blu-ray discs, press **▼**/**▲** to select BD-ROM, then press **OK** to start playback at the beginning of

For DVDs/audio CDs, press ▶ PLAY to resume normal playback.

- · Depending on the disc, playback starts where it
- stopped or at the beginning of the disc.

 If you press STOP twice, playback stops completely. To stat playback again, press ▶ PLAY. Playback starts at the beginning of the disc.

To remove the disc

Press OPEN/CLOSE.



Remove the disc after the disc tray opens completely.

Be sure to press the **OPEN/CLOSE** button to close the disc tray after you remove the disc.

To turn the power off

Press **POWER** button to turn the unit off.



Variable Speed Playback

You can play discs at various speeds, and resume playback from the location where you stopped playback.

Playing in fast reverse / forward directions

AVCHD OND OCD

Press ◀◀ or ▶▶ during playback.

FWD : Fast forward playback

: Fast reverse playback

Each time you press this button, the fast-forward or fast-reverse speed changes in the following sequence:

Fast x 2 \rightarrow Fast x 4 \rightarrow Fast x 8 \rightarrow Fast x 16 \rightarrow Fast x 32 \rightarrow Fast x 64 \rightarrow Fast x 128.

■ To resume normal playback

Press ► PLAY.

Notes:

- The Blu-ray Disc[™] player mutes sound and subtitles during reverse and forward scan.
- The playback speed may differ depending on the disc.

Playing frame by frame

Press **II** ► during still playback.

Each time you press this button, the picture advances one frame.

■ To resume normal playback

Press ► PLAY.

Note: The sound is muted during frame by frame playback.

Press ▶► during playback.

Each time you press this button, the slow-motion speed changes in the following sequence:

Slow x 1/2 → Slow x 1/4 → Slow x 1/8

To resume normal playback

Press ► PLAY.

Notes:

- The sound is muted during slow-motion playback.
- 3 speeds are available.

Locating a Desired Section

Normally, Blu-ray discs and DVDs are divided into titles, and the titles are sub-divided into chapters. Audio CDs are divided into tracks. You can quickly locate any specific title, chapter, or track.

Locating a title using the pop/top menu

BD AVCHD DVD

The pop/top menu appears on the TV screen.

EN

Press ▼ / ▲ / ◀ / ▶ to select the title you want.

If the titles in the top menu are assigned a number, you can directly locate a specific title by pressing its designated number with the number buttons.

Press OK.

Playback starts from Chapter 1 of the selected title.

Locating a specific chapter or track

AVCHD OND OC

Press I ◀ or ▶ I repeatedly to access the chapter or track number you want.

Playback starts from the selected chapter or track.


Playback starts from the beginning of the current chapter or track. When you press twice in quick successions, playback starts from the beginning of the preceding chapter or track.

SKIP (In locate succeeding chapters or tracks.

Note: Some titles may not display chapter numbers.



Repeating a title, chapter or track




Notes:

- The repeat setting will be cancelled when you stop
- The chapter, title or track repeat will be cleared when moving to another chapter, title, track / file or folder.
- Repeat playback does not function during A-B repeat
- Chapter and title repeat are not available with some
- When the repeat setting is set for a MP3 or WMA folder (file), the repeat setting will be cancelled if you select other MP3 or WMA folder (file) to playback.

Repeating a specific segment







Press A-B at the desired ending point B during playback.

The Blu-ray Disc™ player automatically returns to point A and starts repeat playback of the selected segment (A-B).

To resume normal playback

Press A-B until is displayed.

- . Some discs may not permit A-B repeat operation.
- You can specify a segment only within the current title or
- You cannot set the A-B repeat function for a segment that includes multiple camera angles.
- A-B repeat does not function during chapter, title, track or all repeat playback.

Playing in a Random Order

Playing tracks or files in a random order

CD MP3 WMA

Press RANDOM repeatedly to select Random ON during playback.

Once you turn RANDOM function on, the RANDOM indicator will be activated and the system will play all files in a random sequence.

To resume normal playback

Press RANDOM repeatedly until " is

PIP (BONUSVIEW™) Setting

Some Blu-ray discs have the PIP function which enables you to display the secondary video in the primary video. You can call up the secondary video by pressing BONUS VIEW whenever the scene contains the secondary video. See the documentation that came with the disc for playback

> Press BONUS VIEW during playback to turn PIP mode on.

BOUNS VIEW

Press 2nd. AUDIO to turn the audio for the video in the PinP window on or off.

2nd. AUDIO

Press 2nd. SUB to turn the subtitle for the video in the PinP window on or off.



Playing AVCHD/MP3/WMA/JPEG/MKV Files

You can play AVCHD, MP3, WMA, JPEG or MKV files that have been recorded on a disc on the Blu-ray Disc™ player.

Playing files on a data disc



When you insert a data disc containing picture, music, or video files into your player, icons are added to the menu to indicate that video, music, or picture files are available for playback.

Press OPEN/CLOSE to open the disc tray, place a disc that contains video/MP3/JPEG files.

2 In Home Menu, press ▼ / ▲ to select Media, and then press ▶,


If a USB flash drive containing music is inserted at the same time, the system will enter the source selection screen shown as below:



If no USB flash drive is inserted, the system will only show optical disc.

Press ▼ / ▲ to select a desired source and then press ▶ to highlight an option, and then press OK.

(For example: selecting the Pictures)



- i : defines the total number of files that a device contains.
- 2 : shows the currently playing file number.
- 3 : shows all pictures in thumbnail mode.

Settings: This option enables you to define Slide Show Effects (None, Horizontal Scroll, Fade and Shutter) and Slide Show Delay (5 Seconds, 2 Seconds, 1 Second, No Delay, 10 Seconds, 15 Seconds and 30 Seconds). After setting, press ▼ to highlight Ok and then press OK to confirm.



Main Menu: Returns to the main menu.

Previous Folder: This item only appears if your optical disc or USB flash drive contains several different picture folders.

Start Slide Show: This option enables you to view picture (files) one after another automatically.

Browse Music: Goes back to Music folder.

Press ▼ / ▲ to select the desired photo, and then press OK to start playing.

CD: Press REPEAT repeatedly to select the desired repeat mode.

To play music files while viewing photos, follow the following steps:

- Press RETURN.
- Use \P / \blacktriangle to select Browse Music, then press \mathbf{OK} .
- Select the desired track and press **OK** to start playing.
- 6 To stop playing and return to the main menu, follow one of the steps described below:
 - Press STOP.
 - Press RETURN.
 - Press ◀, then use ▼ / ▲ to highlight Main Menu and then press OK to confirm.

Using a USB Flash Drive

You can play MP3, WMA, JPEG or MKV files that have been stored on USB flash drives on the Blu-ray $\mathsf{Disc}^{\mathsf{TM}}$ player.

Operating a USB Flash Drive

Inserting a USB flash drive into the USB port on the back of Blu-ray Disc™ player until it clicks.

2 In Home Menu, press **▼**/**▲** to select Media, and then press **►**.

If no optical disc is inserted, the system will only show USB flash drive.

Press ▼ / ▲ to select a desired source, then press ► to highlight an option, and press OK.

For detailed operations, please follow the instructions in "**Playing files on a data disc**" on page 19 for details.

Removing the USB Flash Drive

In stop mode, gently pull the USB flash drive out slowly.

Notes:

- If you cannot easily insert the USB flash drive, you may have inserted it incorrectly. Try to turnover the device and then insert again.
- Do not remove the USB flash drive during playback.

Using Media Player Function

Operating Media Player function

Set Media Player to "ON".

For detailed operations, please refer to the "Media Player" section in "System Setting" on page 24.

2 In Home Menu, press ▼/▲ to select Media, and then press ▶.

If Media Player is set to "OFF", Media Player will not function

Press ▼/▲ to select a desired source, then press ► to highlight an option, and press OK.


Notes:

- Make sure your player is properly connected to the network before using Media Player. Furthermore, you need other Media Player servers in the network to see and/or hear contents.
- Do not remove the LAN connector during playback.

You can change the default settings to customize performance to your preference.

General Operations

- Press ▼ / ▲ to select Settings in home menu while in full stop mode, the Settings menu appears.
- 2. Press ▶ button, then use ▲ / ▼ button to select the setting options.
- 3. Press **OK** button.
- Press ◀ or RETURN button to return to the previous menu.



Info Menu

This menu displays the following information:

- Software Version
- Software Date
- Netflix ESN
- In the main menu of Settings, press ▶ button, then use ▲ / ▼ button to select Info to display the version information on software and Netflix ESN.
- 2. Press ◀ or **RETURN** to go to the previous menu.

Performing Quick-Setup

- 2. Press \mathbf{OK} to perform Quick Setup.

To exit the setup menu:

- Use ▼ button to highlight "No thanks. I'll go through the full setup menu later", and then press OK.
- Or press

 button directly.

- 3. Follow the on-screen instructions to customize the following settings to your preference:
- OSD Language Settings
- Resolution

- 4. After setting, press \mathbf{OK} to confirm and exit the setup.

Note: If it is the first time for the player to start up or users restore all settings to factory defaults, the system will prompt you to perform Quick Setup. Repeat the steps described as above to complete the setup.

Using BD-Live™ Features

Some (but not all) Blu-ray Disc™ discs contain additional features that are made available to players that are connected to the internet, and have additional memory added. These additional features may include things like.

- · the ability to download new movie trailers
- · additional 'commentary' by actors and directors
- · multiperson game play and chat

In order to access BD-Live™ functions, the player must be properly configured for BD-Live internet access, and it must be equipped with additional memory.

Note: BD-Live™ requires connection of a USB flash drive of at least 1 GB (sold separately) to USB port. Performance of interactive features may vary due to disc design or content, and may also require an always-on broadband internet connection. Firmware update may be required for some interactive features. Some features may require additional bandwidth.

- In the main menu of Settings, press ➤ button, then use ▲ / ▼ button to select BD-Live, then press OK.
- 2. Press ▲ / ▼ to select an option, and then press OK.
- Use ▲ / ▼ to select the desired setting, and then press OK to confirm.
- 4. Press ◀ to go to the previous menu.

BD-Live Internet Access:

- Limit Access Allows Internet access with valid BD-Live™ network access approval.
- Always Allow Access Always allows BD-Live Internet access.
- Prohibit Access Never allows BD-Live Internet access.

In order to set the player up for BD-Live Internet Access, perform the following steps:

- In the main menu of Settings, press ▶ button, then use ▲ / ▼ to select BD-Live, then press OK.
- Press ▲ / ▼ to select "BD-Live Internet Access", and then press OK.
- Use ▲ / ▼ to select the desired setting, and then press OK to confirm.

- Make sure that "Limit Access" or "Always Allow Access" is checked.
- Once the USB flash drive has been inserted, if there is not at least 100Mbyte of free space on the device, you should choose "Erase Blu-ray Storage" from the BD-Live setup menu.
- Press

 to return to the main menu of Settings, then use

 To highlight Network, and then press OK. (For dealis, please refer to "Network Connection Setting" on Page 26.)

Notes:

- Depending on your connection environment, it may take time to connect to the Internet or the Internet may not be connected.
- When BD-Live™ function are used and the unit is connected to the Internet, you may be charged for this communication.
- Do not remove the USB flash drive when using the BD-Live™ function.

BD-Live Storage:

This option is used to tell the Blu-ray Disc[™] player whether or not to use an inserted USB flash drive to store BD-Live[™] content (movie trailers, additional scenes, etc.).

In order to add BD-Live™ memory for BD-Live Internet Access, insert a USB flash drive (1GB is recommended) into the USB port on the player.

Erase Blu-ray Storage:

If you choose **OK** to erase Blu-ray storage, all bookmarks and BD-Live™ content saved in memory are deleted.

Display Setting

- In the main menu of Settings, press ▶ button to select Display, and then press OK to confirm.
- Press ▲ / ▼ to select an option, and then press OK.
- Use ▲ / ▼ to select the desired option, and then press OK to confirm your selection.
- 4. Press ◀ to go to the previous menu.

HDMI Status:

This option displays the HDMI status. If an HDMI TV is connected, **Connected** appears. If an HDMI TV is not connected, **Disconnected** appears.

HDMI Preferred Format:

This option shows the best HDMI format for the connected TV. If HDMI is not pulled out, a composite image is not output.

* HDMI connection is required. Cables are not included. Analog connection is not supported.

Resolution:

You can define the video output resolution in this option.

If your TV is a high-definition TV(HDTV) connected to the HDMI jack on your player and you want your player to set the output resolution based on information exchanged between the TV and your player over the HDMI cable.	HDMI Auto

Notes:

- Selecting a resolution the TV does not support could result in an unstable picture or loss of the picture. See the documentation that came with the TV to find the resolutions the TV supports.
- Only the HDMI output on your player supports 1080p video output at any frame rate.

TV Aspect:

16:9 wide, 16:9 Pillarbox, 4:3 Pan and Scan and 4:3 Letter Box are available for your choice.

Film Mode

Movies are recorded on film at a rate of 24 pictures (frames) per second. Many of the movies on Blu-ray discs are placed on the discs at this frame rate. If your TV supports 24 frames per second, but you would prefer viewing the video at a higher frame rate, you should turn off Film Mode. Off selects a 60 frames/second output format.

Deep Color:

This option decides whether to turn off the Deep Color (color depth) setting for video signals output from the HDMI OUT jack.

Connecting the player and a TV that supports Deep Color allows more accurate color reproduction than when connecting it to a TV that does not support Deep Color. It is recommended to set this option **Off** if the picture is unstable or colors appear unnatural.

Audio Setting

The settings in the Audio menu will configure the Blu-ray Disc™ player's digital audio outputs (HDMI or Coaxial).

- In the main menu of Settings, press ➤ button, then use
 ▲ / ▼ button to select Audio, then press OK button.
- 2. Press ▲ / ▼ to select an option, and then press OK.
- 3. Use ▲/▼ to select your preferred audio items, and then press OK to confirm your selection
- 4. Press ◀ to go to the previous menu.

PCM Downsampling:

If you don't have a surround sound receiver connected to the Blu-ray Disc™ player, you should leave the PCM downsampling to 48 kHz, and proceed to the next setup

If you have a surround sound receiver connected to the Bluray Disc[™] player, and you have connected to the surround receiver via the Blu-ray Disc[™] player's HDMI output, this setting has no effect on the audio going to the HDMI output of the player. Leave the PCM downsampling to 48 kHz, and proceed to the next setup menu item.

NOTE: Incorrectly setting the digital audio output's PCM sampling rate too high may result in unpredictable audio playback

Digital Output:

- $\operatorname{\textbf{PCM}}$ $\operatorname{\textbf{Stereo}}$ $\operatorname{\textbf{Sets}}$ the output to $\operatorname{\textbf{PCM}}$ $\operatorname{\textbf{Stereo}}$ if you do not have an audio receiver connected to your Blu-ray Disc™ player or the audio receiver connected to Blu-ray disc player is not a 5.1/7.1 channel receiver.
- Bitstream HD Lets your player send Dolby TrueHD or DTS-HD MA bitstreams over HDMI (if your player is connected to a compatible HDMI audio receiver). If your player is not connected to a compatible HDMI receiver (for example, your player is connected directly to the TV, a compatible audio signal is automatically sent over the HDMI connection. With this setting, Blu-ray audio is limited to the soundtrack for the main movie
- Bitstream Legacy -- Sends a DTS or Dolby Digital bitstream from the disc over the HDMI connection. Blu-ray audio is limited to the soundtrack for the main movie (no PIP audio).
- **Bitstream Mixed** Sends a DTS or Dolby Digital bitstream over the HDMI or Coaxial connection. This mode is primarily intended for use when you want to hear both PIP audio and the movie audio
- PCM 5.1 Sends a PCM audio signal of up to 5.1 channels over the HDMI connection.
- PCM 7.1 Sends a PCM audio signal of up to 7.1 channels over the HDMI connection.

Dynamic Range Control:

Dynamic Range Control means that you can allow the Bluray Disc™ player to make the loud parts of a movie's audio track quieter than they would be in the theatre, without making the dialog of the actors any quieter. This would be useful, for instance, when you want to watch a movie in the evening when others might be sleeping.

NOTE: This setup menu item has no effect unless you have selected "Bitstream Mixed" in the Blu-ray Disc™ player's audio setup menu.

When Dynamic Range Control is set to Off, movie soundtracks are played with the standard dynamic range. When movie soundtracks are played at low volume or from smaller speakers, you can set Dynamic Range Control to On. Your player applies appropriate compression to make low-level content more intelligible and prevent dramatic passages from getting too loud.

Selecting the "Auto" option turns on the Dynamic Range Control for all Blu-ray Disc™ movie soundtracks except Dolby TrueHD. If you have selected a Dolby TrueHD track on the Blu-ray Disc™ disc, the "auto" selection tells the Blu-ray Disc™ player to only turn on dynamic range control if information embedded in the Dolby TrueHD sound track tells it to do so.

Stereo Downmix:

Select whether to downmix the multi-channel audio into fewer channels.

- Auto Downmixes the multi-channel audio into the specific stereo that the connected equipment supports.
- Stereo (LoRo) Downmixes the multi-channel audio into two channel stereo. Choose when the Blu-ray Disc™ player is connected to the equipment that does not support virtual surround function such as Dolby Pro Logic
- Surround Encoded (LtRt) Downmixes the multichannel audio into surround compatible stereo. Choose when the Blu-ray Disc™ player is connected to the equipment that supports virtual surround function such as Dolby Pro Logic.

Language Setting

- In the main menu of Settings, press ▶ button, then use ▲ / ▼ button to select **Language**, and then press **OK**.
- 2. Press ▲ / ▼ to select OSD, Menu, Audio or Subtitle, and then press OK.
- 3. Use ▲ / ▼ to select your preferred language, and then press **OK** to confirm your selection.
- 4. Press

 to go to the previous menu.

This option enables you to select the on-screen menu language

Menu:

This option lets you to select the disc menu language

Notes:

- Not all languages are available on all discs.
- Most discs only have one menu language.

Audio:

You can choose the audio language from this option to your preference.

Notes:

- Not all languages are available on all discs. Some discs do not let you select the audio language using your player's menu. Instead, you have to select the audio language from the disc setup menu (the menu that appears after you insert the disc).

Subtitle:

You can customize your preferred subtitle language in this option.

Notes:

- Not all languages are available on all discs.
- Some discs do not let you select the subtitle language using your player's menu. Instead, you have to select the subtitle language from the disc setup menu (the menu
- that appears after you insert the disc). You can also select the subtitle language from the subtitle menu in the on-screen menu.

Parental Control

- In the main menu of Settings, press ▶, then press ▲/
 to select Parental, and then press OK.
- 2. Press ▲ / ▼ to select an option, and then press OK.
- 3. Use \blacktriangle / \blacktriangledown to select the desired option, and then press OK to confirm your selection.
- 4. Press ◀ to go to the previous menu.

Note: If Parental Control was previously turned On, you will be prompted to enter the parental control password before being allowed to change these settings. (See "Turning parental control on or off" for details.)

Selecting the parental country

Parental Country is fixed in USA.

- 5 [PG-R] Parental guidance recommended.
- 6 [R] Not suitable for anyone under 17 unless supervised by a parent or adult guardian.
- 7 [NC-17] Not suitable for anyone under 17.
- 8 [Adult] All Blu-ray discs and DVDs can be played.
- 4. Press

 to go to the previous menu.

Setting the parental control password

- 1. In the main menu of **Settings**, press ▶, then press ▲/ ▼ to select Parental, and then press OK.
- 2. Press ▲ / ▼ to select Parental Password, then press OΚ





Disc handling

IR signal check

Analog Audio

An electrical signal that directly represents sound. Compare this to digital audio which can be an electrical signal, but is an indirect representation of sound.

Aspect Ratio

The width of a TV screen relative to its height.

Conventional TVs are 4:3 (in other words, the TV screen is almost square); widescreen models are 16:9 (the TV screen is almost twice as wide as it is high).

AVCHD

AVCHD is a new format for high definition video camcorders which can record and play high-resolution HD images.

BD-Java

With some Blu-ray Disc TM which support Java applications, you can enjoy the interactive functions such as games or interactive menus.

BD-Live™

BD-Live is a BD-video (BD-ROM version 2 Profile 2.0/ Profile 1.1) which contains new functions (e.g. Internet connection), in addition to the BONUSVIEW function.

Blu-ray Disc™ (BD)

Blu-ray Disc[™] is a next generation optical video disc which is capable of storing much more data than a conventional DVD is. The large capacity makes it possible to benefit from the features such as high-definition videos, multichannel surround sounds, interactive menus and so on.

Chapter

Just as a book is split up into several chapters, a title on a BD-video or DVD-video is usually divided into chapters.

Component Video Output

Each signal of luminance (Y) and component ($P_{\rm g}/C_{\rm g}$, $P_{\rm g}/C_{\rm g}$) is independent to output so that you can experience picture Color as it is. Also, due to compatibility with progressive video (525p/480p), you can experience higher-density picture than that in interlace (525i/480i).

Digital Audio

An indirect representation of sound by numbers. During recording, the sound is measured at discrete intervals (44,100 times a second for CD audio) by an analog-to-digital converter, generating a stream of numbers. On playback, a digital-to-analog converter generates an analog signal based on these numbers.

DNS Server

A server which translates Internet domain names into IP addresses.

Dolby® Digital

The system to compress digital sound developed by Dolby Laboratories. It offers you sound of stereo (2ch) or multi-channel audio.

Dolby® Digital Plus

Dolby Digital Plus is the next generation digital audio compression technology developed as an extension to Dolby Digital. Blu-ray Disc supports 7.1 multi-channel surround sound output.

Dolby® TrueHD

Dolby TrueHD is a lossless coding technology developed for next generation optical discs. Blu-ray Disc supports 7.1 multi-channel surround sound output.

DTS

DTS is a multi-channel surround sound system. By connecting to DTS decoder, you can enjoy movie dynamic and realistic sound like movie theater. DTS surround sound technologies were developed by DTS, Inc.

DTS-HD®

DTS-HD is a lossless coding technology developed as an extension of the original DTS Coherent Acoustics format. Blu-ray Disc supports 7.1 multi-channel surround sound output.

Gateway

IP Address of the electronic devices (such as router) which provide Internet access.

HDMI (High-Definition Multimedia Interface)

A digital interface between audio and video source. It can transmit component video, audio, and control signal with one cable connection.

Hub

A device used for connecting multiple device to the network.

IP Address

A set of numbers which are assigned to devices participating in a computer network.

JPEG (Joint Photographic Experts Group)

JPEG is a method of compressing still picture files. You can copy JPEG files on BD-RE/-R, DVD-RW/-R or CD-RW/-R from a computer and play back the files in this unit.

LAN (Local Area Network)

A group of computer networks covering a small area like a company, school or home.

Local Storage

A storage area of sub contents for playing virtual packages on BD-video.

MP3 (MPEG audio layer 3)

MP3 is a method of compressing files. You can copy MP3 files on BD-RE/-R, DVD-RW/-R or CD-RW/-R from the computer and play back the files on this unit.



PCM (Pulse Code Modulation)

The most common system of encoding digital audio, found on CD and DAT. Excellent quality that requires a lot of data compared to formats such as Dolby Digital and MPEG audio. For compatibility with digital audio recorders (CD, MD and DAT) and AV amplifiers with digital inputs, this unit can convert Dolby Digital, DTS, and MPEG audio

Proxy Server

Proxy server is a server which acts as an intermediary between a workstation user and the Internet to ensure security.

Region Code

Regions associate discs and players with particular areas of the world. This unit will only play back discs that have compatible region codes. You can find the region code of your unit by looking on the rear panel. Some discs are compatible with more than one region (or all regions).

Router

A networking device which distinguishes the IP address assigned to each device and routing and forwarding information in the computer network.

Sampling Frequency

The rate which sound is measured by a specified interval to turn into digital audio data. The numbers of sampling in one second defines as sampling frequency. The higher the rate, the better the sound quality.

Subnet Mask

A mask which is used to determine what subnet an IP address belongs to.

Title

A collection of chapters on BD-video or DVD-video.

Track

Audio CD use tracks to divide up the content of a disc. The BD-video or DVD-video equivalent is called a chapter. See also "Chapter".

Virtual Package

The function which copies data to other media (local storage) from the Internet and play the secondary video, secondary audio and the subtitle at the same time. The method of the playback varies depending on discs.

Windows Media™ Audio

Windows Media™ Audio is the audio compressing technology developed by Microsoft. You can copy Windows Media™ Audio files on BD-RE/-R, DVD-RW/-R or CD-RW/-R from a computer and play them back on this unit.

x.v.Color

"x.v.Color" is a promotion name given to the products that have the capability to realize a wide color space based on the xvYCC specifications and is a trademark of Sony Corporation.

This license, the Lesser General Public License, applies to some specially designated software packages-typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete

object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

We protect your rights with a two-step method: (1) we copyright the library, and (2) we offer you this license, which gives you legal permission to copy, distribute and/or modify the library.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder.
