NOTE: The CD includes the User Guide PDF files and INF/ICM display optimization files. The INF file ensures compatibility with Windows operating systems, and the ICM file (Image Color Matching) ensures accurate on-screen colors. ViewSonic recommends that you install both the INF and ICM files.

Precautions

- Sit at least 18" from the LCD display.
- Avoid touching the screen. Skin oils are difficult to remove.
- Never remove the rear cover. This LCD display contains high-voltage parts. You may be seriously injured if you touch them.
- Avoid exposing the LCD display to direct sunlight or another heat source. Orient the LCD display away from direct sunlight to reduce glare.
- Always handle the LCD display with care when moving it.

- Place the LCD display in a well ventilated area. Do not place anything on the LCD display that prevents heat dissipation.
- Ensure the area around the LCD display is clean and free of moisture.

Quick Installation

1. Connect power cord (and AC/DC adapter if required)

2. Connect video cable

- Make sure both the LCD display and computer are turned OFF
- Remove rear panel covers if necessary
- Connect the video cable from the LCD display to the computer

Macintosh users: Models older than G3 require a Macintosh adapter. Attach the adapter to the computer and plug the video cable into the adapter.

3. Turn ON LCD display and computer

Turn ON the LCD display, then turn ON the computer. This sequence (LCD display before computer) is important.

NOTE: Windows users may receive a message asking them to install the INF file. This is on the CD.

4. Insert the ViewSonic Wizard CD into the computer's CD drive.

Follow the on-screen instructions. If your computer does not have a CD-ROM drive, please refer to Customer Support page.

• Wait for the CD-ROM to auto-start.

NOTE: If the CD-ROM does not autostart: double-click on the CD-ROM icon in the Windows Explorer, then doubleclick on **viewsonic.exe**.

• Follow the on-screen instructions.

5. Windows users: Set the timing mode (resolution and refresh rate)

Example: 1680 x 1050 @ 60 Hz.



Using the LCD Display

Setting the Timing Mode

Setting the timing mode is important for maximizing the quality of the screen image and minimizing eye strain. The **timing mode** consists of the **resolution** (example 1680 x 1050) and **refresh rate** (or vertical frequency; example 60 Hz). After setting the timing mode, use the OSD (On-screen Display) controls to adjust the screen image.

For the best picture quality set your LCD display timing mode to:

VESA 1680 x 1050 @ 60Hz.

To set the Timing Mode:

- 1. Set the resolution: Right-click on the Windows desktop > Properties > Settings > set the resolution.
- 2. Set the refresh rate: See your graphic card's user guide for instructions.

WARNING: Do not set the graphics card in your computer to exceed the maximum refresh rate of 75Hz; <u>doing so may result in permanent damage to your LCD display</u>.

Identifying parts and controls

- 1. The LED light indicates the state of working. During operation, the LED Light is bright green. When dormant, the LED Light is orange.
- 2. The power button () is used to identify the state of power. You can use the power button to control on & off.
- **3.** The function keys are used for adjusting all settings. When you need some adjustment, you can achieve the goals by pressing any of the function menus. Details for all the function menus are subsequently described.

Working with OSD Group

You will find that the OSD is very easy to use. You can identify the function of a button through the corresponding icon displayed on the pop-up window of OSD. Now there are 3 pictures, which show that a button represents different functions in different levels of the architecture.



- 1. Press () button to start.
- 2. Press any of the rest 4 buttons to activate the OSD menu.
- 3. Press the corresponding function icon button on the pop-up window of the OSD.

Customizing your Monitor

The On Screen Display (OSD) system provides a full range of customizing tools to optimize your display.

Important: Although you could perform comprehensive customizing, we strongly recommend that you use the "AUTO ADJUSTMENT" function.

It can utilize the default values to thoroughly optimize the performance of the display. Activate the OSD menu.

Select the first button on the left we to activate the "AUTO ADJUSTMENT" function. In addition, we have also prepared other relatively simple methods to change the display modes. There are 4 modes, which include: GENERAL, MOVIE, PICTURE, GAME.

Hot keys Introduction

1. Auto Adjustment

When the OSD functions are displayed, press the first button on the left , and then you can automatically optimize the image performance.

2. Theme Mode Menu

When the OSD functions are displayed, press the second button on the left \mathbf{x} to shift the mode. You may press \mathbf{x} and \mathbf{x} to make adjustments between 4 modes.

Press \land or \blacksquare , and then you can leave automatically.

3. Main Menu

When the OSD functions are displayed, press the second button on the right \blacksquare to enter the main menu. And then press \triangleleft or \triangleright to select the option.

Press or to enter into the option.


Press \land or \blacksquare to leave.

Function Keys Operation

According to the tree-like directory, you can discover the whole OSD system is like a map. This tree-like directory can help you to become aware of the whole system. During the whole process, you need to know the following actions.

- 1. Activate the OSD main menu: Under the energized condition, press any function key to execute the function.
- 2. Confirm the selection: Press the ok button.
- 3. Browse the previous or next option: Press \leq and \geq .
- **4.** Adjust the option value: Press \oplus and \oplus to adjust the value.
- 5. Return to the higher level menu. Press 📰 or 🔼 to return to the higher level.
- 6. Exit: Press 📰 to exit OSD menu; Or if you do not press any button, it will automatically disappear after 30 seconds.

Troubleshooting

No power

- Make sure power button (or switch) is ON.
- Make sure A/C power cord is securely connected to the LCD display.
- Plug another electrical device (like a radio) into the power outlet to verify that the outlet is supplying proper voltage.

Power is ON but no screen image

- Make sure the video cable supplied with the LCD display is tightly secured to the video output port on the back of the computer. If the other end of the video cable is not attached permanently to the LCD display, tightly secure it to the LCD display.
- Adjust brightness and contrast.
- If you are using an Macintosh older than G3, you need a Macintosh adapter.

Wrong or abnormal colors

- If any colors (red, green, or blue) are missing, check the video cable to make sure it is securely connected. Loose or broken pins in the cable connector could cause an improper connection.
- Connect the LCD display to another computer.
- If you have an older graphics card, contact ViewSonic[®] for a non-DDC adapter.

Control buttons do not work

• Press only one button at a time.

Cleaning the LCD Display

- MAKE SURE THE LCD DISPLAY IS TURNED OFF.
- NEVER SPRAY OR POUR ANY LIQUID DIRECTLY ONTO THE SCREEN OR CASE.

To clean the screen:
