
OPERATORS MANUAL

SAFETY INFORMATION ON THE UNIT

DANGER: Never use blades, wire or flailing devices. This unit is designed for line trimmer use only. Use of any other accessories or attachments will increase the risk of injury.



WARNING: Trimmer line throws objects violently. You and others can be blinded/ injured. Wear safety glasses and leg protection. Keep body parts clear of rotating line.



Keep children, bystanders, and animals 50 feet (15 meters) away. If approached stop unit immediately.

OPERATOR SAFETY

Always wear safety • Dress properly. glasses or similar eye protection when operating, or performing maintenance, on your unit (safety glasses are available).

Eye protection should meet the requirements of ANSI Z87.1.

- Always wear face or dust mask if operation is dusty.
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. Do not go barefoot or wear sandals. Stay clear of spinning line.
- Secure hair above shoulder length. Secure or remove loose clothing or clothing with loosely hanging ties, straps, tassels, etc. They can be caught in moving parts.
- Being fully covered also helps protect you from debris and pieces of toxic plats thrown by spinning line. Stay Alert. Do not operate this unit when you are tired, ill, or under the influence of al-
- cohol, drugs, or medication. Watch what you are doing; use common sense.
- Wear hearing protection.
- · Never start or run inside a closed room or building. Breathing exhaust fumes can kill.
 Keep handles free of oil and fuel.

UNIT/MAINTENANCE SAFETY

- Disconnect the spark plug before performing maintenance except carburetor adjustments.
- Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working condition.
- · Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper Íenath.
- Use only 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope, string, etc.
- Install required shield properly before using the unit. Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- · Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor adjustments.
- Use only recommended Weed Eater® accessories and replacement parts.
- Have all maintenance and service not explained in this manual performed by an authorized service dealer.

FUEL SAFETY

- Mix and pour fuel outdoors.
- Keep away from sparks or flames.
- Use a container approved for fuel.
- Do not smoke or allow smoking near fuel or the unit.
- · Avoid spilling fuel or oil. Wipe up all fuel spills.



- · Move at least 10 feet (3 meters) away from fueling site before starting engine.
- Stop engine and allow to cool before removing fuel cap.
- Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage the trimmer head and be thrown causing serious injury.

- Use only for trimming, mowing, and sweep-ing. Do not use for edging, pruning or hedge trimmina.
- Keep firm footing and balance. Do not overreach
- Keep all parts of your body away from muf-fler and spinning line. Keep engine below waist level. A hot muffler can cause serious burns.
- Cutting on left side of the shield will throw debris away from the operator.
- Use only in daylight or good artificial light.

TRANSPORTING AND STORAGE

- Allow the engine to cool; secure unit before storing or transporting in vehicle.
- Empty fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by the tube.
- Store the unit out of the reach of children



After 50 hours of use, we recommend that your muffler be serviced or replaced by your Authorized Service Dealer.

ASSEMBLY

AWARNING: Make sure unit is properly assembled and all fasteners are secure.



ATTACHING THE HANDLE

 Assemble the handle to the unit as shown; make sure bottom of handle is seated in the groove in the trigger housing.


NOTE: Adjustment knob must be assembled on the side of unit opposite operator's position.

 Pivot handle to a comfortable position. Tighten handle securely.

ATTACHING THE SHIELD

AWARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line. The line limiter blade (on underside of shield) is sharp and can cut you.Remove wing nut from shield.

- Insert bracket into slot as shown.
- Pivot shield until bolt passes through hole in bracket
- Securely tighten wing nut onto bolt.



FUEL YOUR UNIT


This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.

STARTING

HOW TO STOP YOUR UNIT

To stop the engine, push and release the engine STOP switch. The switch will automatically return to the ON position. Wait 5 seconds before attempting to restart unit to allow switch to reset.

HOW TO START YOUR UNIT



WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause seri-

ous burns. COLD ENGINE STARTING (or a warm engine after running out of fuel)

- Set unit on a flat surface.
- Slowly press the primer bulb 6 times.
- Move choke lever to FULL CHOKE position.
- Squeeze the throttle trigger fully and hold through all remaining steps.
- Pull starter rope handle sharply 6 times.
- Move choke lever to HALF CHOKE posi-
- tion. • Pull starter rope handle no more than 6
- Pulls, until engine runs.
 Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

STARTING A WARM ENGINE

- Move choke lever to OFF CHOKE position.
- Pull starter rope handle until engine runs.

• If engine does not start in 5 pulls, follow instructions in STARTING A COLD EN-GINE.

USING YOUR UNIT

OPERATING POSITION



Cut from your right to your left.

ADVANCING THE CUTTING LINE

Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. A metal blade attached to the shield will cut the line to the proper length.


TWIST-N-EDGE


- Pull the tab toward the engine.
- Twist the tube to the edging position; release the tab.



REPLACING THE LINE

- Remove spool by firmly pulling on tap button.
- Clean entire surface of hub and spool.
- Replace with a pre-wound spool, or cut two 12–1/2 feet lengths of 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
 Insert ends of the line about 1/2 inch (1 cm)
- Insert ends of the line about 1/2 inch (1 cm) into the small holes on the inside of the spool.





• Wind the line evenly and tightly onto the spool. Wind in the direction of the arrows

• Push the lines into the notches, leaving 3 to 5 inches (7 - 12 cm) unwound.

SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Carburetor adjustment is a complicated task. We recommend that you take your unit to an Authorized Service Dealer. Damage will oc-cur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable. SPARK PLUG

Replace the spark plug yearly using a Cham-pion RCJ-8Y plug. Spark plug gap is 0.025".

Push spool into hub until it snaps into place. Pull the lines extending outside of the hub to TROUBLESHOOTING TABLE

MANUFACTURER'S WARRANTY COVERAGE: If any emissions related part on your engine (as listed under Emissions Control Warranty Parts List) is defective or a defect in the materials or workmanship of the engine causes the failure of such an emission related part, the part will be repaired or replaced by POULAN/WEED EATER.
