## General safety guidelines

Always observe the following precautions to reduce the risk of injury and property damage.

---

### Service

Do not attempt to service a product yourself unless instructed to do so by the Customer Support Center. Use only a service provider who is approved to repair your particular product.

**Note:** Some parts can be upgraded or replaced by the customer. These parts are referred to as Customer Replaceable Units, or CRUs. Lenovo expressly identifies CRUs as such, and provides documentation with instructions when it is appropriate for customers to replace those parts. You must closely follow all instructions when performing such replacements. Always make sure that the power is turned off and that the product is unplugged from any power source before you attempt the replacement. If you have any questions or concerns, contact the Customer Support Center.

---

### Power cords and power adapters

Use only the power cords and power adapters supplied by the product manufacturer.

Never wrap a power cord around the power adapter or other object. Doing so can stress the cord in ways that can cause the cord to fray, crack or crimp. This can present a safety hazard.

Always route power cords so that they will not be walked on, tripped over, or pinched by objects.

Protect the cord and power adapters from liquids. For instance, do not leave your cord or power adapter near sinks, tubs, toilets, or on floors that are cleaned with liquid cleansers. Liquids can cause a short circuit, particularly if the cord or power adapter has been stressed by misuse. Liquids can also cause gradual corrosion of the power cord terminals and/or the connector terminals on the adapter which can eventually result in overheating.

Always connect power cords and signal cables in the correct order and ensure that all power cord connectors are securely and completely plugged into receptacles.

Do not use any power adapter that shows corrosion at the ac input pins and/or shows signs of overheating (such as deformed plastic) at the ac input or anywhere on the power adapter.

Do not use any power cords where the electrical contacts on either end show signs of corrosion or overheating or where the power cord appears to have been damaged in any way.

---

## Extension cords and related devices

Ensure that extension cords, surge protectors, uninterruptible power supplies, and power strips that you use are rated to handle the electrical requirements of the product. Never overload these devices. If power strips are used, the load should not exceed the power strip input rating. Consult an electrician for more information if you have questions about power loads, power requirements, and input ratings.

---

## Plugs and outlets

If a receptacle (power outlet) that you intend to use with your computer equipment appears to be damaged or corroded, do not use the outlet until it is replaced by a qualified electrician.

Do not bend or modify the plug. If the plug is damaged, contact the manufacturer to obtain a replacement.

Some products are equipped with a three-pronged plug. This plug fits only into a grounded electrical outlet. This is a safety feature. Do not defeat this safety feature by trying to insert it into a non-grounded outlet. If you cannot insert the plug into the outlet, contact an electrician for an approved outlet adapter or to replace the outlet with one that enables this safety feature. Never overload an electrical outlet. The overall system load should not exceed 80 percent of the branch circuit rating. Consult an electrician for more information if you have questions about power loads and branch circuit ratings.

Be sure that the power outlet you are using is properly wired, easily accessible, and located close to the equipment. Do not fully extend power cords in a way that will stress the cords.

Connect and disconnect the equipment from the electrical outlet carefully

---

## Batteries

All personal computers manufactured by Lenovo contain a non-rechargeable coin cell battery to provide power to the system clock. In addition many mobile products such as ThinkPad notebook PCs utilize a rechargeable battery pack to provide system power when in portable mode. Batteries supplied by Lenovo for use with your product have been tested for compatibility and should only be replaced with Lenovo approved parts.

Never attempt to open or service any battery. Do not crush, puncture, or incinerate batteries or short circuit the metal contacts. Do not expose the battery to water or other liquids. Only recharge the battery pack strictly according to instructions included in the product documentation.

Battery abuse or mishandling can cause the battery to overheat, which can cause gasses or flame to “vent” from the battery pack or coin cell. If your battery is damaged, or if you notice any discharge from your battery or the buildup of foreign materials on the battery leads, stop using the battery and obtain a replacement from the battery manufacturer.

Batteries can degrade when they are left unused for long periods of time. For some rechargeable batteries (particularly Lithium Ion batteries), leaving a battery unused in a discharged state could increase the risk of a battery short circuit, which could

shorten the life of the battery and can also pose a safety hazard. Do not let rechargeable Lithium-Ion batteries completely discharge or store these batteries in a discharged state.

---

## Heat and product ventilation

Computers generate heat when turned on and when batteries are charging. Notebook PCs can generate a significant amount of heat due to their compact size. Always follow these basic precautions:

- Do not leave the base of your computer in contact with your lap or any part of your body for an extended period when the computer is functioning or when the battery is charging. Your computer produces some heat during normal operation. Extended contact with the body could cause discomfort or, potentially, a skin burn.
- Do not operate your computer or charge the battery near flammable materials or in explosive environments.
- Ventilation slots, fans and/or heat sinks are provided with the product for safety, comfort, and reliable operation. These features might inadvertently become blocked by placing the product on a bed, sofa, carpet, or other flexible surface. Never block, cover or disable these features.

---

## CD and DVD drive safety

CD and DVD drives spin discs at a high speed. If a CD or DVD is cracked or otherwise physically damaged, it is possible for the disc to break apart or even shatter when the CD drive is in use. To protect against possible injury due to this situation, and to reduce the risk of damage to your machine, do the following:

- Always store CD/DVD discs in their original packaging
- Always store CD/DVD discs out of direct sunlight and away from direct heat sources
- Remove CD/DVD discs from the computer when not in use
- Do not bend or flex CD/DVD discs, or force them into the computer or their packaging
- Check CD/DVD discs for cracks before each use. Do not use cracked or damaged discs

### Product description

The ThinkPad CD-RW/DVD Combo II Ultrabay Slim Drive can write to and read from CD-RW and CD-Recordable (CD-R) discs, and can read mass-produced, stamped CDs and DVDs. This drive can also read DVD-RAM, DVD-R, DVD-RW, DVD+R, and DVD+RW formatted media. (Some DVD+R and DVD+RW media brands may not be compatible.)

In addition to this *Software and User's Guide CD*, you should have received the following:

- CD-RW/DVD Combo II Ultrabay Slim Drive
- Carrying case
- *Laser Safety Guide*
- *Quick Reference Guide*

**Note:** Your kit might also contain a software update diskette.

Contact your place of purchase if an item is missing or damaged. Be sure to retain your proof of purchase. It might be required to receive warranty service. See Appendix A, "Service and Support," on page A-1 for technical support information.

---

### Software description

Your *CD-RW & DVD-ROM Software and User's Guide CD* contains the following software:

- **Drive Letter Access (DLA)**

This software enables you to write directly to CD-RW or CD-R media using the drive letter like you would if you were writing to a diskette. All disc format

types can be formatted by DLA. With DLA, you can drag-and-drop files, create new directories, or save files from any application directly to your CD-RW/DVD-ROM Combo II drive.

- **UDF reader**

This software enables you to install software for reading DVD-RAM, DVD-RW, and CD-RW media on computers with DVD drives. It also allows you to read DLA-created discs on systems without DLA installed.

- **RecordNow**

RecordNow is disc mastering software that allows you to create your own music or data discs from files on your computer, or from other disc media such as CDs or DVDs. Music discs created with RecordNow will play on any CD player, whether it's at home, in your car, or through your computer's CD-ROM. RecordNow also makes it easy to create data discs that can be read on any appropriate CD or DVD disc reader.

**Note:** Some DVD players cannot read CD-R media. Refer to the documentation that accompanied your drive for information on supported media.

RecordNow guides you, step-by-step, through the recording process with simple Wizards and an intuitive user interface.

Using RecordNow you can create:

- Exact copies of existing discs - The Exact Copy feature makes a duplicate of your master disc, transferring the disc layout of the original disc to your CD-R or CD-RW media.
- Discs of archived data from your hard drive - The Make a Data Disc feature is used to store electronic data, such as the files and applications that reside on your computer's hard drive. Unlike music discs, data discs are used to store files that are readable only by a computer, and cannot be played on your home or car stereo-even if audio files are on the disc.
- Music compilations from WAV, MP3, or WMA files, or from existing music discs - The Make a Music Disc feature creates custom music discs from files on your hard drive or your existing music discs. The CD music database feature can automatically tag your files with track information to help you sort through your collection.

**Note:** Please reference the RecordNow On-line Help, for more information on how to Make an Exact copy, Create a Data Disc, or to Create an Audio disc with RecordNow. Please also see "Using the RecordNow software" on page 2-6 for more information.

To start RecordNow, complete the following procedure:

1. Click **Start**.
2. Click **Programs**.
3. Click **RecordNow**.
4. Click **RecordNow** to open the main recording software window.

- **Intervideo WinDVD**

This software enables you to play back DVD videos on your computer or to play video files from your hard disk drive.

**Note:** Some graphics adapters such as the FIREGL, Intergraph, and 3DLabs, do not support DVD video playback.



---

## Installation requirements

To install the CD-RW/DVD Combo II Ultrabay Slim Drive, your ThinkPad computer must contain the following requirements:

- ThinkPad system with an Combo II Ultrabay Slim Drive
- ThinkPad Advanced Dock
- ThinkPad X4 Ultrabase Dock or Dock II with a ThinkPad Slim Drive Adapter for Ultrabay 2000 option
- Microsoft Windows<sup>®</sup> XP or Microsoft Windows 2000 Professional operating system

**Note:** Lenovo offers limited support for computers with Microsoft Windows 95, Windows 98, Microsoft Windows Millennium Edition (Me), or Microsoft Windows NT<sup>®</sup> Desktop operating systems.

---

## Installing the drive

Your ThinkPad computer includes a help system, Access ThinkPad, that provides drive installation instructions specific to your computer. To correctly install the CD-RW/DVD Combo II into the Ultrabay Slim drive bay, use the instructions given in the Access ThinkPad help system.

## Chapter 2. Using the CD-RW/DVD Combo II Ultrabay Slim Drive

This section provides information on how to handle, load, and care for DVDs and CDs and how to care for your CD-RW/DVD Combo II Ultrabay Slim Drive.

---

### Before you begin

For best results, review the following guidelines before using the drive:

- Do not move your ThinkPad computer while formatting or writing a disc as this might cause data errors. Also, minimize typing while formatting or writing to a disc, as this might also cause data errors.
- Keep the ThinkPad computer on a flat surface when writing to a disc.
- Make sure the ThinkPad computer is plugged into an ac outlet when using the drive. The disc might be damaged if the battery runs out while writing to a disc.
- Turn screensavers off. Using a screensaver might interrupt the formatting and writing process.
- Do not put your ThinkPad computer into hibernation or suspend mode while writing to a disc.

**Note:** The read and write results of the drive depend upon the quality and characteristics of the DVD or CD media used.

---

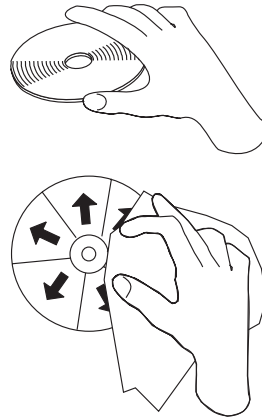
### Handling and caring for a disc

Carefully handle and clean discs, especially writable media types such as CD-R and CD-RW discs, so that they remain readable. You can prolong the life of your discs by using the following precautions:

- Always store discs in their original packaging
- Always store discs out of direct sunlight
- Always store discs away from direct heat sources
- Remove discs from the computer when not in use
- Check disc for cracks BEFORE each use
- DO NOT force discs into the computer/packaging
- DO NOT bend or flex discs

**IMPORTANT:** DO NOT use discs that are cracked.

<b>Attention:</b> Wiping a disc using a circular motion can cause data loss.
--



- Handle a disc by the edges or the center hole. Do not touch the surface of a disc.
- To remove dust or fingerprints, wipe a disc from the center to the edge with a soft, lint-free cloth.
- Do not write on the surface of a disc.
- Do not place a disc in direct sunlight.
- Do not use commercial cleaners to clean a disc.
- Do not bend a disc.

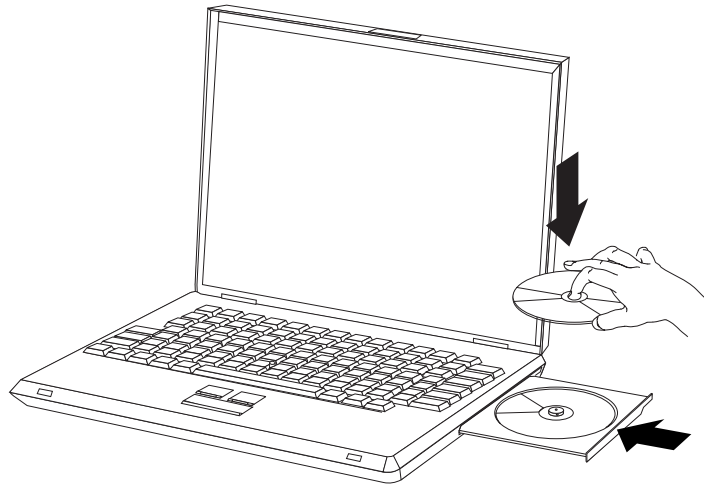
## Caring for the CD-RW/DVD Combo II Ultrabay Slim Drive

To protect your drive during operation, observe the following precautions:

- Remove the disc from the drive before moving the drive.
- Do not insert foreign objects into the drive.
- Do not stack objects on the drive.
- Do not remove the drive cover or attempt to service the drive.
- Do not operate the drive under any of the following conditions:
  - High temperature, high humidity, or direct sunlight
  - Excessive vibration, sudden shock, or inclined surface
  - Excessive dust

---

## Loading a disc



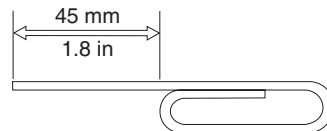
1. Press the Eject button. The tray slides out of the drive.
2. Place a disc in the tray with the label facing up.
3. Close the tray by gently pushing the tray in until it latches.

**Attention:** Do not use force or insert foreign objects to open the tray. If your tray does not open when you press the Eject button, see “Manually ejecting a disc” for more information.

---

## Manually ejecting a disc

If you press the Eject button and the tray does not slide out, turn off the computer and straighten a large paper clip to form a tool, as shown in the illustration. The straightened end must extend at least 45 mm (1.8 in.). Insert the extended end into the manual-eject hole on the front of the drive. Push the paper clip until the tray opens. Gently pull out the tray until you can remove the disc.



---

## Using the DVD function

To use the DVD function, you need to set up your computer as follows after installing the CD-RW/DVD Combo II into the Ultrabay Slim drive bay:

1. Enable the DMA setting (Windows XP and Windows 2000 users only).
2. Install WinDVD (the DVD movie player program).

**Note:** The DVD movie player is supported by Windows 2000 and later versions. You can check which version of Windows 2000 you are using by doing the following:

1. Click **Start**, move the cursor to **Settings**, and then click **Control Panel**.
2. Double-click **System**.  
Read the numbers under “System”.
  - 4.00.950B means that your version is Windows 2000 OSR2.0 or OSR2.1.

- 4.00.950C means that your version is Windows 2000 OSR2.5.

## Enabling the DMA setting

This section explains enabling the DMA setting with Windows 2000 and Windows XP:

### For Windows 2000

1. Click **Start**, move the cursor to **Settings**, and click **Control Panel**.
2. Double-click **System**.
3. Click the **Hardware** tab.
4. Click the **Device Manager** button.
5. Click **IDE ATA/ATAPI controller** to pull down the submenu.
6. Double-click **Secondary IDE**.
7. Select the **DMA is available** as the Transfer Mode.
8. Click **OK**.
9. Click **Close** to close System Properties window. A message displays, informing you that the system settings have changed.
10. Click **OK** to restart the system.

### For Windows XP

1. Click **Start**, move the cursor to **My Computer**, and click on it.
2. Click on **View system information** under System Tasks.
3. Click the **Hardware** tab.
4. Click the **Device Manager** button.
5. Click **IDE ATA/ATAPI controller** to pull down the submenu.
6. Double-click **Secondary IDE**.
7. Click the **Advanced Settings** tab.
8. Select **DMA if available** as the Transfer Mode.
9. Click **OK**.
10. Click **Close** to close the System Properties window.

## Installing WinDVD and viewing a DVD movie

To install WinDVD, go to the "Software" section of the *Software and User's Guide* CD.

After you install the CD-RW/DVD Combo II Ultrabay Slim Drive and WinDVD, you can view a DVD movie. But first you need to set the DVD region code for your DVD content.

### DVD region codes

DVD region codes help protect the contents of a DVD. The world is divided into six regions and specific content can be viewed only in the appropriate region. For example, content for Region 1 can be viewed only in the U.S. and Canada. WinDVD is also region-specific.

You can verify the region code of the content by looking at the region code symbol on the back of the content packaging.

Region code	Region
1	U.S., Canada

Region code	Region
2	Europe, Middle East, South Africa, Japan
3	Southeast Asia, Taiwan, Korea
4	Latin America, Australia, New Zealand
5	Former Soviet Union, North Africa, India
6	People's Republic of China

Start WinDVD by inserting the DVD into the drive. The region code is automatically set and you can view the movie. This is the initial setting.

After the region code has been set, if you insert a DVD with a different region code, you are prompted to change the region code. You can change the region code from your initial setting up to four times.

After the region code has been changed from its initial setting four times, it is fixed and can no longer be changed. Thereafter, you can play DVD content only from that region.

To display the region code status, click the **WinDVD Properties** button on the WinDVD user interface. The **General** tab contains this information.

## Starting WinDVD

To start WinDVD, complete the following procedure:

1. Click **Start**.
2. Click **Programs**.
3. Click **InterVideo WinDVD**.
4. Click **InterVideo WinDVD** to open the DVD movie player window.

For more information on how to play the DVD movie player, refer to the WinDVD help information on the *Software and User's Guide CD*. If you want to watch a DVD movie on your TV, refer to the online information provided with your computer.

### Notes:

1. Your computer has been configured to provide the highest quality audio and video playback obtainable with the available system resources. You can alter the default settings by changing the video resolution setting within the Control Panel. Some systems do not have enough resources to provide full-quality audio and video playback at all resolution settings. If you experience poor playback performance, adjust the resolution to a lower setting.
2. Audio or video streams are decoded by software. The audio and video subsystems need to be fully functional and enabled.

---

## Using the CD-R and CD-RW function

The CD-RW/DVD Combo II Ultrabay Slim Drive can write to both CD-R and CD-RW discs. CD-R discs cannot be erased, but can be used with standard CD-ROM drives and CD players.

You can use CD-R discs to record audio tracks, store data, archive files, and copy files from another CD.

CD-RW discs can be erased and rewritten, but can be used only with newer CD-RW-compatible CD-ROM and DVD-ROM drives. You can use CD-RW discs to back up, store, and update files or to copy files from another CD.

**Notes:**

1. CD-R discs are playable on audio CD players. CD-RW discs are not playable on most audio CD players.
2. The software included with this drive does **not** enable the drive CD-recording capabilities with DOS, Windows 3.x, or OS/2<sup>®</sup> operating systems.

For more information on using the software, refer to “Using drive letter access (DLA)” and “Using the RecordNow software.”

---

## Using drive letter access (DLA)

Drive Letter Access (DLA) is provided so that you can write data to CD-R and CD-RW media. CD-RW media can be written to many times, while CD-R media can only be formatted and written to once.

To format and write to CD-R or CD-RW media:

1. Insert a disc into the drive.
2. Double-click **My Computer**. Right-click the CD-RW/DVD-ROM Combo II drive letter.
3. Click **Format**. Formatting can take up to 90 minutes.
4. After formatting is complete, you can drag and drop files to the Multi-Burner Ultrabay Slim drive icon, or you can move files in Windows Explorer.

To make CD-R media compatible in other computers:

1. Double-click **My Computer**. Right-click the CD-RW/DVD-ROM Combo II drive letter.
2. Click **Make Compatible**.

To use UDF formatted CD-RW media in other computers, a UDF reader is included on the *User's Guide and Software CD*. To use the UDF reader, follow this procedure:

1. Insert the *User's Guide and Software CD* into the CD or DVD drive of the computer you want to use the UDF formatted discs with.
2. Click **Start**.
3. Click **Run**.
4. Type `e:\UDF\language` where *e* is the drive letter of the CD or DVD drive, and *language* is your language.
5. Click **OK**.
6. Double-click **SETUP.EXE** and follow the on-screen instructions.

**Note:** The UDF reader is only needed on systems that do not have another DLA program installed.

---

## Using the RecordNow software

RecordNow allows you to record Audio CDs, Data CDs, and copy existing CDs. Detailed information about using RecordNow is included in the RecordNow help. You can access RecordNow help by pressing **F1** inside the RecordNow menu.



To start RecordNow in Windows Me or Windows 2000, select **Start→Programs→RecordNow**.

To start RecordNow in Windows XP, select **Start→All Programs→RecordNow**.

Once RecordNow is started, select on of the following three processes:

- **Make an Exact Copy:** Select this to back up your own CDs, or make copies of CDs you have previously created. After you select this option, RecordNow will prompt you to insert your disc to be copied, and then will prompt you when to insert a blank disc.
- **Make a Music Disc:** Select this option to create an audio CD. The second screen will ask if you want to make an audio CD from MP3 and Wave files on your hard disk, or from other audio CDs. There is also a selection to make a disc for an MP3 player, which is a specially formatted data disc that can be played in stand-alone MP3 players.
- **Make a Data Disc:** Select this option to create a disc containing data files from your hard disc. If you want to add files to an appendable disc, insert it in the drive before selecting **Make a Data Disc**. You can add files and folders to the Data Disc window by Drag and Drop or by browsing your hard disk. When you are satisfied with your data CD files, press the **Burn** button. You will be prompted to insert a disc if needed, and asked whether you want to erase CD-RW media if one is inserted.
- Once RecordNow is started, you can also perform special operations:
  - Clicking on the **Favorites** button will allow you to load a previously saved audio, data, MP3, or CD image to burn a new copy.
  - Dropping an ISO or GI CD image into the files box for a data CD will record the image file directly onto the CD.
  - To make an ISO image of a CD with RecordNow, select **Copy a CD** and set the destination recorder to record file to hard disk.

**Note:** To limit the recording speed in RecordNow select "**Tools**", "**General**" "**Advanced**", and then under "Select drive speed", use the pull down menu to choose a slower speed.

---

## Backing up a CD

To copy a commercial CD, you must own the copyright or obtain permission from the copyright owner. If you do not own the copyright or do not obtain permission from the copyright owner, you might be violating copyright law and might be subject to payment of damages or other remedies. For more information on copyright law, consult your legal advisor.

---

## Problem solving

Computer problems can be caused by hardware, software, or user error. The information in this section might be useful to help you solve problems or to gather helpful information you can pass on to a service technician. You might also need to refer to your computer, operating-system, or sound-adaptor publications.

Review the following list for any problem descriptions that might fit your situation.

### **You cannot create a multi-session disc.**

Be sure that there is enough space left on the disc for another session. Writing a session requires lead-in and lead-out space (about 15 MB) in addition to the data that is recorded.

### **You cannot successfully write to a CD-R or CD-RW disc.**

Take the following actions:

1. Verify that the process is not being interrupted by a screen saver, an antivirus program, an Internet or e-mail program, or other software. Disable the functions that might interrupt the write operation.
2. Verify that the hard disk has been defragmented.
3. Consult the hard disk drive manufacturer or vendor if an older hard disk drive is conducting a thermal recalibration during a write operation.
4. Replace the CD if it is bad or scratched.
5. Reduce the recording speed.
6. Change media brands and retry.
7. RecordNow has a checkbox that you can select to disable it during recording.

### **You cannot eject a CD.**

Take the following actions after ensuring that the drive is not in the process of writing to a disc:

1. Eject the CD through software.
2. Use the Eject button.
3. Turn off the computer. Wait 45 seconds; then turn on the computer and try using the Eject button again.
4. If other methods do not work, use the manual-eject hole, using instructions given in "Manually ejecting a disc" on page 2-3.

### **You cannot read from the CD after successfully writing to it.**

Take the following actions:

1. If you can read the CD in another CD player or you can see previous sessions, the directory information might be damaged on the volume, making it unreadable. To get ideas for troubleshooting, check the documentation that comes with the software.
2. You might have a damaged CD-R or CD-RW disc. Try a new CD-R disc or CD-RW disc, or another brand of CD.
3. If you can read from a CD-RW disc in the writing drive, make sure that a UDF Reader program is installed in the computer.
4. Avoid writing at the slower 1X speed unless required by your computer.

**You cannot make a screen capture in WinDVD.**

1. Open the WinDVD side panel, and click the **Wrench icon**. Go to the Video tab. Uncheck "**Use Hardware Decode Acceleration.**"

**One or more of the sliders in the WinDVD Color side panel are grayed out.**

1. All sliders being grayed out when the player idle is normal. If one or more of the sliders is inactive when video is playing, try Step 2 or 3.
2. Open the WinDVD side panel, and click the **Wrench icon**. Go to the Video Tab. Change the state of "Use Hardware Color Acceleration."
3. Update your video driver.

The warranties provided by Lenovo Group Limited or one of its subsidiaries (called "Lenovo") in this Statement of Limited Warranty apply only to Machines you purchase for your use, and not for resale. The term "Machine" means a Lenovo machine, its options, features, conversions, upgrades or peripheral products, or any combination of them. The term "Machine" does not include any software programs, whether pre-loaded with the Machine, installed subsequently or otherwise. **Nothing in this Statement of Limited Warranty affects any statutory rights of consumers that cannot be waived or limited by contract.***

#### **What this Warranty Covers**

Lenovo warrants that each Machine 1) is free from defects in materials and workmanship and 2) conforms to Lenovo's Official Published Specifications ("Specifications") which are available on request. The warranty period for the Machine starts on the original date of installation and is specified in Part 3 - Warranty Information. The date on your invoice or sales receipt is the date of installation unless Lenovo or your reseller informs you otherwise. Unless Lenovo specifies otherwise, these warranties apply only in the country or region in which you purchased the Machine.

**THESE WARRANTIES ARE YOUR EXCLUSIVE WARRANTIES AND REPLACE ALL OTHER WARRANTIES OR CONDITIONS, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OR CONDITIONS OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SOME STATES OR JURISDICTIONS DO NOT ALLOW THE EXCLUSION OF EXPRESS OR IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. IN THAT EVENT, SUCH WARRANTIES ARE LIMITED IN DURATION TO THE WARRANTY PERIOD. NO WARRANTIES APPLY AFTER THAT PERIOD. SOME STATES OR JURISDICTIONS DO NOT ALLOW LIMITATIONS ON HOW LONG AN IMPLIED WARRANTY LASTS, SO THE ABOVE LIMITATION MAY NOT APPLY TO YOU.**

#### **What this Warranty Does not Cover**

This warranty does not cover the following:

- any software programs, whether pre-loaded or shipped with the Machine, or installed subsequently;
- failure resulting from misuse, accident, modification, unsuitable physical or operating environment, or improper maintenance by you;
- failure caused by a product for which Lenovo is not responsible; and
- any non-Lenovo products, including those that Lenovo may procure and provide with or integrate into a Lenovo Machine at your request.

The warranty is voided by removal or alteration of identification labels on the Machine or its parts.

Lenovo does not warrant uninterrupted or error-free operation of a Machine.

Any technical or other support provided for a Machine under warranty, such as assistance with "how-to" questions and those regarding Machine set-up and installation, is provided **WITHOUT WARRANTIES OF ANY KIND**.

#### **How to Obtain Warranty Service**

Warranty service may be provided by Lenovo, IBM, your reseller if authorized to perform warranty service, or an authorized warranty service provider. Each of them is referred to as a "Service Provider."

If the Machine does not function as warranted during the warranty period, contact a Service Provider. If you do not register the Machine with Lenovo, you may be required to present proof of purchase as evidence of your entitlement to warranty service.

#### **What Lenovo Will Do to Correct Problems**

Scheduling of service will depend upon the time of your call and is subject to parts availability. Service levels are response time objectives and are not guaranteed. The specified level of warranty service may not be available in all worldwide locations, additional charges may apply outside your Service Provider's normal service area, contact your local Service Provider representative or your reseller for country and location specific information.

#### 1. Customer Replaceable Unit ("CRU") Service

Lenovo will ship CRUs to you for you to install, Tier 1 CRUs are easy to install whereas Tier 2 CRUs require some technical skill and tools. CRU information and replacement instructions are shipped with your Machine and are available from Lenovo at any time on your request. You may request that a Service Provider install CRUs, at no additional charge, under the type of warranty service designated for your Machine. Lenovo specifies in the materials shipped with a replacement CRU whether a defective CRU must be returned.
