## RECALIBRATE

Your SF500 automatically recalibrates every two months. To manually recalibrate, turn off and press and hold the Heart Rate button until you hear voice prompt instructions.

## Battery Use & Safety

### DON'Ts

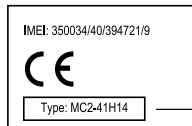
