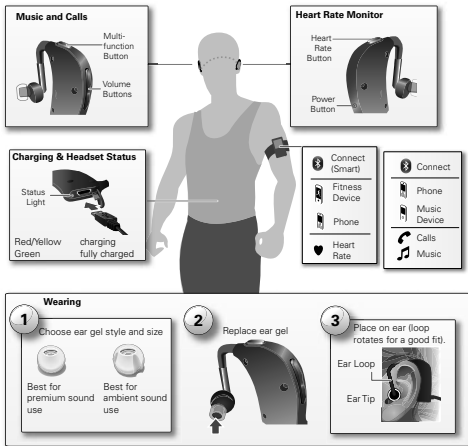

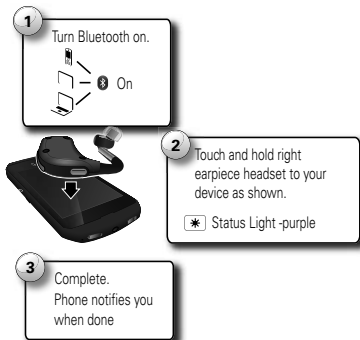

CALLS & MUSIC (NFC METHOD)

Note: Motorola SF700 is a Bluetooth® Smart heart rate monitor. Wireless connection to a Bluetooth® Smart Ready device enables transmission of heart rate data. Check your phone or device manual for Bluetooth compatibility.

Tip: Wireless heart rate connection is setup by the Bluetooth® Smart Ready device (no action is required on the SF700).

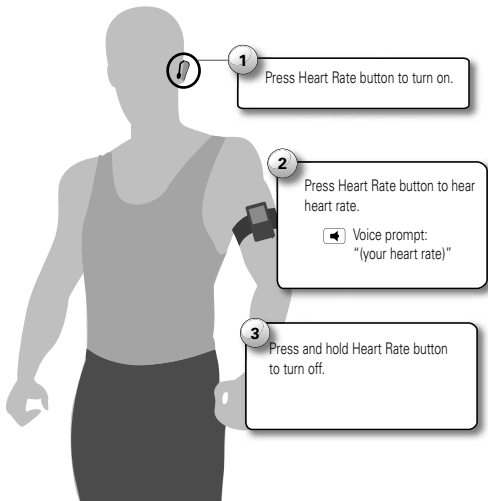

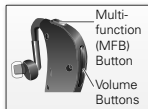

RESET AND RECALIBRATE

To reset and recalibrate your headset to factory default settings, press and hold MFB button and press Power button when turning the headset on.

Note: The headset automatically recalibrates every two months.

Battery Use & Safety

DON'Ts

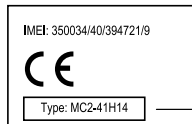
