**Tip:** Wireless heart rate connection is setup by the Bluetooth® Smart Ready device (no action is required on the SF700).





steady purple	NFC pairing mode
rapid blue/purple flashes	connecting to your call/music device
slow blue flash	in standby (wireless connection exists for calls and music on;y)
slow green flash	in standby (wireless connection exists for call, music, and heart rate monitoring)
slow yellow flash	in standby (wireless connection exists for heart rate monitoring only)
quick yellow flash	in calibrating mode
quick blue flash	incoming/outgoing call
blue pulse	on a call
quick purple flash	music paused or stopped

### **RESET AND RECALIBRATE**

To reset and recalibrate your headset to factory default settings, press and hold MFB button and press Power button when turning the headset on.

## Battery Use & Safety

#### DON'Ts

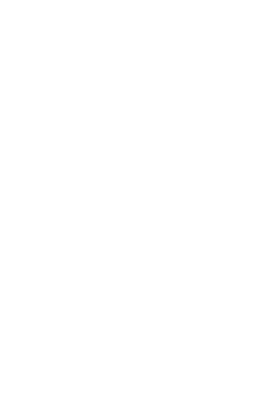
