Introduction

The Compaq V55 Color Monitor is a microprocessor-based, intelligent scanning monitor that automatically locks in on the most common display modes. This monitor operates most efficiently when used with a Compaq compatible graphics controller.



Product Features

The monitor features include the following:

- 15-inch CRT with a 13.7-inch (34.7 cm) diagonal viewable image size
- Easy-to-access front panel controls
- Universal Serial Bus (USB) pass-through connectors for use with USB peripherals (mouse, etc.)

- Plug and play capability if supported by your system
- Tilt control (image rotation) functionality
- Automatically scans all horizontal frequencies from 30 to 60 kHz and vertical frequencies from 47.5 to 125 Hz
- Supports VGA, Super VGA, and 1024×768 resolutions
- Energy Saver feature, when activated, results in a power savings of greater than 90 percent
- Macintosh-compatible timing with optional connector



If you call Compaq to place an order, be sure to have the serial number of your monitor available. The serial number is located on the front base of your monitor. This number is necessary for all purchases.

Setting Up the Monitor

To set up the monitor, ensure that the power is turned off to the monitor, computer system, and other attached devices, then follow these steps:

- 1. Place the monitor in a convenient, well-ventilated location near your computer.
- 2. Connect the monitor signal cable **1** to the 15-pin connector on the rear panel of the computer and tighten the screws.
- Be sure the signal cable aligns with the 15-pin connector. Do not force the cable onto the connector or you may damage the signal cable.



3. Connect the monitor power cord **2** to the rear panel of the monitor, then plug the other end into an electrical outlet that is easily accessible and close to the monitor.



WARNING: To reduce the risk of electric shock or damage to your equipment, do not disable the power cord grounding feature. This equipment is designed to be connected to a grounded (earthed) power outlet that is easily accessible to the operator. The grounding plug is an important safety feature.

CAUTION: Be sure that the power outlet you plug your power cord into is easily accessible and located as close to the monitor as possible. When you need to disconnect power to the equipment, be sure to unplug the power cord from the power outlet.

USB Connectors

The base of the monitor has two Universal Serial Bus (USB) connectors. Use connector **①** to connect the USB signal cable to the computer. Use connector **②** to connect USB compatible plug and play devices such as a keyboard, mouse, or joystick if supported by your computer. This feature provides USB pass-through and does not support USB host requirements.

CAUTION: This USB connector is not designed for use with high speed USB devices such as a video camera, scanner, etc. Compaq recommends connecting high speed devices directly to the computer.




These USB connectors operate as a pass-through system. Your computer must have a USB host controller installed for any USB-connected devices to operate.



CAUTION: To prevent deterioration of signal transfer or malfunction of USB devices, USB cables should not exceed the combined length of 9.75 feet (3.0 meters). This length includes both the USB signal cable and the USB peripheral cable.

Front Panel Controls Continued

Setting Contrast and Brightness controls to their maximum settings may cause the screen to appear out of focus. To correct this appearance, decrease the Brightness setting.

To adjust screen controls, complete the following procedures:

- 1. Press the desired control function button once. *Example:* if you want to make adjustments to the horizontal position (centering), press the Horizontal Position icon once.
- 2. Press the Minus and Plus buttons to change the horizontal position of the screen display.

After a period of two seconds, the adjustments are automatically saved.

Dual Function Controls

Some controls have dual functions and, when pressed in pairs, will adjust alternate screen functions. The following table identifies which controls to press together to adjust a particular function.

To make the adjustment:

- 1. Press both buttons simultaneously and hold them for 2-3 seconds, or the time indicated in the table.
- 2. Use the Minus or Plus buttons to adjust the settings for Parallelogram, V-linearity, Pinbalance, and Tilt.

The Minus and Plus buttons do not adjust the following controls: Degauss, Recall, User-Delete, and Low Power Override. To make an adjustment using these controls, simply depress the required pair of buttons for 2-6 seconds and wait two seconds before making another adjustment.

After a period of two seconds, the adjustments are automatically saved.

Allow the monitor to warm up for 30 minutes before performing the following procedures. The screen image stabilizes after a warm-up period.

Optimizing Contrast

For best results, set your screen to a dark background (such as the DOS prompt) before adjusting the following settings:

- 1. Set the brightness and contrast controls to their lowest settings.
- 2. Increase brightness until the background portions of the screen are visible, then slowly reduce brightness until the background is just extinguished.
- 3. Adjust contrast control to your preference.

Optimizing Focus

The default image size is preset at the factory. The Horizontal and Vertical Size and Position controls located on the front control panel can be used to increase the screen size beyond the default setting. However, increasing the screen image beyond the default settings may degrade the focus at the outer edge of the screen.

To enhance focus, use the lowest brightness level that gives satisfactory results in your viewing environment.

Settings that maximize contrast may not offer optimum focus, and settings that maximize focus may not offer optimum contrast.

User Modes

The video controller signal may occasionally call for a mode that is not preset if:

- You are not using a compatible Compaq graphics adapter.
- You are not using a preset mode.

If this occurs, you may need to readjust the parameters of the monitor screen by using the controls on the front panel. The monitor automatically stores the new setting, then automatically recognizes the new mode just as it does a preset mode. In addition to the 10 preset modes that can be changed and stored, there are 4 user modes that can be entered and stored. When the 4 user mode settings are exceeded, the newest setting will replace the setting closest to its own setting.

To revert back to the factory default settings, select Reset using the dual control adjustments for the front panel controls, and the factory default resolutions will replace the current operating mode with the original or factory default display mode.

Energy Saver Feature

The energy saver feature has three different modes of operation:

- Full power mode
- Suspend mode
- Sleep mode

By selecting settings in the computer's Energy Saver utility, you determine the length of inactivity before the monitor goes into suspend or sleep mode.

The following table describes the monitor energy saver levels available during the different modes of operation.

Refer to your computer manual for instructions on setting energy saver features (sometimes referred to as power management features).

The energy saver features for monitors only work when connected to computers that have energy saver features.

Care and Maintenance

This section explains how to care for and maintain your Compaq monitor during normal everyday use.

Protecting the Monitor

To protect your monitor from overheating and other types of damage, follow these suggestions:

- Use only a power source and connection appropriate for this monitor, as indicated on the marking label/back plate.
- If an extension cord or power strip is used, make sure that the cord or strip is rated for the product and that the total ampere ratings of all products plugged into the extension cord or power strip do not exceed 80% of the extension cord or strip ampere ratings limit.
- Do not overload an electrical outlet, power strip, or convenience receptacle. The overall system load must not exceed 80% of the branch circuit rating. If power strips are used, the load should not exceed 80% of the power strip input rating.
- Install the monitor near an outlet that you can easily reach. Disconnect the product by grasping the plug firmly and pulling it from the outlet. Never disconnect it by pulling the cord.
- Unplug the monitor from the wall outlet before cleaning. Do not use liquid cleaners or aerosol cleaners.
- Slots and openings in the cabinet are provided for ventilation. These openings must not be blocked or covered. Never push objects of any kind into cabinet slots or other openings.
- Do not place plants on top of the monitor. Water or dirt from the plant may fall into the vents.
- Do not drop the monitor or place it on an unstable surface.
- Do not allow anything to rest on the power cord. Do not walk on the cord.

- Keep the monitor in a well-ventilated area, away from excessive light, heat, and moisture. Keep the monitor away from high capacity transformers, electric motors, and other strong magnetic fields.
- Do not open the monitor cabinet or attempt to service this product yourself. Adjust only those controls that are covered

by the operating instructions. If the monitor is not operating properly or has been dropped or damaged, contact your Compaq authorized dealer, reseller, or service provider.

Cleaning the Monitor

To clean the monitor, follow these steps:

- 1. Turn off the monitor and the computer.
- 2. Dust the monitor by wiping the screen and the cabinet with a soft, clean cloth.

If the screen requires additional cleaning, use any antistatic CRT screen cleaner.



CAUTION: Do not use benzene, thinner, ammonia, or any volatile substance to clean the monitor screen or cabinet. These chemicals may damage the monitor screen and cabinet finish.

Shipping the Monitor

Keep the original packing box in a storage area. You may need it later if you move or ship your monitor.
