


## Scotchlok™ E-9BM Crimping Tool



## **Application**

The Scotchlok<sup>™</sup> E-9BM Crimping Tool, with adjustable jaw inserts, crimps Scotchlok<sup>™</sup> discrete type connectors and is a maintenance tool for modular splicing.

## **Selection and Installation of Jaw Inserts**

- 1. Select the jaw insert combination to be used. See Table 1.




Figure 1. Removal of jaw inserts

- 2. Remove the jaw inserts from the jaw using a screwdriver. See Figure 1.

3. Install the jaw inserts in the positions selected by pushing the tool firmly against a hard surface until they snap into position.

All Scotchlok Butt and Tap type connectors	Thick - Thick
UDW, UIB, UIR and UIY Inline connectors	Thick - Thin
All MS <sup>2™</sup> Cross-Connect Modules, all Scotchlok Inline connectors and all 4000 and 4008 Series Modular connectors	Thick-Thin
