# Introduction

The APC Smart-UPS® RT is a high-performance, uninterruptible power supply (UPS) that provides protection for electronic equipment from utility power blackouts, brownouts, sags and surges. The UPS filters small utility line fluctuations and isolates electronic equipment from large disturbances by internally disconnecting from utility line power. The UPS provides continuous power from the internal battery until utility power returns to safe levels or the battery is fully discharged.

# INSTALLATION

### Read the Safety Instruction sheet before installing the UPS.

## Unpacking

Inspect the UPS upon receipt. Notify the carrier and dealer if there is damage.

The packaging is recyclable; save it for reuse or dispose of it properly.





- Wiring must be performed by a qualified electrician.
- Adhere to all national and local electrical codes.
- Install a utility circuit breaker for input wiring, (see tables below).

- 1. Switch the UPS input circuit breaker (see A in diagram) and utility circuit breakers OFF.
- 2. Remove the input access panel, (see **B** in diagram).
- 3. Remove circular knockout.
- 4. Run appropriate size wire through the access panel, and connect to the terminal block, (Green: Ground, Brown: Hot, Blue: Neutral). **Connect the ground wire first.** Use appropriate strain reliefs, (not included).
- 5. For three-phase input, set the input phase selector switch, (see C in diagram) to "3". For single-phase input, leave the switch in the default position of "1".
- 6. Replace the access panel.

### BASIC CONNECTORS

। Serial Com	Power management software and interface kits can be used with the UPS. Use only interface kits supplied or approved by APC. Any other serial interface cable will be incompatible with the UPS connector.
Ethernet Port	Connect the UPS to the network using the Network Management Card.
EPO Terminal	Emergency Power Off terminal allows the user to connect the UPS to the central EPO system.
+ TVSS Screw	The UPS features a transient voltage surge-suppression (TVSS) screw for connecting the ground lead on surge suppression devices such as telephone and network line protectors. When connecting grounding cable, disconnect the unit from the utility power outlet.
External Battery Pack Connectors	External battery packs must be connected to these connectors located on the rear panel of the unit.

### **APC BATTERY SOLUTION**

### THIRD PARTY BATTERY SOLUTION

Batteries must be Sealed Lead-Acid type. Use 50 A, 250 VDC fuses with an Interrupt rating of  $\ge 20,000$  A.

Ensure that the external batteries are wired prior to connecting the batteries to the UPS.


Two separate, isolated 192 V battery systems are required when using a third party battery solution. One cable assembly must be wired to each 192 V battery system. Two cable assemblies are included with the UPS, one for each 192 V battery system.

#### Connect the Ground and Wire the Battery System

- 1. Connect the ground wires (included), to each battery enclosure ground and the TVSS screw on the back of the UPS.
- 2. Cut off one of the connectors on each cable assembly revealing the positive and negative wires in each cable.



- 3. Connect the positive (red), and negative (black) wires to the positive and negative terminals on each external battery system. Ensure that the proper polarities are connected.
- 4. Plug the cable connectors into the battery connector receptacles on the back of the UPS.



#### **CONNECT EQUIPMENT AND POWER TO THE UPS**

- 1. Connect equipment to the UPS.
- 2. Turn on all connected equipment. To use the UPS as a master ON/OFF switch, ensure all connected equipment is switched ON. The equipment will not be powered until the UPS is turned on.
- 3. Switch the utility circuit breaker on.
- 4. To power up the UPS press the total button on the front panel.
  - The UPS battery charges when it is connected to utility power.
  - Allow at least 24 hours for the batteries to fully charge prior to connecting equipment to the UPS.
- 5. Configure the Network Management card. Refer to the Network Management card user manual.

# TERMINAL MODE TO CONFIGURE UPS PARAMETERS AND PROGRAM THE NUMBER OF BATTERY PACKS


Terminal Mode is a menu driven interface that enables enhanced configuration of the UPS.

Connect the serial cable from the computer to the serial com connector on the back of the UPS.


Instructions for use with PowerChute® Network Shutdown software:


- 1. Open a terminal program. Example: HyperTerminal
  - From the Desktop, go to Start => Programs => Accessories => Communication =>HyperTerminal.
- 2. Double-click on the HyperTerminal icon.
  - Follow the prompts to choose a name and select an icon. Disregard the message, "...must install a modem," if it is displayed. Click OK.
  - Select the COM port that is connected to your UPS. The port settings are:
    - ✓ bits per second 2400
    - ✓ data bits 8
    - ✓ parity none
    - ✓ stop bit 1
    - ✓ flow control none
    - Press ENTER
- 3. Example for setting the number of external battery packs:
- Once the blank terminal window is open, follow these steps to enter the number of battery packs:
  - Press ENTER to initiate terminal mode. Press ENTER multiple times, until the prompt User Name: is displayed. Follow the prompts. Type slowly, waiting until each character appears on the screen prior to typing the next character.
    - Network Management card defaults:
      - User Name: apc
      - Password: apc
  - Press 1 and ENTER to select Device Manager.
    - Select the model by entering the corresponding number, then press Enter.
  - Press 3 and ENTER to select Configuration.
  - Press 1 and ENTER to select Battery.
  - Press 2 and ENTER to change the Battery Settings.
    - Type in the number of external battery packs. Number of packs: 1= 1920 VAh, 2 = 3840 VAh, 3 = 5760 VAh, etc.
  - Press 3 and ENTER to accept the changes.
  - Press ESC multiple times (5) to return to the main menu.
  - Press 4 and ENTER to log out.

# **OPERATION**



## SMART-UPS RT FRONT DISPLAY





Indicator	Description
Online	The Online LED illuminates when the UPS is drawing utility power and performing double conversion to supply power to connected equipment.
On Battery	The UPS is supplying battery power to the connected equipment.
Bypass	The Bypass LED illuminates indicating that the UPS is in bypass mode. Utility power is sent directly to connected equipment during bypass mode operation. Bypass mode operation is the result of an internal UPS fault, an overload condition or a user initiated command either through an accessory or the manual bypass switch. Battery operation is not available while the UPS is in bypass mode. Refer to <i>Troubleshooting</i> in this manual.
Fault	The UPS detects an internal fault.
X	Refer to <i>Troubleshooting</i> in this manual.
Overload	An overload condition exists. Refer to <i>Troubleshooting</i> in this manual.
Replace Battery	The battery is disconnected or must be replaced. Refer to <i>Troubleshooting</i> in this manual.

Feature	Function
Power On	Press this button to turn on the UPS. (See below for additional capabilities.)
Power Off	Press this button to turn off the UPS.

Feature	Function
Normal/Bypass	Manual bypass enables the user to manually put connected equipment into bypass mode. While in bypass mode the utility power bypasses the UPS and goes directly to the connected equipment. Battery operation is not available while the UPS is in bypass mode. Refer to <i>Troubleshooting</i> in this manual.
Cold Start	This is not a normal condition.
Test	When there is no utility power and the UPS is off, press and hold the to power up the UPS and connected equipment. The UPS will emit two beeps. During the second beep, release the button.
Self-Test	<b>Automatic:</b> The UPS performs a self-test automatically when turned on, and every two weeks thereafter, (by default). During the self-test, the UPS briefly operates the connected equipment on battery.
	Manual: Press and hold the button for a few seconds to initiate the self-test.

The self-test does not affect the voltage display. Press and hold the test button to view the utility voltage bar graph display. After a few seconds the five-LED, <i>Battery Charge</i>
	display on the right of the front panel shows the utility input voltage. Refer to the figure at left for the voltage reading (values are not listed on the UPS). The display indicates the voltage is between the displayed value on the list and the next higher value.

### **BATTERY OPERATION**

The UPS switches to battery operation automatically if the utility power fails. While running on battery, an alarm beeps four times every 30 seconds.

Press the feet button to silence this alarm. If the utility power does not return, the UPS continues to supply power to the connected equipment until the battery is fully discharged.

When two minutes of run time remain the UPS emits a continuous beeping. If PowerChute software or the Network Management card are not being used, files must be manually saved and the computer must be turned off before the UPS fully discharges the battery.

The UPS battery life differs based on usage and environment. Refer to <u>www.apc.com</u> for on battery runtimes.



#### CONNECT THE EPO (EMERGENCY POWER OFF)

The output power can be disabled in an emergency by closing a switch connected to the EPO.

Adhere to national and local electrical codes when wiring the EPO. Wiring must be performed by a qualified electrician.



The switch should be connected to a normally open switch contact. External voltage is not required; the switch is driven by 12V internal supply. In closed condition, 2mA of current are drawn

The EPO switch is internally powered by the UPS for use with non-powered switch circuit breakers.

The EPO circuit is considered a Class 2 circuit, (UL, CSA standards) and a SELV circuit (IEC standard).

Both Class 2 and SELV circuits must be isolated from all primary circuitry. Do not connect any circuit to the EPO terminal block unless it can be confirmed that the circuit is Class 2 or SELV.

If circuit standard cannot be confirmed, use a contact closure switch.

Use one of the following cable types to connect the UPS to the EPO switch:

- CL2: Class 2 cable for general use
- CL2P: Plenum cable for use in ducts, plenums, and other spaces used for environmental air.
- CL2R: Riser cable for use in a vertical run in a floor-to-floor shaft.
- CLEX: Limited use cable for use in dwellings and for use in raceways.
- For installation in Canada: Use only CSA certified, type ELC (extra-low voltage control cable).
- For installation in other countries: Use standard low-voltage cable in accordance with local regulations.

# **Battery Replacement**

See your dealer or contact APC at the Web site, <u>www.apc.com</u> for information on replacement battery modules.

### Service

If the UPS requires service do not return it to the dealer. Follow these steps:

- 1. Review the problems discussed in the *Troubleshooting* section of this manual to eliminate common problems.
- 2. If the problem persists, contact APC Customer Support through the APC Web site, <u>www.apc.com</u>.
  - Note the model number of the UPS, the serial number located on the back of the unit, and the date purchased. If you call APC Customer Support, a technician will ask you to describe the problem and attempt to solve it over the phone. If this is not possible, the technician will issue a Returned Material Authorization Number (RMA#).
  - If the UPS is under warranty, repairs are free.
  - Procedures for servicing or returning products may vary internationally. Refer to the APC Web site for country specific instructions.
- 3. Pack the UPS in its original packaging.
  - If the original packing is not available, refer to the APC Web site, <u>www.apc.com</u>, for information about obtaining a new set.
  - Pack the UPS properly to avoid damage in transit. Never use Styrofoam beads for packaging. Damage sustained in transit is not covered under warranty.

# Always DISCONNECT THE BATTERY(S) before shipping in compliance with U.S. Department of Transportation (DOT) and IATA regulations.

4. Mark the RMA# on the outside of the package.

Return the UPS by insured, prepaid carrier to the address given to you by Customer Service.


