



This video, along with the mower operator's manual and the warning messages on the mower, will significantly assist in this important education.

If you or any mower operator have not seen this video, Watch the Video, Read this **Operator's Manual**, and **Complete** the **Video Guidebook** before operating your new mower. 

A safe and careful operator is the best operator. Safety is of primary importance to the manufacturer and should be to the owner/operator. Most accidents can be avoided by being aware of your equipment, your surroundings, and observing certain precautions. The first section of this manual includes a list of Safety Messages that, if followed, will help protect the operator and bystanders from injury or death. Read and understand these Safety Messages before assembling, operating or servicing this implement. This equipment should only be operated by those persons who have read the Manual, who are responsible and trained, and who know how to do so safely and responsibly.

The Safety Alert Symbol combined with a Signal Word, as seen below, is used throughout this manual and on decals which are attached to the equipment. The Safety Alert Symbol means: "ATTENTION! BECOME ALERT! YOUR SAFETY IS INVOLVED!" The Symbol and Signal Word are intended to warn the owner/operator of impending hazards and the degree of possible injury faced when operating this equipment..

Practice all usual and customary safe working precautions and above all---remember safety is up to <u>YOU</u>. Only <u>YOU</u> can prevent serious injury or death from unsafe practices.

**CAUTION!** 

The lowest level of Safety Message; warns of possible injury. Decals located on the Equipment with this Signal Word are Black and Yellow.



**WARNING!** Serious injury or possible death! Decals are Black and Orange.



Imminent death/critical injury. Decals are Red and White. (SG-1)

Learn how to stop the tractor engine suddenly in an emergency. Never allow inexperienced or untrained personnel too operate the Tractor and Implement without supervision. Make sure the operator has fully read and understood the manuals prior to operation. (SG-4)



## WARNING!




Always maintain the safety decals in good readable condition. If the decals are missing, damaged, or unreadable, obtain and install replacement decals immediately. (SG-5)

### WARNING!



Make certain that the "Slow Moving Vehicle" (SMV) sign is installed in such a way as to be clearly visible and legible. When transporting the Equipment use the Tractor flashing warning lights and follow all local traffic regulations. (SG-6)



#### WARNING!



Operate this Equipment only with a Tractor equipped with an approved roll-over-protective system (ROPS). Always wear seat belts. Serious injury or even death could result from falling off the tractor-particularly during a turnover when the operator could be pinned under the ROPS. (SG-7)




Do not modify or alter this Implement. Do not permit anyone to modify or alter this Implement, any of its components or any Implement function.  $_{\rm (SG-8)}$ 

### DANGER!



BEFORE leaving the tractor seat, always engage the brake and/or set the tractor transmission in parking gear, disengage the PTO, stop the engine, remove the key, and wait for all moving parts to stop. Place the tractor shift lever into a low range or parking gear to prevent the tractor from rolling. Never dismount a Tractor that is moving or while the engine is running. Operate the Tractor controls from the tractor seat only. (SG-9)

## **DANGER!**



Never allow children or other persons to ride on the Tractor or Implement. Falling off can result in serious injury or death.

(SG-10)







Never allow children to operate or ride on the Tractor or Implement.



## WARNING!



Do not mount the Tractor while the tractor is moving. Mount the Tractor only when the Tractor and all moving parts are completely stopped.



#### DANGER!



Start tractor only when properly seated in the Tractor seat. Starting a tractor in gear can result in injury or death. Read the Tractor operators manual for proper starting instructions. (SG-13)



#### DANGER!



Never work under the Implement, the framework, or any lifted component unless the Implement is securely supported or blocked up to prevent sudden or inadvertent falling which could cause serious injury or even death. (SG-14)





#### WARNING!



The operator and all support personnel should wear hard hats, safety shoes, safety glasses, and proper hearing protection at all times for protection from injury including injury from items thrown by the equipment. (SG-16)





#### CAUTION!



PROLONGED EXPOSURE TO LOUD NOISE MAY CAUSE PER-MANENT HEARING LOSS! Tractors with or without an Implement attached can often be noisy enough to cause permanent hearing loss. We recommend that you always wear hearing protection if the noise in the Operator's position exceeds 80db. Noise over

85db over an extended period of time will cause severe hearing loss. Noise over 90db adjacent to the Operator over an extended period of time will cause permanent or total hearing loss. Note: Hearing loss from loud noise [from tractors, chain saws, radios, and other such sources close to the ear] is cumulative over a lifetime without hope of natural recovery. (SG-I7)

#### WARNING!



Transport only at safe speeds. Serious accidents and injuries can result from operating this equipment at unsafe speeds. Understand the Tractor and Implement and how it handles before transporting on streets and highways. Make sure the Tractor steering and brakes are in good condition and operate properly.

Before transporting the Tractor and Implement, determine the safe transport speeds for you and the equipment. Make sure you abide by the following rules:

- Test the tractor at a slow speed and increase the speed slowly. Apply the Brakes smoothly to determine the stopping characteristics of the Tractor and Implement. As you increase the speed of the Tractor the stopping distance increases. Determine the maximum safe transport speed for you and this Equipment.
- 2. Test the equipment at a slow speed in turns. Increase the speed through the turn only after you determine that it is safe to operate at a higher speed. Use extreme care and reduce your speed when turning sharply to prevent the tractor and implement from turning over. Determine the maximum safe turning speed for you and this equipment before operating on roads or uneven ground.
- Only transport the Tractor and Implement at the speeds that you have determined are safe and which allow you to properly control the equipment.



Be aware of the operating conditions. Do not operate the Tractor with weak or faulty brakes. When operating down a hill or on wet or rain slick roads, the braking distance increases: use extreme care and reduce your speed. When operating in traffic always use the Tractor's flashing warning lights and reduce your speed. Be aware of traffic around you andwatch out for the other guy. (SG-19)

### WARNING!



Never attempt to lubricate, adjust, or remove material from the Implement while it is in motion or while tractor engine is running. Make sure the tractor engine is off before working on the Implement.



### **WARNING!**



Periodically inspect all moving parts for wear and replace when necessary with authorized service parts. Look for loose fasteners, worn or broken parts, and leaky or loose fittings. Make sure all pins have cotter pins and washers. Serious injury may occur from not maintaining this machine in good working order. (SG-21)



#### WARNING!



Always read carefully and comply fully with the manufacturers instructions when handling oil, solvents, cleansers, and any other chemical agent.  $_{(SG-22)}$ 



#### DANGER!



Never run the tractor engine in a closed building or without adequate ventilation. The exhaust fumes can be hazardous to your health.

## DANGER!

KEEP AWAY FROM ROTATING ELEMENTS to prevent entanglement and possible serious injury or death. (SG-24)







Never allow children to play on or around Tractor or Implement. Children can slip or fall off the Equipment and be injured or killed. Children can cause the Implement to shift or fall crushing themselves or others. (SG-25)

## WARNING!



Do not exceed the rated PTO speed for the Implement. Excessive PTO speeds can cause Implement driveline or blade failures resulting in serious injury or death.  $_{(SG-26)}$ 

### DANGER!



**NEVER use drugs or alcohol** immediately before or while operating the Tractor and Implement. Drugs and alcohol will affect an operator's alertness and coordination and therefore affect the operator's ability to operate the equipment safely. Before operating the Tractor or Implement, an operator on prescription or over-the-counter medication must consult a medical professional regarding any side effects of the medication that would hinder their ability to operate the Equipment safely. **NEVER** knowingly allow anyone to operate this equipment when their alertness or coordination is impaired. Serious injury or death to the operator or others could result if the operator is under the influence of drugs or alcohol. (SG-27)



In addition to the design and configuration of this Implement, including Safety Signs and Safety Equipment, hazard control and accident prevention are dependent upon the awareness, concern, prudence, and proper training of personnel involved in the operation, transport, maintenance, and storage of the machine. Refer also to Safety Messages and operation instruction in each of the appropriate sections of the Tractor and Equipment Manuals. Pay close attention to the Safety Signs affixed to the Tractor and Equipment. (SG-18)

### WARNING!



Mow only in conditions where you have clear visibility in daylight or with adequate artificial lighting. Never mow in darkness or foggy conditions where you cannot clearly see at least 100 yards in front and to the sides of the tractor and mower. Make sure that you can clearly see and identify passersby, steep slopes, ditches, drop-offs, overhead obstructions, power lines, debris and foreign objects. If you are unable to clearly see this type of items discontinue mowing. (SGM-1)

## DANGER!



There are obvious and hidden potential hazards in the operation of this Mower. REMEMBER! This machine is often operated in heavy brush and in heavy weeds. The Blades of this Mower can throw objects if shields are not properly installed and maintained. Serious injury or even death may occur unless care is taken to insure the safety of the operator, bystanders, or passersby in the area. Do not operate this machine with anyone in the immediate area. Stop mowing if anyone is within 100 yards of mower. (SGM-2)



### DANGER!



All Safety Shields, Guards and Safety devices including (but not limited to) - the Deflectors, Chain Guards, Steel Guards, Gearbox Shields, PTO integral shields, and Retractable Door Shields should be used and maintained in good working condition. All safety devices should be inspected carefully at least daily for missing or broken components. Missing, broken, or worn items must be replaced at once to reduce the possibility of injury or death from thrown objects, entanglement, or blade contact. (SGM-3)



## **DANGER!**



The rotating parts of this machine have been designed and tested for rugged use. However, the blades could fail upon impact with heavy, solid objects such as metal guard rails and concrete structures. Such impact could cause the broken objects to be thrown outward at very high velocities. To reduce the possibility of property damage, serious injury, or even death, never allow the cutting blades to contact such obstacles. (SGM-4)

#### WARNING!



Extreme care should be taken when operating near loose objects such as gravel, rocks, wire, and other debris. Inspect the area before mowing. Foreign objects should be removed from the site to prevent machine damage and/or bodily injury or even death. Any objects that cannot be removed must be clearly marked and carefully avoided by the operator. Stop mowing immediately if blades strike a foreign object. Repair all damage and make certain rotor or blade carrier is balanced before resuming mowing. (SGM-5)



## WARNING!



Many varied objects, such as wire, cable, rope, or chains, can become entangled in the operating parts of the mower head. These items could then swing outside the housing at greater velocities than the blades. Such a situation is extremely hazardous and could result in serious injury or even death. Inspect the cutting area for such objects before mowing. Remove any like object from the site. Never allow the cutting blades to contact such items. (SGM-6)

### WARNING!



Mow at the speed that you can safely operate and control the tractor and mower. Safe mowing speed depends on terrain condition and grass type, density, and height of cut. Normal ground speed range is from 0 to 5 mph. Use slow mowing speeds when operating on or near steep slopes, ditches, drop-offs, overhead obstructions, power lines, or when debris and foreign objects are to be avoided. (SGM-7)

## WARNING!



Avoid mowing in reverse direction when possible. Check to make sure there are no persons behind the mower and use extreme care when mowing in reverse. Mow only at a slow ground speed where you can safely operate and control the tractor and mower. Never mow an area that you have not inspected and removed debris or foreign material. (SGM-

#### WARNING!



Do not put hands or feet under mower decks. Blade Contact can result serious injury or even death. Stay away until all motion has stopped and the decks are securely blocked up. (SGM-9)

## DANGER!



Replace bent or broken blade with new blades. NEVER ATTEMPT TO STRAIGHTEN OR WELD ON BLADES SINCE THIS WILL LIKELY CRACK OR OTHERWISE DAMAGE THE BLADE WITH SUBSEQUENT FAILURE AND POSSIBLE SERIOUS INJURY FROM THROWN BLADES. (SGM-10)

#### DANGER!



Always disconnect the main PTO Driveline from the Tractor before performing service on the Mower. Never work on the Mower with the tractor PTO driveline connected and running. Blades or Drivelines could turn without warning and cause immediate entanglement, injury or death. (SRM-3)

#### DANGER!



Make sure the PTO shield is installed when using PTO-driven equipment. Always replace the PTO shield if it is damaged or missing. (S3PT-8)



#### DANGER!




There are obvious and hidden potential hazards in the operation of this Mower. REMEMBER! This machine is often operated in weeds and in heavy grass. The Blades of this Mower can throw objects if shields are not properly installed and maintained. Serious injury or even death may occur unless care is taken to insure the safety of the operator, bystanders, or passersby in the area. Do not operate this machine with anyone in the immediate area. Stop mowing if anyone is within 100 yards of mower. (SFM-1)



#### DANGER!



All Safety Shields, Guards and Safety devices including (but not limited to) - the Discharge Deflectors, Steel Guards, Gearbox Shields, Belt Shileds, and PTO Shields should be used and maintained in good working condition. All safety devices should be inspected carefully at least daily for missing or broken components. Missing, broken, or worn items must be replaced at once to reduce the possibility of injury or death from thrown objects, entanglement, or blade contact. (SFM-2)



### DANGER!



Rotary Mowers are capable under adverse conditions of throwing objects for great distances (100 yards or more) and causing serious injury or death. Follow safety messages carefully



### STOP MOWING IF PASSERSBY ARE WITHIN 100 YARDS UNLESS:

- -Mower Deck Shielding, and Discharge Deflector are installed and in good, working condition;
- -Mower section is running close to and parallel with the ground without exposed Blades;
- -Passersby are outside the existing thrown-object zone;
- -All areas have been thoroughly inspected and all foreign material such as rocks, cans, glass, and general debris has been removed.

NOTE: Where there are grass and weeds high enough to hide debris that could be struck by the blades, the area should be: inspected and large debris removed, mowed at an intermediate height, inspected closely with any remaining debris being removed, and mowed again at desired final height. (This will also reduce power required to mow, reduce wear and tear on the Mower drivetrain, spread cut material better, eliminate streaking, and make the final cut more uniform.) (SFM-3)

## WARNING!



Relieve hydraulic pressure prior to doing any maintenance or repair work on the Implement. Place the Implement on the ground or securely blocked up, disengage the PTO, and turn off the tractor engine. Push and pull the Remote Cylinder lever in and out several times prior to starting any maintenance or repair work. (S3PT-9)



#### WARNING!



Never leave Tractor and Implemented unattended while the implement is in the lifted position. Accidental operation of lifting lever or a hydraulic failure may cause sudden drop of unit with injury or death by crushing. To properly park the implement when disconnecting it from the tractor, lower the stand and put the retaining pin securely in place, or put a secure support under the A-Frame. Lower the implement carefully to the ground. Do not put hands or feet under lifted components. (SPT-1)

#### WARNING!



Be particularly careful when transporting the Implement with the Tractor. Turn curves or go up hills only at a low speed and using a gradual steering angle. Rear mounted implements move the center of gravity to the rear and remove weight from the front wheels. Make certain, by adding front ballast, that at least 20% of the tractor's weight is on the front wheels to prevent rearing up, loss of steering control or Tractor tip-over. Slow down on rough or uneven surfaces to prevent loss of steering control which could result in property damage or possible injury. Do not transport unless 3-Point lift lever is fully raised and in the latched transport position. Dropping implement in transport can cause serious damage to the tractor and/or Implement and possibly cause the operator or others to be injured or killed. (S3PT-2)

### WARNING!



Do not let the Blades turn when the Mower Deck is raised for any reason, including clearance or for turning. Raising the Mower deck exposes the Cutting Blades which creates a potentially serious hazard and could cause serious injury or even death from objects thrown from the Blades. (SRM-7)



#### WARNING!



The rotating parts of this machine continue to rotate even after the PTO has been turned off. The operator should remain in his seat for 60 seconds after the brake has been set, the PTO disengaged, the tractor turned off, and all evidence of rotation has ceased. (3PT-10)

"Wait a minute...Save a life!"

#### DANGER!



Do not operate this Equipment with hydraulic oil leaking. Oil is expensive and its presence could present a hazard. Do not check for leaks with your hand! Use a piece of heavy paper or cardboard. High-pressure oil streams from breaks in the line could penetrate the skin and cause tissue damage including gangrene. If oil does penetrate the skin, have the injury treated immediately by a physician knowledgeable and skilled in this procedure. (SG-15)



## **DANGER!**





This section is intended to explain in broad terms the concept and effect of federal laws and regulations concerning employer and employee equipment operators. This section is not intended as a legal interpretation of the law and should not be considered as such.

**Employer-Employee Operator Regulations** 

U.S. Public Law 91-596 (The Williams-Steiger Occupational and Health Act of 1970) OSHA

#### This Act Seeks:

"...to assure so far as possible every working man and woman in the nation safe and healthful working conditions and to preserve our human resources..."

#### **DUTIES**

Sec. 5 (a) Each employer-

- (1) shall furnish to each of his employees employment and a place of employment which are free from recognized hazards that are causing or are likely to cause death or serious physical harm to his employees;
- (2) shall comply with occupational safety and health standards promulgated under this Act.
  - (b) Each employee shall comply with occupational safety and health standards and all rules, regulations and orders issued pursuant to this Act which are applicable to his own actions and conduct.

#### **OSHA Regulations**

OSHA regulations state in part: "At the time of initial assignment and at least annually thereafter, the employer shall instruct every employee in the safe operation and servicing of all equipment with which the employee is, or will be involved."

#### **Employer Responsibilities:**

To ensure employee safety during Tractor and Implement operation, it is the employer's responsibility to:

- 1. Train the employee in the proper and safe operation of the Tractor and Implement.
- 2. Require that the employee read and fully understand the Tractor and Implement Operator's manual.
- 3. Permit only qualified and properly trained employees to operate the Tractor and Implement.
- 4. Maintain the Tractor and Implement in a safe operational condition and maintain all shields and guards on the equipment.
- 5. Ensure the Tractor is equipped with a functional ROPS and seat belt and require that the employee operator securely fasten the safety belt and operate with the ROPS in the raised position at all times.
- 6. Forbid the employee operator to carry additional riders on the Tractor or Implement.
- 7. Provide the required tools to maintain the Tractor and Implement in a good safe working condition and provide the necessary support devices to secure the equipment safely while performing repairs and service.
- 8. Require that the employee operator stop mowing if bystanders or passerbys come within 100 yards.

### Child Labor Under 16 Years of Age

Some regulations specify that no one under the age of 16 may operate power machinery. It is your responsibility to know what these regulations are in your own area or situation. (Refer to U.S. Dept. of Labor, Employment Standard Administration, Wage & Home Division, Child Labor Bulletin #102.)





## Be a Responsible Operator





For safe operation of your equipment, you must be a responsible operator. A responsible operator must clearly understand the written instructions supplied by the manufacturer, be trained-including actual operation of the equipment and know the safety rules and regulations for the worksite.

Drugs can and alcohol will affect an operator's alertness and coordination and therefore affect the operator's ability to operate the equipment safely. An operator should **NEVER** use drugs which affect alertness, judgement

## Safety Management of Hazards and Risks

In addition to equipment design and configuration, HAZARD CONTROL and ACCIDENT PREVENTION are dependent upon the owner's and operator's awareness, concern, prudence, and proper training in the operation, transport, maintenance and storage of equipment.

SAFETY MANAGEMENT OF HAZARDS AND RISKS IS ESSENTIAL TO RESPONSIBLE OWNERS AND OPERATORS OF TRACTORS AND MOWERS.

REVIEW THE FOLLOWING SAFETY MANAGEMENT OF LISTED HAZARDS AND RISKS:

## Thrown Object Hazard

POSSIBLE THROWN OBJECT INJURY RISKS EXIST FOR MOWER OPERATORS AND BYSTANDERS DURING MOWER OPERATIONS FROM THE FOLLOWING:

DISCHARGED OBJECTS (ROCKS, DEBRIS, BROKEN MOWER BLADES, BLADE BOLTS, CABLES, CHAINS, WIRE, ETC ....) FROM THE MOWER.

## **Equipment Protective Devices And Recommended** Safety Practices

The mower deck and protective devices cannot prevent all objects or debris from escaping the blade enclosure area in every mowing condition. It is possible for objects to escape and travel several hundred (300) feet.

## RECOMMENDED SAFETY PRACTICES

Read manufacturer's operator manual(s) for recommended operating safety practices. Explain the practices to users or operators who cannot read. TO HELP PREVENT SERIOUS INJURY OR DEATH FROM OBJECTS

STRIKING OPERATOR OR OTHER PERSONS DO THE FOLLOWING:



• Keep bystanders several hundred (300) feet from mowing area.





## Tractor and Mower Rollover or Overturn Hazards and Risks

A POSSIBLE ROLLOVER OR OVERTURN INJURY RISK EXISTS TO MOWER OPERATORS DURING MOWING OPERATIONS FROM THE FOLLOWING:

- ROUGH TERRAIN, STEEP SLOPES, HOLES, BUMPS, RUTS, ROCKS, STUMPS OR OTHER OBSTRUCTIONS THAT COULD OVERTURN TRACTOR AND MOWER.
- EXCESSIVE GROUND SPEEDS FOR THESE TERRAIN CONDITIONS.

## Equipment Protective Devices and Recommended Safety Practices

When possible remove stumps, stones, etc.. or mark them and other obstructions clearly to avoid upsets, breakdowns, and dangerous driving conditions. Use extreme care to maintain control over the equipment when operating in these terrain conditions.

#### RECOMMENDED-TRACTOR ROPS

A tractor equipped with ROPS or enclosed ROPS cab and seat belt for operator safety is essential for additional operator protection when operating mower in these terrain conditions.

## RECOMMENDED-TRACTOR STABILITY ADJUSTMENTS


Read the tractor operator's manual for adjustments to increase tractor stability:

- · Adding front and rear wheel weights or ballast.
- · Adjusting wheel spacing to maximum width .
- Adding off-side counter ballast to side-mounted and boom mowers.

## **Mounting Tractor Safely**

## Before mounting:

· Clean shoes and wipe hands.

### During mounting and dismounting:

- · Use handholds and step plates.
- · Never grab steering wheels or controls for handholds.
- Never mount or dismount from a moving tractor.

## Tractor And Mower Controls Safety Test

### Before starting:

- Fasten and adjust seat belt on your ROPS-equipped tractor.
- · Check parking brake for engagement.
- Check PTO disengagement.
- Check all controls for Neutral or Park position.
- · Warn others in area before starting tractor.
- Follow tractor manufacturer's recommended starting procedures.

#### After starting:

- Check all instruments, gauges and indicator lights for normal operation.
- Check all tractor controls, steering and brakes for proper function.
- · Repair improperly functioning tractor before using.
- Raise and lower mower for driveline bottoming out or engagement problems.
- Check your equipment for excessive vibration and unusual poisses







## Mowing In Reverse Safety

Avoid mowing in reverse direction when possible.

## Wing Or Boom Type Mower Overhead Obstruction Hazards and Risks

Check for overhead obstructions with raised wings or boom-type mowers to avoid serious injury or death by contact with:

- Electrical power lines.
- · Low tree limbs.
- Other overhead obstructions.


## Wing And Side Mount Mowers Safety

When mowing with wing and side-mount mowers:


Raised wing positions reduces shielding protection and increases the thrown object and blade contact hazard risks.

To avoid serious injury or death by thrown objects or blade contact from raising and lowering wings during mowing operations:

- Do not mow with bystanders in mowing area.
- Be sure no one is near mower while raising or lowing wings.
- Keen the exposed rotating wing blade time to a practical minimum during

# Mowing Uneven Terrain Safely

The tractor and mower stability is reduced on slopes and uneven terrain.

You can prevent tractor and mower overturns and maintain equipment stability control by:

- Reviewing tractor and mower operator's manuals for operating safety practices on slopes and uneven terrain conditions. Explain the practices to those users and operators who cannot read.
- Avoiding extremely steep slope operations.
- Using extreme care to maintain control over your equipment when operating in these conditions.
- Increasing tractor stability by adding wheel weights and increasing wheel spacing (Refer to tractor operator's manual for recommendations)
- Using ROPS and seat-belt-equipped tractor for operator safety during mowing operations.
- Maintaining minimum ground speed.
- · Making wide and gradual turns.
- Avoiding sudden starts, stops, and turns when operating up, down, or across slopes.
- Not raising rear-mount or side-mount mowers or mower wings from the ground during these operations .
- Keeping alert for holes, bumps, ruts, rocks, stumps or other obstructions that could overturn tractor and mower.

# While transporting on public roads:

- Obey all local traffic regulations.
- Approach intersections with caution.
- Observe speed and traffic control signs.
- Avoid panic stops and sharp turns.







# **Dismounting Tractor Safely**

# Before dismounting tractor:

- Use proper equipment shutdown practice for your safety.
- Lower implement to the ground, stop engine and PTO, set brakes, allow all moving parts to stop, and remove key before dismounting from tractor.
- Never dismount from moving equipment.
- · Never jump from machines.
- · Dismount carefully.
- Check for slippery steps
- · Keep feet and hands away from controls.
- · Use handholds and steps during dismount.
- Face machine and use 3 point contact (2 hands, 1 foot or 2 feet, 1 hand).

# Safety - During Maintenance **DEMONS**

# Maintenance Safety

Do the following for your safety before performing any maintenance, repairs or service procedures:

- Follow proper equipment shutdown practice.
- Wear all the protective clothing and personal safety devices necessary to safely perform the job.
- Refer to your manufacturer's manuals for proper maintenance, repair and service procedures. Explain the procedures to those users and operators who cannot read.

Stored energy sources (electrical, mechanical, hydraulic, pneumatic, chemical, thermal, etc..) must be either locked, blocked, relieved, disconnected, stopped, secured, neutralized, controlled or reduced to a practical minimum before any maintenance, repair or service procedures can be done safely.

# Some basic safety practices to prevent potential injuries from energy releasing sources:

- Disengage PTO before shutting off engine.
- Place controls in PARK or NEUTRAL before shutting off engine.
- Set parking brake or block wheels.
- Allow all moving parts to stop.
- · Lower mower to ground.
- Lower wings to ground on wing-type mowers.
- · Shut off tractor engine.
- Lock ignition and remove key.
- Look and listen for evidence of moving parts before opening shields.
- Securely support or block-up mower before working underneath mower or other lifted components.
- Securely support, block-up, or lock-up mower wings with locking devices before working near or underneath a wing-type mower.
- Relieve hydraulic system pressure by moving controls several times in all directions.
- Relieve pressure before disconnecting or disassembling any pressurized system.
- Block or relieve spring pressure before disassembling any spring-loaded mechanism.
- Securely support or block up any elevated machine component before working on it.
- · Avoid flames, sparks, or smoking near any fuels.

# Mower Manufacturer Parts and Your Safety

Most mower manufacturers use special fasteners and specially designed parts to meet mowing operations requirements.


Critical safety-related parts (Self-locking blade bolts, blades, pins, shields or other special items) have specific strength, design and fit requirements for the make and model mower you are using.

Modifications or repair parts not approved by the mower manufacturer can cause serious safety hazard exposure risk to you and others.

# TO AVOID SERIOUS INJURY OR DEATH FROM UNAPPROVED PARTS OR MODIFICATIONS:


- Do not substitute common hardware for self-locking blade bolts or other special part items.
- Do not substitute blades, pins, shields or other critical safety-related parts.
- Do not use grade 5 or 8 bolts to replace grade 2 shear bolts.

FOLLOW THE SAFETY PRACTICE OF ALWAYS CHECKING THE MOWER FOR PROPER FUNCTION AFTER ALL ADJUSTMENTS REPAIRS OR SERVICE.














# INTRODUCTION

This Rotary Mower is designed with care and built with quality materials by skilled workers. Proper assembly, maintenance, and operating practices, as described in this manual, will help the owner/operator get years of satisfactory service from the machine.

The purpose of this manual is to familiarize, and instruct. The Assembly Section instructs the owner/operator in the correct assembly of the Mower using standard and optional equipment. The Parts Listing section is designed to familiarize the owner/operator with replaceable parts on the Mower. This section provides exploded assembly drawings of each mower component illustrating each piece and the corresponding part number.

Careful use and timely service saves extensive repairs and costly downtime losses. The Operation and Maintenance Sections of the manual train the owner/operator how to work the Mower correctly and attend to appropriate maintenance. The Trouble Shooting Guide helps diagnose difficulties with mower and offers solution to the problems.

Safety is of primary importance to the owner/operator and to the manufacturer. The first section of this manual includes a list of Safety Messages, that, if followed, will help protect the operator and bystanders from injury or death. Many of the Safety Messages will be repeated throughout the manual. The owner/operator/dealer should know these Safety Messages before assembly and be aware of the hazards of operating this mower during assembly, use, and maintenance. The Safety Alert Symbol combined with a Signal Word, as seen below, is intended to warn the owner/operator of impending hazards and the degree of possible injury faced when operating this machine.





# **ASSEMBLY**

The Breeze Mowers will attach to most tractors with Cat. I Three-Point hitch and a 540 RPM PTO. **DO NOT EXCEED HORSEPOWER RECOMMENDATIONS.** 

DANGER!

Operating with PTO speed over 540 RPM can cause excessive vibration with subsequent machine failure which can cause serious injury or even death. Never exceed 600 RPM.

### **DEALER SET-UP INSTRUCTIONS**

Assembly of this mower is the reponsibility of the Rhino dealer. The mower should be delivered to the owner completely assembled, lubricated, and adjusted for normal cutting conditions.

Set up mower as received from the factory with these instructions. Remove mower from carton. Open parts box and lay parts out to make location easy. Refer to parts lists and exploded view drawings for more detail.

This mower is shipped partially assembled. Assembly will be easier if components are aligned and loosely assembled before tightening hardware.

**CAUTION!** 

Always use personal protection devices such as eye and ear protectors during assembly.



### A-FRAME ATTACHMENT

Attach the rear brace bars (18) to the lugs on the rear of the deck with m12 x 40mm bolts (19), m12 flatwasher (20), m12 lockwasher (21), & m12 locknuts (22). Attach the A-Frame bars (2) to the lugs on the front of the deck

with the same hardware as the rear. Attach the other end of the A-Frame bars at the top and outside the rear brace bars (18) and top link (14) with 3/4" x 5-1/2" bolt (17), bushing (15) & 3/4" nut (11). Top link pin (16) is placed through the open end set of holes of the top linkand secured with hair clip pin. See **Figure 1**.






# **ASSEMBLY**

### **CASTER WHEEL ATTACHMENTS**

Axle arm (1) comes attached to deck weldment. Install caster fork assemblies by installing spacers (2) onto fork shaft (4) and inserting into tube with bushings on each end of axle arm (1). Place spacers (5) on top of tube and retain using pin (3). See **Figure 2.** 




### **DRIVELINE ATTACHMENT - To Gearbox**

- 1. Insert yoke onto splined shaft. Twist red collar on end yoke.
- 2. Slide yoke (with collar twisted) onto gearbox shaft.
- 3. Move yoke back and forth until collar clicks and locks the yoke in place.

The safe operation of this machine is the responsibility of the operator. The operator should be familiar with the cutter and tractor and all safety practices before starting operation. This mower is designed for lawn or grass mowing. It is not designed for rough conditions or heavy weed mowing. It is equipped with suction type blades for best results in lawn mowing.

Always operate tractor PTO at 540 rpm.

This section provides information for attaching mower to tractor and preparing it for field operation. Review this data prior to tractor hookup and operation.

#### TRACTOR PREPARATION

### **Ballast**

An implement code of has been assigned to the fully-equipped Lift-Type Breeze mower so that you can determine the tractor front ballast requirements. Refer to your tractor Operator's manual for the code number and ballasting requirements.

## WARNING!



Do not operate with less than 20% of tractor's gross unballasted mass on front wheel with mower in transport position.

# **Wheel Treads**

Tractor wheel tread spacing should be increased when working on inclines or rough ground to reduce the possibility of tipping.

#### Stabilizer Bars or Sway Blocks

Use stabilizer bars or sway blocks to prevent side sway of the mower.

#### **Drawbar**

Shorten or remove the tractor Drawbar so it will not interfere with the up and down movement of the Mower.

## **WARNING!** Do not get between Tractor and Mower when engine is running!



### **ATTACHING MOWER TO TRACTOR - LIFT TYPE**

This mower is designed for 540 RPM PTO, CAT I hitch tractor only. Back the tractor up to the mower so that the lower Draft Arms are in alignment with the mower lower lift pins. Stop the engine, lock the brakes or place the tractor in park. Connect the tractor and Stabilizer Bars to the lower lift pins. Adjust the Top link so it will pin to the top holes in the A-Frame or into holes in floating top link.

#### DRIVELINE ATTACHMENT TO TRACTOR

- 1. Grab and twist black collar on end of attaching yoke toward cutter.
- 2. Slide yoke (with collar displaced) onto PTO shaft.
- 3. Move yoke back and forth until locking collar clicks and locks the yoke in place.

#### WARNING!



When attaching PTO yoke to tractor PTO shaft, it is important that spring activated locking collar rotates freely and is seated in groove on PTO shaft.

#### WARNING!

Be sure PTO shielding and all other shielding is installed and is in good condition.



**IMPORTANT:** When raising cutter to transport height, be sure there is clearance between the cutter and driveline. Damage will result if driveline hits cutter deck.

#### **CUTTING HEIGHT ADJUSTMENT**

### WARNING!



Avoid personal injury! Be sure tractor engine is off, key is removed, and ALLOW BLADES TO STOP TURNING before dismounting to make adjustments.

**Important:** Avoid very low cutting heights. Striking the ground with blades gives the most damaging shock loads a cutter can encounter and will cause damage to cutter and drive.

- 1. Using the tractor, raise the mower off the ground and support under it with secure blocking so not to let the mower drift down during maintenance.
- 2. Holding wheel and yoke assembly up, remove quick-lock pin from top of gauge wheel spindle. Position full length spacers and half spacer as required. All spacers on top of spindle tube allows for approximately 1" cutting height. Adjustments range form 1" to a maximum of 4-3/8" in 3/8" increments.
- 3. Adjust the length of tractor top links, so that when lifting the mower the front will raise 1"- 2" inches before rear gauge wheels leave the ground. This will allow the flexible hitch to pivot and allow the mower to follow the contour on uneven ground.

# **STARTING & STOPPING CUTTER**

Power for operating cutter is supplied from tractor PTO. Refer to your tractor manual instructions for engaging and disengaging the PTO. Always engage the PTO at low engine rpm. Always operate at recommended PTO speed of 540 RPM. Learn how to stop tractor and cutter quickly in case of an emergency.

**IMPORTANT:** Stop cutter and tractor immediately upon striking an obstruction. Inspect the cutter and repair any damage before resuming operation. **Do not disengage PTO when engine is at full PTO RPM. Always idle engine before disengaging PTO.** 

# **WARNING!**



Avoid personal injury. When attempting to stop a tractor which does not have live PTO, the momentum created by the blade carrier of a rotary cutter can cause the tractor to be pushed forward. DO NOT operate this cutter unless tractor has live or independent PTO.

Operation Section 4-3

To commence operation, reduce engine speed and engage the tractor PTO. Before starting to cut, gradually increase engine speed to develop full PTO speed.

Enter the area to cut with the cutter operating at PTO speed and, if it becomes necessary to temporarily regulate engine speed during operations, increase or decrease the throttle gradually.

To transport, disengage the PTO, raise full transport height.

#### **CUTTING SPEED**

Proper ground speed for cutting will depend upon the height, type, and density of material to be cut.

Normally, ground speed will range from 1-1/2 to 3 mph. Tall dense material should be cut at low speed while thin medium height material can be cut at a faster ground speed.

#### **CUTTING TIPS**

Always operate PTO at recommended RPM when cutting. This is necessary to maintain proper blade speed and to produce a clean cut.

Under certain conditions, tractor tires may roll some grasses down and prevent them from being cut at the same height as the surrounding area. When this occurs, reduce the tractor ground speed, but maintain PTO RPM. The lower speed will permit grasses to be at least partially rebound and be cut. Taking a partial cut and/or reversing the direction of travel may also produce a cleaner cut.

As often as possible, stop mowing when other people are passing by. Although the Mower is shielded to prevent objects from being thrown out by the blades, no one shield device is 100% effective. The operator has greater knowledge of the dangers of being around this Mower while it is operational than the person on the street.

# WARNING!



Avoid personal injury. Pick up all rocks and other debris before cutting. Enter new areas carefully. Cut material higher the first time to allow cutter to clear unseen objects. Never assume an area is clear. Always check.

Extremely tall grass should be cut twice. Raise cutter and cut twice the desired height. Cut the second time at desired height at 90 degrees to first pass.


Remember, sharp blades produce cleaner cuts and use less power.

Before cutting, analyze the area to determine the best cutting procedure. Consider the height and type of material and the terrain type: hilly, level or rough.

Grass is best cut when it is dry. Mowing wet grass can cause plugging resulting in grass clumps behind the mower.

Grass should be mowed frequently as shorter clippings deteriorate faster.

**The grass is discharged** to the rear and slightly to the right. To keep clippings of to streets and sidewalks mow two to three passes clockwise as shown in **Figure 1**.

## **DETACHING & STORING**

Lower the mower to the ground. Park the tractor with the transmission in the correct gear (Automatic Transmission-- Neutral). Set the parking brake, shut off the engine, and remove the key. Wait until the PTO stops rotating before getting down from the tractor.

Disconnect the driveline from the tractor PTO and store it to prevent it from contacting the ground.

Always reinstall the master shield over the tractor PTO shaft. This shield should always remain in place except when connecting or disconnecting driveline.

#### BEFORE OPERATING OR TRANSPORTING THIS MOWER

Always display this SMV emblem (FIGURE 2) on the rear of the tractor transporting this mower where it is clearly visible to oncoming traffic. Prominent display of this symbol will help the operator avoid accidents which could cause injury or possibly death.



Raise mower to full transport or until driveline just hits deck at front. If distance between colored tape and outer shield tube is 1-9/16 or less, drive tubes should be shortened per **Figure 4**.

always maintain 1-9/16 clearance when operated in shortest working position. shorten inner and outer guard tubes equally. Shorten inner and outer sliding profiles by the same amount that the shield tubes were shortened. Round off all sharp edges and remove burrs. Grease sliding profiles. **Figure 4**.



#### FRONT GAUGE WHEEL INTERFERENCE CHECK

Do not operate mower until this interference check has been performed. If you change tractors, you must perform the check for that mounting.

Raise mower with tractor hydraulics to maximum height of tractor lift.

Pivot both front gauge wheels forward and check that there is clearance between gauge wheels and tractor tires.





Figure 5 - Front Gauge Wheel Clearance

If there is interference, you must restrict tractor three point lift height so mower cannot be raised beyond set point. **FIGURE 5**. Adjust tractor top link length to maximize clearance.



## **LUBRICATION INFORMATION**

Do not let excess grease collect on or around parts, particulary when operating in sandy areas. The illustrations below shows lubrication points. The chart gives the frequency of lubrication in hours, based on normal operating conditions. Severe or unusual conditions may require more frequent lubrication. **Figure 1.** 

Use an SAE multi-purpose, lithium-type grease for all locations shown. Be sure to clean the fitting thoroughly before using grease gun. Failure to maintain proper lubrication will result in damage to U-joints, gearbox, and/or driveshaft.



# **GEARBOX**

The Gearboxes have been filled with lubricant to the Test Plug Level prior to shipment. However, you should check the oil level at Test Plug before operating, and frequently thereafter.

The gearbox should not require additional lubricant unless the box is cracked or a seal is leaking. It is recommended that the oil level plug be removed after every 8 to 10 hours of operation and oil added until it runs out Test Plug hole. The Test Plug is located on the back of the Gearbox. Filler Plug is located on top back of Gearbox. Figure 2.




Recommended lubricant is NLGI 000 Grease, Rhino P/N 00765444 with a one quart capacity.

NOTE: Overfilling the Gearbox will cause pressure to build up and cause Oil Seals to leak.

**ATTENTION:** If the Gearbox suddenly starts making an unusual noise, stop at once, check for leaks, and refill Gearbox as required.

# **GAUGE WHEEL ASSEMBLIES**

Gauge wheels are equipped with bushings which require grease daily. Grease Fittings are provided in the Wheel Hub and Gauge Wheel Pivot . Grease after 8 hours of use. **FIGURE 3.**

#### DRIVELINE LUBRICATION

Grease Fittings are located on the Cross Assembly of each U-Joint and on the telescoping tubes. Grease the U-Joint after each 8 hours of use. Figure 4. Do not force grease through the Needle Cup Assemblies.



The telescoping PTO shaft inside the shielding must be lubricated daily. Figure 4.

Disconnect driveline from tractor and pull halves apart. Insert grease into outer profile cavity on half attached to gearbox and spread evenly. Install driveline halves together.

Reconnect driveline to tractor. Raise and lower cutter after applying grease to spread over joint working area.



When attaching PTO yoke to tractor PTO shaft, it is important that the spring-activated locking twist collar rotates freely and locking ball are seated on the groove on PTO shaft. A loose yoke could slip off and result in personal injury or damage to cutter.

# **BLADE SPINDLE LUBRICATION**

Blade spindles must be lubricated daily (every 8 hrs). Access lubrication fitting through hole in outer sheilds and in center gearbox mounting. Each spindle has vent hole in top just under drive pulley and must be lubricated enough each time to force small amount of grease out. **NOTE:** Do not over lube as excess grease may get on belt drive.

## **BLADE SERVICING**

Inspect blades before each use to determine that they are properly installed and in good condition. Replace any blade that is bent, excessively nicked, worn, or has any other damage. Small nicks can be ground out when sharpening.


Use only original equipment blades on this cutter. They are made of special heat-treated alloy steel. Substitute blades may not meet specification and may fail in a hazardous manner that could cause injury.

#### **BLADE SHARPENING**

Always sharpen both cutting edges of each blade at the same time, the same amount, to maintain balance. Follow original sharpening pattern as shown. Do not sharpen blade to a razor edge, but leave a 1/32" blunt edge. Do not sharpen back side of blade. **Figure 6.** 

WARNING!

Avoid personal injury. Always block the cutter up to prevent it from falling when the blades and/ or carrier are being serviced.



**NOTE:** Always check blades for balance after sharpening. Grind heavy end to obtain proper balance.

## **BLADEREMOVAL**

Hold the end of blade using heavy leather gloves and remove left hand threaded bolt.

## **BLADE INSTALLATION**

Install washer on blade bolt, insert bolt into blade, insert seal protector washer over blade bolt and then thread bolt into spindle shaft. **NOTE:** Blade bolt has left hand threads. Tighten blade bolt to 70 ft. lbs. torque. Use heavy leather gloves during tightening process to hold blade and wrench.

Shut off mower and tractor. Loosen all four nuts (1) on gearbox slide plate (2). Loosen jam nut (3) on tension adjustment bolt (4). Tighten adjustment bolt until belt deflection along front of belts is 3/4" with approximately 10 pounds applied to center of length. **DO NOT OVERTIGHTEN.** Tighten jam nut and nuts on Gearbox slide plate.



Ensure that right-hand belt is in the lower groove of gearbox sheave and that left-hand belt is in the upper groove of gearbox sheave. ## **STORAGE**

Your rotary mower represents an investment from which you should get the greatest possible benefit. Therefore, when the season is over, the cutter should be thoroughly checked and prepared for storage so that a minimum amount of work will be required to put it back into operation for the next season. The following are suggested storage procedures:

- 1. Thoroughly clean the cutter.
- 2. Lubricate the cutter as covered in Maintenance Section.
- 3. Tighten all bolts and pins to the recommended torque.
- 4. Check the cutter for worn or damaged parts. Make replacements immediately.
- 5. Store the cutter in a clean, dry place with the cutter housing resting on blocks.
- 6. Use spray touch-up enamel where necessary to prevent rust and maintain the appearance of the cutter.

## PROPER TORQUE FOR FASTENERS

The chart lists the correct tightening torque for fasteners. When bolts are to be tightened or replaced, refer to this chart to determine the grade of bolts and the proper torque except when specific torque values are assigned in manual text.

**NOTE:** These values apply to fasteners as received from supplier, dry or when lubricated with normal engine oil. They do not apply if special graphited or molydisulphide greases or other extreme pressure lubricants are used. This applies to both UNF fine and UNC coarse threads.



# **BLADE SPINDLE INSTRUCTIONS - Figure 9**

- 1. Remove grease fitting (9), nut (8), and washers (7), from spindle shaft (3).
- 2. Support spindle housing (1) on flange and press shaft through bearings.
- 3. Reomve bearings from housing and shaft.

## **ASSEMBLY**

- 1. Press new bearings (2) into housing with seal to outside in each bearing. NOTE: Be sure spacer (5) is between bearings when installing last bearing.
- 2. Place seal protector (4) and one washer (6) onto shaft and insert into lower bearing. Place shaft (3) on flat surface and press on inner race of upper bearing using hollow pipe or tube. NOTE: Place washer (6) on top bearing and press against it to avoid damaging bearing seal.

#### 2. REMEDIES AND PROCEDURES.

- 2.01. This limited warranty is not effective unless the Purchaser returns the Registration and Warranty Form to Manufacturer within 30 days of purchase.
- 2.02. Purchaser claims must be made in writing to the Authorized Dealer ("Dealer") from whom Purchaser purchased the goods or an approved Authorized Dealer ("Dealer") within 30 days after Purchaser learns of the facts on which the claim is based.
- 2.03. Purchaser is responsible for returning the goods in question to the Dealer.
