

For Products Purchased In The U.S.A.
Cobra Electronics Corporation warrants that its Cobra GMRS radio(s), and the component pathereof, will be free of defects in workmanship and materials for a period of one year from the date of first consumer purchases. This warranty may be enforced by the first consumer purchaser, provided that the product is utilized within the U.S.A.

Cobra will, without charge, repair or replace, at its option, defective GMRS radio(s), products or component parts upon delivery to the Cobra Factory Service department, accompanied by more of the date of first consumer purchase, such as a duplicated copy of a sales receipt.
