F to SMB Adapter Cable, 10-Pack: SRD-FSMB-10

Introduction

The SRD-FSMB-10 is a package of ten adapter cables, each used to adapt an RG-6 cable with F-connector to the SMB type antenna input connector on a Crestron[®] XM or SIRIUS[®] satellite radio tuner. Each adapter cable is three feet in length, composed of lightweight, small diameter cable to reduce stress at the SMB jack on the tuner.

Installation

Attach the F-male connector from the antenna to the F-female connector on the SRD-FSMB cable.

Plug the SMB-plug into the SMB-jack on the radio.

CAUTION: Do not pull on the cable to remove the SMB-plug from the radio. Always pull on the connector with a twisting motion. Damage to the adapter will result if the cable is pulled.

Authorized returns must be shipped freight prepaid to CRESTRON, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. CRESTRON reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- 3. Return freight charges following repair of items under warranty shall be paid by CRESTRON, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

CRESTRON Limited Warranty

CRESTRON ELECTRONICS, Inc. warrants its products to be free from manufacturing defects in materials and workmanship under normal use for a period of three (3) years from the date of purchase from CRESTRON, with the following exceptions: disk drives and any other moving or rotating mechanical parts, pan/tilt heads and power supplies are covered for a period of one (1) year; touchscreen display and overlay components are covered for 90 days; batteries and incandescent lamps are not covered.

CRESTRON is not liable for any claim made by a third party or made by the purchaser for a third party.

CRESTRON shall, at its option, repair or replace any product found defective, without charge for parts or labor. Repaired or replaced equipment and parts supplied under this warranty shall be covered only by the unexpired portion of the warranty.

Except as expressly set forth in this warranty, CRESTRON makes no other warranties, expressed or implied, nor authorizes any other party to offer any warranty, including any implied warranties of merchantability or fitness for a particular purpose.
