

SAFETY INFORMATION

WARNING: This product contains and/or generates chemicals known to the State of California to cause cancer or birth defects, or other reproductive harm.

IMPORTANT: Read this owner's manual carefully and completely before trying to assemble, operate, or service this fireplace. Improper use of this fireplace can cause serious injury or death from burns, fire, explosions, electrical shock, and carbon monoxide poisoning.

ADANGER: Carbon monoxide poisoning may lead to death!

This fireplace is a vented product. This fireplace will not produce any gas leakage into your home if properly installed This fireplace must be installed by a qualified (certified or licensed) service person. If this unit is not properly installed by a qualified service person gas and/or carbon monoxide leakage (spillage) can occur.

Carbon Monoxide Poisoning: Early signs of carbon monoxide poisoning resemble the flu, with headaches, dizziness, or nausea. If you have these signs, the fireplace may not have been installed properly. **Get fresh air at once!** Have fireplace inspected and serviced by a qualified service person. Some people are more affected by carbon monoxide than others. These include pregnant women, people with heart or lung disease or anemia, those under the influence of alcohol, and those at high altitudes.

Propane/LP and Natural Gas: Propane/LP and natural gases are oderless. An odor-making agent is added to the gas. The odor helps you detect a gas leak. However, the odor added to the gas can fade. Gas may be present even though no odor exists.

Make certain you read and understand all warnings. Keep this manual for reference. It is your guide to safe and proper operation of this fireplace.

AWARNING: Any change to this fireplace or its controls can be dangerous.

- 1. This appliance is only for use with the type of gas indicated on the rating plate. This appliance is not convertible for use with other gases unless a certified kit is used.
- 2. For a propane/LP fireplace, do not place propane/LP supply tank(s) inside any structure. Locate propane/LP tank(s) outdoors. To prevent performance problems, do not use propane/LP fuel tank of less than 100 lbs. capacity.
- 3. If you smell gas:
 - · shut off gas supply
 - do not try to light any appliance
 - do not touch any electrical switch; do not use any phone in your building
 - immediately call your gas supplier from a neighbor's phone. Follow the gas supplier's instructions
 - if you cannot reach your gas supplier, call the fire department.
- 4. Never install the fireplace
 - in a recreational vehicle
 - in windy or drafty areas where curtains or other combustible (flammable) objects can make contact with the fireplace front
 - in high traffic areas

- 5. This fireplace reaches high temperatures, Keep children and adults away from hot surfaces to avoid burns or clothing ignition. Fireplace will remain hot for a time after shutdown. Allow surfaces to cool before touching.
- 6. Carefully supervise young children when they are in the room with fireplace.
- Do not modify this fireplace under any circumstances. Any parts removed for servicing must be replaced prior to operating fireplace.
- 8. Turn fireplace off and let cool before servicing, installing, or repairing. Only a qualified service person should install, service or repair this fireplace. Have fireplace inspected annually by a qualified service person.
- You must keep control compartments, burners, and circulating air passages clean. More frequent cleaning may be needed due to excessive lint and dust from carpeting, bedding material, etc. Turn off the gas valve and pilot light before cleaning fireplace.
- 10. Have venting system inspected annually by a qualified service person. If needed, have venting system cleaned or repaired. See *Cleaning and Maintenance*, page 20.
- 11. Keep the area around your fireplace clear of combustible materials, gasoline, and other flammable vapor and liquids. Do not run fireplace where these are used or stored. Do not place items such as clothing or decorations on or around fireplace.
- 12. Do not use this fireplace to cook food or burn paper or other objects.
- 13. Do not use any solid fuels (wood, coal, paper, cardboard, etc.) in this fireplace. Use only the gas type indicated on the nameplate.
- 14. This appliance, when installed, must be electrically grounded in accordance with local codes or, in the absence of local codes, with the *National Electric Code, ANSI/NFPA 70*, or the *Canadian Electric Code, CSA C22.1*.
- 15. Do not use fireplace if any part has been exposed to or under water. Immediately call a qualified service person to arrange for replacement of the unit.
- 16. Do not operate fireplace if any log is broken or missing.
- 17. Do not use a blower insert, heat exchanger insert, or other accessory not approved for use with this fireplace.
- Do not operate fireplace with glass door removed, cracked, or broken.
- 19. Provide adequate clearances around air openings.

NOTICE: This product is intended only as a supplement to your central heating system and is not to be installed as a primary source of heat. You may use this product for emergency heating during a power outage.




Figure 1 - B-Vent Fireplace

LOCAL CODES

Install and use fireplace with care. Follow all local codes. In the absence of local codes, use the current *National Fuel Gas Code ANSI Z223.1/NFPA 54** (USA) or the current *CSA-B149.1 Installation Code* (Canada).

PRODUCT FEATURES

These are a few facts that can help you understand and enjoy your vented decorative fireplace:

- The (V)CB36(N,P)(E) series of vented decorative fireplaces may be recessed into an exterior chase, an interior flush wall enclosure or a framed-in corner installation.
- Models (V)CB36(N,P) are equipped with a millivolt gas control system that does not require electricity to operate. A piezo ignitor is provided to light the pilot without using matches or lighters.
- Models (V)CB36(NE/PE) are equipped with an electronic ignition system that requires 120VAC to operate. An electrode ignitor automatically lights the pilot flame when the fireplace is turned on.
- These fireplaces can accept any approved 4" B-Type venting system and must be terminated vertically through the roof using a listed type vent cap only. See venting instructions on pages # and # for proper venting requirements.
- These vented fireplaces require indoor air for combustion and must be installed in a room of sufficient size to provide adequate fresh air for safe and proper operation. The room intended for installation must be of sufficient size to meet the requirements for an unconfined space as defined in the *National Fuel Gas Code*, *ANSI Z223.1/NFPA 54*, *Section 5.3*, *Air for Combustion and Ventilaton*. If sufficient air for combustion is not available a make-up air kit model AK4 may be required to provide outside air to this appliance. Check your local codes as to specific requirements for make-up air.
- This fireplace may be installed in any room of the house provided all local codes and these installation instructions are followed.

PRE-INSTALLATION PREPARATION LOCATION AND SPACE REQUIREMENTS




Figure 2 - Common Fireplace Locations

Determine the safest and most efficient location for your DESA direct-vent fireplace. Make sure that rafters and wall studs are not in the way of the venting system. Coose a location where the heat output is not affected by drafts, air conditioning ducts, windows or doors. Figure 2 shows some common locations. Be aware of all restrictions and precautions before deciding the exact location for your fireplace and termination cap.

When deciding the location of your fireplace, follow these rules:

- Do not connect this fireplace to a chimney flue servicing a separate solid-fuel burning fireplace or appliance.
- Do to high temperatures, do not locate this fireplace in high traffic areas, windy or drafty areas, or near furniture or draperies.
- Proper clearances must be maintained.




Figure 3 - Fireplace Bottom Dimensions

- If your fireplace is to be installed directly on carpeting, vinyl tile, or any combustible material other than wood, it must be installed on a metal or wood panel extending the full width and depth of the fireplace. See Figure 3.
- Only trim kits supplied by DESA shall be used in the installation of this fireplace, see Accessories, page 33.

- Do not install aftermarket vent dampers. Manual or Auto matic vent dampers are not approved for use with this appliance.
- Your fireplace is designed to be used in zero clearance installations. Wall or framing material can be placed directly against any exterior surface on the back, sides, or top of your fireplace, except when clearances are required from flue vent pipe. See Clearances on page 5.
- If recessed into a wall, you can avoid extra framing by positioning your fireplace against an already existing framing member.
- A hearth extension is not required with this appliance. If one is installed, it is for austhetic purposes only and does not have to meet standard requirements for hearth extensions.
- If you plan on installing a television or entertainment center recessed above your fireplace, it is recommended that you maintain a minimum 18" above the top of louver opening.
- When locating the termination cap, it is important to observe the minimum vent height and clearances required under code, see *Venting Installation Instructions*, page 7.
- · Do not recess termination cap into a wall or siding.
- You may paint the termination cap with 450°F (232°C) heatresistant paint to coordinate with the exterior finish.

PACKAGING AND REMOVAL

The (V)CB36 vented decorative gas fireplaces are packaged with:

- one box containg a 4-log set located on the burner in the firebox.
- one bag containing the owner's manual with installation instructions, operator's guide, and warranty information.
- one bag of glowing ember material.
- one bag of vermiculite hearth treatments.

Remove the shrinkwrap securing the 2 carton trays to the unit. Lift the top carton tray off and remove the four corner posts. Discard the bottom tray once the unit is moved into position.

Note: To prvent damage to ceramic logs and glass panels you may want to remove them before positioning and framing the unit. To access firebox, see Hearth Access and Assembly, page ##.

CLEARANCES

Minimum clearances to combustibles for the fireplace are as follows:

Back, and sides 0" (0 mm)

Perpendicular walls 10" (254 mm)

Floor 0" (0 mm)

Ceiling to louver opening 36" (914 mm)

Front 36" (914 mm)

Top 0" (0 mm)

B-Vent Surfaces 1" (26 mm) (See venting instructions

for specifics on vent clearances.)

Mantel Clearances (See - Mantel Clearances for specific

clearances to combustible mantels.)

Combustible material with a maximum thickness of 5/8" (16 mm) may be flush with the top and sides of the front face of the fireplace.

FRAMING AND FINISHING

Figure 5 shows typical framing of this fireplace. Figure 6 shows framing for corner installation. All minimum clearances must be met.

For overall unit dimensions, framing allowances, and vent collar locations, see *Unit Dimensions*, **Figure 7** on page 6.

For available accessories for this fireplace, see *Accessories* on page 33. If you are using a seperate combustible mantel piece, refer to **Figures 8** and **9** for proper height and clearances. You can install a noncombustible mantel at any height above the fireplace opening. *Note:* Non-combustible mantels may discolor!




Figure 4 - Unpacking Fireplace




Figure 5 - Framing Clearances for Flush, Wall Installation




Figure 6 - Framing Clearances for Corner Installation




Figure 7 - (V)CB36 Unit Dimensions

MANTEL CLEARANCES




Figure 8 - Side Clearances for Combustible Mantels

Figure 8 shows projected mantel depths at various heights above the top of the louver opening. Figure 7 shows the minimum allowable distances from various mantel components in relation to the both sides of the fireplace opening.

WARNING: When finishing appliance, do not overlap combustible materials onto the black front face. Brick, tile, or other non-combustible materials may be applied to the face provided that any fireplace openings are not blocked and gaps in the material used and the face are sealed with a non-combustible caulking.




Figure 9 - Clearances for Combustible Mantels

INSTALLATION PRECAUTIONS

NOTICE: Failure to follow these instructions will void the warranty.

- · Wear gloves and safety glasses for protection
- · Use extreme caution when using ladders or when on roof tops
- · Be aware of electrical wiring locations in walls and ceilings

The following actions will void the warranty on this product:

- Installation of any damaged venting component
- Unautorized modification of the venting system (Do not cut or alter vent components)
- Installation of any component part not manufactured or approved by DESA.
- Installation other than as instructed by these instructions

WARNING: Read all instructions completely and thoroughly before attempting installation. Failure to do so could result in serious injury, property damage or loss of life.

WARNING: B-type vent pipe airspace clearance to combustibles is 1" on all sides. Where the vent pipe passes through a vertical wall a listed thimble approved for use with B-type vent must be used.

VENTING INSTALLATION

A 4" B-type venting system must be connected to the appliance for venting to the outside of the building.

The following section is provided as a guide to install a standad B-type vent installation.

Standing codes requirements concerning B-type vent installations may vary within your state, province or local codes juristdition. Therefore, it is recommended that you check with your local building code authority for specific requirements or in absence of local codes, follow Section 7.0 of the current *National Fuel Gas Code NFPA No. 54/ANSI Z223.1* or in Canada with *CAN/CSA B149 for Category I systems using double wall B-1 vent pipe.*

This gas appliance must be vented to the outdoors only and may not be terminated into an attic space or into a chimney flue servicing a solid-fuel burning appliance.

This appliance may be vented through a manufactured chimney liner system if all are listed, inspected and approved by local codes and/or building authorities.




Figure 10 - Typical B-Vent Configuration

The examples shown in Figure 10 are typical of most B-vent installations and code practices.

WARNING: This gas fireplace and vent assembly must be vented directly to the outside. The venting system must NEVER be attached to a chimney serving a separate solid fuel burning apppliance.

VENTING INSTALLATION Continued

Example 1: Shows the minimum allowable system height and lateral offset for a 60° degrees or greater inclination. Code specifies that offsets at 60° degrees or greater are considered horizontal and must follow the 75% percent rule for lateral to total certical system height. Codes also allows only one offset in the total system when at 60° degrees or greater. The total vertical height in this example represents the minimum height of 8 feet and therefore the allowable lateral is 6 feet when the 75% percent rule applies. If the lateral length must exceed 75% then the system must be sized in accordance with the Category I venting tables.

Example 2: Shows multiple offsets each at 45° degrees of inclination. Multiple offsets are permitted if they do not exceed 45° degrees of inclination. The total lengths of the two offsets are not required to meet the 75% percent rule.

Example 3: Shows a single offset at 45° degrees of inclination and therefore the lateral length at 10 feet of offset does not have to meet the 75% percent allowable rule.

In each case the offsets must be supported and firestops must be positioned wherever the vent must pass through a sub-floor, ceiling joist or an attic overhang. The vent pipe must terminate vertically into a listed type vent cap and extend a sufficient height through an approved roof flashing, roof jack or a roof thimble. At all points the listed clearances must be maintained.

Vent terminations must be located in accordance with height and proximity rules of NFPA No. 54 or CAN/CSA B149. These rules apply to vents at 12 in. diameter or less and require a minimum height in accordance with the roof pitch and a minimum of 8 ft. distance from a vertical wall or obstruction (see **Figure 11**).

If venting horizontally through a side wall becomes necessary, a listed thimble approved for use with B-type vent must be used. Check with your local codes before venting through a side wall.

Some codes areas allow the use of existing B-type vent systems if the system is at or above the recommended diameter of the flue.

The flue connection must be made using listed B-type connectors and the existing system must be code inspected for damage and proper installation.

It is not recommended that this appliance be common vented with and existing gas burning appliance. However, if it becomes necessary to common vent the appliance, the venting system must be sized and configured in accordance with the common venting guides Appendix G of the current *National Fuel Gas Code NFPA No. 54/ANSI Z223.1* and in Canada with *CAN/CSA B149*.


Note: Before connecting this appliance to an existing vent system or a common venting system consult with your local architect planner, or building official.

CHECKING FOR PROPER VENTING

After completing and checking the electrical, gas and vent connections, follow the lighting instructions and allow the main burner to run for approximately 5 minutes. Hold a match or butane lighter flame, near the opening between the glass and the fireplace face and play it along the entire length of the opening (Smoke may also be used). Proper venting will tend to draw flame or smoke into the appliance. Improper venting, escaping or spillage of burned gas, is indicated when the match flickers or goes out. See **Figure 12**.

Smoke will also tend to disperse away from the appliance.

If the appliance is not venting properly, shut it off and notify your installer or a qualified service agency to inspect the venting system.

ELECTRICAL SUPPLY CONNECTION

CAUTION: Disconnect the electrical power to the supply circuit before attempting to connect or service this appliance.

A pre-wired junction box receptacle with strain relief is provided on the right side of the cabinet for hard wiring the unit to a 15 Amp, 120VAC, 60Hz grounded branch circuit. If the installation demands that the electrical supply be connected from the left side, the entire receptacle box can be relocated to the left side by following these instructions:

Note: If you do not need to relocate the junction box, to connect the electric supply follow steps 8 through 11 only:




Figure 13 - Relocating Junction Box Receptacle and Electrical Supply Connection

- 1. Remove the 2 screws and outer cover with strain relief bushing on the right side of the cabinet (see **Figure 13**).
- 2. Remove inner retaining screw on the junction box mounting tab.
- 3. Slide the junction box up until the screw mounting tab is lined up to the notch in the outer cabinet.
- 4. Swing the junction box out and slip the retaining flange out through the slot in the outer cabinet.
- Remove the two screws and outer cover on the left side of the outer cabinet.
- 6. Reinsert the junction box retaining flange through the slot now on the left side and swing the screw mounting tab back through the notch as before.
- 7. Slide the junction box down till the mounting tab holes line up and replace the inner retaining screw.
- 8. With the junction box cover removed, pull the end of 3-wire Romex supply line through the universal strain relief bushing on the cover. (see **Figure 13**).
- Strip back the outer Romex to about 4" and connect the black, white and green wires accordingly using 3 wire nut connectors.
- 10. Tuck the tailing wires into the junction box and replace the junction box cover using the 2 remaining screws.
- 11. Tighten the adjustment on the universal stran bushing to secure the Romex sheathing and complete the supply connection.

WARNING: This appliance, when installed must be electrically grounded in accordance with local code or in the absence of local code, with the current National Electric Code, ANSI/NFPA 70, or the Canadian Electric Code, CSA C22.1.

WIRING DIAGRAMS

NOTICE: This appliance is equipped with a vent safety shutoff switch which will shut down the appliance in case of a venting problem. Do not bypass the vent safety shutoff switch. If the appliance should shut down, have a qualified installer, service agency, or your gas supplier inspect the vent before operating.

CAUTION: label all wires prior to disconnection when servicing controls. Wiring errors can cause improper and dangerous operation. Verify proper operation after servicing.




Figure 14 - Millivolt Ignition Wiring Diagram




Figure 15 - Electronic Ignition Wiring Diagram

INSTALLING OPTIONAL CONTROLS

INSTALLING OPTIONAL WALL MOUNT SWITCH - GWMS2




Figure 16 - Connecting Remote Receiver or Wall Switch to the Gas Control Valve

- Connect one terminal of 15 ft. wire from the wall switch to the male connector on the high limit harness. Connect remaining wire terminal to the TH terminal on the valve. Make sure that the wire terminals are in the positions on the unit as pictured in Figure 16. If wires are not connected as shown the switch will not work.
- Route the 15 ft. wire through hole openings with bushings provided on either side of the fireplace cabinet.
- Connect one bare wire end to each of the terminals of the GWMS2 wall switch.
- 4. Install the wall switch and cover in the wall.

IMPORTANT: Do not use any other wire than that provided with the GWMS2 wall switch kit. Do not exceed 15 ft. of distance from the valve connection. Using wire of higher gage or turns or exceeding the minimum distance will increase resistance at the control valve causing unreliable performance of the fireplace controls.

INSTALLING OPTIONAL WIRELESS HAND-HELD REMOTE CONTROL - MODEL HRC100

Installing Remote Receiver

- 1. Open bottom louver and locate the switch bracket on the right
- Locate the battery clip mounted on the back of the receiver. Slide a 9-volt alkaline battery (not included) through the clip




Figure 17 - Attaching Alkaline Battery to Receiver

- 3. Attach the terminal wires to the battery. (see **Figure 17**).
- Connect one wire from receiver to the male connector on high limit harness and one to "TH" on control valve (see Figure 16).
- 5. Locate the two plastic mounting clips provided with the kit.




Figure 18 - Mounting Remote Receiver to Bracket

- 6. Use the clips to mount the receiver on remote mounting bracket. as shown in **Figure 18.**

Installing 9-Volt Alkaline Battery in Hand-Held Remote Control Unit

- 1. Remove battery cover on back of remote control unit.




Figure 19 - Installing Battery in Hand-Held Control Unit (HRC100 Series)

- 2. Attach terminal wires to a 9-volt alkaline battery (not included). Place battery into the battery housing. (see **Figure 19**).
- 3. Replace battery cover onto remote control unit..

INSTALLING OPTIONAL WIRELESS REMOTE CONTROL - MODEL WRC (Electronic Ignition)

Installing and Activating the Remote Receiver

- 1. Open bottom louver and locate the plug receptacle. The plug receptacle is located either on the right or left side of cabinet.




Figure 20 - Connecting WRC Remote Control Electronic

- 2. The WRC model receiver does not require a battery. The receiver can be installed by first plugging the short extension cord into the fireplace receptacle. Then plug the receiver unit into the extension cord. Finally plug the ignition module plug into the receiver unit (see **Figure 20**).




Figure 21 - Installing Battery into Back of Handset

- Activate the remote handset battery by removing the insulating tab on the back of the handset (see Figure 21). The battery is included pre-installed.
- 4. Once the battery is activated the unit is ready to use.
- 5. Replace the bottom louver panel.

HIGH ALTITUDE INSTALLATION

Your DESA direct-vent fireplace has been tested and approved in the USA for elevations from 0-2000 feet (610 m) and in Canada at elevations from 0-4500 feet (1372 m).

When installing a non-high altitude fireplace at an elevation above 2000 feet (610 m) (in the USA), you may need to decrease the input rating by changing the existing burner orifice to a smaller size. Reduce input 4% for each 1000 feet (305 m) above sea level. Check with your local gas company for proper derate procedure and orifice size.

When installing this fireplace in Canada at an elevation above 4500 feet (1372 m), Check with local or provincial code authorities.

Consult your local gas company to help determine the proper orifice for your location.

For assistance with any high altitude installation contact DESA's Customer Service Department at 1-866-672-6040.

GAS SUPPLY AND PIPING

CHECK GAS TYPE

Use proper gas type for the fireplace unit you are installing. If your gas supply is not correct, do not install fireplace. See retailer where you purchased the fireplace for proper fireplace according to your gas type or to purchase gas conversion kit (see *Accessories*, page 33).

INSTALLING GAS PIPING TO FIREPLACE

▲ WARNING: A qualified service person must connect fireplace to gas supply. Follow all local codes.

ACAUTION: For propane/LP units, never connect fireplace directly to the propane/LP supply. This heater requires an external regulator (not supplied). Install the external regulator between the fireplace and propane/LP supply.




Figure 22 - External Regulator with Vent Pointing Down (Propane/LP Only)

INSTALLING GAS PIPING TO FIREPLACE (Cont.)

Installation Items Needed

Before installing fireplace, make sure you have the items listed below:

- external regulator (when Propane/LP gas is supplied)
- piping (check local codes)
- sealant (resistant to propane/LP gas)
- equipment shutoff valve *
- test gauge connection *
- sediment trap
- tee joint
- pipe wrench
- approved flexible gas line with gas connector (if allowed by local codes)
- *A CSA design-certified equipment shutoff valve with 1/8" NPT tap is an acceptable alternative to test gauge connection. Purchase the CSA design-certified equipment shutoff valve fromyour retailer.

For propane/LP connection only, the installer must supply an external regulator. You must reduce incoming gas pressure to between 11 and 14 inches of water column. If you do not reduce incoming gas pressure, fireplace regulator damage could occur. Install external regulator with the vent pointing down as shown in **Figure 22**, page 11.

Pointing the vent down protects it from freezing rain or sleet.

CAUTION: Use only new, black iron or steel pipe. Internally-tinned copper tubing may be used in certain areas. Check your local codes. Use pipe of 1/2" inside diameter or greater to allow proper gas volume to fireplace. If pipe is too small, undue loss of volume will occur.




Figure 23 - Gas Connection

Installation must include an equipment shutoff valve, union and plugged 1/8" NPT tap. Locate NPT tap within reach for test gauge hook up. NPT tap must be upstream from fireplace (see **Figure 23**).

IMPORTANT: Install main gas valve (equipment shutoff valve) in an accessible leation. The main gas valve is for turning on or shutting off the gas to the appliance.

Check your building codes for any special requirements for locating equipment shutoff valve to fireplaces.

Apply pipe joint sealant lightly to male NPT threads. This will prevent excess sealant from going into pipe. Excess sealant in pipe could result in clogged fireplace valves.

WARNING: Use pipe joint sealant that is resistant to liquid petroleum (LP) gas.

CONNECTING FIREPLACE TO GAS SUPPLY

Installation Items Needed

- 3/4" and a 7/8" open end wrench or adjustable wrench
- sealant (resistant to propane/LP gas, not provided)
- 1. Remove lower lower door panel by lifting up unit disengaged and swing forward and out of the locating slots at the bottom.
- Route flexible gas line (provided by installer) from equipment shutoff valve to fireplace. Route flexible gas supply line through one of the access holes on each side of the fireplace cabinet.




Figure 24 - Connecting Flexible Gas Line to Millivolt Valve

- 3. Attach flexible gas line from gas supply to the 1/2" flare fitting provided on the control valve (see **Figure 24**).
- 4. Check all gas connections for leaks. See *Checking Gas Connections*, page 13.

CHECKING GAS CONNECTIONS

WARNING: Test all gas piping and connections, internal and external to unit, for leaks after installing. or servicing. Correct all leaks at once.

WARNING: Never use an open flame to check for a leak. Applynoncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

Pressure Testing Gas Supply Piping System Test Pressures In Excess of 1/2 PSIG (3.5 kPa)

- 1. Disconnect fireplace and its individual equipment shutoff valve from the gas supply piping system. Pressures in excess of 1/2 psig (3.5 kPa) will damage fireplace gas regulator.
- Cap off open end of gas pipe where equipment shutoff valve was connected.
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas fireplace or opening main gas valve located on or near gas meter for natural gas fireplace, or by using compressed air.
- 4. Check all joints of gas supply piping sytem. Apply noncorrosive leak detection fluid to all joints at once.
- Reconnect fireplace and equipment shutoff valve to gas supply Check reconnected fittings for leaks.

Test Pressures Equal To or Less Than 1/2 PSIG (3.5 kPa)




Figure 25 - Equipment Shutoff Valve

- 1. Close equipment shutoff valve (see Figure 25).
- Pressurize supply piping system by either opening propane/LP supply tank valve for propane/LP gas fireplace or opening main gas valve located on or near gas meter for natural gas fireplace, or by using compressed air.




Figure 26 - Checking Gas Joints for Propane/LP Gas Fireplace




Figure 27 - Checking Gas Joints for Natural Gas Fireplace

- Check all joints from propane/LP supply tank or gas meter to equipment shutoff valve (see Figure 26 for propane/LP or Figure 27 for natural gas). Apply noncorrosive leak detection fluid to all joints. Bubbles forming show a leak. Correct all leaks at once.

Pressure Testing Fireplace Gas Connections

- 1. Open equipment shutoff valve (see **Figure 25**).
- 2. Open propane/LP supply tank valve for propane/LP fireplace or main gas valve located on or near gas meter for natural gas fireplace.
- 3. Check all joints from equipment shutoff valve to gas valve (see **Figure 26** for propane/LP or **Figure 27** for natural gas, Apply noncorrosive leak detection fluid to all joints. Bubbles formed show a leak. Correct all leaks at once.
- Light fireplace (see Operating Fireplace, page 16 or 17 depending on ignition system). Check all other internal joints for leaks.
- 5. Turn off fireplace (see To Turn Off Gas to Appliance, page 16 or page 17 depending on ignition system).

HEARTH ACCESS AND ASSEMBLY

AWARNING: If fireplace has been running, turn off and let cool before accessing or servicing the unit.

Removing Lower Louver Access Panel




Figure 28 - Removing Lower Louver Access Panel

- Use your index fingers to locate the left and right spring latches found just under the top louver then draw them inward to release the pins holding the panel on the side face (see Figure 28).
- 2. Swing the louver panel out until it clears the fireplace opening.
- 3. Pull the entire panel out until the bottom tabs are free of the slot openings in the lower face frame.

Removing Top Louver Trim Panel

The top louver panel may be removed for inspection and cleaning by following the instructions for removing the lower louver access panel. (see **Figure 28**).

Removing/Replacing Glass Door

If replacement of glass is necessary, the entire assembly, glass and frame, must be replaced. If glass is broken, wear gloves and tape the remaining fragments onto the frame.




Figure 29 - Removing/Replacing Glass Door

- 1. Placing a screw driver or your finger tips into the gap between the lower glass panel rail and the bottom face frame, lift the glass door assembly until the door pins clear the locating holes in the bottom face frame (see detail **Figure 29**).




Figure 30 - Removing/Replacing Glass Door

- 2. Swing bottom glass panel assembly out until the door pins on the lower rail clears the bottom face frame (see **Figure 30**).
- 3. Lower the door down until the upper door pins are free of the locating holes in the spring clips and place in a safe area.
- Replace glass panel in reverse order by inserting the top door pins into the spring clips, lifting up at the lower frame rail, and locating the bottom pins in the holes on the lower face frame.

WARNING: Handle glass door panel with care. Do not strike, slam, or otherwise abuse glass. Do not operate fireplace with glass door removed, cracked, or broken.

INSTALLING LOGS AND GLOWING EMBERS

A 4 piece ceramic log set comes packed inside the unit firebox. Removal of glass door is necessary to unpack and assemble the logs and add hearth treatments. Follow steps under *Removing/Replacing Glass Door*, page 14 to access the logs and burner.

Assemble the logs and add burner treatments as follows:




Figure 31 - Installing Logs

- Position the base log onto burner log mounts. (see Figure 31).
 Note: The cut out on the bottom should fit over the mounts and the base log should be positioned against the rear panel
- 2. Position the holes on the bottom of the rear log over the pins on the base log **Figure 31**).
- 3. Position the top left log and top right log onto the rear log and base log as shown in (see **Figure 31**).

WARNING: The glass door must be securely in place before running this fireplace. Do not run this fireplace if glass is missing or broken.

- 4. Open the bag of ember materials.




Figure 32 - Applying Ember Material

- 5. Break apart about quarter sized pieces and place about a single layer along the full length of the ember tray to hide the bottom edge of the base log. (see **Figure 32**).
- 6. Replace the glass door and louver panels. See *Removing/Replacing Glass Door*, page 14.

Manual Ignition System



FOR YOUR SAFETY READ BEFORE LIGHTING



WARNING: If you do not follow these instructions exactly, a fire or explosion may result causing property, damage, personal injury or loss of life.

- A. This appliance has a pilot which must be lighted by hand. When lighting the pilot, follow these instructions exactly.
- B. BEFORE LIGHTING smell all around the appliance area for gas. Be sure to smell next to the floorbecause some gas is heavier than air and will settle on the floor.

WHAT TO DO IF YOU SMELL GAS

- Do not try to light any appliance.
- Do not touch any electric switch; do not use any phone in your building.
- Immediately call your gas supplier from a neighbor's Phone. Follow the gas supplier's instructions.
- If you cannot reach your gas supplier, call the fire department.
- C. Use only your hand to push in or turn the gas control knob. Never use tools. If the knob will not push in or turn by hand, don't try to repair it, call a qualified service technician. Force or attempted repair may result in a fire or explosion.
- D. Do not use this appliance if any part has been under water. Immediately call a qualified service technician to inspect the appliance and to replace any part of the control system and any gas control which has been under water.

LIGHTING INSTRUCTIONS



- 1. STOP! Read the safety information above.
- 2. Open lower louver panel.
- 3. Turn off all electric power to the fireplace.





Figure 33 - Control Valve Millivolt

- 4. Push in gas control knob slightly and turn clockwise to "OFF" (see Figure 33).
- 5. Wait five (5) minutes to clear out any gas. Then smell for. gas, including near the floor. If you smell gas, STOP! Follow "B" in the safety information above. If you don't smell gas go to the next step.
- 6. The pilot is located by the main burner and should not require accessing for lighting.
- 7. Turn gas control knob counterclockwise to "PILOT"
- 8. Push in gas control knob all the way and hold. Immediately light the pilot by repeatedly depressing the piezo spark ignitor until a flame appears. Continue to hold for about one (1) minute after the pilot is lit. Release gas control knob and it will pop back. Pilot should remain lit. If it goes out, repeat steps 5 through 8.

- If gas control knob does not pop up when released, stop and immediately call your service technician or gas suppier.
- If the pilot will not stay lit after several tries, turn the gas control knob to "OFF" and call your service technician or gas supplier.
- 9. Turn on all electric power to fireplace.
- 10. Turn gas control knob counterclockwise / to "ON"
- 11. Close lower louver panel.

NOTICE: During initial operation of a new heater, the burning of residues from the manufacturing process of the firebox and logs will produce a paper-burning smell and orange flames. Open a window for the first few hours of operation to adequately vent this smell.




Figure 34 - Turning Equipment Shutoff Valve to the OFF Position





Figure 35 - Pilot




Figure 36 - Setting the Selector Switch, Gas Control Knob, and Variable Control Knob for Remote Operation




Figure 37 - On/Off Hand Held Remote Control Unit HRC100

WARNING: Do not connect the appliance gas controls to a 120 VAC power source. Damage or injury may occur.

Light the fireplace as instructed in *Lighting Instructions* on page 16. If using a HRC remote with a wall switch set the remote selector switch switch to the ON position. See Figure 36.

The wall switch may now be used to turn the burner flame ON and OFF.

To turn the fireplace off, turn the wall switch and /or remote selector switch to the OFF position and turn the gas control knob back to PILOT. The pilot will remain lit.

IMPORTANT: To turn the pilot off, turn the gas control knob on the heater to the OFF position.

INSPECTING BURNERS

Check pilot flame pattern and burner flame patterns often.

PILOT ASSEMBLY

The pilot assembly is factory preset for the proper flame height Alterations may have occurred during shipping and handling. Call a qualified service person to readjust the pilot if necessary.




Figure 38 - Pilot Assembly (Millivolt System)

The position and pattern of the pilot flames in relation to the sensing devices should be as shown in **Figures 38** and **39** respectively.

The pilot flame may need adjustment in order for the thermocouple, thermopile and/or the ignition system to sense the pilot flame.

If your pilot assembly does not meet these requirements:

- turn fireplace off (see *To Turn Off Gas to Appliance*, page 16 or 17)
- see sections under Troubleshooting, pages 32 through 36




Figure 39 - Pilot Assembly (Electronic Ignition System)

BURNER FLAME PATTERN

Burner flames will be steady; not lifting or floating. Flame patterns will be different from unit to unit and will vary depending on installation type and weather conditions.

If the vent configuration is installed incorrectly, the flames will lift or "ghost". This can be dangerous. Inspect the flames after installation to ensure proper installation and performance.




Figure 40 - Typical Flame Pattern

Figure 40 shows a typical flame pattern.

If burner flame pattern differs from that described:

- turn fireplace off (see To Turn Off Gas to Appliance, page 16 or 17)
- see *Troubleshooting*, pages 21 through 25




Figure 41 - Adjusting Air Setting

AIR ADJUSTMENT SETTING

The main burner air shutter opening is factory set to the following:

1/8" - Natural Gas

3/4" - LP / Propane Gas

The air shutter may require adjustment depending on the altitude, venting condition, burner operation and general flame appearance.

If flames are lifting or sooting the shutter may require opening. If flames are too blue or improperly lighting the shutter may require closing. See **Figure 41** for proper air adjustment.

IMPORTANT: Do not reduce the air shutter opening any lower than the designed minimum stop setting of 1/8"

CLEANING AND MAINTENANCE

WARNING: Turn off fireplace and let cool before cleaning.

CAUTION: You must keep control areas, burners, and circulating air passages of fireplace clean. Inspect these areas of fireplace before each use. Have fireplace inspected yearly by a qualified service person. Fireplace may need more frequent cleaning due to excessive lint from carpeting, bedding mate rial, pet hair, etc.

GLASS DOOR

WARNING: Handle glass door panel with care. Do not strike, slam, or otherwise abuse glass. Do not operate fireplace with the glass door removed, cracked, or broken.

WARNING: Do not use abrasive cleaners as this may damage glass. Use a nonabrasive household glass cleaner to clean glass. Do not clean glass when hot.

Glass must be cleaned periodically. During start-up it is normal for condensation to form on the inside of the glass causing lint, dust, and other airborne particles to cling to the glass surface. During initial start-up a slight film may form on the glass due to paint curing. The glass should be cleaned several times with a non-ammonia, non-abrasive household cleaner and warm water after the first two weeks of operation. Thereafter, clean the glass two or three times during each heating season, depending on the usage and circumstances present. Refer to *Removing/Replacing Glass Door*, on page 14 of this manual when removing glass door for cleaning.

WARNING: Only parts supplied by the manufacturer should be used when replacing broken or damaged glass door panel (see Replacement Parts, page 26). This glass door panel is a complete unit. No substitute materials may be used.

ACAUTION: Wear gloves and safety glasses while handling or removing broken glass. Do not remove if glass is hot. Keep children and pets away from glass.

If glass has been broken, carefully remove glass door (see *Removing/Replaceing Glass Door*, page 14). Vacuum all glass pieces with a shop vac.

ACAUTION: Do not vacumm if pieces are hot.

Use only the tempered glass door replacement intended for this fireplace (see Replacement Parts, page 26 for detail on ordering). No substitutions may be made. See *Removing/Replacing Glass Door*, on page 14 for instructions for replaceing glass door.

WARNING: Do not block required air openings around glass or louver panels. Ventilated compartments should be inspected and vacummed at least once a year to prevent blockage prior to operation.

PILOT AND BURNERS

- Remove ember material before cleaning burners and replace
- Burner and controls should be cleaned with compressed air to remove dust. dirt, or lint.
- Use a vacuum cleaner or small, soft bristled brush to remove excess dust, dirt, or lint.

LOGS

- If you remove logs for cleaning, refer to *Installing Logs and Glowing Embers*, page 15, to properly replace logs.
- Use a vacuum cleaner to remove any carbon buildup on logs.
- Replace log(s) if broken. See *Replacement Parts* on page 26.
- Replace ember material periodically as needed. See Replacement Parts on page 26.

VENTING SYSTEM

Conduct annual inspection of the venting system following these guidlines:

- Check areas of venting system that are exposed to the weather corrosion (rust spots or streaks and, in extreme cases, holes). Have these items replaced immediately by a qualified service person.
- 2. Remove the vent cap and shine a flashlight ito vent. Remove any foreign material.
- Check for evidence of excessive condensation. Continuous condensation can cause corrosion of caps, pipes, and fittings and can be caused by having excessive lateral runs, too many elbows, or exterior portions of the system being exposed to cold weather.
- 4. Inspect joints to verify that no pipe section or fitting has been distributed and loosened. Check mechanical supports such as wall straps for rigidity.

Manual Ignition System

Note: All troubleshooting items are listed in order of operation.

WARNING: Turn off heater and let cool before servicing. Only a qualified service person should service and repair heater.

CAUTION Never use a wire, needle, or similar object to clean pilot. This can damage pilot unit.

The two most common causes of a malfunctioning gas appliance are:

- 1. Loose wiring connections
- 2. Construction debris clogging the pilot and/or gas control valve filter
