Chapter 1: Warnings and Cautions



WARNING

QUALIFIED SERVICE TECHNICIAN OPERATIONS:

Only a qualified service technician is authorized to remove the Top Cover and to access any of the components inside the product. Before removing the Top Cover, see Section 10.1, "Safety: Before Removing the Top Cover" on page 59 and Chapter 7, "Warnings and Cautions".



WARNING

ANCHOR THE EQUIPMENT RACK:

The equipment rack must be anchored to an unmovable support to prevent it from falling over when one or more products are extended in front of the rack on slides. You must also consider the weight of any other device installed in the rack. A crush hazard exists should the rack tilt forward which could cause serious injury.

Only use a screwdriver tip to push in lock tabs on rack slides. A pinch hazard exists if fingers are used for this purpose.



WARNING

TELECOMMUNICATIONS NETWORK CONNECTION:

The telecommunication interfaces of this product are not intended for direct connection to "outside plant" signal conductors (metallic). The product shall be isolated, by channel banks or office repeaters, from any connections to network or terminal equipment, that lie outside of the same building. The telecommunication interface connections are considered to be, and meet the requirements of, SELV circuits (not TNV). Refer also to any region specific regulatory requirements of network connection in Chapter 4, "Regulatory Specifications and Declarations".

Note that for some geographic regions, and subject to limitations, the T1/E1 ports of Dialogic[®] SS7HDP boards in Dialogic[®] SS7G22 products may be connected to "outside plant" signal conductors, and therefore become TNV-1 circuits. WARNING

IF AC POWER SUPPLIES ARE INSTALLED:

MAINS AC POWER DISCONNECT:

The AC power cord(s) is considered the mains disconnect for the product and must be readily accessible when installed. If the individual product power cord(s) will not be readily accessible for disconnection then you are responsible for installing an AC power disconnect for the entire rack unit. This main disconnect must be readily accessible, and it must be labelled as controlling power to the entire rack unit, not just to this product. To remove all power, two AC cords must be removed.

GROUNDING THE RACK INSTALLATION:

To avoid the potential for an electrical shock hazard, you must include a third wire safety ground conductor with the rack installation. If the product power cord is plugged into an AC outlet that is part of the rack, then you must provide proper grounding for the rack itself. If the product power cord is plugged into a wall AC outlet, the safety ground conductor in the power cord provides proper grounding only for this product. You must provide additional, proper grounding for the rack and other devices installed in it.

OVERCURRENT PROTECTION:

The product is designed for an AC line voltage source with up to 20 Amps of overcurrent protection per cord feed. If the power system for the equipment rack is installed on a branch circuit with more than 20 Amps of protection, you must provide supplemental protection for the product. The overall current rating of the product configured with two power supplies is less than 2.5 Amps.



WARNING

AC POWER CORD:

Do not attempt to modify or use an AC power cord that is not the exact type required. You must use a power cord that meets the following criteria:

- 1. Rating: For U.S./Canada cords must be UL Listed/CSA Certified type SJT, 18-3 AWG. For outside U.S./Canada cords must be flexible harmonized (<HAR>) or VDE certified cord with 3 x 0.75mm conductors rated 250 VAC.
- Connector, wall outlet end: Cords must be terminated in grounding-type male plug designed for use in your region. The connector must have certification marks showing certification by an agency acceptable in your region and for U.S. must be rated 125% of overall current rating of the product.
- 3. Connector, product end: The connectors that plug into the AC receptacle on this product must be an IEC 320, sheet C19, type female connector.
- 4. Cord length: Cords must be less than 4.5 meters (14.76 feet) long.

ISOLATION:

The product with DC input is to be installed in a Restricted Access Location in accordance with articles 110-16, 110-17 and 110-18 of the National Electric Code, ANSI/NFPA 70. The DC source must be capable of providing up to 200 W of continuous power per feed pair. Connection to a DC source should only be performed by a QUALIFIED SERVICE TECHNICIAN.

MAIN DC POWER DISCONNECT:

You are responsible for installing a properly rated DC power disconnect for the entire rack unit. This DC power disconnect must be readily accessible, and it must be labelled as controlling power to the entire rack unit, not just to this product.

GROUNDING THE RACK INSTALLATION:

To avoid the potential for an electrical shock hazard, you must reliably connect a safety ground conductor to the product. The safety ground conductor must be a minimum 14AWG connected to the safety ground studs on the rear of the product, with a closed two-hole crimp terminal. The nuts on the safety ground stud should be installed with a 10 in/lbs torque. The safety ground conductor provides proper grounding only for this product. You must provide additional, proper grounding for the rack and other devices installed in it.

OVERCURRENT PROTECTION:

Overcurrent protection circuit breakers must be provided as part of each host equipment rack and must be installed between the DC source and this product. The branch circuit protection shall be rated minimum 75 VDC, 10 Amps maximum per feed pair. If the DC power system for the equipment rack is installed with more than 10 Amps of protection, you must provide supplemental protection for this product. The overall current rating of this product configured with two power supplies is less than 4 Amps.





Caution

Anti-Static Handling Procedures:

The product contains Electrostatic Sensitive Devices (ESDs), which may be permanently damaged if incorrectly handled. If modules are removed from the chassis they must be handled in accordance with appropriate anti-static handling procedures. Refer to IEC61340-5-1 Electrostatics - Part 5-1: Protection of electronic devices from electrostatic phenomena - General requirements for further details. Caution

Temperature:

The temperature, in which this product operates when installed in an equipment rack, must not go below 5 °C (41 °F) or rise above 40 °C (104 °F). Extreme fluctuations in temperature can cause a variety of problems in your product.



Caution

Ventilation:

The equipment rack must provide sufficient airflow to the front of the product to maintain proper cooling. The rack must also include ventilation sufficient to exhaust a maximum of 790 BTUs per hour for this product. The rack selected and the ventilation provided must be suitable to the environment in which the product will be used.



Chapter 2: Introduction

2.1 Purpose

This manual addresses the hardware aspects of the Dialogic[®] SS7G21 and SS7G22 Signaling Servers (hereinafter sometimes referred to collectively as "the SS7G21 and SS7G22 products" and individually as "SS7G21" and "SS7G22," respectively). It includes the specification of the products, a functional description of the internal hardware modules, details of all the used interface connections (including pinouts) and provides installation instructions. The manual also describes maintenance procedures, allowing the user to make module-level replacements in the field, and lists the part numbers for spare parts. Users should refer first to Chapter 11, "International Warnings", for important safety information.

This manual should be read in conjunction with the appropriate SS7G2x < Operating Mode > User Manual, which gives full details of operation, including the user interface and a full description of all configuration parameters and commands. Section 2.10, "Related Information" on page 13 lists the various user manuals.


2.2 Products

The Signaling Servers covered by this manual include:

- Dialogic[®] SS7G21
- Dialogic® SS7G22

The physical appearance of the units is shown in Figure 1.

Figure 1. Dialogic® SS7G21 and SS7G22 Signaling Servers



The product variants use the same 2U-high chassis intended for rack mounting in a standard 600mm x 600mm rack (DIN 41494). Depending on the product variant, the chassis contains:

- An AC-input or a DC-input Power Supply Cage, with a single plug-in Power Supply Module. Optionally, a second module provides hot-swap redundancy.
- A Server Board (containing dual Intel Xeon processors)
- A Hard Disk Drive (HDD)
- CD-ROM Drive
- Up to three SS7 Signaling Boards
- Four 1 Gigabit/s Ethernet ports
- Cooling fans

The main difference between the SS7G21 and the SS7G22 is the type of Dialogic[®] SS7 Signaling Boards (hereinafter sometimes referred to as "SS7 Signaling Boards") used and hence the number of SS7 links supported. The SS7G21 supports up to 12 SS7 links and 12 linksets, while the SS7G22 supports up to 128 SS7 links and 32 linksets.



A list of product variants to which this manual applies can be found in Section 2.11, "Applicability" on page 14.

2.3 Power Supplies

An SS7G21 or SS7G22 product can be ordered with one of the following:

- AC-input Power Supply Cage (SS7G21A, SS7G22A)
- DC-input Power Supply Cage (SS7G21D, SS7G22D)

The Power Supply Cage, which is mounted towards the left rear of the chassis, contains the Power Supply Modules. Both the AC and DC-input Power Supply Cage may contain up to two Power Supply Modules and can be configured as follows:

- One Power Supply Module installed (this is the factory standard setting). Units configured in this manner
 can supply a fully loaded product, but do not provide dual redundancy. The second position contains a
 filler module.
- Two Power Supply Modules installed. Units configured in this manner are dual redundant. In the event of a failure of any one Power Supply Module, the operation of the product is unaffected.

When the product is configured with two Power Supply Modules, the hot-swap feature allows the user to replace a failed module without interrupting system functionality.

Caution: The Power Supply Modules used in the AC-input Power Supply Cage can **not** be used in the DC-input Power Supply Cage. Similarly, the Power Supply Modules used in the DC-input Power Supply Cage can **not** be used in the AC-input Power Supply Cage. The correct product variant must be specified at time of ordering, see Chapter 12, "Part Number Reference".

2.4 Server Board

The chassis incorporates a Server Board incorporating dual Intel Xeon processors with 512 KB L2 cache and 1 GB DRAM DIMM memory. The Server Board has a Riser Board, which supports the fitting of up to three full-length PCI SS7 Signaling Boards. See Section 2.7, "SS7 Signaling Boards" on page 12 for more information on the types of SS7 Signaling Boards that are installed.

2.5 Hard Disk Drive

As standard, a Hard Disk Drive (HDD) is installed in a drive bay in the front of the chassis, accessible by removing the front bezel of the product. A spare assembly is available for the HDD, see Chapter 12, "Part Number Reference".

2.6 CD-ROM Drive

A CD-ROM drive is accessible at the front panel, and may be used for loading software updates.

2.7 SS7 Signaling Boards

The SS7G21 and SS7G22 use intelligent multi-port interface boards with one or more on-board signaling processors for the processing of SS7 signaling links. The SS7 Signaling Boards are full-size PCI form factor boards that occupy one, two, or three board positions in a Riser Board mounted on the Server Board. The SS7 Signaling Boards each provide four (or two) primary rate telecommunications (PCM) interfaces, each being individually configured at run-time under software control to operate as a T1 or E1 interface with selectable line code and frame format. For SS7 Signaling Boards with two PCM interfaces, there are also two synchronous V.11 (V.35 compatible) serial interfaces, on a shared connector. See Section 6.5, "SS7 Serial Interface Ports" on page 36 and Appendix A for more information.

The number of SS7 signaling links that can be terminated by an SS7 Signaling Board depends on the board type as described below. Signaling links may be presented either as a timeslot on an external PCM interface, or as a synchronous V.11 serial interface when provided by the board. Signaling links can operate at 64kb/s, 56kb/s or 48kb/s. The SS7 Signaling Boards also support configurable clock recovery priorities with automatic switching to a new clock source on failure, and automatic restoration on recovery of the failed clock source.



Depending on the variant, an SS7G21 can contain one of the following:

- Up to three Dialogic® SPCI2S boards, each providing two T1/E1 interfaces and two V.11 serial ports
- Up to three Dialogic® SPCI4 boards, each board providing four T1/E1 interfaces

Each SPCI2S and SPCI4 board supports 4 SS7 links, giving the SS7G21 a maximum capacity of 12 SS7 links.

Depending on the variant, an SS7G22 can contain:

- Up to three Dialogic[®] SS7HDP boards, each board providing four T1/E1 interfaces
- The SS7G22 can optionally be obtained without SS7 signaling boards, typically for use in IP signaling applications

Each SS7HDP board supports up to 64 SS7 links, and the maximum capacity of an SS7G22 is 128 SS7 links.

For information on the signaling interfaces provided by standard products, refer to Section 2.11, "Applicability" on page 14.

For more information on the SPCI2S and SPCI4 signaling boards, refer to the SPCI2S, SPCI4 User Manual. For more information on the SS7HDP signaling board, refer to SS7HDP Installation Guide (card) and SS7HDP Regulatory Notices.

2.8 Ethernet Ports

The SS7G21 and SS7G22 provide four Gbit/s Ethernet ports. Two of these ports are provided on the Server Board; the other two are provided by a pre-installed low-profile Ethernet PCI board.

2.9 Cooling

The product contains a fan array consisting of two 80 x 38mm fans and two 40 x 28mm fans to cool the Server Board and other components. Air flows in through the front bezel over the peripheral bay and the hard drive bays, passes through the fans and over the baseboard, and exhausts through the rear of the chassis. The power supplies have their own cooling ventilation. A fan failure is indicated by one of the alarm LED's located on the front panel. See also the Caution relating to ventilation on page 12.

CRT Alarm LED (amber)

When lit continuously, indicates the presence of a critical fault. A critical fault is an error or event that is detected by the unit and indicates failure of an important subsystem that critically degrades operation of the unit. Some critical faults may indicate an error or event that either has, or may lead to, a fatal failure of the unit and urgent action should be taken to resolve the cause of the fault. An example is an over temperature condition due to the failure of the cooling system or the failure of an SS7 Signaling Board. The critical alarm relay is engaged. The full list of critical alarms is given in the appropriate SS7G2x < Operating Mode > User Manual. Section 2.10, "Related Information" on page 13 lists the various user manuals.

MJR Alarm LED (amber)

When lit continuously, indicates the presence of a major fault. A major fault is an error or event that is detected by the unit that has a discernible impact on the unit's operation. In this case, the unit can continue to operate, but in a "degraded" fashion (that is, with reduced performance or non-fatal loss of features). Prompt action should be taken to resolve the cause of a Major fault. An example is a Remote Alarm Indication (RAI) on one of the PCM trunks. The major alarm relay is engaged. The full list of major



alarms is given in the appropriate SS7G2x < Operating Mode > User Manual. Section 2.10, "Related Information" on page 13 lists the various user manuals.

MNR Alarm LED (amber)

When lit continuously, indicates the presence of a minor fault. A minor fault is an error or event that is detected by the unit but has little or no impact on the actual unit's operation. The full list of minor alarms is given in the appropriate SS7G2x < Operating Mode > User Manual. Section 2.10, "Related Information" on page 13 lists the various user manuals.

PWR Alarm LED (amber)

When lit continuously, indicates the presence of a power fault. The power alarm relay is engaged.

• 0 Activity/Fault LED (green/amber)

Indicates SCSI Hard Disk Drive (HDD) 0 activity when green, or a SCSI HDD 0 fault when amber.

1 Activity/Fault LED (green/amber)

Indicates SCSI Hard Disk Drive (HDD) 1 activity when green, or a SCSI HDD 1 fault when amber.

ON LED (green)

When lit continuously, indicates the presence of DC power in the product. The LED goes out when the power is turned off or when the power source is disrupted.

NIC Activity LED (green)

Indicates activity on either network interface, ENET1 or ENET2.

• ID LED (white)

This white LED is used in conjunction with the ID switch, and back panel ID LED (blue), to provide a service technician facility to highlight a specific SS7G21 or SS7G22 in a rack of similar units. The LEDs can be illuminated and deactivated by the ID switch (see description below).

ID switch

In conjunction with the front and back panel ID LEDs, this switch provides a service technician facility to highlight a specific SS7G21 or SS7G22 in a rack of similar units. Pressing the ID switch toggles the front and back panel ID LEDs between the illuminated and deactivated states.

Back Panel

• ID LED (blue, inside grill)

This blue LED, visible through the grill at the back of the SS7G21 and SS7G22, is used in conjunction with the front panel ID Switch and ID LED (white), to provide a service technician facility to highlight a specific SS7G21 or SS7G22 in a rack of similar units. The LEDs can be illuminated and deactivated by the ID switch (see description above). See Figure 4, "Back Panel Connectors and Indicators" on page 33 for the location of the blue LED.

Visual Indicators on the Ethernet Ports

The Ethernet ports have built-in indictors that provide visual indications of link activity and port speed. See Section 6.6, "Ethernet Interfaces" on page 38 for more information.

A single bi-color LED, on the back of each module, provides power supply status as described in the following table.

Chapter 5: Hardware Description

5.1 Overview

The Dialogic[®] SS7G21 and SS7G22 products are equipped with a Server Board containing dual Intel Xeon processors with 512 KB L2 cache and 1 GB DRAM DIMM memory. The Server Board also includes a Riser Board that can contain up to three SS7 Signaling Boards as follows:


- The SS7G21 can contain up to three SPCI2S or SPCI4 boards providing up to 12 SS7 signaling links, connected via up to 12 interface ports. These ports may be a combination of PCM (T1/E1) interface ports and V.11 SS7 serial interface ports according to the type of SS7 Signaling Board installed. See Section 2.7, "SS7 Signaling Boards" on page 12 for more information.
- The SS7G22 can contain up to three SS7HDP boards providing 64 SS7 signaling links per board up to a system maximum of 128 signaling links. All ports are PCM (T1/E1) interface ports. See Section 2.7, "SS7 Signaling Boards" on page 12 for more information.

These products support a high availability feature option of redundant/hot-swap Power Supply Modules. The standard product is supplied with a single AC or DC Power Supply Module as determined at time of order.

See Chapter 12, "Part Number Reference" for a list of the available product variants and protocols, plus expansion options or spare assemblies, and accessories. Rack mounting is described in Section 5.4, "Rack Mounting Options" on page 34.

See Section 3.10, "Physical Specifications" on page 19 for the product weight and dimensions. Figure 2 presents a front view of the product.

Figure 3. Front Panel Controls, Indicators and Switches



Figure 4. Back Panel Connectors and Indicators



5.4 Rack Mounting Options

A number of optional mounting arrangements are available for the Dialogic[®] SS7G21 and SS7G22 products. The mounting hardware that you order depends on your application. See Chapter 12, "Part Number Reference" for information on selecting the correct mounting hardware.

Note: Mounting kits are separately orderable and are not included with the product.

Complete installation instructions are included with each mounting kit. This section gives a brief description of each type of mounting kit to facilitate the selection of the most appropriate mounting hardware. The basic rack mount kits available are:

- SS7G20R19LBR This rack mount kit consists of L-shaped brackets, and permits fixed installation of the SS7G21 and SS7G22 to 2-post Central Office (CO) type 19" wide racks.
- SS7G20R19MNT and SS7G20R23MNT These rack mount kits are of a *rail* construction, with brackets allowing installation of the SS7G21 and SS7G22 in either 2-post or 4-post racks. The rails are not free-sliding rails, and are not intended to allow the product to be accessed in an extended position.
 SS7G20R19MNT is for 19" wide standard EIA (universal hole spacing) racks. SS7G20R23MNT is for 23" wide standard EIA (universal hole spacing) or ETSI (European) racks.

The mounting kits described above have been tested with the DC server chassis that is used in SS7G21 and SS7G22, and in that application are shown to meet full NEBS-3 specifications, including Seismic zone-4.

The following mount option is also available for use with SS7G21 and SS7G22, but may not provide full compliance with NEBS-3 requirements:

• SS7G20RSLKIT – This is an *enabling kit*, rather than a full mounting kit, and requires the independent procurement of sliding rails such as, Accuride† model # 305-A-LR, or similar. This mounting option is suited to 19" wide racks.

In addition, there are a number of threaded fixing holes along the sides of the product, and it may be possible to utilize alternative mounts from other sources. In such cases, the performance is unknown, and care should be taken not to use excessively long fixing screws.

Warning: Do **not** rely on rack mounting arrangements for grounding of the product. See WARNINGS on GROUNDING THE RACK INSTALLATION in Chapter 1, "Warnings and Cautions". Apply the Warning for AC power supplies or DC power supplies as appropriate.



Chapter 6: Interfaces

This section provides connector pinout details for all used interface connectors on the SS7G21 and SS7G22. For locations refer to Section 5.3, "Back Panel" on page 33.

6.1 DC Power Input Terminal Block

A DC Power Input Terminal Block is provided at the rear of the DC-input Power Supply Cage (DC products only). Connection to a DC power source should be performed only by a **qualified service tecnhician**. Details are therefore included in Part II of this manual, see Section 9.2, "Power Supply Related Actions" on page 50. See also Section 6.2 following.

6.2 Safety Ground Studs for Earthing

Two 8-32 UNC safety ground studs are provided for attachment of safety ground conductor to the product when using the DC power supply option. Connection of the safety ground conductor should only be performed by a **qualified service tecnhician**. Details are therefore included in Part II, see Section 9.2.1, "Safety Ground Studs, Conductor Installation" on page 51.

6.3 AC Power Input

Two AC power input connectors, type IEC320, are provided at the rear of the Power Supply Cage of AC powered product. Each connector supplies input power to one of the two Power Supply Module positions, refer to Section 5.3, "Back Panel" on page 33 for details. These connectors provide the safety ground connections for the product.

When selecting a suitable power cord(s) for connection to the AC power input(s), ensure that the cords comply with the AC POWER CORD warning provided in Chapter 1, "Warnings and Cautions".

When selecting a suitable AC power outlet(s) for connection of the other end of the power cord(s), ensure that the outlet is earthed, and that it complies with the IF AC POWER SUPPLIES ARE INSTALLED warning in Chapter 1, "Warnings and Cautions" which covers the following aspects; mains AC power disconnect, grounding the rack installation, and overcurrent protection.

When in doubt, consult a qualified service tecnhician.

6.4 PCM Interface Ports






Figure 6. PCM Ports on SPCI4 Boards





Figure 7. PCM Ports on SS7HDP Boards

Each SS7 Signaling Board provides primary rate telecommunications (PCM) interfaces, each being individually configured at run-time under software control to operate as balanced T1 or E1 ports, with selectable line code and frame format. Depending on the type of SS7 Signaling Board(s) installed, there may be two (Figure 5) or four (Figure 6 and Figure 7) PCM interfaces per board. For information on setting the port configurations, see the appropriate SS7G2x < Operating Mode > User Manual. Section 2.10, "Related Information" on page 13 lists the various user manuals.

Figure 5. PCM Ports on SPCI2S Boards

The T1/E1 ports on the SS7 Signaling Boards are Safety Extra Low Voltage (SELV), that is, the apparatus connects to the outside network via Network Termination units (NT1). Use twisted-pair, screened cables, grounded at both ends, to ensure the EMC and error-free performance of the product. See also Section 4.3.3, "Telecommunications" on page 28 for information on potential usage as TNV-1 ports.

The connectors are 8-way RJ45, and are labelled L3 and L4 in Figure 5, or L1 to L4 in Figure 6 and Figure 7. These labels can be used together with the SS7 Signaling Board position number (see Section 5.3, "Back Panel" on page 33) to give each port a unique identifier for wiring schedules and unit configuration.

The connector pinout and signal descriptions are shown in Table 5.


6.5 SS7 Serial Interface Ports

SS7 Signaling Boards of type SPC12S provide two synchronous SS7 serial interface ports. Both ports are presented in a single 26-way female high density D-type connector, and use V.11 (V.35 compatible) electrical interface characteristics. See Appendix A.

The connector is labelled Aux in Figure 8 and on the products. Table 6 identifies the ports as A and B. This can be used with the SS7 Signaling Board position number (see Section 5.3, "Back Panel" on page 33) to give each port a unique identifier for wiring schedules and unit configuration.

The SS7 serial interface ports on the SPCI2S are designated as SELV. Install the ferrite clamp(s), provided with this product, on each SS7 serial interface port cable, close to the connector backshell, to ensure the EMC performance of the product. The connector pinout and signal assignment is given in Table 6.

The SS7 serial interface ports may be clocked either by an internally generated clock or by an externally applied clock. In both cases, the same clock is used for both the Transmit data and the Receive data.

For internal clock operation, use the Transmit clock pins and make no connection to the Receive clock pins on the D-type connector. For external clock operation, connect the clock source to the Receive clock pins on the D-type connector and make no connection to the Transmit clock pins.



An SS7 Serial Interface Port Splitter Cable is available, DKL26 (see Chapter 12, "Part Number Reference"). This is a cable that converts from the dual V.11 26-way high density D connector (detailed in Table 6) to two 15-way male DB15 connectors (detailed in Table 7). When installing this cable, ensure that the ferrite clamp is fitted close to the 26-way connector.

6.6 Ethernet Interfaces


To ensure EMC product regulation compliance for intra-building lightning surges, the product shall only be used with shielded LAN cables that are grounded at both ends.

Two pairs of Ethernet connectors are provided on the SS7G21 and SS7G22. ENET 1 and ENET 2 are provided by the Server Board, and ENET LNK A and ENET LNK B are provided by a separate low-profile PCI NIC. Figure 9 shows the Ethernet connectors provided by the PCI NIC and the Server Board.

The Ethernet interface connectors incorporate status LED indicators. The LEDs on the network interface connectors indicate link/activity on the network and the speed of operation. The green LED, when on, indicates network connection and when blinking indicates TX/RX activity. The speed LED indicates 1000 Mbps when amber, 100 Mbps when green, and 10 Mbps when off. Table 8 shows the Ethernet connector pinouts.

A **NIC Activity LED** (green) on the front panel provides an indication of activity on the ENET 1 or ENET 2 ports. See Section 5.2, "Front Panel" on page 32 for more information.



6.7 Serial Port (COM2)

One serial port (COM2, marked **10101**) is provided on the back panel. This is an RS232 port using an 8-way RJ45 connector (see Figure 10). The serial port can be used for configuration and management of the product. The serial port is designated as SELV.

Note: There is a similar connector on the front panel, but it is not enabled on these products.

An RJ45 to DB9 serial cable, DKL29, is supplied with the product. This cable converts from the RJ45 connector pin out to a conventional 9-way female DB9 connector. The pinout of the product serial port (COM2), and the interconnection of the DKL29 serial cable, is described in Table 9.

6.8 Alarms

The alarms port interface is a 15-way male DB15 connector (see Figure 11). This connector allows remote notification of alarm conditions. Table 10 shows the alarms connector pinouts. Each alarm (Major, Minor, Critical and Power) is the output of a SPDT relay contact. A common contact with normally open and normally closed connections is included. Power alarm has just a common and normally open contact outputs. The alarms port is designated as SELV.



CAUTION

Do not apply more than 60 Volts (maximum) to any pin or combination of pins on the Alarms connector.

Figure 11. Alarms Connector



Chapter 7: Warnings and Cautions



WARNING

QUALIFIED SERVICE TECHNICIAN OPERATIONS:

Only a qualified service technician is authorized to remove the Top Cover and to access any of the components inside the product. Before removing the Top Cover, see Section 10.1, "Safety: Before Removing the Top Cover" on page 59 and Chapter 7, "Warnings and Cautions".



WARNING

ANCHOR THE EQUIPMENT RACK:

The equipment rack must be anchored to an unmovable support to prevent it from falling over when one or more products are extended in front of the rack on slides. You must also consider the weight of any other device installed in the rack. A crush hazard exists should the rack tilt forward which could cause serious injury.

Only use a screwdriver tip to push in lock tabs on rack slides. A pinch hazard exists if fingers are used for this purpose.



WARNING

TELECOMMUNICATIONS NETWORK CONNECTION:

The telecommunication interfaces of this product are not intended for direct connection to "outside plant" signal conductors (metallic). The product shall be isolated, by channel banks or office repeaters, from any connections to network or terminal equipment, that lie outside of the same building. The telecommunication interface connections are considered to be, and meet the requirements of, SELV circuits (not TNV). Refer also to any region specific regulatory requirements of network connection in Chapter 4, "Regulatory Specifications and Declarations".

Note that for some geographic regions, and subject to limitations, the T1/E1 ports of Dialogic[®] SS7HDP boards in Dialogic[®] SS7G22 products may be connected to "outside plant" signal conductors, and therefore become TNV-1 circuits. See Section 4.3.3, "Telecommunications" on page 28 for more details.





WARNING

IF AC POWER SUPPLIES ARE INSTALLED:

MAINS AC POWER DISCONNECT:

The AC power cord(s) is considered the mains disconnect for the product and must be readily accessible when installed. If the individual product power cord(s) will not be readily accessible for disconnection then you are responsible for installing an AC power disconnect for the entire rack unit. This main disconnect must be readily accessible, and it must be labelled as controlling power to the entire rack unit, not just to this product. To remove all power, two AC cords must be removed.

GROUNDING THE RACK INSTALLATION:

To avoid the potential for an electrical shock hazard, you must include a third wire safety ground conductor with the rack installation. If the product power cord is plugged into an AC outlet that is part of the rack, then you must provide proper grounding for the rack itself. If the product power cord is plugged into a wall AC outlet, the safety ground conductor in the power cord provides proper grounding only for this product. You must provide additional, proper grounding for the rack and other devices installed in it.

OVERCURRENT PROTECTION:

The product is designed for an AC line voltage source with up to 20 Amps of overcurrent protection per cord feed. If the power system for the equipment rack is installed on a branch circuit with more than 20 Amps of protection, you must provide supplemental protection for the product. The overall current rating of the product configured with two power supplies is less than 2.5 Amps.



WARNING

AC POWER CORD:

Do not attempt to modify or use an AC power cord that is not the exact type required. You must use a power cord that meets the following criteria:

- 1. Rating: For U.S./Canada cords must be UL Listed/CSA Certified type SJT, 18-3 AWG. For outside U.S./Canada cords must be flexible harmonized (<HAR>) or VDE certified cord with 3 x 0.75mm conductors rated 250 VAC.
- Connector, wall outlet end: Cords must be terminated in grounding-type male plug designed for use in your region. The connector must have certification marks showing certification by an agency acceptable in your region and for U.S. must be rated 125% of overall current rating of the product.
- 3. Connector, product end: The connectors that plug into the AC receptacle on this product must be an IEC 320, sheet C19, type female connector.

ISOLATION:

The product with DC input is to be installed in a Restricted Access Location in accordance with articles 110-16, 110-17 and 110-18 of the National Electric Code, ANSI/NFPA 70. The DC source must be electrically isolated by double or reinforced insulation from any hazardous AC or DC source. The DC source must be capable of providing up to 200 W of continuous power per feed pair. Connection to a DC source should only be performed by a QUALIFIED SERVICE TECHNICIAN.

MAIN DC POWER DISCONNECT:

You are responsible for installing a properly rated DC power disconnect for the entire rack unit. This DC power disconnect must be readily accessible, and it must be labelled as controlling power to the entire rack unit, not just to this product.

GROUNDING THE RACK INSTALLATION:

To avoid the potential for an electrical shock hazard, you must reliably connect a safety ground conductor to the product. The safety ground conductor must be a minimum 14AWG connected to the safety ground studs on the rear of the product, with a closed two-hole crimp terminal. The nuts on the safety ground stud should be installed with a 10 in/lbs torque. The safety ground conductor provides proper grounding only for this product. You must provide additional, proper grounding for the rack and other devices installed in it.

OVERCURRENT PROTECTION:

Overcurrent protection circuit breakers must be provided as part of each host equipment rack and must be installed between the DC source and this product. The branch circuit protection shall be rated minimum 75 VDC, 10 Amps maximum per feed pair. If the DC power system for the equipment rack is installed with more than 10 Amps of protection, you must provide supplemental protection for this product. The overall current rating of this product configured with two power supplies is less than 4 Amps.

Caution

Temperature:

The temperature, in which this product operates when installed in an equipment rack, must not go below 5 °C (41 °F) or rise above 40 °C (104 °F). Extreme fluctuations in temperature can cause a variety of problems in your product.



Caution

Ventilation:

The equipment rack must provide sufficient airflow to the front of the product to maintain proper cooling. The rack must also include ventilation sufficient to exhaust a maximum of 790 BTUs per hour for this product. The rack selected and the ventilation provided must be suitable to the environment in which the product will be used.




Chapter 8: Tools and Supplies Needed

Procedures in Part II of this manual require the following tools and supplies (see Figure 12):

- Jumper-removal tool or needle-nosed pliers
- Small flat-bladed screwdriver
- Phillips (cross-head) screwdriver (#2)
- Pen or pencil
- Anti-static wrist strap and conductive foam pad (recommended)
- Cable tie

Note: Blue-colored items (such as handles, buttons, and screws) represent service touch points. Remove power from system before servicing these components. Green-colored items (such as handles, levers, and buttons) represent hot-pluggable components.

Record the model and serial number of the product, all installed options, and any other pertinent information specific to the product.

A list of part numbers of available spare parts is provided in Chapter 12, "Part Number Reference".





Chapter 9: Product Installation and Hot-Swap Actions

This chapter describes actions that must be performed by a **qualified service technician**, but which do **not** require the removal of the Top Cover of the product. Before commencing these procedures, read Chapter 7, "Warnings and Cautions" in Part II of this manual.

Do **not** proceed to remove the Top Cover without consulting Section 10.1, "Safety: Before Removing the Top Cover" on page 59 and Section 10.2, "Warnings and Cautions: Working Inside the Product" on page 59.

9.1 Installation Overview

Installation of a Dialogic[®] SS7G21 or SS7G22 product involves the following tasks performed in the order shown. References to more detailed task descriptions are provided where appropriate.

To install an SS7G21 or SS7G22 unit, proceed as follows:

- 1. Read all warnings and cautions. See Chapter 7, "Warnings and Cautions" for details.
- 2. Choose the right product to suit the application taking into account the number and type of interface ports, the link processing capability, and whether the product needs to be AC- or DC-powered. See Section 12, "Part Number Reference" on page 79 for more information on the available product variants.
- 3. Install any hardware options purchased, for example, an extra PSU module (see Section 9.2, "Power Supply Related Actions" on page 50) or mounting rails for the product (see Section 5.4, "Rack Mounting Options" on page 34 for more information).
- 4. Physically install the product in an equipment rack or as a free standing unit.
- 5. Connect the product to ground:
 - When installing a DC-powered product, see Section 9.2.1, "Safety Ground Studs, Conductor Installation" on page 51.
 - When installing an AC-powered product, the ground connection and power connection are part of the same operation. See step 6 below.
- 6. Connect the power source:
 - When installing a DC-powered product for the first time, see Section 9.2.2, "DC Power Supply Module, Initial Connections" on page 51. When replacing a product, see Section 9.2.3, "DC Power Supply Module, Transferring Connections" on page 53.
 - When installing an AC-powered product, see Section 6.3, "AC Power Input" on page 35. In either case, ensure that the chosen power source meets the relevant requirements for "MAINS AC/DC POWER DISCONNECT" and "OVERCURRENT PROTECTION" as described in Chapter 7, "Warnings and Cautions".
- 7. Connect line interface, Ethernet interface, and alarm cables. See Chapter 6, "Interfaces" for connector details and pinout information for the various interfaces.
 - To ensure that you avoid EMC problems with the installation, comply with the instructions and advice given in Section 4.3.2, "EMC" on page 28.
 - For safety and operational aspects affecting network connections, comply with the advice given in Section 4.3.3, "Telecommunications" on page 28 and any region-specific requirements in Section 4.2.3, "FCC Part 68 Statement - USA" on page 26,
 - Section 4.2.4, "Telecommunications Attachment Notice Canada" on page 27,
 - Section 4.2.6, "Telecommunications Notice Australia / New Zealand" on page 27,
 - Section 4.2.7, "Telecommunications Notice Taiwan" on page 27.
- 8. Power up the product.
- 9. Complete the following software and configuration steps, all of which are fully described in the appropriate SS7G2x < Operating Mode > User Manual. Section 2.10, "Related Information" on page 13 lists the various user manuals.
 - Check whether a software download and upgrade is required.
 - Install optional software licenses.
 - Set the IP addresses of the unit.
 - Enable the selected Operating Mode (SIU, DSC or SGW).
 - Note: The SIU Operating Mode is enabled by default.



- Configure the product.
- 10. When installation is complete and the system is operating as intended, consider if you will want to install a replacement Hard Disk Drive (HDD) in the future. If you do, now is an ideal time to perform a backup of the System Configuration, which is a necessary step before the HDD can be replaced. For information on how to back up the System Configuration, read the instructions in Section 9.3.1, "Backing up the System Configuration" on page 56.

Note: The installer or developer must ensure that the product configuration, and any related application that is running, provides an implementation that complies with the services offered by the local Public Switched Telephone Network (PSTN) operator. In case of doubt, network specifications must be consulted.

9.2 Power Supply Related Actions

There are many different actions that may be required with regard to the Power Supply Modules and their connections. These can be found in the sub-sections below, or referenced from them, as follows:

• Product Installation, Power Wiring for DC Products

This consists of two essential actions, and one optional action.

- First connect the Safety Ground Studs as described in Section 9.2.1.
- Carry out initial wiring of a DC Power Supply Module as described in Section 9.2.2.
- If the dual redundant option is required, order and install a second DC Power Supply Module.
 Installation of the second module is described below.

Product Installation, Power Wiring for AC Products

This consists of one essential actions, and one optional action.

- Connection of the AC-input Power Supply Cage is described in Section 9.2.4.
- If the dual redundant option is required, order and install a second AC Power Supply Module.
 Installation of the second module is described below.

Note: There is no need to connect the Safety Ground Studs on AC powered products, as the Safety Ground is provided in the mains cords.

Second Power Supply Module Installation in DC Products

This operation is basically the same, whether it is carried out at the time of initial installation of the basic product, or if it is decided to add a second DC Power Supply Module at a later date. The benefits of using a dual-redundant power supply configuration are described in Section 2.3, "Power Supplies" on page 12. Removal of the filler module is basically the same as removing a DC Power Supply Module as described in Section 9.2.5, which also covers the insertion of the DC Power Supply Module, including the use of the 'latches'. Take this opportunity to check that the Safety Ground Stud connection is in good order, as described in Section 9.2.1. Wiring of the second module follows the description in Section 9.2.2.

Second Power Supply Module Installation in AC Products

This operation is basically the same, whether it is carried out at the time of initial installation of the basic product, or if it is decided to add a second AC Power Supply Module at a later date. The benefits of using a dual-redundant power supply configuration are described in Section 2.3, "Power Supplies" on page 12. Removal of the filler module is basically the same as removing an AC Power Supply Module as described in Section 9.2.6, which also covers the insertion of the AC Power Supply Module, including the use of the 'latches'. Connection for the second module simply requires both mains cords to be used on the AC-input Power Supply Cage, as described in Section 9.2.4.

Replacement of Power Supply Module in DC Products

The general actions required, such as (un)latching, removal and insertion of modules, are described in Section 9.2.5.

Transferring of the connections from the 'removed' module, to the 'replacement' module, are described in Section 9.2.3.

If replacing a failed module, it is possible that the relevant fuse may need replacement. It should be possible to determine if this is necessary from the LED indication on the new module.



Replacement of Power Supply Module in AC Products

The general actions required, such as (un)latching, removal and insertion of modules, are described in Section 9.2.6.

The connections are unaffected by AC Module replacement.

If replacing a failed module, it is possible that the relevant fuse may need replacement. It should be possible to determine if this is necessary from the LED indication on the new module.

9.2.1 Safety Ground Studs, Conductor Installation

Two 8-32 UNC safety ground studs are provided for attachment of a safety ground conductor to the product. These are for use only with DC powered product. Connection of a safety ground conductor should only be performed by a **qualified service technician**.

When connecting the safety ground conductor, ensure that it complies with the WARNING – IF DC POWER SUPPLIES ARE INSTALLED, sub-section GROUNDING THE RACK INSTALLATION in Chapter 7, "Warnings and Cautions".

The safety ground conductor must be a minimum 14AWG. To connect the safety ground conductor to the safety ground studs with a two-hole crimp terminal lug:

- 1. Place an 8-32 UNC nut on one safety ground stud and tighten to 10 in-lb.
- 2. Place the safety ground conductor terminal lug on the safety ground studs.
- 3. Place another 8-32 UNC nut on the same safety ground stud so that the safety ground conductor terminal lug is between the two nuts and tighten the second nut to 10 in-lb.

When installing the product in locations other than telecommunications centres, ensure that the safety ground conductor is less than 3 metres in length.


The two-hole crimp terminal lug must have a hole spacing of 5/8-inch, and must suit the conductor size in use, for example, Panduit[®] part number LCD8-10A-L, which suits 8AWG conductor.

9.2.2 DC Power Supply Module, Initial Connections

For DC powered products, each Power Supply Module is provided with its own DC power input terminal block, mounted directly on the rear of the module. Connection to a DC source should only be performed by a **qualified service technician**. See also Section 9.2.1, "Safety Ground Studs, Conductor Installation" on page 51. See Figure 13 for the location of the terminal block on DC Power Supply Modules.



Figure 13. DC Power Supply Module Terminal Block



The product is supplied with an insulating cover over the terminal block. To gain access to the terminals, apply gentle pressure to flip up the cover, while using a small flat blade screwdriver to unlatch each side in turn. When the wiring is complete the cover must be flipped down, and securely latched at both sides. All wiring terminals connected to the DC power input terminal block must be insulated, with no accessible bare metal when the cover is closed.

When installing a second Power Supply Module to provide the redundant/hot-swap facility, each module needs to be independently connected to a separately-fused DC source.

Each DC power input terminal block has two positive and two negative terminals as shown in Figure 14. Normally, only one pair (+ and -) on each module need to be connected to the external DC source, but if you require to operate on dual-redundant external DC sources, then both pairs shall be connected to separately-fused external DC sources. Note however that the two pairs are directly connected together within the module, and so the type of external source has to be chosen accordingly. Although the terminals are directly connected, they must not be used to connect onward the DC source to another example of this, or any other, product (this could result in exceeding the current rating of wiring, fuses, terminal block or internal connections, and also the onward connection would be disrupted during hot-swap of a PSU module).

Figure 14. DC Power Input Connector




The terminal block accepts standard terminal lugs that accept 14 AWG wire gauge, for example, Network™ stock # 81N1501 type CRS-TO-1406-HT. The width (labeled 'W' in Figure 15) of the lug can be no larger than 0.25 inches.

When selecting an appropriately sized power wire, consider the power rating of the product, and the length of the cable run. When installing the product in locations other than telecommunications centres, ensure that the cables connecting the DC power input, and the safety ground conductor, are less than 3 metres in length.

When selecting a suitable DC power source for connection to, ensure that it complies with the WARNING – IF DC POWER SUPPLIES ARE INSTALLED warning in Chapter 7, "Warnings and Cautions". This covers the following aspects; isolation, installation in a restricted-access location, main DC power disconnect, grounding the rack installation, and overcurrent protection.

9.2.3 DC Power Supply Module, Transferring Connections

When replacing a DC Power Supply Module, the terminal block, with wires attached, can be removed from the faulty Power Supply Module and assembled to the replacement Power Supply Module as follows:

1. Remove the two screws that secure the terminal block to the Power Supply Module and pull the terminal block away from the module. See Figure 13 on page 52.

Note: Removing the two screws also frees the terminal block cover, but it can be retained by attaching it to the removed terminal block.

- 2. Remove the faulty Power Supply Module from the chassis.
- 3. Install the replacement Power Supply Module. See Section 9.2.5, "Replacing a DC Power Supply Module" on page 53.
- 4. On the newly installed Power Supply Module, lift the insulating cover on the terminal block to access the two screws that secure the terminal block to the chassis.
- 5. Remove the two screws and carefully pull the terminal block away from the Power Supply Module.
- 6. Align the old terminal block (with wires attached) with the terminal block receptacle on the new Power Supply Module and carefully push the terminal block into the Power Supply Module.
- 7. Secure the terminal block in position using the two securing screws. See Figure 13 on page 52.
- 8. Close and latch the insulating cover so that it covers the terminals.

9.2.4 AC-input Power Supply Cage, Connection

Two AC power input connectors, type IEC320, are provided at the rear of the Power Supply Cage of AC powered product. Connection to an AC power outlet is covered in Part I, Section 6.3, "AC Power Input" on page 35 (it is not essential for it to be performed by a qualified service technician).

9.2.5 Replacing a DC Power Supply Module

Observe the following cautions:



Note: For DC powered products, the power source should be disconnected from any module while it is being removed or installed. When hot-swap functionality is required, ensure that one module remains installed, connected, and powered at all times.



CAUTION 1

Both module positions should have either a Power Supply Module or a filler module installed whenever the product is operational. Otherwise the cooling efficiency of the remaining module is impaired. During a Hot-swap operation there is a brief interval when one position is empty. If the replacement Power Supply Module is not immediately available, then a filler module must be installed.




CAUTION 2

AC Power Supply Modules cannot be used in the DC-input Power Supply Cage, and similarly, DC Power Supply Modules cannot be used in the AC-input Power Supply Cage. The correct product variant/Power Supply Module must be specified at time of ordering, see Chapter 12, "Part Number Reference".

Install or replace a DC Power Supply Module as follows:

- 1. Remove the terminal block with wires attached from the faulty DC Power Supply Module as described in Section 9.2.3, "DC Power Supply Module, Transferring Connections" on page 53.
- 2. Press the green button on the DC Power Supply Module (labeled A in Figure 16).
- 3. Rotate the green handle downward (labeled **B** in Figure 16).
- 4. Using the green handle, pull the Power Supply Module or filler module outward (labeled **C** in Figure 16).
- 5. When installing/reinserting a DC Power Supply Module, make sure the green handle is in the downward position before sliding the module into the Power Supply Cage. Press the module firmly into place, then rotate the handle upward to complete the insertion.
- 6. Assemble the terminal block (with wires attached) to the replacement DC Power Supply Module as described in Section 9.2.3, "DC Power Supply Module, Transferring Connections" on page 53.

9.2.6 Replacing an AC Power Supply Module

Observe the following cautions:



Note: For AC powered products, the power source may be connected and turned on during Power Supply Module installation/replacement. When hot-swap functionality is required two AC power cords must be connected.



CAUTION 1

Both module positions should have either a Power Supply Module or a filler module installed whenever the product is operational. Otherwise the cooling efficiency of the remaining module is impaired. During a Hot-swap operation there is a brief interval when one position is empty. If the replacement Power Supply Module is not immediately available, then a filler module must be installed.




CAUTION 2

AC Power Supply Modules cannot be used in the DC-input Power Supply Cage, and similarly, DC Power Supply Modules cannot be used in the AC-input Power Supply Cage. The correct product variant/Power Supply Module must be specified at time of ordering, see Chapter 12, "Part Number Reference".

Install or replace an AC Power Supply Module as follows:

- 1. Squeeze the green locking tab on the AC Power Supply Module (labeled A in Figure 17).
- 2. Rotate the green handle downward (labeled **B** in Figure 17).
- 3. Using the green handle, pull the Power Supply Module or filler module outward (labeled C in Figure 17).
- 4. When installing/reinserting a Power Supply Module, make sure the green handle is in the downward position before sliding the module into the Power Supply Cage. Press the module firmly into place, then rotate the handle upward to complete the insertion.

9.3 Hard Disk Drive (HDD) Replacement

The SS7G20SHDD Spare Hard Disk Drive for Dialogic® SS7G21 and SS7G22 Signaling Servers, consists of a spare hard disk drive, which contains the operating software for use with a SS7G2x Signaling Server. It allows the recovery of systems that have suffered HDD failure, but is subject to the pre-condition that the system operator must have prepared a System Configuration backup in advance of the HDD failure. It is recommended that this is done once a system installation is complete and operating as intended, and should be repeated each time significant configuration or license changes are made.

The SS7G20SHDD is preinstalled with SS7G2x Software Distribution V4.04 or later.



An SS7G20SHDD may be used in any SS7G2x Signaling Server, however, it requires a valid System License for that system. The process for making a backup of the System License and additional configuration files is described below.

Note: Only one hard disk may be used in an SS7G2x at any time. Using more than one may adversely affect system operation.

A Hard Disk Drive replacement process occurs in three stages:

- 1. "Backing up the System Configuration" on page 56.
- 2. "Replacing the Hardware" on page 56.
- 3. "Restoring the System Configuration" on page 57.

9.3.1 Backing up the System Configuration

Before the Hard Disk Drive can be replaced, a backup of the system configuration, System License, protocol licenses and operating software must exist.

In systems running SS7G2x Software V4.04 or later, the system takes a copy of these files and stores them in the syslog subdirectory of the siuftp account at startup. These files may be recovered using FTP and archived by transferring them to an ISO9660 format CD-ROM ready for restoration at a later date.

Table 11 lists the files backed up to the syslog subdirectory at startup.

Table 11. Files Backed Up to the syslog Subdirectory at Startup

9.3.2 Replacing the Hardware



WARNING

No more than one hard disk drive should be fitted in the SS7G2x. The hard disk drive should only be fitted in the left-hand Chassis slot.


Note: The diagram below shows the numbers and arrows on the right-hand Chassis slot. This is for illustration only, and the instructions to use the left-hand Chassis slot must be followed.

The steps below describe the actions required to replace the hardware. The SS7G2x must be powered-off before replacing the hardware.

1. To remove the bezel, loosen the two captive screws and lift the bezel outwards.

- 2. To unlock the carrier from the chassis, press the green tab on (horizontal) lever to the right to unlock the lever. Rotate lever 90 degrees clockwise to a vertical position, to disconnect the SCSI drive connection.
- 3. To remove the carrier, press to the right the green latch at the left end of the carrier handle, allowing the handle to swing out, and the carrier to be unlocked. Pull on the handle in the direction of the arrow to remove the HDD carrier from the chassis.
- 4. To install the HDD in the carrier, install, then tighten four 6-32 UNC screws to secure the HDD to carrier.
- 5. To reinstall the HDD carrier into the chassis, place the carrier fully into the chassis slot, and press the handle flat to the front, making sure the green latch clicks into place to secure the carrier to the chassis.
- 6. To engage the HDD SCSI connections, rotate the green lever 90 degrees counterclockwise to a horizontal position. Press gently down on the green area until the locking tab pops out to the left. To ensure the drive is fully engaged with the SCSI connector, use firm but gentle pressure on the green area. On releasing the pressure, check that the lever is locked in the horizontal position.
- 7. Finally, replace the bezel and tighten the two captive screws.

9.3.3 Restoring the System Configuration

Once the new SS7G20SHDD has been installed, the previous system configuration should be restored. The ISO9660 format CD-ROM containing backup of the system configuration, System License, protocol licenses and operating software, which was described in Section 9.3.1, "Backing up the System Configuration" on page 56, should be inserted into the CD-ROM drive. The system will install the backup files from the CD-ROM at startup and may automatically restart if a different version of the SS7G2x Software Distribution is being installed.

After the restoration process has completed, the CD-ROM should be removed to prevent the backup configuration from overwriting subsequent configurations.





Chapter 10: Working Inside the Product

This chapter describes actions that must be performed by a **qualified service technician**, and which require the removal of the Top Cover from a Dialogic[®] SS7G21 or SS7G22 product. Before commencing these procedures, read the Chapter 7, "Warnings and Cautions", the safety advice in Section 10.1, and the warnings and cautions, in Section 10.2. The removal of the Top Cover is described in Section 10.3, and the internal layout is described in Section 10.4. The procedures that follow describe actions on components internal to the product.

10.1 Safety: Before Removing the Top Cover

Before removing the Top Cover at any time to work inside the product, observe these safety guidelines:

- 1. Turn off all peripheral devices connected to the product.
- 2. Power down the product by pressing and holding the power switch (🖒) on the front of the chassis for several seconds. After the product shuts down and the fans stop rotating, unplug or disconnect the power cords to remove standby power from the product.
- 3. Label and disconnect all peripheral cables and all telecommunication lines connected to connectors or ports on the back of the product.

10.2 Warnings and Cautions: Working Inside the Product

These warnings and cautions apply whenever the Top Cover of the product is removed.

Only a **qualified service technician** should remove the Top Cover of the product. Only a **qualified service technician** should integrate, configure, or service the product.



WARNING

POWER SWITCH

Shutting down the product with the Power switch on the front of the product does **not** remove all power from the product. To remove all power from the product, you must also unplug or disconnect the power cords from the product. Unplugging or disconnecting the power cords from the product removes the ± 12 Volt standby power that is present when the product is powered down (standby).



WARNING

HAZARDOUS CONDITIONS, POWER SUPPLY

Hazardous voltage, current, and energy levels are present inside the power supply. There are no user-serviceable parts inside the power supply; only technically qualified personnel should do servicing.



WARNING

HAZARDOUS CONDITIONS, DEVICES AND CABLES

Hazardous electrical conditions may be present on power, telephone, and communication cables. Turn off the product and unplug or disconnect power cords, telecommunications systems, networks, and modems attached to the product before removing the Top Cover. Otherwise, personal injury or equipment damage can result.



WARNING

HAZARDOUS CONDITIONS, PROCESSORS AND POWER SUPPLIES

Thermal conditions may be present in the processor or memory complex. Allow all fans to continue to run until they shut down on their own after power has been turned off. After the fans stop rotating, you can unplug or disconnect the power cords.





Caution

Electrostatic Discharge (ESD) and ESD Protection:

ESD can damage Hard Disk Drives (HDDs), boards, and other parts. We recommend that you do all procedures in this chapter only at an ESD-protected workstation. If one is not available, provide some ESD protection by wearing an anti-static wrist strap attached to chassis ground (any unpainted metal surface) on your product when handling parts.



Caution

ESD and Board Handling:

Always handle boards carefully. They can be extremely sensitive to ESD. Hold boards only by their edges. After removing a board from its protective wrapper or from the product, place it on a grounded surface free of static electricity. Do not slide boards over any surface.



Caution

Cooling and Air Flow:

For proper cooling and airflow, always install the Top Cover before turning on the product. Operating the product without the Top Cover in place can damage product components.

10.3 Removing and Installing the Top Cover

Removal of the Top Cover is necessary when installing or removing internal components. The Top Cover does not have to be removed when installing or replacing Power Supply Modules or Hard Disk Drives (HDDs), but it must be removed for installing SS7 Signaling Boards.



WARNING

If the unit is rack-mounted, make sure that the rack is anchored securely so it will not tilt forward when the unit chassis is extended. A crush hazard exists should the rack tilt forward that could cause serious injury.



Caution

For proper cooling and airflow, do not operate the SS7G21 or SS7G22 with the Top Cover removed. Always reinstall the Top Cover before turning the unit on.

To remove the Top Cover, follow this procedure:


- 1. Remove the Top Cover securing screw, which is on the side of the unit, near the back corner (labelled **A** in Figure 19). Retain the screw for replacement when the Top Cover is refitted.
- 2. Push down on the blue locking button on the Top Cover while sliding the Top Cover rearward to release it from the chassis.
- 3. Lift the Top Cover up to remove.

To install the Top Cover (after completing internal work), follow this procedure:

- 1. Place the Top Cover over the top of the chassis, slightly back from the front panel.
- 2. Slide the Top Cover forward until the blue locking button snaps shut.
- 3. Replace, and securely tighten, the Top Cover securing screw (labeled A in Figure 19).

Figure 20. Internal Product Layout



10.5 SS7 Signaling Boards

SS7G21 and SS7G22 are available with up to three SS7 Signaling Boards installed. The types of SS7 Signaling Boards that are installed depends on the model number.

The procedures in Section 10.5.1 to Section 10.5.3 describe the addition of new boards, and software License Buttons, but the general description can be applied to the replacement of a failed board. See Chapter 12, "Part Number Reference" for ordering information on standard product variants, SS7 Signaling Boards and software License Buttons.

SS7G21 Variants

For the Dialogic® SS7G21 product, two possible types of SS7 Signaling Board can be use:

- SPCI2S boards have two E1/T1 PCM interface ports, and two V.11 (V.35 compatible) ports on a shared connector. See Appendix A.
- SPCI4 boards have four E1/T1 PCM interface ports (and no V.11).

SS7G21 product variants with one, two, or three SPCI2S boards can be ordered by the suffix D1W, D2W or D3W respectively, for example, SS7G21AD1W. Product variants with one, two, or three SPCI4 boards can be ordered by the suffix Q1W, Q2W or Q3W respectively, for example, SS7G21AQ1W.

In the case of the D1W, D2W, or Q1W, Q2W product variants, it is possible to add further SS7 Signaling Boards, although each board purchased also requires a software License Button.

SS7G22 Variants

For the Dialogic[®] SS7G22 product, one type of board can be used:

• SS7HDP boards have four E1/T1 PCM interface ports (and no V.11).

SS7G22 product variants with zero, one, two, or three SS7HDP boards can be ordered by the suffix 00W, H1W, H2W or H3W accordingly, for example, SS7G22AH1W.

In the case of 00W, H1W, H2W variants, it is possible to add further SS7 Signaling Boards, although each board purchased also requires a software License Button.

10.5.1 Preparing SPCI Signaling Boards for Installation in SS7G21

The quantity, type, position and configuration of pre-installed SPCI Signaling Boards is determined by the product variant suffix; D1W, D2W, D3W, Q1W, Q2W or Q3W, as shown in Table 13.

Use Table 13 to determine the position and configuration of any additional (or replacement) SPCI Signaling Boards, and prepare the boards for installation. Ensure that the correct type of board is used. See Section 10.5, "SS7 Signaling Boards" on page 62.



Prepare an SPCI2S or SPCI4 Signaling Board for installation as follows:

- 1. Unscrew and discard the ISA edge retainer from new SPCI Signaling Boards (right end in Figure 21). Record the board and License Button serial numbers on your product records, then fit the license button.
- 2. Set the ADDR switch on the SPCI Signaling Board as in Table 13. The BOOT switch shall be set to 0 for all boards.
- 3. Ensure that 7 jumpers are fitted at J3 (CLK TERM). The jumpers are fitted in the "Linked" or "Open" (offset) position according to Table 13.

Note: The ADDR switch setting number is used only for internal functionality of the product. The board position number must be used for all configuration and wiring schedule purposes.

10.5.2 Preparing Dialogic® SS7HDP Signaling Boards for Installation in SS7G22

The type of signaling board must be the SS7HDP. The quantity, position and configuration, of pre-installed SS7HDP Signaling Boards is determined by the product variant suffix; 00W, H1W, H2W or H3W, as shown in Table 14.

Use Table 14 to determine the position and configuration of any additional (or replacement) SS7HDP Signaling Boards, and prepare the boards for installation.



Prepare an SS7HDP Signaling Board for installation as follows:

- Unscrew and discard the ISA edge retainer from a new SS7HDP Signaling Board (right end in Figure 22).
 Record the board and software License Button serial numbers on your product records, then fit the
 Licence Button.
- 2. Set the ADDR switch on the SS7HDP Signaling Board as in Table 14.

Note: The ADDR switch setting number is used only for internal functionality of the product. The board position number must be used for all configuration and wiring schedule purposes.

10.5.3 Installing or Replacing an SS7 Signaling Board

Installation of extra SS7 Signaling Boards in positions No. 2 and No. 3, or replacement of a board in any position, follow basically the same steps, but ensure that in each case the SS7 Signaling Board fitted is correctly configured as identified in Table 13, "Signaling Board Positions and Configurations for SS7G21 Product Variants" on page 63 and Table 14, "Signaling Board Positions and Configurations for Dialogic® SS7G22 Product Variants" on page 64.

Install/Replace an SS7 Signaling Board as follows, referring to Figure 23:

1. Remove the Top Cover. See Section 10.3.



- 2. To remove the Signaling Board Subsystem, un-latch it from the chassis by placing your thumb on the rear chassis rail, and your fingers inside the recess at the rear of the Subsystem. A gentle squeeze will then lift the rear part of the Subsystem and release the Riser Board from its connector. The Signalling Board Subsystem can then be simply lifted upward out of the chassis.
- 3. Loosen the captive screw, and remove the PCI card keep.
- 4. If installing an extra SS7 Signaling Board, unscrew and remove the PCI filler bracket from the slot in which the SS7 Signaling Board is to be inserted. Retain the screw.







Figure 24. Cable Tie Securing SS7 Signaling Board to Card Keep Frame

- 5. If replacing an SS7 Signaling Board, cut the cable tie securing the board to the frame near the PCI card keep location, as shown in Figure 24. Unplug the CT Bus cable connector from that board. Remove, but retain, the screw on that PCI end bracket. The SS7 Signaling Board should then be unplugged from the Riser Board, and be withdrawn from the frame.
- 6. Insert or replace the new SS7 Signaling Board, ensuring that the edge connector fully engages in the Riser Board socket, and that the PCI end bracket tang (see Figure 23) locates in the loop on the frame. Take great care to ensure that the EMC gasket (metal) fingers on the inside of the frame are not damaged, and that the PCI end bracket of the SS7 Signaling Board is centrally aligned to make good contact with them, and allow clear access for the network interface connectors.
- 7. Reinstall and tighten the screw on the PCI end bracket.
- 8. Reinstall the PCI card keep, and tighten the captive screw.
- 9. Connect the CT Bus cable to the SS7 Signaling Board. See CT Bus Cable Notes below.
- 10. Insert a new cable tie into the SS7 Signaling Board hole, tighten and crop, as shown in Figure 24.
- 11. Reinsert the Signaling Board Subsystem into the chassis, taking care to make sure that the interlocking metal tabs on the back of the Signaling Board Subsystem are correctly inserted into the slots in the back of the chassis, and that the Riser Board edge connector fully engages in the Server Board socket.
- 12. Install the Top Cover. See Section 10.3.

Figure 23. Installing and Replacing an SS7 Signaling Board

CT Bus Cable Notes

Note: When the CT Bus cable is installed, it is important that the two end connectors must be connected to boards. To achieve this consider the following:

- For single board systems, the CT Bus cable cannot be connected. For systems delivered as "single board", the cable is stowed in clips fastened to the underside of the Top Cover.
- If adding a second board to a system, the CT Bus cable should be taken from the clips and connected to the two boards.
- For "two board" systems, the two end connectors of the CT Bus cable must be used, and only the center connector may be left disconnected.

10.6 Replacing the Back-up Battery

A lithium battery on the Server Board provides power to maintain date and time settings in the absence of main AC or DC power. When the battery starts to weaken, it loses voltage, and the date and time settings may be wrong. The battery may be replaced by one labeled with Manufacturer and Part Number information that is identical to that marked on the original battery, or contact your customer service representative for advice on approved equivalent devices.



To replace the back-up battery, follow this procedure:

- 1. Observe the Safety and ESD advice, warnings and cautions in Section 10.1 and Section 10.2.
- 2. Remove the Top Cover as described in Section 10.3, and remove the Signaling Board Subsystem with the SS7 Signaling Board(s) as described in Section 10.5.
- 3. Locate the battery on the Server Board (see Figure 25).
- 4. Push the upper end of the metal retainer away from the battery; the battery pops up.
- 5. Remove the battery from its socket.
- 6. Dispose of the old battery according to local ordinance.
- 7. Remove the new battery from its package.
- 8. Being careful to observe the correct polarity, lay the new battery in the socket.
- 9. Push the new battery down; the metal retainer locks the battery in the socket.
- 10. Replace the Signaling Board Subsystem and Top Cover as described in Section 10.5.3 and Section 10.3.
- 11. Restore the date and time settings by using the CNTDS command, as detailed in the appropriate SS7G2x < Operating Mode > User Manual.

Figure 25. Replacing the Back-up Battery









11.1 WARNING: English





- 4. Label and disconnect all telecommunication cables and all other cables connected to connectors or ports on the back of the system.
- 5. Provide some electrostatic discharge (ESD) protection by wearing an anti-static wrist strap attached to chassis ground of the system—any unpainted metal surface—when handling components.
- 6. Do not operate the system with the chassis covers removed.



After you have completed the five SAFETY steps above, you can remove the system covers. To do this:

- 1. Remove and save all screws from the covers.
- 2. Remove the covers.



For proper cooling and airflow, always reinstall the chassis covers before turning on the system. Operating the system without the covers in place can damage system parts. To install the covers:

- 1. Check first to make sure you have not left loose tools or parts inside the system.

Appendix A

A.1 Connecting to V.11 (V.35-Compatible) SS7 Links

This appendix discusses the issues of connecting SS7G21 product variants which include SPCI2S boards to a V.35 interface. See the Chapter 12, "Part Number Reference" for the complete list of products variants. Units designated SS7G21ADxW and SS7G21DDxW have SPCI2S boards pre-installed.

The V.35 interface was originally specified by CCITT as an interface for 48 kbps line transmissions, and was discontinued by the CCITT (now ITU-T) in 1988, when it was replaced by recommendations V.10 and V.11.

V.35 has been adopted as a standard interface to carry SS7 to an STP in North America. The interface is little used in Europe and Asia.

V.35 is a mixture of balanced (RS-422 like) and common earth (RS-232 like) signal interfaces. The control lines including DTR, DSR, DCD, RTS and CTS are single wire common earth interfaces, functionally compatible with RS-232 level signals. The data and clock signals are balanced, RS-422 like signals.

There appears to be many different styles of connectors used in SS7 networks for connection to V.35 interfaces; the most common being an M34 "block connector".

A.1.1 Connectors on the SPCI2S Signaling Board

The SPCI2S provides two V.11 interfaces, designated as port A and port B. Both interfaces are physically sited on the same connector, that is, a high-density, 26-way D-type (DB) female connector, essentially 26 pins in a standard 15-way back shell. See Section 6.5, "SS7 Serial Interface Ports" on page 36 for more information.

The V.11 ports on the SPC12S support clock and data signals only, they do **not** support any control lines. On the practical side, this does sometimes mean that it is necessary to loopback one or more control lines to the remote end of the interconnecting cable, or in some circumstances be disabled at the remote equipment. It should not be significant in the operation of the SS7 protocol, since SS7 has very good built-in error detection that guickly detects any break in the signaling path (for whatever reason).

A.1.2 Cabling

Since it may be difficult to obtain a high-density, 26-way, D-type connector, Dialogic is able to supply a "Y" cable, type DKL26 (product ID SS7DKL26), that connects to the high-density, D-type connector on the rear of the SPCI2S and terminates in two standard, 15-way, D-connectors (DB15), one connector for each V.11 port.

The details and pinouts for this "Y" cable are provided in the Section 6.5, "SS7 Serial Interface Ports" on page 36. Suggested pinouts for other possible cabling situations are also described.

Where this cable is not appropriate, the following sections describe a number of different interconection examples that may aid the process of selecting the appropriate cabling.

Note: There is no standard for the signal "polarity" or "naming convention". Therefore, in order to make the equipment operate correctly, it may be necessary to reverse the connections between the true and inverted sense of a signal.

A.1.3 Clocking

Physically, the SPCI2S has two sets of clock pins for each serial port. These are designated "Transmit Clock" and "Receive Clock". The "Transmit Clock" is always an output, while the "Receive Clock" is always an input.

The following clocking modes are currently supported:

1. SPCI2S/SIU Generates Clocking

In this mode, the "Transmit Clock" signal is driven (at 64kb/s) by the SPCI2S/SIU. This signal is used to generate the transmit data and clock in the received data.

2. SPCI2S/SIU Receiving Clock

In this mode, the "Transmit Clock" signal is not used. The "Receive Clock" is applied externally to the SPCI2S and this is used for both generating the transmit data and clocking in the received data.

Most systems use mode b). However, if you are connecting to a switch that needs to be supplied a clock then mode a) is appropriate.

The use of transmit or receive clock is achieved by the settings of the MTP_LINK parameters in the SIU config.txt file appropriately (this is discussed further in Section A.1.4 below).

A.1.4 Configuring the SIU (SPCI2S) to Operate on V.11 Ports

In order to configure an MTP link to use the V.11 port correctly, the appropriate settings in the MTP_LINK command are required. Refer to the appropriate *SS7G2x <Operating Mode> User Manual* for details. Section 2.10, "Related Information" on page 13 lists the various user manuals.

Subsystem The appropriate selection of SS7 Signaling Boards for a given variant, configured,

mounted and retained in a sub-frame with Riser Board, which can be easily removed

and re-inserted in the main chassis as a single sub-assembly.

SPC12S A PCI board (full product ID: SS7SPC12SQ) that combines onboard support for SS7

common channel signaling protocols, with two digital line interfaces (T-1/E-1) and an
