INSTALLATION TIPS

Install vertically with cartridge hanging down and allow 2 inches above and below unit for cover removal and service access

Use 1/4" water line

The water inlet must supply a minimum of 0.5 $\ensuremath{\mathsf{gpm}}$

Allow at least a 1-1/2" clearance below the cartridge for easy cartridge replacement

Flush cartridge by running water through system for five minutes at full flow

OPERATION TIPS

Change cartridges on a regular 6-month preventative maintenance program

Change cartridges when capacity is reached or when pressure falls below 10 psi

Service flow rate must not exceed 0.5 gpm

Always flush the filter cartridge at time of installation and cartridge change


